(incorporated with limited liability in the Hellenic Republic with registration number 154558160000)

€5 billion Global Covered Bond Programme III

Under this €5 billion global covered bond programme III (the "**Programme**"), Eurobank S.A. (the "**Issuer**" or "**Eurobank**") (which entity following a demerger acquired all the assets and liabilities of Eurobank Ergasias S.A., (see "Demerger" below)) may from time to time issue bonds (the "**Covered Bonds**") denominated in any currency agreed between the Issuer and the relevant Dealer(s) (as defined below).

Application has been made to the Luxembourg Stock Exchange to approve this document as a base prospectus (the "**Base Prospectus**") pursuant to Part IV of the Luxembourg Act dated 16 July 2019 on prospectuses for securities for the purpose of admitting the Covered Bonds on the Euro MTF market of the Luxembourg Stock Exchange ("**Euro MTF**") and to be valid for a period of 12 months from the date of its approval.

Application has also been made to the Luxembourg Stock Exchange for Covered Bonds issued under the Programme to be admitted to trading on the Luxembourg Stock Exchange's Euro MTF market and to be listed on the official list of the Luxembourg Stock Exchange (the "**Official List**"). This document is not a base prospectus for the purposes of Section 12(a)(2) or any other provision of or rule under the United States Securities Act of 1933 (as amended) (the "**Securities Act**").

References in this Base Prospectus to Covered Bonds being listed and all related references shall mean that such Covered Bonds are intended to be admitted to trading on the Luxembourg Stock Exchange's Euro MTF market and are intended to be listed on the official list of the Luxembourg Stock Exchange's Euro MTF market for the purposes of Directive 2014/65/EU (the "**MiFID II**").

The Programme also permits Covered Bonds to be issued on the basis that they may be admitted to listing, trading and/or quotation on such other stock exchange or stock exchanges as may be agreed between the Issuer and the relevant Dealer. Covered Bonds may be unlisted or may be listed or admitted to trading, as the case may be, on other stock exchanges or markets agreed between the Issuer, the Trustee and the relevant Dealer(s) in relation to each issue. The Final Terms relating to each Tranche of the Covered Bonds will state whether or not the Covered Bonds are to be listed and/or admitted to trading and, if so, on which other stock exchanges or markets as may be agreed with the Issuer.

The maximum aggregate nominal amount of all Covered Bonds from time to time outstanding under the Programme will not exceed €5 billion (or its equivalent in other currencies calculated as described herein).

The payment of all amounts due in respect of the Covered Bonds will constitute direct and unconditional obligations of the Issuer, having recourse to assets forming part of the cover pool (the "**Cover Pool**").

The Covered Bonds may be issued on a continuing basis to one or more of the Dealers specified under "*General Description of the Programme*" and any additional Dealer appointed under the Programme from time to time, which appointment may be for a specific issue or on an ongoing basis (each a "**Dealer**" and together the "**Dealers**"). References in this Base Prospectus to the **relevant Dealer** shall, in the case of an issue of Covered Bonds being (or intended to be) subscribed by more than one Dealer, be to the lead manager of such issue and, in relation to an issue of Covered Bonds subscribed by one Dealer, be to such Dealer.

The price and amount of Covered Bonds to be issued under the Programme will be determined by the Issuer and each relevant Dealer at the time of issue in accordance with prevailing market conditions. Notice of the aggregate nominal amount of Covered Bonds, interest (if any) payable in respect of Covered Bonds, the issue price of Covered Bonds and any other terms and conditions not contained herein which are applicable to each Series or Tranche (as defined under "*Terms and Conditions of the Covered Bonds*") of Covered Bonds will be set out in a separate document specific to that Series or Tranche called the final terms (each, a "**Final Terms**") which, with respect to Covered Bonds to be listed on the Official List and admitted to trading on the Luxembourg Stock Exchange's Euro MTF market, will be delivered to the Luxembourg Stock Exchange on or before the date of issue of such Series or Tranche of Covered Bonds.

The rating of certain Series of Covered Bonds to be issued under the Programme may be specified in the applicable Final Terms as assigned by S&P Global Ratings, a division of S&P Global ("**S&P**") (or such other ratings that may be agreed by the Rating Agencies from time to time). S&P is established in the European Union and is registered under Regulation (EC) No. 1060/2009 (as amended) (the "**CRA Regulation**"). As such, S&P is included in the list of credit rating agencies published by the European Securities and Markets Authority on its website (at <https://www.esma.europa.eu/credit-rating-agencies/cra-authorisation>) in accordance with the CRA Regulation. A security rating is not a recommendation to buy, sell or hold securities and may be subject to suspension, change or withdrawal at any time by the assigning rating organisation. Investing in Covered Bonds issued under the Programme involves certain risks. The principal risk factors that may affect the ability of the Issuer to fulfil its obligations in respect of the Covered Bonds are discussed under "*Risk Factors*" below.

Interest and/or other amounts payable under the Covered Bonds may be calculated by reference to EURIBOR or €STR which constitute "benchmarks" under Regulation ("**EU**") 2016/1011 (the "**EU Benchmarks Regulation**") as specified in the relevant Final Terms. As of the date of this Base Prospectus, the administrator of EURIBOR (being the European Money Markets Institute) is included in the European Securities and Markets Authority's Register of administrators under Article 36 of the EU Benchmarks Regulation. The administrator of €STR, being as at the date of this Base Prospectus, the European Central Bank is not required to be registered on the European Securities and Markets Authority's register of administrators by virtue of Article 2 of the EU Benchmarks Regulations.

This Base Prospectus does not comprise a base prospectus for the purposes of Article 8 of Regulation (“EU”) 2017/1129 (as amended, the “**Prospectus Regulation**”).

This Base Prospectus comprises a base prospectus for the purposes of Part IV of the Luxembourg Act dated 16 July 2019 on prospectuses for securities.

The Issuer accepts responsibility for the information contained in this Base Prospectus and the Final Terms and for each Tranche of the Covered Bonds issued under the Programme and declares that, having taken all reasonable care to ensure that such is the case, the information contained in this Base Prospectus is, to the best of its knowledge, in accordance with the facts and contains no omission likely to affect its import.

For a period of 12 months following the date of this Base Prospectus, copies of each Final Terms (in the case of Covered Bonds to be admitted to trading on the Euro MTF market of the Luxembourg Stock Exchange) and the Base Prospectus will be available free of charge from the registered office of the Issuer and from the specified office of the Paying Agents for the time being in London or in Luxembourg at the office of the Luxembourg Listing Agent.

This Base Prospectus is to be read in conjunction with all documents which are deemed to be incorporated herein by reference (see the section entitled *Documents Incorporated by Reference* below). This Base Prospectus shall be read and construed on the basis that such documents are so incorporated and form part of this Base Prospectus. Any websites referred to or which have hyperlinks included in this Base Prospectus are for information purposes only and shall not be incorporated by reference in and do not form part of (save to the extent of any documents held on such website which are expressly incorporated by reference into this Base Prospectus) this Base Prospectus.

Each Series (as defined herein) of Covered Bonds may be issued without the prior consent of the holders of any outstanding Covered Bonds (the “**Covered Bondholders**”) subject to the terms and conditions set out herein under “*Terms and Conditions of the Covered Bonds*” (the “**Conditions**”) as completed by the Final Terms. This Base Prospectus must be read and construed together with any supplements hereto and with any information incorporated by reference herein and, in relation to any Series of Covered Bonds which is the subject of Final Terms, must be read and construed together with the relevant Final Terms. All Covered Bonds will rank *pari passu* and rateably without any preference or priority among themselves, irrespective of their Series, except for their respective Issue Dates, Interest Commencement Dates and/or Issue Prices.

The Issuer confirmed to the Dealer(s) named under "*General Information*" below that this Base Prospectus contains all information which is (in the context of the Programme, the issue, offering and sale of the Covered Bonds) material; that such information is true and accurate in all material respects and is not misleading in any material respect; that any opinions, predictions or intentions expressed herein are honestly held or made and are not misleading in any material respect; that this Base Prospectus does not omit to state any material fact necessary to make such information, opinions, predictions or intentions (in the context of the Programme, the issue and the offering and sale of the Covered Bonds) not misleading in any material respect; and that all proper enquiries have been made to verify the foregoing.

No person has been authorised to give any information or to make any representation not contained in or not consistent with this Base Prospectus or any other document entered into in relation to the Programme or any information supplied by the Issuer or such other information as is in the public domain and, if given or made, such information or representation should not be relied upon as having been authorised by the Issuer or any Dealer or any Arranger.

Neither the Dealer(s) nor any Arranger nor any of their respective affiliates have authorised or separately verified the whole or any part of this Base Prospectus and none of them makes any representation, recommendation or warranty (express or implied) or accepts any responsibility or liability as to the accuracy, adequacy, reasonableness or completeness of the information contained in this Base Prospectus or any document or agreement relating to the Covered Bonds or any Transaction Document. None of the Arrangers or the Dealers shall be responsible for any matter which is the subject of, any statement, representation, warranty or covenant of the Issuer contained in the Covered Bonds or any Transaction Documents, or any other agreement or document relating to the Covered Bonds or their distribution or any Transaction Document. Neither the Arrangers nor the Dealers shall be responsible for the execution, legality, effectiveness, adequacy, genuineness, validity, enforceability or admissibility in evidence of the Covered Bonds, the Transaction Documents or any other agreement or document relating to the Covered Bonds. Covered Bonds have not been and will not be registered under the United States Securities Act of 1933 (as amended) (the "**Securities Act**") and are subject to U.S. tax law requirements. Subject to certain exceptions, Covered Bonds may not be offered, sold or delivered within the United States or to U.S. persons. Covered Bonds may be offered and sold outside the United States in reliance on Regulation S under the Securities Act ("**Regulation S**").

PRIIPs / IMPORTANT – EEA RETAIL INVESTORS – If the Final Terms in respect of any Covered Bonds includes a legend entitled "Prohibition of Sales to EEA Retail Investors", the Covered Bonds are not intended to be offered, sold or otherwise made available to and should not be offered, sold or otherwise made available to any retail investor in the European Economic Area ("**EEA**"). Consequently no key information document required by Regulation (EU) No 1286/2014 as it forms part of UK domestic law by virtue of the EUWA (the "**UK PRIIPs Regulation**") for offering or selling the Covered Bonds or otherwise making them available to retail investors in the UK has been prepared and therefore offering or selling the Covered Bonds or otherwise making them available to any retail investor in the UK may be unlawful under the UK PRIIPs Regulation.

A determination will be made in relation to each issue about whether, for the purpose of the MiFID Product Governance rules under EU Delegated Directive 2017/593 (the "**MiFID Product Governance Rules**"), any Dealer subscribing for any Covered Bonds is a manufacturer in respect of such Covered Bonds, but otherwise neither the Dealers nor any of their respective affiliates will be a manufacturer for the purpose of the MiFID Product Governance Rules.

MiFIR PRODUCT GOVERNANCE / TARGET MARKET – The Final Terms in respect of any Covered Bonds will include a legend entitled "**UK MiFIR Product Governance**" which will outline the target market assessment in respect of the Covered Bonds and which channels for distribution of the Covered Bonds are appropriate. Any person subsequently offering, selling or recommending the Covered Bonds (a "**Distributor**") should take into consideration the target market assessment; however, a distributor subject to the FCA Handbook Product Intervention and Product Governance Sourcebook (the "**UK MiFIR Product Governance Rules**") is responsible for undertaking its own target market assessment in respect of the Covered Bonds (by either adopting or refining the target market assessment) and determining appropriate distribution channels.

A determination will be made in relation to each issue about whether, for the purpose of the UK MiFIR Product Governance Rules, any Dealer subscribing for any Covered Bonds is a manufacturer in respect of such Covered Bonds, but otherwise neither the Arranger nor Dealers nor any of their respective affiliates will be a manufacturer for the purpose of the UK MiFIR Product Governance Rules.

Neither this Base Prospectus nor any Final Terms constitutes an offer or an invitation to subscribe for or purchase any Covered Bonds and should not be considered as a recommendation by the Issuer, the Arranger, the Dealer(s) or any of them that any recipient of this Base Prospectus or any Final Terms should subscribe for or purchase any Covered Bonds. Each recipient of this Base Prospectus or any Final Terms shall be taken to have made its own investigation and appraisal of the condition (financial or otherwise) of the Issuer.

Each investor contemplating investing in any Covered Bond should: (i) determine for itself the relevance of the information contained in (including incorporated by reference into) this Base Prospectus, (ii) make its own independent investigation of the financial condition and affairs, and its own appraisal of the creditworthiness, of the Issuer and such Covered Bonds and (iii) make its own determination of the suitability of any such investment in light of its own circumstances, with particular reference to its own investment objectives and experience, and any other factors that are relevant to it in connection with such investment, in each case, based upon such investigation as it deems necessary.

The maximum aggregate principal amount of Covered Bonds outstanding at any time under the Programme will not exceed €5 billion (and for this purpose, the principal amount outstanding of any Covered Bonds denominated in another currency shall be converted into euro at the date of the agreement

to issue such Covered Bonds (calculated in accordance with the provisions of the Programme Agreement)). The maximum aggregate principal amount of Covered Bonds which may be outstanding at any one time under the Programme may be increased from time to time, subject to compliance with the relevant provisions of the Programme Agreement as defined under "*Subscription and Sale*".

In this Base Prospectus, unless otherwise specified, references to a **Member State** are references to a Member State of the European Economic Area, references to **€**, **EUR** or **euro** are to the currency introduced at the start of the third stage of European economic and monetary union pursuant to the Treaty establishing the European Community (as amended) and references to **Swiss francs** or **CHF** are to the lawful currency for the time being of Switzerland.

In this Base Prospectus, all references to **Greece** or to the **Greek State** are to the Hellenic Republic and all references to the **UK** are to the United Kingdom and references to **£** or **Sterling** are to the lawful currency for the time being of the United Kingdom.

In connection with the issue of any Series of Covered Bonds, the Dealer or Dealers (if any) named as the Stabilising Manager(s) (or persons acting on behalf of any Stabilising Manager(s)) in the applicable Final Terms may over allot Covered Bonds or effect transactions with a view to supporting the market price of the Covered Bonds at a level higher than that which might otherwise prevail. However, stabilisation may not necessarily occur. Any stabilisation action may begin on or after the date on which adequate public disclosure of the terms of the offer of the relevant Series of Covered Bonds is made and, if begun, may cease at any time, but it must end no later than the earlier of 30 days after the issue date of the relevant Tranche of Covered Bonds and 60 days after the date of the allotment of the relevant Tranche of Covered Bonds. Any stabilisation or over allotment must be conducted by the relevant Stabilising Manager(s) (or person(s) acting on behalf of any Stabilising Manager(s)) in accordance with all applicable laws and rules.

THE DEMERGER

On 20 March 2020, the core banking operations of the former Eurobank Ergasias S.A. were demerged. As part of the demerger:

- the former Eurobank Ergasias S.A. was renamed Eurobank Services and Holdings S.A. ("**Eurobank Holdings**") on 23 March 2020;
- a new wholly-owned banking subsidiary of Eurobank Holdings, Eurobank S.A. (the "**Issuer**"), was established;
- the Issuer assumed, by operation of universal succession under Greek law, all of the assets and liabilities of the core banking operations of the former Eurobank Ergasias S.A.; and
- Eurobank Holdings became the holding company for the 88 companies that, together with Eurobank Holdings, as at 30 September 2020 comprised the "**Group**".

In this disclosure, references to the Issuer should, for any period prior to 20 March 2020, be read as construed as references to the banking activities of the former Eurobank Ergasias S.A. and references to the Group should, for any period prior to 20 March 2020, be read as construed as references to the former Eurobank Ergasias S.A. and its consolidated entities.

The demerger was part of a major transformation designed to achieve:

- the legal separation of the Issuer that will allow its management to focus on core banking activities;
- a significant balance sheet de-risking through the securitisation of non-performing exposures ("**NPEs**"), while retaining those that the Issuer believes have better recovery and curing potential; and
- accelerated reduction of NPEs, as evidenced by the Group having achieved an NPE ratio of 5.2 per cent. as at 30 June 2023 (compared to an NPE ratio of 32.8 per cent. as at 30 June 2019).

The demerger of the core banking operations of the former Eurobank Ergasias S.A. (including its subsidiaries and associates) constitutes a common control transaction that involves the set-up of a new company, which is neither the acquirer, nor a business and therefore it is not a business combination as defined by IFRS 3 '*Business Combinations*'. As IFRS 3 guidance did not apply to the demerger, it has been accounted for as a capital re-organisation of the transferred business on the basis that no substantive economic change has occurred. In line with the Group's accounting policy for business combinations that involve the formation of a new entity in the case of a capital reorganisation, the acquiring entity (in this case the Issuer) incorporated the assets and liabilities of the acquired entity (in this case the banking sector transferred from the former Eurobank Ergasias S.A.) at their carrying amounts, as presented in the books of that acquired entity. The capital reorganisation did not have any impact on the Group's consolidated financial statements.

In the unconsolidated financial statements of Eurobank Holdings included in the Eurobank Holdings Annual Financial Report for the year ended 31 December 2020, the assets and liabilities of the business transferred (including investments in subsidiaries and associates) to the Issuer were derecognised and the investment in the Issuer was recognised at cost, which is the carrying value of the net assets given up. The Issuer incorporated the assets and liabilities of the business transferred to it at their pre-combination carrying amounts with a corresponding increase in share capital. Pre-existing valuation reserves under IFRS that were transferred to the Issuer were separately recognised in the Issuer's total equity.

As part of the demerger, Eurobank Holdings maintained activities and assets that are not related to the core banking operations but are mainly related to the strategic planning of the administration of non-performing loans and the provision of services to other Group companies and third parties. Further, Eurobank Holdings retained significant interests in certain securities and certain entities. For any assets or liabilities that could not be transferred, Eurobank Holdings will collect or liquidate the assets in accordance with the Issuer's instructions and the Issuer has agreed to indemnify Eurobank Holdings for the settlement of the liabilities including any associated costs or losses.

Further information relating to the de-merger and the associated transformation can be found in note 44 to the Issuer's Annual Financial Report for the year ended 31 December 2020.

RISK FACTORS

In purchasing Covered Bonds, investors assume the risk that the Issuer may become insolvent or otherwise be unable to make all payments due in respect of the Covered Bonds. There are a wide range of factors which individually or together could result in the Issuer becoming unable to make all payments due in respect of the Covered Bonds. It is not possible to identify all such factors or to determine which factors are most likely to occur, as the Issuer may not be aware of all relevant factors and certain factors which it currently deems not to be material may become material as a result of the occurrence of events outside the Issuer's control. The Issuer has identified in this Base Prospectus a number of factors which could materially adversely affect its business and ability to make payments due under the Covered Bonds.

The Issuer believes that the risks described below are the material risks inherent in the transaction for Covered Bondholders, but the Issuer does not represent that the statements below regarding the risks relating to the Covered Bonds are exhaustive. Additional risks or uncertainties not presently known to the Issuer or that the Issuer currently considers immaterial may also have an adverse effect on the Issuer's ability to pay interest, principal or other amounts in respect of the Covered Bonds. Prospective Covered Bondholders should read the detailed information set out in this document and reach their own views, together with their own professional advisers, prior to making any investment decision.

In addition, factors which are material for the purpose of assessing the market risks associated with Covered Bonds issued under the Programme are also described below.

Prospective investors should also read the detailed information set out elsewhere in this Base Prospectus and reach their own views prior to making an investment decision. Words and expressions defined in the "Terms and Conditions of the Covered Bonds" below or elsewhere in this Base Prospectus have the same meanings in this section. Investing in the Covered Bonds involves certain risks. Prospective investors should consider, among other things, the following.

Unless otherwise specified, references in this Base Prospectus to the “**Group**” are to Eurobank Holdings and its consolidated entities.

Factors that may affect the Issuer's ability to fulfil its obligations under instruments issued under the Programme

Economic and political risks

The Group's business is significantly affected by macroeconomic and financial developments, particularly in Greece.

The Issuer is the most significant operating member of the Group and one of the systemic banks operating in Greece. The Issuer's business, operating results, financial condition and prospects are in various ways exposed to the economic and financial performance, creditworthiness, prospects and economic outlook of companies and individuals operating in Greece or with a significant economic exposure to the Greek economy. For example, the Issuer's business activities depend on the level of demand for banking, finance

and financial products and services, as well as on its customers' capacity to service their obligations, or maintain or increase their demand for the Issuer's services. Customer demand and their ability to service their liabilities depend considerably on their overall economic confidence, business prospects or employment status, Greece's fiscal situation, investment and procurement by the Greek government and municipalities, and the general availability of liquidity and funding at a reasonable cost.

The Issuer operates mainly in Greece and its operations comprise the majority of the Group's business. For example, in the six month period ended 30 June 2023, the Group's Greek operations accounted for 75 per cent. of its operating income and 72 per cent. of its net interest income.

As a result, the Group's business, operating results, asset quality and general financial condition are directly and significantly affected by macroeconomic conditions and financial developments in Greece.

According to the Hellenic Statistical Authority ("**ELSTAT**"), real GDP in Greece decreased by 24.3 per cent. during the period from 2008 to 2016 based on the European System of Accounts methodology. The real GDP in Greece recovered by 7 per cent. between 2016 and 2019. Despite the negative effect of the COVID-19 pandemic (2020 real GDP growth rate at -9.0 per cent.), the balance turned positive again in 2021 with a real GDP growth rate of 8.4 per cent. According to ELSTAT's 1st estimation for the Gross Domestic Product (7 March 2023), the 2022 real GDP registered a growth rate of 5.9%. According to the Greek government's Draft Budget submitted in Greek parliament in early October 2023 ("**2024 Draft Budget**"), the real growth rate for 2023 is estimated at 2.3% and expected at 3.0% for 2024. The respective IMF forecast (April 2023) was at 2.6%. According to the European Commission's 2023 Spring Forecast (Forecast¹ as of May 2023), the real growth rate for 2023 and 2024 is expected at 2.4 per cent. and 1.9 per cent. respectively. However, negative macroeconomic developments in Greece following the Financial Crisis (as defined below) had a severe adverse effect on the Greek banking system; in particular, this affected Greek banks' capital ratios as significant losses driven by large write downs of the value of Greek government debt holdings and high levels of NPEs were incurred – such losses also constrained Greek banks' liquidity.

In addition to their effect on the Group's operations in Greece, the adverse macroeconomic and financial developments in Greece since the Financial Crisis (as defined below) also had a material adverse effect on the Group's reputation, its competitive position as against international banks and deposits in the Group's international operations.

A positive side effect of the COVID-19 pandemic for Greece was the inclusion of Greek Government Bonds ("**GGBs**") in the European Central Bank's ("**ECB**") Pandemic Emergency Purchase Programme ("**PEPP**") in March 2020. The PEPP purchases ended at the end of March 2022 but the maturing principal payments from securities purchased in the context of the PEPP (including securities issued by Greece) will be reinvested at least until the end of 2024. Moreover, according to the ECB, in the event of renewed market

fragmentation and in order to ensure the transmission of monetary policy to the Greek economy, the purchases of Greek bonds will continue over and above redemptions. Furthermore, in July 2021, the ECB's Governing Council approved the establishment of the Transmission Protection Instrument ("TPI"), a new tool for secondary market purchases of securities that will also contribute to the effective transmission of monetary policy when activated. As of the end of September 2023, net GGB purchases by the ECB through the PEPP amounted to €38.3 billion.

Greece's macroeconomic and financial prospects remain sensitive to international conditions. The inflation, resulted principally from the energy price crisis that followed the Russian invasion of Ukraine on 24 February 2022 and, to a lesser extent, from post-COVID19 related supply shortages, persists despite the interest rate hikes already implemented by the ECB. The Harmonised Index of Consumer Prices ("HICP") rate for the Euro area ("EA") is estimated at 5.8 per cent. for 2023 and expected at 2.8 per cent. for 2024 from 8.4 per cent. in 2022, according to the European Commission's 2023 Spring Forecasts (February 2023). The respective HICP figures for Greece are 9.3 per cent. for 2022 and 4.2 per cent. and 2.4 per cent. for 2023 and 2024 respectively. In turn, the rise in inflation worldwide led the main central banks to raise their policy rates. The ECB raised its policy rates by 50 basis points on 27 July 2022, by 75 basis points on 14 September 2022, by 75 basis points on 2 November 2022, by 50 basis points on 21 December 2022, by 50 basis points on 8 February 2023, by 50 basis points on 22 March 2023, by 25 basis points on 10 May 2023, by 25 basis points on 21 June 2023, by 25 basis points on 2 August 2023 and by 25 basis points on 14 September 2023. Overall, the interest rate on the ECB's main refinancing operations ("MRO") increased from 0.00 per cent., prior to the July 2022 ECB Governing Council Meeting to 4.50 per cent. on 20 September 2023. This process resulted in higher sovereign borrowing costs. The yield of the 10-year GGBs increased from 1.34 per cent at the end of December 2021 (before the start of the Russian invasion in Ukraine) to 4.36 per cent. in 29 September 2023, with the 10 year GGBs spread over Bunds at 151.5 basis points at the end of 2021 to 151.7 basis points on 29 September 2023. A protracted deterioration in risk assessment internationally, and/or in macroeconomic or liquidity conditions in the Euro Area or globally, and/or in the emerging geopolitical risks globally, could have a negative impact on the risk assessment of Greece and the Greek private sector, as well as affect economic conditions and Greek asset valuations.

Any of these factors could weaken Greece's capacity to access the markets in competitive terms, which could result in higher borrowing and debt servicing costs for the Government and reduce the liquidity available to the private sector in general.

The outbreak of COVID-19 has impacted and may further adversely impact the Group and its customers, counterparties, employees, and third-party service providers, and a new outbreak is likely to have a material adverse effect on the Group's business, financial position, results of operations and prospects

The COVID-19 pandemic has adversely affected production, disrupted supply chains, altered demand patterns, increased uncertainty, and resulted in widespread volatility not seen since the Financial Crisis (as defined below). For more details on the economic impact of the pandemic, and the actions undertaken

by the EU and Greek authorities to contain it and mitigate its social and economic effects, see paragraph “*The COVID-19 pandemic in 2020-2022*” in the section “*Economic Overview*”.

In May 2021, Greece started repealing the COVID-19 restrictions that it had introduced between March 2020 and April 2021. As of September 2023, the majority of such restrictions have been repealed. The Greek government has indicated that the possibility of a new nationwide lockdown is not on the table; if required, any containment measures and restrictions would be introduced locally, with fully vaccinated individuals exempt from such containment measures and restrictions where possible.

Due to widespread vaccination, risks associated with COVID-19 have significantly decreased in 2023, compared to the risk prevailing between 2020 and 2022. However, a new outbreak of COVID-19 cannot be definitively ruled out. It is not therefore possible at this time to accurately predict the ultimate impact of such an outbreak on the global and Greek economy, and/or the Group. Adverse consequences on the Group in such a case could include: (i) declines in net interest income and non-interest income from reduced activity or higher volatility, as well as declining prices in financial, real estate and/or commodities markets,

(ii) higher credit losses and increases in expected credit losses as a result of the Group's customers failing to meet existing payments or other obligations, this being caused by businesses remaining closed, unemployment rising and/or the Group's clients and customers drawing on their lines of credit or seeking additional loans or payment holidays to help finance their personal or business needs, (iii) a further reduction in demand for the Group's products and services, including loans, deposits and asset management services, (iv) failure to meet the minimum regulatory capital and liquidity ratios and other legal requirements, (v) possible downgrades to the Group's credit ratings, and (vi) disruptions to significant portions of the Group's operations, resulting from illness and quarantines, shelter-in-place arrangements, governmental actions and/or other containment measures.

The Greek economy remains susceptible to economic, financial and other changes arising from international developments

Non-transitory nature of the current inflationary pressures

Since the gradual reopening of the global economy from the pandemic-induced lockdowns in 2021, inflation rate has increased in most advanced economies around the world. This is attributed to a variety of reasons, including the Russian invasion of Ukraine and the energy price hikes resulting from the sanctions imposed on Russia, the strong post-lockdown spike in demand, and the disruptions in supply chains due to other local or sector-specific factors. According to the ECB (September 2023), Euro Area inflation is expected to stay above the 2.0 per cent. target for an extended period (with inflation expected at 5.6 per cent., 3.2 per cent. and 2.1 per cent. in 2023, 2024 and 2025 respectively) from 2.6 per cent. and 8.4 per cent. in 2021 and 2022 respectively. Similarly, according to the Federal Reserve latest projections of June 2023, the US inflation rate is expected to be 3.3 per cent., 2.5 per cent and 2.2 per cent. for 2023, 2024 and 2025 respectively.

The Harmonised Index of Consumer Prices (“**HICP**”) increase in both the Euro Area (“**EA**”) and Greece was driven mainly by energy prices, even before the Russian invasion of Ukraine on 24 February 2022, mainly due to supply constraints in the respective markets. The Russian invasion in Ukraine and the still ongoing energy crisis, amplified the negative effect on prices and inflation spikes. Recent inflation deceleration is mainly attributed to milder weather in winter months of 2022-2023, reduced fossil fuel demand, elevated natural gas inventories, initiatives to curb energy demand and to substitute Russian fuel imports with alternatives as well as the central banks’ policy.

According to Eurostat’s provisional data (8 June 2023), the EA real GDP growth was at 5.4 per cent. and 3.3 per cent. in 2021 and 2022 respectively. Under the ECB’s baseline scenario (September 2023), real GDP growth in the EA was estimated at 0.7 per cent. in 2023 (from 3.4 per cent. in 2022) and was expected at 1.0 per cent. and 1.5 per cent. in 2024 and 2025 respectively. At the same time, inflation in the EA was estimated at 5.6 per cent. in 2023 (from 8.4 per cent. in 2022) and was expected at 3.2 per cent. and 2.1 per cent. in 2024 and 2025 respectively. The ECB’s sensitivity analysis using alternative paths for energy prices points to upside risks compared to the aforementioned baseline scenario.

According to Focus Economics (“**FE**”), a private sector firm that collects forecasts, the market consensus in October 2023 for the real GDP growth rate in the EA is at 0.6 per cent. and 0.9 per cent. in 2023 and 2024 respectively, while the respective inflation rate (HICP) consensus forecasts are at 5.6 per cent. and 2.8 per cent. in 2023 and 2024 respectively.

In a similar vein, persistent inflationary pressures and the continuation of the war in Ukraine is expected to continue to have a significant impact in Greece through energy price hikes, possible delays in direct investments and lower tourist revenues due to slower economic growth of its main trading partners (despite its limited direct trade and financial linkages with Russia and Ukraine). According to Eurostat’s provisional data, the real GDP growth rate for Greece for 2021 and 2022 is at 8.4 per cent. and 5.9 per cent. respectively and inflation rate in HICP terms is at 0.6 per cent. and 9.3 per cent. respectively. According to the 2024 Draft Budget, the real GDP growth is estimated at 2.3 per cent. for 2023 and estimated at 3.0 per cent. for 2024. The HICP for 2023 is expected at 4.0 per cent. and estimated at 2.4 per cent. for 2024. According to FE’s October 2023 market consensus forecast, real GDP growth in Greece was expected to be 2.2 per cent. and 2.0 per cent. for 2023 and 2024 respectively. FE’s inflation forecasts were 4.1 per cent. and 2.4 per cent. for 2023 and 2024 respectively.

Should the inflation spike persist or increase further in the following quarters, this would adversely impact Greek households, businesses, banks and the Greek government. Reduced purchasing power of households, and increased costs for businesses, could reduce the size and/or the quality of the pool of prospective borrowers, and increase repayment delinquency rates. On the fiscal side, it could lead to lower tax revenue, and induce higher government spending in relief measures. The prolongation of inflationary pressures into the last quarter of 2023 and beyond could also induce more ECB policy rate hikes.

Exacerbation of natural disasters due to climate change

Global warming and climate change are negatively affecting and are expected to further affect Greece in the future. Potential consequences include (i) adverse effects on human health and welfare, (ii) increased demand for energy around the year, making carbon-dependent economies like Greece more vulnerable to international fluctuations in fossil fuel supply and prices, (iii) extreme weather and natural disasters, such as wildfires, heatwaves, hurricanes, floods, frost waves and hailstorms occurring with increasing frequency, (iv) increased fiscal costs, including lower tax revenue and higher public spending on prevention, management and relief measures of such natural disasters and (v) the permanent devaluation or destruction of part of the output generated by activities that rely heavily on the climate and the natural environment, such as tourism, agriculture, forestry, and fishing, and the impact of this on GDP, employment, competitiveness, and state and tax capacity.

These factors can have a significant negative effect on the Group, reducing demand for its products and services, and adversely impacting the financial position and creditworthiness of its customers, and cause widespread insolvency. They can also have an indirect impact by worsening the financial environment and exerting upwards pressure on Greece's sovereign borrowing costs.

Greece's economy remains susceptible to significant downside risks

Despite the emergence from a long recession in 2017, economic and financial conditions in Greece remain susceptible to significant downside risks, many of which have been aggravated by the impact of and the recent inflationary pressures caused by the energy crisis and the aftermath of the COVID-19 pandemic, including:

Low absorption of EU funds, limited implementation capacity of the relevant projects and reforms, and/or failure to meet the prerequisites for fund disbursement

The Recovery and Resilience Facility (“RRF”) funds need to be committed to eligible projects and initiatives before the end of 2027 and the end of 2023, respectively, and these projects and initiatives must be completed before the end of 2030 and the end of 2026, respectively. Funds not committed, and disbursed funds not spent, will be returned to the European Commission (the “EC”). There is limited discretion in the allocation of RRF funds: a comprehensive list of projects, reforms, and initiatives to be funded must be submitted to the EC for approval in the form of a National Recovery and Resilience Plan (“NRRP”), setting out how the proposed spending will help the benefiting country achieve certain milestones and targets. Moreover, according to the RRF regulations, funds shall be disbursed under strict conditions and under a strict timeline. The total amount of the RRF funds is up to €30.5 bn (€17.8 bn in grants and € 12.7 bn in loans). Greece has been also allocated ca €40bn through Multiannual Financial Framework (MFF 2021–2027, EU's long-term budget), out of which close to €21bn will fund investments and initiatives under its new Partnership Agreement for the Development Framework (ESPA 2021–2027).

In July 2021, the Economic and Financial Affairs Council approved the Greek NRRP titled “Greece 2.0”. A pre-financing of €4 billion was disbursed in August 2021. So far a total of nearly €11.1bn of RRF funds

(€5.7bn in grants and €5.4bn in loans) were disbursed: the first two regular payments of €3.6 billion each were disbursed in April 2022 and January 2023 respectively towards the respective “Greece 2.0” structural reform milestones. Past experience from similar programmes in Greece has shown that full absorption of EU funds may be challenging due to red tape, coordination issues between different levels of government, incomplete enforcement of contracts and long court delays. Yet there are signs suggesting that the situation has improved lately: fund absorption has accelerated significantly in the past two years (it was at a low of 32.7 per cent. between 2014 and 2018, but had exceeded 70 per cent. at the end of 2021); the commitment of the Greek authorities is reflected in the fact that the Greek NRRP was one of the first to be submitted to, and approved by, the EC; it is also guided by a comprehensive new Growth Plan for the Greek Economy (Pissarides, Vayanos, Vettas, and Meghir, 2020) that was seen as a solid plan by EU sources.

Nevertheless, any failure of the government to achieve the milestones and targets stipulated by the EC, or any delays in the completion of NSRF and RRF projects and initiatives, may lead to the delay or even withholding of the respective funds, causing negative impacts on the country’s growth rate, competitiveness, shock-resilience, borrowing capacity, and cost of borrowing. Furthermore, even if RRF projects are completed, failure to successfully implement the structural reforms stipulated in the Greek NRRP in their entirety would significantly reduce the long-term impact of the realised projects on GDP growth and sustainability. It could also fail to attract the amount of private investment planned in the Greek NRRP, leading to an outcome inferior to the one estimated by BoG (which is a permanent increase in GDP by 6.9 per cent. by the end of 2026).

Prolonged fiscal and external sector imbalances

The persistent so-called “twin deficits” (i.e. primary fiscal and current account deficits) constituted a key feature in the growth path of Greece in the decades preceding the debt crisis of the 2010s. Following the pandemic-induced recession, the combination of these deficits emerged again in 2020 and 2021 (see paragraph “Greek economy outlook for 2023 and 2024” in the section “Economic Overview”). Despite any similarities to the past, there are also crucial differences: (i) the twin deficits of 2020, 2021 and 2022 appear to be more a consequence of the energy crisis and the pandemic, rather than a structural feature of the Greek economy, as similar macroeconomic imbalances have been observed at a global level in the past three years; (ii) Greece committed in the SGP2023-26 to return to primary fiscal surpluses from 2023 onwards. Following the resolution of the political risk, the above items currently constitute one of the main factors affecting the decisions of the rating agencies towards Greece. At the date of this prospectus Greece is one notch below investment grade according to Fitch and Moody’s. DBRS’ rating improved to “BBB(low)” in September 2023 and S&P’s to “BBB-“ on 20 October 2023, both with a stable outlook, achieving investment grade for the first time since early 2011. S&P rating improved to “BBB-“ in October 2023 with a stable outlook, the first investment grade from the three main rating agencies.

An extended prolongation of the above imbalance, caused by a failure by Greece to (i) continue on a primary fiscal surplus path according to the requirements of the post programme surveillance and its debt sustainability analysis from 2023 onwards and (ii) reduce its current account deficit, would reduce Greece’s external solvency, exert upward pressures on the government’s borrowing costs, and delay the upgrading

of Greece's sovereign rating by the international rating agencies, which is a prerequisite for the eligibility of GGBs in the ECB's various asset purchase programmes.

Adverse geopolitical developments in the near or broader region

Greece constitutes the south-easternmost border of the EU and thus is the most natural crossing point for irregular migrants to reach Western and Northern Europe. Materialisation of this risk could cause fiscal pressures on Greece as a result of increased administrative, logistic and supply costs related to the hosting of the refugees crossing through Greece, and the processing of their asylum applications. Additional risks may stem from developments in the Eastern Mediterranean region related to the delineation of maritime boundaries and exclusive economic zones.

Other country-related risks

Greece's economic performance remains sensitive to a number of internal factors, the most significant risk factors being:

- Pressures on economic activity: additional pressures on economic activity could arise from the introduction of new fiscal measures as a part of the Greek government's efforts to ensure a timely achievement of the medium-term fiscal targets and the continuation of achievement of positive primary fiscal balances from 2023 onwards without achieving its real GDP rate target for the said year; already the 2023 primary fiscal balance in the 2024 Draft Budget is estimated at 1.1 per cent. of GDP and expected at 2.1 per cent. for 2024. This would negatively impact the private sector's savings, consumption, and investment. These effects could adversely affect financial conditions and credit demand, and weaken economic growth in the near to medium term.
- Reversal of labour or product markets reforms: a potential reversal of some reforms in the labour or product markets could reduce market flexibility and lead to rising wage or other cost pressures, threatening to reverse competitiveness gains achieved in previous years. Moreover, amid an inflationary environment, pressure on wage and pension increases might further contribute to an inflationary spiral and also create risks for the short term fiscal targets.
- The real estate market: increase of real estate prices has been a positive development as it has improved collateral values posted by borrowers and supported domestic spending through positive wealth effects. However, the high backlog of unsold houses, in conjunction with the gradual acceleration in foreclosures by banks and the Greek government due to defaults on loans and tax obligations, is expected to continue to feed into the supply side of the market. Moreover, the relatively high tax pressure on real estate is expected to continue to challenge the recovery of the real estate market.

To the extent that the aforementioned risks materialise, they are likely to continue to exert pressure on private consumption and could lead to delayed investment and capital spending decisions, thus reducing demand for the services offered by the Group. The Group's business activities are dependent on the level

of banking, finance and financial products and services it offers, as well as its customers' capacity to repay their liabilities. In particular, savings levels and credit demand are heavily dependent on customer confidence, disposable income trends, and the availability and cost of funding, any of which could be negatively affected by the materialisation of any of the above factors. Moreover, the Group's customers may further decrease their risk tolerance to non-deposit investments such as stocks, bonds and mutual funds, which would continue to adversely affect the Group's fee and commission income.

The Group conducts significant international activities outside Greece and the Group is exposed to political instability and other risks in these countries

In addition to its operations in Greece, the Group has substantial operations in Bulgaria, Cyprus and Luxembourg. The Group's international operations accounted for 24 per cent. of its gross loans as at 30 June 2023 and 28 per cent. of its net interest income in the period ended 30 June 2023.

The Group's international operations are exposed to the risk of adverse political or economic developments in the countries where it operates

These risks are heightened in certain countries, such as Bulgaria and Cyprus, where the Group faces particular financial and operational risks. Bulgaria had been confronted with the risk of political instability for a prolonged period of almost two years but such risk has recently decreased following the formation of a coalition government in June 2023. The target date for Bulgaria adopting the euro remains deferred to 1 January 2025 (from 1 January 2024 initially), as the economy of Bulgaria failed to meet the inflation criteria (while there are also delays in the adoption of all necessary legislation). However, inflation in Bulgaria has been put on a downward trend since late 2022. The Consumer Price Index ("CPI") came in at 7.7 per cent. year-on-year in August, having more than halved since December 2022 (when it stood at 16.9 per cent. year-on-year). Modest optimism is also spurred from the 2Q2023 GDP print as it expanded by 0.4 per cent. quarter-on-quarter in seasonally adjusted terms, the same pace with the first quarter of 2023. The Bulgarian economy continued to avoid recession despite the high energy prices and the broader unfavourable external environment but based on the decelerating annual GDP print (+1.8 per cent. year-on-year in the second quarter of 2023 from +2.1 per cent. year-on-year in the first quarter of 2023 in seasonally adjusted terms) a gradual deceleration trend is spotted. In Cyprus, the NPL ratio continues to rank among the highest in the EU. It weakened slightly during the 2022 period from 11.0 per cent. at the end of December 2021 to 9.3 per cent. at the end of December 2022. According to the most recent Bank of Cyprus data, the NPLs at the end of June 2023 were at 8.7 per cent. with households NPLs at 11.2 per cent. and SMEs NPLs at 9.2 per cent. (from 11.2 per cent., 13.4 per cent. and 9.4 per cent. respectively in June 2022). Throughout 2023, some particular factors could affect the financing policy of the banking sector in Cyprus, associated mainly with the foreclosure proceedings suspension for loans up to March 2023, the on-going preparation of a new real estate protection scheme, as well as the enactment of the "mortgage-to-rent" scheme in July 2023. On the economic growth front, FY2022 real GDP increase in Cyprus decelerated to 5.6 per cent. from 6.6 per cent. in 2021, less than initially expected due to the Russian war in Ukraine. The slowdown sharpened in the first half of 2023, with growth rates of 3.2 per cent. year-on-year in the first quarter of 2023 and 2.3 per cent. year-on-year in the second quarter of 2023, and the quarterly change

turning negative in the latter period for the first time in the last two years (-0.4 per cent.). In addition, the economies of these countries may be negatively impacted by subdued external demand, tightening global financial conditions stemming from several central banks' efforts to reduce persistently high inflation and restore price stability, and lingering geopolitical tensions following Russia's invasion of Ukraine in February 2022. These factors could have a material adverse effect on the Group's business and results of operations, with their impact already evident on the increased borrowing costs the economies of the Central, Eastern and Southeastern Europe region are confronted with.

The Group is vulnerable to disruptions and volatility in the global financial market

Most of the economies with which Greece has strong export links, including a number of European economies, have been adversely affected by COVID-19 and continue to face high levels of private or public debt. Concerns remain about the longer term economic impact of COVID-19, including the potential path of economic recovery both in Europe and globally. Moreover, additional risks have emerged in 2022. The unexpected onset of the Russia-Ukraine war, and subsequent Western sanctions imposed on Russia have created expectations of higher geopolitical risks and have increased volatility in financial markets. Further, though wholesale gas prices have declined sharply to 1-½ year lows, well before Russia's invasion of Ukraine, there is still some delayed pass-through of past increases to household bills, while the boost from the pandemic-reopening of the European economy appears to be fading. Furthermore, persistently high inflation has drastically changed the monetary policy outlook during the year in many developed (e.g., the EA, the US and the UK) and emerging economies (e.g., Latin America, Eastern Europe and parts of Asia). Policy rates have risen sharply and may potentially move even higher in the coming months in both the EA and the US. Expectations for the continuation and uncertainty on the extent of further restrictive policy actions, especially in major economies, have increased the downside risks to the economic outlook, adversely affected market sentiment and further contributed to increased volatility in financial markets. Such factors may have a corresponding adverse effect on the Group's business and results of operations.

The Group's business and results of operations, both in Greece and abroad, have been in the past, and are likely to continue to be in the future, materially affected by many factors of a global nature, including political and regulatory risks and the condition of public finances; the availability and cost of capital; the liquidity of global markets; the level and volatility of equity prices, commodity prices and interest rates; currency values; the availability and cost of funding; inflation; the stability and solvency of financial institutions and other companies; investor sentiment and confidence in the financial markets; global pandemic diseases or a combination of any of these factors.

Funding risks

A considerable portion of the Group's funding is in the form of customer deposits and if the Group is unable to continue to increase its deposits its business may be significantly constrained

Customer deposits are the Group's principal source of non-equity funds. Over the past few years, the Group has been able to increase its deposits base from €44.8 billion as at December 2019 to €57.2 billion as at 31 December 2022, and to €55.9 billion as at 30 June 2023. As at 30 June 2023, customer deposits

accounted for 81 per cent. of the Group's total non-equity funding (for this purpose defined as the sum of customer deposits, amounts due to credit institutions, amounts due to central banks and debt securities in issue).

There is significant competition for retail and corporate deposits in Greece. The Group faces competition mainly from other Greek banks, Greek branches of foreign banks and foreign banks acting for certain international companies, many of which may have greater resources and superior credit ratings. The Group's competitors may be able to attract deposits faster or secure funding at lower rates.

The ongoing availability of sufficient deposits to fund the Group's loan portfolio is subject to changes in factors outside the Group's control, including in particular:

- potential depositors' concerns regarding the economy in general, the financial services industry or the Group in particular;
- potential significant deterioration in economic conditions and outlook in Greece or other changes that result in customers withdrawing their deposits;
- potentially increased competition for gathering deposits in the context of restrictive monetary policies (in the EA and globally) and sharply rising interest rates;
- the availability and extent of deposit guarantees; and
- the availability of alternative products to deposits such as government issued securities available for the public.

Any loss of customer confidence in the Group or in the Greek banking sector in general could significantly increase the Group's deposit outflows or increase the cost of its deposits in a short period of time. If the Group experiences an unusually high level of withdrawals and is unable to replace such withdrawals, the unavailability of funding or higher funding costs may have an adverse effect on the Group's business and results of operations. Unusually high levels of withdrawals could prevent the Group from funding its operations and meeting minimum liquidity requirements. In such circumstances, the Group may not be in a position to continue to operate without additional funding, which the Group may not be able to secure.

The Group's ability to obtain unsecured funding debt is gradually improving however sustained access to capital markets remains relatively limited

The long period of recession and weak economic growth in Greece resulting from the Greek Financial Crisis (as defined below) adversely affected Eurobank's credit rating, limited the Group's access to international markets for debt funding and significantly reduced the Group's deposit funding; these factors caused the Group to become reliant on funding from the Eurosystem. The deterioration in Eurobank's credit rating during that period also caused increased funding costs and the need to provide additional collateral in repurchase agreements and other collateralised funding agreements, including Eurobank's agreements with the ECB and the Bank of Greece. The Group's access to the capital markets for funding,

in particular unsecured funding and funding from the short-term interbank market, was also severely restricted during that period.

More recently, due to (a) improvements in the Greek sovereign credit rating; (b) the successful execution of the Group's corporate transformation project (which aimed to substantially reduce the Group's NPE ratio and improve the Group's financial condition); (c) positive signs of market access; (d) the modest gradual improvement of Eurobank's credit rating, and (e) the need to comply, over time, with regulatory obligations regarding the MREL Requirement, the Group's ability to obtain liquidity through unsecured funding has been gradually improving. As a result, the Group began implementing its strategy of returning to the international debt capital markets and in 2021, 2022 and the first half of 2023 has successfully issued a total of EUR 2bn of MREL eligible senior preferred debt instruments in four capital market transactions and EUR 0.3bn MREL eligible Tier II debt instruments. Moreover the Group is planning to continue such issuances in the coming years with the goal of further consolidating its access to capital markets, while also satisfying regulatory requirements (there is, however, no assurance that such strategy will continue to be feasible in the short or medium-term, especially as its rating still remains constrained relative to other European periphery peer banks while market conditions and outlook have deteriorated from mid 2022 onwards in light of the restrictive central bank interest rates policies in Europe and elsewhere, which may continue to affect investor sentiment and consequently Eurobank's and the Group's sustained ability to access capital markets).

Since the end of January 2019, the ECB has been the only source of official sector funding for Eurobank. Following the ECB's decision to relax collateral rules and offer more attractive funding terms to financial institutions in the first half of 2021 (in an effort to mitigate the adverse impact of COVID-19 on the European economy by encouraging lending), the Group has increased its ECB funding to €8.8 billion (of which €8.0 billion was raised in Greece) as at 31 December 2022 and at €7.4bn as at 30 June 2023.

The amount of Eurosystem funding available to the Group is tied to the value and/or the rating of the collateral the Group is able to provide, including, for example, the Group's holdings in Greek government bonds, whose value may decline (particularly if the economy weakens, see "—The Group is exposed to impairment losses and market volatility due to its exposure to investment securities below). In addition, if Eurosystem were to revise its collateral standards or change the rating requirements for collateral securities, such that these instruments are no longer eligible to serve as collateral, the Group's funding cost would increase and the Group's access to liquidity would become more limited.

The Group may require additional capital to satisfy supervisory capital requirements and such capital may prove difficult or expensive to obtain or may not be available

The Group and Eurobank are required by their regulators to maintain minimum capital ratios. As at 30 June 2023, the Group had a phased-in CET1 ratio of 15.6 per cent. (calculated under Regulation (EU) 575/2013 as in force) against a supervisory review and evaluation process ("SREP") CET 1 capital requirement of 6.05 per cent. (excluding buffer requirements). Based on the end-state Basel III requirements in 2025, the Group had a fully loaded CET1 ratio of 16.3 per cent. The required capital levels may increase in the future

(for example, the countercyclical capital buffer is increased from 25bps (2Q2023) to 38bps in 2023 year end: the Other Systematically Important Institution (O-SII) Buffer: the SREP process as applied to Eurobank or any future SSM-wide stress tests conducted by the ECB could, in each case, result in higher capital requirements that apply specifically to Eurobank) and/or the manner in which the relevant capital requirements are applied may change in a manner that adversely affects the Group's and/or Eurobank's capital ratios.

Effective management of regulatory capital is critical to the Group's ability to operate, to grow organically and to pursue its strategy. Any change that limits the Group's or Eurobank's ability to efficiently manage its balance sheet and regulatory capital resources, including, for example:

- reductions in profits and retained earnings or losses, whether as a result of the worsening economic conditions caused by inflationary pressures, asset write-downs or otherwise, which would reduce the amount of regulatory capital;
- increases in risk-weighted assets (“**RWAs**”) which, without an appropriate increase in regulatory capital, would reduce the relevant capital ratios;
- delays in, or an inability to effect, the disposal of certain assets that would, if disposed of, reduce RWAs;
- inability to syndicate loans that would, if syndicated, reduce RWAs, whether as a result of adverse market conditions or otherwise; or
- inability to access capital funding sources in order to increase regulatory capital, whether as a result of a lack of liquidity in the funding markets generally or an adverse change in the Group's financial condition or rating,

could have a material adverse impact on the Group's financial condition and regulatory capital position, could result in Eurobank's ratings being adversely affected, and could also result in regulatory actions designed to ensure the Group's compliance with the required ratios. In an extreme scenario, if the Group is unable to maintain its minimum regulatory capital ratios in the future, this may lead to the implementation of one or more resolution tools. See “- Impact of the bank recovery and resolution directive”.

The Issuer's funding cost and access to liquidity and capital depend on the credit ratings of both the Issuer and Greece

Eurobank's ratings are:

S&P issuer long-term credit rating: “BB-” (positive outlook), upgraded on 25 April 2023 from “B+”;

Fitch long-term issuer default rating: “BB” (stable outlook), upgraded on 19 September 2023 from “BB-”;
and

Moody's senior unsecured debt rating: "Ba1" (positive outlook)], upgraded on 19 September 2023 from "Ba3".

Each of the above ratings are below the level identified by the respective rating agencies as investment grade. Reflecting these sub-investment grade ratings, Eurobank's ability to obtain unsecured funding in the capital markets is limited and may also attract a high cost (relative to a scenario where Eurobank has investment grade credit ratings). See "—The Group's ability to obtain unsecured debt is gradually improving however sustained access to capital markets remains relatively limited" above.

During 2022 and 2023, each of S&P, Fitch and Moody's upgraded Eurobank's long term rating or its outlook on the basis of significant improvement in its asset quality as well as its prospects for generating stronger earnings. Challenges mentioned by rating agencies include any potential deterioration in the operating environment and in funding conditions from inflationary pressures or from the escalation of geopolitical developments.

Furthermore, in 2022 rating agencies assigned a rating to Eurobank Holdings, with the current long term rating being:

S&P long-term issuer credit rating: "B" (positive outlook), upgraded on 25 April 2023 from "B-"; and

Fitch long-term issuer default rating: "BB" (stable outlook), upgraded on 19 September 2023 from BB-.

Greece's credit ratings are:

S&P: "BBB-" (stable outlook), upgraded on 20 October 2023 to investment grade from "BB+";

Fitch: "BB+" (stable outlook); and

Moody's: "Ba1" (stable outlook).

Furthermore, on September 2023, DBRS upgraded the Hellenic Republic to "BBB(low)" with a stable outlook, assigning also investment grade status.

Each of Greece's credit ratings has been upgraded since mid-2018, based on the perceived success of the European Stability Mechanism ("**ESM**") stability support programme and improving economic conditions. The possibility of a future downgrade or negative change in rating outlook remains. For example, future Greek governments have committed to maintain significant primary surpluses for a long period and this could pose both economic and political challenges in the future. In particular, any failure to effectively adhere to these commitments in the medium-term could result in financial instability and a downgrade in Greece's rating, which could in turn result in a downgrade of Eurobank's ratings (either through the application of the sovereign ceiling or because the economic and political factors leading to the Greece downgrade are perceived by the rating agencies as also being likely to adversely affect Eurobank's credit position). See "—Greece's economy remains susceptible to significant downside risks" above.

Negative publicity following a downgrade in Eurobank's credit rating may have an adverse effect on depositors' sentiment, which may increase Eurobank's dependence on Eurosystem funding. In addition, any adverse change in Eurobank's ratings, including as a result of adverse stress test outcomes (whether for Eurobank or one or more other Greek banks), could negatively affect Eurobank's return to the capital and interbank markets for funding, increase Eurobank's funding costs and/or restrict the alternative sources of funding available to it.

Credit and other financial risks

The Group is exposed to potential deterioration in its customer loan portfolio which could lead to increased impairment charges and reduced profitability

The Group has a significant portfolio of customer loans which had a net balance of €40.5 billion, or 50 per cent. of the Group's assets, as at 30 June 2023. A substantial portion of the Group's customer loans are secured by collateral such as real estate, securities, term deposits and receivables. In particular, mortgage loans are one of the Group's principal asset classes totalling €9.6 billion as at 30 June 2023.

The Group is exposed to the risk of a significant deterioration in the performance of its customer loan portfolio. This could arise as a result of a variety of factors, including changes in macroeconomic conditions, the performance of specific sectors of the economy, the deterioration of the competitive position of the counterparties, the downgrading of individual counterparties, the indebtedness level of families, increases in unemployment, changes in law and the performance of the real estate market. Many of these factors could also result in a further significant reduction in the value of any security provided to the Group by its customers and/or the inability of its customers to supplement the security provided. Any significant deterioration in the performance of the Group's customer loan portfolio could result in the Group recording significant impairment charges and/or write-offs in respect of the assets, which could materially adversely affect its business and results of operations.

For example, the financial crisis in Greece that started after 2008 resulted in a significant increase in past due loans. The financial crisis also resulted in a decline in housing prices that started in 2009 and continued until the end of 2017, according to the Bank of Greece (the "**Financial Crisis**"). This decline materially weakened the quality of the Group's mortgage loans and contributed to its high impairment charges in the years following 2008.

Should economic recessions occur in the future, particularly if they are associated with prolonged periods of high interest rates, increasing unemployment and falling property values, the Group is likely to experience significant adverse consequences in respect of its customer loan portfolio.

The Group is exposed to impairment losses and market volatility due to its exposure to investment securities

The Group has a significant portfolio of investments in debt securities (primarily Greek and other government bonds), which amounted to €13.6 billion, or 17 per cent. of the Group's assets, as at 30 June 2023.

Investment securities comprise of debt securities classified at amortised cost (“**AC**”) and at fair value through other comprehensive income (“**FVOCI**”). The AC debt securities measured at amortised cost, interest income, realised gains and losses on derecognition, and changes in expected credit losses are included in the income statement.

The FVOCI debt securities are measured at fair value with changes in their fair value recorded in other comprehensive income, except for interest income, related foreign exchange gains or losses and expected credit losses, which are recognised in the income statement. Cumulative gains and losses previously recognised in OCI are transferred from OCI to the income statement when the debt instrument is derecognised.

The Group performs a periodic impairment analysis on its investment debt securities. Any significant increase in credit risk, whether based on qualitative factors (such as negative macroeconomic changes) or quantitative factors, could give rise to an increase in impairment with a consequent adverse impact on the Group's results. In addition, volatility in market prices of FVOCI debt securities could significantly impact shareholders' equity through unrealised valuation results recorded in OCI.

Volatility in interest rates may negatively affect the Group's net interest income and impairment provisions for loans, and may have other adverse consequences.

The Group relies on deposits for a significant portion of its funds. Deposits represent low-cost funding for the Group due to the relatively low rates paid, in particular in relation to current accounts. The Group's overall net interest margin, which is the difference between the yield on its interest-bearing assets and the cost of its interest-bearing liabilities as a percentage of interest-bearing assets, varies according to prevailing interest rates and is a significant factor in determining the Group's profitability. Net interest margins vary according to the prevailing level of interest rates and are generally compressed in a low interest rate environment and the opposite in a rising interest rates environment. This is relevant in the current financial climate, with rates currently increasing in the Eurozone and even more so in the United States (in response to increased inflationary pressures). Interest rates are highly sensitive to many factors beyond the Group's control, including monetary policies, and domestic and international economic and political conditions. Future events could change the interest rate environment in Greece or in the other markets where the Group operates.

Since the majority of the Group's loan portfolio effectively re-prices within a year, rising interest rates, if customers cannot be refinanced at better terms in a higher interest rate environment or face difficulties in servicing their loans due to increased instalment payments, may reduce the Group's customers' capacity to repay their obligations and thus may result in increased provisioning needs for impairment on loans and advances to customers.

The Group is exposed to risks faced by other financial institutions that are the Group's counterparties.

The Group routinely transacts with counterparties in the financial services industry, including brokers and dealers, commercial banks, investment banks, mutual and hedge funds, and other institutional clients. Sovereign credit pressures, sanctions and exclusion from financial communication networks (e.g., Russian sanctions) may weigh on other financial institutions, limiting their funding operations and weakening their capital adequacy by reducing the market value of their sovereign and other fixed income holdings. These concerns have adversely impacted, and may continue to adversely impact, inter-institutional financial transactions.

Concerns about, or the enforcement of sanctions on, or a default by, a financial institution could lead to significant liquidity problems and losses or defaults by other financial institutions, as the commercial and financial soundness of many financial institutions may be closely related as a result of credit, trading, clearing and other relationships. Many routine transactions into which the Group enters expose the Group to significant credit risk in the event of default by one of its financial institution counterparties. Even a perceived lack of creditworthiness of a financial institution counterparty may lead to liquidity pressures or losses. In addition, the Group's credit risk may be exacerbated when any collateral that it holds cannot be enforced or is liquidated at a loss. Severe liquidity problems in particular financial institutions or broader financial services industry, or a failure/default by a significant financial institution counterparty, could potentially have a material adverse effect on the financial markets more broadly and the Group's business and results of operations.

Risks relating to regulation

The Group's business is subject to complex regulation, which has changed significantly since the Financial Crisis and is likely to continue changing, imposing a significant compliance burden on the Group and increasing the risk of non-compliance

The Group is subject to financial services laws, regulations, administrative acts and policies in each jurisdiction where it operates. Many of these regulatory requirements are new or have changed significantly since the Financial Crisis, and the Group expects that its regulatory environment will continue to evolve. Examples of significant regulatory change since the Financial Crisis include the so called EU banking package which was enacted in June 2019 by way of two directives (the Capital Requirements Directive V (or CRD V) and the Bank Recovery and Resolution Directive II (or "BRRD II")) and two regulations (the Capital Requirements Regulation II (or "CRR II")) and the Single Resolution Mechanism Regulation II (or "SRMR II"), with the objective to further reduce risk in the EU banking sector by making a number of targeted amendments to existing EU legislation that implement to a large extent the international reforms agreed by the Basel Committee on Banking Standards and the Financial Stability Board, as well as the General Data Protection Regulation (Regulation (EU) 2016/679), the Sustainable Finance Disclosures Regulation (Regulation (EU) 2019/2088), the Taxonomy Regulation (Regulation (EU) 2020/852) along with its Delegated Regulations that have come into force and other regulatory requirements. Although, in

response to the COVID-19 pandemic, targeted amendments to the EU prudential framework for banks were enacted pursuant to Regulation (EU) 2020/873 (sometimes referred to as the CRR Quick Fix), as a result of these and other ongoing and possible future changes in the financial services regulatory framework, the Issuer faces an increasing regulatory burden, and compliance with such regulations has increased and is expected to continue to increase the Group's capital requirements and compliance costs. Current and future regulatory requirements may be different or applied differently across jurisdictions, and even requirements with EEA-wide application may be applied differently in different jurisdictions.

Compliance with new requirements may also restrict certain types of transactions, affect the Group's strategy and limit or require the amendment of rates or fees that the Group charges on certain loans and other products, any of which could lower the return on the Group's investments, assets and equity. New regulatory requirements may also have indirect consequences for the global financial system, the Greek financial system or the Group's business, including increasing competition, increasing general uncertainty in the markets, or favouring or disfavouring certain lines of business. The Group cannot predict the effect of any such changes on its business and results of operations.

Greater and more complex regulatory requirements also increase the risk of non-compliance. As a result, the Group may become involved in various disputes and legal proceedings in Greece and other jurisdictions, including litigation and regulatory investigations. These disputes and legal proceedings are subject to many uncertainties, and their outcomes are often difficult to predict, particularly in the earlier stages of a case or investigation. Adverse regulatory action or adverse judgments in litigation could result in fines or in restrictions or limitations on the Group's operations, any of which could result in a material adverse effect on its reputation or financial condition. In addition, any determination by national competent authorities that the Group has not acted in compliance with applicable local laws in a particular market, or any failure to develop effective working relationships with such authorities, could have a material adverse effect not only on the Group's businesses in that market but also on its reputation generally.

In respect of judicial proceedings, inquiries, or cases under investigation by state or regulatory authorities, the Hellenic Competition Commission continues to investigate all Greek systemic banks, including the Issuer, in relation to issues concerning concerted practices.

Changes in consumer protection laws might limit the fees that the Group may charge in certain banking transactions

Changes in consumer protection laws in Greece and other jurisdictions where the Group has operations could limit the fees that banks may charge for certain products and services such as mortgages, unsecured loans and credit cards. If introduced, such laws could reduce the Group's net income, though the amount of any such reduction cannot be estimated at this time. Such effects could have a material adverse effect on the Group's business, financial condition, results of operations and prospects.

The requirements of the deposit guarantee schemes applicable throughout the EU may result in additional costs for the Group

Banks within the Group are subject to a number of deposit guarantee schemes under which the member banks are responsible for funding the scheme which typically is designed to repay deposits up to a defined amount in the event that a member bank becomes insolvent.

The Issuer and the Group's banks in Bulgaria, Luxembourg and Cyprus are all subject to national schemes mandated by the 2014 EU Directive on deposit guarantee schemes, although all of these schemes are being gradually transferred to the Single Resolution Fund. In Serbia, the Group's banking subsidiary is also subject to a national scheme mandated by the Law on Deposit Insurance by which all deposits of individuals, entrepreneurs, micro entities and small and medium-sized businesses (“**SMEs**”) up to EUR 50,000 are insured by this state agency. Particularly in the event of a material bank insolvency, banks within the Group may in the future be required to increase their contributions to any relevant deposit guarantee scheme, which could adversely affect the Group's operating results.

Bank recovery and resolution procedures applicable to the Group may materially impact its business and results of operations if implemented and the Issuer could be adversely affected by its MREL Requirements

The BRRD has been implemented in Greece and the other EU countries in which the Group has banking operations. The BRRD aims to safeguard financial stability and minimise taxpayers' contributions to bail-outs or exposures relating to credit institutions and investment firms considered to be at risk of failing.

In the EU countries in which the Group has banking operations, the bank recovery and resolution legislation gives the relevant authorities tools and powers to handle crises at the earliest possible moment. These tools and powers include early intervention measures such as the removal of senior management or members of the board of the institution concerned.

Where a credit institution is determined to be failing or likely to fail and there is no reasonable prospect that any alternative solution would prevent such failure, the relevant resolution authority may take resolution action, provided that this is necessary in the public interest. The resolution action is intended to ensure the continuity of the credit institution's critical services and manage its failure in an orderly fashion. The resolution powers and tools available to the resolution authority comprise the asset separation tool, the bridge institution tool, the sale of business tool and the bail-in tool. If the Issuer experiences severe financial difficulties in the future, the application of any of the powers and tools under the banking recovery and resolution regulations applicable to it could adversely affect the composition of the Issuer's Board of Directors and management team and the Issuer's financial condition, results of operations and credit rating. The resolution authorities may also decide to alter the maturities of any Covered Bonds or to reduce their nominal interest rate.

Under the BRRD, as amended by Directive 2019/879 (“**BRRD II**”), which has been transposed into Greek law pursuant to Law 4799/2021 amending Greek Law 4335/2015, European banks are required to maintain certain types of instruments in order to meet the minimum requirement for own funds and eligible liabilities (“**MREL**”). These resources should be eligible to absorb losses and/or recapitalise an institution in case of a resolution without recourse to taxpayers' money. The Single Resolution Board (“**SRB**”) has determined

its MREL policy, setting out the applicable MREL Requirements, indicating that its MREL decisions, including those with respect to subordination, in implementing the new framework, will be taken based on this policy in the annual resolution planning cycle. In line with this MREL policy, the Greek banks have been granted an extension until 31 December 2025 to meet their respective final MREL targets. For the Issuer, the interim binding MREL target (applicable from 1 January 2022), amounted to 14.51 per cent. of its total risk exposure amount, plus combined buffers, while the fully calibrated MREL (final target) to be met by 31 December 2025 stands at 23.57 per cent. of its total risk exposure amount, plus combined buffers applicable at that date. Given the Issuer's current credit ratings, if the MREL target is set at a significantly higher level, the Issuer would need to issue a larger amount of eligible liabilities to meet the MREL Requirements (as defined in Condition 3E) at a very significant cost which could adversely affect the Issuer's operating results.

Should the Issuer fail to meet its combined buffer requirement (which will also be considered in conjunction with its MREL resources), resolution authorities have the power to prohibit certain distributions. The relevant resolution authority may also exercise its supervisory powers under Article 104 of Directive 2013/36/EU of the European Parliament and of the Council of 26 June 2013, as amended by Directive (EU) 2019/878 of 20 May 2019 and as may be further amended or replaced from time to time ("**CRD IV**") in case of a breach of the Issuer's MREL target. As a result, the powers set out in the BRRD and the application of the MREL Requirements may impact the management of the Issuer as well as, in certain circumstances, the rights of creditors, including holders of Covered Bonds issued under the Programme. See "Regulatory Considerations - Minimum requirements for own funds and eligible liabilities (MREL)" for further detail.

The Group may not be allowed to continue to recognise the main part of deferred tax assets under IFRS as regulatory capital, which may have an adverse effect on its operating results and financial condition

The Group currently includes deferred tax assets ("**DTAs**"), calculated in accordance with IFRS, in calculating its capital and capital adequacy ratios. As at 30 June 2023, the Group DTAs were €4.1 billion. As at 31 December 2022, the Group DTAs were €4.2 billion.

Under applicable capital requirements regulations, the Group is required to deduct certain DTAs from its Common Equity Tier 1 ("**CET1**") capital. The amount of this deduction increases until it is fully applied in 2024. This deduction had a significant impact on Greek credit institutions, including the Issuer, when it was introduced in 2013. Since then, new Greek legislation has been introduced that permits Greek credit institutions to convert certain DTAs into a deferred tax credit ("**DTC**") against the Hellenic Republic. As at 30 June 2023, the Group's eligible DTAs were €3.4 billion (31 December 2022: €3.4 billion).

In April 2015, the EC announced that it had sent requests for information to Spain, Italy, Portugal and Greece regarding their treatment of deferred tax credits for financial institutions under national law. Even though the EC has not yet launched a formal investigation, there can be no guarantee that the tax credit provisions described above will not be challenged by the EC as illegal state aid. If such a challenge was

successfully made, Greek credit institutions would ultimately not be allowed to maintain certain DTCs as regulatory capital. Given that, as at 30 June 2023, 48.1 per cent. of the Group's CET1 capital was comprised of DTCs, this could have a material adverse effect on the Group's capital base and consequently its capital ratios.

In addition, any adverse change in the regulations governing the use of DTCs as part of the Group's regulatory capital could also affect the Group's capital base and capital ratios. If any of the above risks materialise, this could have a material adverse effect on the Group's ability to maintain sufficient regulatory capital, which may in turn require the Group to issue additional instruments qualifying as regulatory capital, to liquidate assets, to curtail business or to take any other actions, any of which may have a material adverse effect on the Group's operating results, financial condition and prospects.

Other risks

If the Group's reputation is damaged, this would affect its image and customer relations, and could adversely affect the Group's business, financial condition, operating results and prospects

Reputational risk is inherent to the Group's business activity. Negative public opinion towards the Group or the financial services sector as a whole could result from real or perceived practices in the banking sector in general, such as money laundering, negligence during the provision of financial products or services, or even from the way that the Group (or one of its competitors) conducts, or is perceived to conduct, its business.

Negative publicity and negative public opinion could adversely affect the Group's ability to maintain and attract customers, in particular, institutional and retail depositors, which could adversely affect the Group's business and results of operations and, in extreme cases, could lead to an accelerated outflow of funds from customer deposits, which could result in the Group or another member of the Group being unable to continue operating without additional funding support, which it may not be able to secure.

As a systemically important bank in Greece, Cyprus and Bulgaria, the impact of this risk on the Group is likely to be more severe should it materialise.

The Group's operational systems and networks are exposed to significant cyber security and other risks

Certain of the Group's operations, including those outsourced to third parties, rely on the secure processing, storage and transmission of confidential and other information. The Group keeps an extensive amount of personal and other customer-specific information for its retail, corporate and governmental customers, and must accurately and securely record, process and reflect their extensive account transactions. The proper functioning of the Group's payment systems, financial and sanctions controls, risk management, credit analysis and reporting, accounting, customer service and other information technology systems, as well as the communication networks between its branches and main data processing centres, are critical to the Group's operations.

The threat to the security of the Group's information held on customers from cyber attacks continues to increase. Activists, rogue states and cyber criminals are among those targeting computer systems. Risks to technology and cyber-security change rapidly and require continued focus and investment. Given the increasing sophistication and scope of potential cyber attacks, it is possible that future attacks may lead to significant breaches of security. Any such breaches may expose the Group to significant legal as well as reputational harm, which could have a material adverse effect on its business and results of operations. The Group's computer systems, software and networks are also exposed to technological failure or other threats including, but not limited to, unauthorised access, intentional or inadvertent loss or destruction of data (including confidential customer information), computer viruses or other malicious code, natural disasters and other events.

If one or more of these events occurs, it could result in the disclosure of confidential customer or corporate information, and disruptions or malfunctions in the operations of the Group, its customers or other third parties. The Group may be required to spend significant additional resources to modify its protective measures or to investigate and remediate vulnerabilities or other exposures. It may also be subject to litigation, regulatory penalties and financial losses as well as reputation risks.

The Group is exposed to the risk of fraud and illegal activities

The Group's businesses are dependent on their ability to process and report accurately and efficiently a high volume of complex transactions across numerous and diverse products and services, in different currencies and subject to a number of different legal and regulatory regimes. Operational risks are present in the Group's businesses, through inadequate or defective internal processes (including financial reporting and risk monitoring processes) or from people-related events (including the risk of fraud and other criminal acts carried out against the Group, errors by employees, violations of internal instructions and policies and failure to document transactions properly or obtain proper authorisation) or external events (including natural disasters or the failure of external systems). There can be no assurance that the risk controls, loss mitigation and other internal controls or actions in place within the Group will be effective in controlling each of the operational risks faced by it. Any weakness in these controls or actions could result in a material adverse impact on the Group's business and results of operations, and could result in reputational damage.

The Group is also subject to rules and regulations related to money laundering and terrorist financing. Compliance with anti-money laundering and anti-terrorist financing rules entails significant cost and effort. Non-compliance with these rules may have serious consequences, including adverse legal and reputational consequences. The Group may not be able to comply at all times with all rules applicable to money laundering and terrorist financing, particularly in countries such as Serbia which are perceived to be higher risk in this regard. Any violation, or even any suspicion of a violation, of these rules may have serious legal, financial and reputational consequences, which could have a material adverse effect on the Group's business and results of operations.

The Group's guidelines and policies for risk management may prove inadequate for the risks faced by its businesses

The management of business, regulatory and legal risks requires guidelines and policies for the accurate identification and control of a large number of transactions and events. Such guidelines and policies may not always be adequate. Some of the measures taken by the Group to manage various risks are to enter into hedging transactions to manage market risks, to issue credit risk limits for each counterparty to which the Group is exposed in its lending business, to have sufficient security for credits provided, and to do customary due diligence to manage legal risks. Some of these and other methods used by the Group to manage, estimate and measure risk, such as value-at-risk (“**Var**”) analyses, are based on historic market behaviour. The methods may therefore prove to be inadequate for predicting future risk exposure, which may prove to be significantly greater than what is suggested by historic experience or may not reflect political risks and geopolitical developments. Historical data may also not adequately allow prediction of circumstances arising due to government interventions and stimulus packages, which increase the difficulty of evaluating risks.

Other methods for risk management are based on evaluation of information regarding markets, customers or other information that is publicly known or otherwise available to the Group. Such information may not always be correct, updated or correctly evaluated.

In addition, the Group's hedging strategies may not always prove to be effective. Where a hedging strategy is based on historical trading patterns and correlations, unexpected market developments may adversely affect the effectiveness of the strategy. In addition, the Group does not economically hedge all of its risk exposure in all market environments or against all types of risk. The Group is also exposed to certain types of risk including foreign currency risk where currency derivatives against other currencies may be unavailable. Even when the Group is able to hedge certain of its risk exposures, the methodology by which certain risks are economically hedged may not qualify for hedge accounting, in which case changes in the fair value of such instruments are recognised immediately in the income statement, which may result in additional volatility in the Group's income statement.

The Group's financial risk management strategy is described in note 5.2 to the 2022 Consolidated Financial Statements.

Factors that may affect the Issuer's ability to fulfil its obligations under Covered Bonds issued under the Programme

The Covered Bonds will be obligations of the Issuer only

The Covered Bonds will be solely obligations of the Issuer and will not be obligations of or guaranteed by the Trustee, the Asset Monitor, the Account Bank, the Agents, the Hedging Counterparties, the Arranger, the Dealer(s) or the Listing Agent (as defined below). No liability whatsoever in respect of any failure by the Issuer to pay any amount due under the Covered Bonds shall be accepted by any of the Arranger, the Dealer(s), the Hedging Counterparties, the Trustee, the Asset Monitor, the Agents, the Account Bank, the Listing Agent or any company in the same group of companies as such entities or any other party to the transaction documents relating to the Programme.

Maintenance of the Cover Pool

Pursuant to the Greek Covered Bond Legislation, the Cover Pool is subject to the Statutory Tests set out in the Greek Covered Bond Legislation. Failure of the Issuer to take immediate remedial action to cure any one of these tests within five Athens Business Days of such breach will result in the Issuer not being able to issue further Covered Bonds and any failure to satisfy the Statutory Tests may have an adverse effect on the ability of the Issuer to meet its payment obligations in respect of the Covered Bonds. Furthermore, a failure to comply with the Greek Covered Bond Legislation may also result in the Bank of Greece subjecting the Issuer to administrative sanctions pursuant to Articles 23 and 24 of the Covered Bond Law. In addition, the Issuer has covenanted to comply with the requirements of the Covered Bond Law (including, but not limited to Articles 17 and 18 of the Covered Bond Law and Chapter III of the Secondary Covered Bond Legislation). Pursuant to the Covered Bond Law, the Issuer must maintain a cover pool liquidity buffer to cover the maximum cumulative net liquidity outflow on the Covered Bonds over the next 180 days using the extended maturity date for calculation purposes in the case of extendable covered bonds. Pursuant to the Covered Bond Law, the liquidity buffer can only consist of Liquid Assets, which shall include assets purchased from funds standing to the credit of the Liquidity Buffer Reserve Ledger. Covered Bondholders should note that the Issuer covenants on a contractual basis, pursuant to the Servicing and Cash Management Deed, to maintain the Liquidity Buffer Reserve Ledger on the basis set out in the section "*Servicing and Cash Management Deed – Liquidity Buffer Reserve Ledger*".

Pursuant to the Servicing and Cash Management Deed after the occurrence of an Issuer Event the Cover Pool is subject to an Amortisation Test. The Amortisation Test is intended to ensure that the Cover Pool Assets are sufficient to meet the obligations under all Covered Bonds outstanding together with senior expenses that rank in priority to or pari passu with amounts due on the Covered Bonds. Failure to satisfy the Amortisation Test on any Calculation Date following an Issuer Event or an Issuer Insolvency Event causes all Series of Covered Bonds to become Pass-Through Covered Bonds and the Issuer will, to the extent funds are available to do so, pay amounts of principal in respect of the Covered Bonds on each Interest Payment Date. See "*Risks in relation to Pass-Through Covered Bonds*" below.

Factors that may affect the realisable value of the Cover Pool or any part thereof

The realisable value of each loan (a "**Loan**") and any mortgages, mortgage pre-notations, guarantees or indemnity payments which may be granted or due in connection therewith (the "**Related Security**") comprised in the Cover Pool may be reduced by:

- (a) default by borrowers (each borrower being, in respect of a Loan Asset, the individual specified as such in the relevant mortgage terms together with each individual (if any) who assumes from time to time an obligation to repay such Loan Asset (the "**Borrower**")) in payment of amounts due on their Loans;
- (b) changes to the lending criteria of the Issuer;

- (c) deteriorating asset valuations resulting from market conditions as well as specific property related deterioration; and
- (d) possible regulatory changes by the regulatory authorities.

However, it should be noted that the Statutory Tests, the Amortisation Test and the Individual Eligibility Criteria are intended to ensure that there will be an adequate amount of Loan Assets in the Cover Pool to enable the Issuer to repay the Covered Bonds and accordingly it is expected (but there is no assurance) that the Loan Assets could be realised for sufficient value to enable the Issuer to meet its obligations under the Covered Bonds.

Limited description of the Cover Pool

Covered Bondholders will not receive detailed statistics or information in relation to the Loan Assets in the Cover Pool, because it is expected that the constitution of the Cover Pool will frequently change due to, for instance:

- (i) the Issuer assigning Additional Cover Pool Assets to the Cover Pool; and
- (ii) the Issuer removing Cover Pool Assets from the Cover Pool or substituting existing Cover Pool Assets in the Cover Pool with Additional Cover Pool Assets.

There is no assurance that the characteristics of the Loan Assets assigned to the Cover Pool will be the same as those Loan Assets in the Cover Pool as at that date. However, each Loan Asset will be required to meet the Individual Eligibility Criteria, comply with the provisions of the Greek Covered Bond Legislation and be subject to the representations and warranties set out in the Servicing and Cash Management Deed. The Issuer will also be obliged to provide reports to Covered Bondholders that meet the requirements of Article 16 of the Covered Bond Law, which includes requirements to report certain characteristics of the Loan Assets in the Cover Pool on an aggregated basis. In addition, the Statutory Tests are intended to ensure that the Cover Pool adheres to certain requirements, including that the nominal value of the Cover Pool exceeds the Principal Amount Outstanding of all Series of Covered Bonds by at least 5 per cent. for so long as Covered Bonds remain outstanding (although there is no assurance that it will be so). The Asset Monitor will provide quarterly and annual agreed upon procedures reports on the required tests to the Bank of Greece (being the Statutory Tests as of the date of this Base Prospectus) where exceptions, if any, will be noted, but there can be no assurance that this will be so, nor that the Issuer will provide investor reports that fully comply with the requirements of Article 16 of the Covered Bond law.

No due diligence on the Cover Pool

None of the Arranger nor the Dealers have or will undertake any investigations, searches or other actions in respect of any assets contained or to be contained in the Cover Pool but will instead rely on the representations and warranties provided by the Issuer in the Programme Agreement.

Default by Borrowers in paying amounts due on their Loans

Borrowers may default on their obligations under the Loans in the Cover Pool. Defaults may occur for a variety of reasons. The Loans are affected by wider economic, credit, liquidity and interest rate risks. Various factors influence mortgage delinquency rates, prepayment rates, repossession frequency and the ultimate payment of interest and principal, such as changes in the national or international economic climate, regional economic or housing conditions, changes in laws, interest rates, inflation, the availability of financing, yields on alternative investments, political developments and government policies including any remaining impact of the coronavirus global pandemic 2019 (COVID-19) See – “*Economic and political risks – The Group’s business is significantly affected by macroeconomic and financial developments particularly in Greece*”). Other factors in Borrowers’ individual, personal or financial circumstances may affect the ability of Borrowers to repay the Loans. Loss of earnings, illness, divorce and other similar factors may lead to an increase in delinquencies by and bankruptcies of Borrowers, and could ultimately have an adverse impact on the ability of Borrowers to repay the Loans. In addition, the ability of a Borrower to sell a property given as security for a Loan at a price sufficient to repay the amounts outstanding under that Loan will depend upon a number of factors, including the availability of buyers for that property, the value of that property and property values in general at the time.

Changes to the Lending Criteria of the Issuer

Each of the Loans originated by the Issuer will have been originated in accordance with its Lending Criteria at the time of origination. The Lending Criteria of the Issuer also includes the Lending Criteria applied by Proton Bank and New TT Hellenic Postbank SA (which merged with the Issuer in November and December 2013 respectively). It is expected that the Issuer’s Lending Criteria will generally consider, inter alia, type of property, term of loan, age of applicant, the loan-to-value ratio, status of applicant and credit history. The Issuer retains the right to revise its Lending Criteria from time to time but would do so only to the extent that such a change would be acceptable to a reasonable, prudent mortgage lender. If the Lending Criteria change in a manner that affects the creditworthiness of the Loans, that may lead to increased defaults by Borrowers and may affect the realisable value of the Cover Pool, or part thereof, and the ability of the Issuer to make payments under the Covered Bonds.

Deteriorating asset valuations resulting from market conditions

A decline in the value of the real estate securing the Loans under the Cover Pool may result from a further deterioration of financial conditions in Greece, regional housing conditions, changes in property tax laws and regulation, and government policies and the impact on COVID-19 on the Greek economy (see “*Economic and political risks – The Group’s business is significantly affected by macroeconomic and financial developments, particularly in Greece*” below). This value may be materially different from the fair value determined at the time of loan origination, which could adversely affect the realizable Cover Pool Value and the Issuer’s ability to meet its obligations under the Covered Bonds.

Additionally, the risks associated with deterioration of market values are further mitigated, to an extent, by the method of calculation of the aggregate Outstanding Principal Balance of all Loans in the Cover Pool as provided in the Statutory Tests.

Risks relating to Pre-Approved Loans

After the conversion of loans granted from the former "New TT Hellenic Postbank S.A." ("**NTT**") into the core Eurobank systems in April 2014, the Issuer acquired the total mortgage portfolio of the former NTT, along with the special category "old type mortgage loans" (the "**Pre-Approved Loans**").

This special programme of Pre-Approved Loans was offered from the former NTT with the following main product characteristics. The mortgage loans were targeted specifically to employees (and pensioners) of the Greek State and Companies/Institutions of the broader public sector, cooperating with the Issuer. They were offered to employees requesting a mortgage loan (for purchase/construction/repair of residential property), due to the stability of the source of income (public sector employees) and the way the loan was repaid (instalments withheld directly through monthly payroll). Thus, the key competitive advantage of this type of mortgage loan is its repayment method (through payroll). The loan instalments are not paid directly by the Borrower, but are requested from the Issuer by the Company/Institution in which the customer is employed. Although the vast majority of this portfolio is currently serviced through monthly payroll, a small percentage of such loans no longer operate under the above facility and are serviced like any other ordinary mortgage loan (paid directly by the debtor). Historically, pre-approved loans perform better than ordinary mortgage loans, as each month instalments are withdrawn directly through the Borrower's payroll.

However, Borrowers are still liable to repay the full amount of the instalment due under the relevant Loan. If the Company/Institution fails to pay the instalment or if the Borrower is no longer an employee of the relevant Company/Institution, then the Borrower may be unable to meet payments due under their Loan agreement. If the Borrower fails to pay the full amount under its Loan, the Issuer may be unable to satisfy its obligations under the Covered Bonds.

Risks relating to Loans denominated in a currency other than euro

CHF Loans are included in the Cover Pool. If an FX Swap has been put in place, amounts received by the Issuer in Swiss Francs in respect of such CHF Loans will be paid to the FX Swap Provider (with the exception of such CHF amounts which are used to make payments under any CHF denominated Covered Bonds or other liabilities secured by the Cover Pool and denominated in CHF, outstanding from time to time). Amounts received by the Issuer from the FX Swap Provider will be paid into the EUR Transaction Account prior to an Issuer Event and will form part of the Covered Bonds Available Funds and be applied by the Issuer in accordance with the applicable Priorities of Payments following an Issuer Event. The risks associated with CHF Loans are mitigated to an extent by limiting the aggregate Outstanding Principal Balance of all CHF Loans in the Cover Pool to 20 per cent of the aggregate Outstanding Principal Balance of all Loans comprising the Cover Pool.

Risks relating to Subsidised Loans

In the Hellenic Republic, subsidies are available to borrowers in respect of interest payments made under residential mortgage loans. The availability and amount of a subsidy is determined by reference to the financial and social circumstances of a borrower and is made available from the Greek State and/or the Greek Workers Housing Association (“**OEK**”). In accordance with article 35 of Greek law 4144/2013, the Manpower Employment Organisation (“**OAED**”) became successor of both the OEK and the Greek Workers Housing Organisation (“**OEE**”) and acquired every right and obligation thereof. As of 14 February 2012, OEK and OEE ceased to exist pursuant to article 1 paragraph 6 of Greek law 4046/2012. Assets, liabilities and any kind of pending cases since the entry into force of Greek law 4144/2013 were transferred from those legal persons to OAED. The OAED was renamed the Public Employment Service (“**DYPA**”) pursuant to Greek law 4921/2022.

Regarding loans, in respect of which exclusively OEK made payment of the subsidised interest amount, DYPA shall continue the payments thereof (as a universal successor of OEK). The Greek State, the OEK and any other applicable Greek State owned entity's subsidy payments will be part of the Cover Pool in accordance with the Covered Bond Law along with the other receivables under the loan agreements.

The Issuer receives the subsidised component of interest due under some of the Subsidised Loans from the DYPA, the Greek State or any other applicable Greek State owned entity.

DYPA maintains a savings bank account at Eurobank (the “**DYPA Savings Account**”) and the Servicer will be authorised to deduct the amount of the subsidy related to the relevant Subsidised Loan from this account and then transfer such amounts to the EUR Collection Account or, following an Issuer Event, to the EUR Transaction Account according to the terms of the Servicing and Cash Management Deed. On the other hand, until such withdrawal from the DYPA Savings Account by the Servicer, DYPA remains liable to the Issuer for the relevant subsidy. If the DYPA Savings Account balance for any given month has not been sufficiently replenished by the DYPA in advance of the next month's automated deduction of the subsidy amounts, the remaining balance owing to Eurobank and which is to be transferred by the Servicer into the EUR Collection Account or, following an Issuer Event, the EUR Transaction Account will be deducted once additional funds have been deposited by the DYPA.

The Greek State will make payments of the subsidised interest amounts to Eurobank into an account maintained at Eurobank (the “**Eurobank Bank of Greece Account**”). The Servicer shall be authorised to transfer such amounts to the EUR Collection Account or, following an Issuer Event, to the EUR Transaction Account according to the terms of the Servicing and Cash Management Deed. The Servicer will notify the Greek State of the subsidised interest amounts that are payable by it and will undertake to take any action necessary to ensure that the Greek State makes payment of the relevant subsidised interest amounts.

In respect of any other subsidies provided by a Greek State owned entity, the amounts paid by way of subsidy will be transferred by the Servicer into the EUR Collection Account or, following an Issuer Event, to the EUR Transaction Account in accordance with the standard procedures applicable to such entity and

the Servicer shall notify the relevant state subsidised entity of the amount of any such subsidy due as soon as possible.

Historically, subsidised loans perform better than non-subsidised loans, as the Greek State or the OEK and its successor DYPA (as appropriate) is required to make payments of the subsidised interest amounts. However, Borrowers are liable to repay the full amount of interest due under the relevant Loan. If the Greek State and/or DYPA fails to pay any subsidised interest amounts then the Borrower may be unable to meet payments due under their Loan. If the Borrower fails to pay the full amount under its Loan, the Issuer may be unable to satisfy its obligations under the Covered Bonds.

By virtue of Article 55 of Greek Law 4305/2014 the Borrower may file a petition for the extension of its DYPA Subsidised Loans provided that at the date of such petition the amount of any due payments that remain unpaid does not exceed the aggregate of six monthly instalments. The period set by the abovementioned provision for the filing of such petition was within six months from the publication of Greek Law 4305/2014 which took effect on 31 October 2014 but such period was extended until 31 December 2015 by virtue of the joint ministerial decision of the Minister of Finance, Infrastructure, Development and Tourism and the Minister of Labour Social Security and Social Solidarity under number 19068/819/4-5-2015 and then further extended until 31 December 2016 by virtue of the joint ministerial decision of the Minister of Finance, Development and Tourism and the Minister of Labour, Social Security and Social Solidarity under number 21559/732/2016. Also, ministerial decision of the Minister of Labour, Social Security and Social Solidarity under number 52246/3173/26/1/2018 allows eligible borrowers of loans funded by own funds of OEK to restructure such loans and specifically to restructure the amount of the loan, the repayment of capital, interest on capital, capitalised interest, default interest and the term of the loan and was amended by, among others, ministerial decision number 50530/2821/3-2-2021 to provide for the extension of the petition until 30 June 2021. Therefore, the said law, as amended per above, may have an adverse effect on the timing of the amount of collections under the loans granted to the Borrowers that make use of its provisions.

The DYPA pays subsidised interest amounts under the relevant Subsidised Loans on a monthly basis and up to two months in arrears and the Greek State pays subsidised interest amounts under the relevant Subsidised Loans every six months in arrears. Accordingly, the Issuer will not receive the portion of the interest that is subsidised by the DYPA and the Greek State in respect of such Subsidised Loan at the same time as the unsubsidised portion of interest paid by the Borrower. In addition, a Greek State owned entity may not pay the subsidy at the same time as unsubsidised amounts are paid by the Borrower.

Under Greek law, the Greek State and DYPA will not benefit from sovereign immunity in respect of their obligations. Investors should also note that enforcement of judgments against Borrowers of Subsidised Loans, the Greek State or the DYPA may be subject to limitations.

Any changes in Greek law or the administrative practice of the Greek State or the DYPA which affect the timing and amount of subsidised interest payable could result in an adverse effect on the ability of the Issuer to make payments in respect of the Covered Bonds.

Borrower inability to repay due to CHF/EUR exchange rate fluctuations

Borrowers of Loans denominated in Swiss Francs (the “CHF Loans”) choosing to pay their Loans in EUR may become unable to repay the loans in the event of wide fluctuations in CHF/EUR currency exchange rates and as a result may default. As a result of such defaults, the Issuer may not receive payments it would otherwise be entitled to from such Borrowers. If there are insufficient funds available as a result of such defaults, then the Issuer may not be able, after making the payments to be made in priority thereto, to pay, in full or at all, amounts of interest and principal due to holders of the Covered Bonds. In this situation, there may not be sufficient funds to redeem the Covered Bonds on or prior to the Final Maturity Date. The risk is mitigated to an extent by limiting the aggregate Outstanding Principal Balance of all CHF Loans in the Cover Pool to 20 per cent of the aggregate Outstanding Principal Balance of all Loans comprising the Cover Pool. See “Eurobank S.A. – Legal Matters”.

Appointment of a Special Administrator following the occurrence of an Issuer Insolvency Event

In the event of insolvency of the Issuer, the Greek Covered Bond Legislation (in conjunction with Greek insolvency law) provides that the Cover Pool will at all times remain segregated from the insolvency estate of the Issuer until payment of all amounts due to the Covered Bondholders have been made in full. Article 21 of the Covered Bond Law provides that the Trustee shall be obliged to appoint a Special Administrator upon the insolvency or resolution of the Issuer pursuant to the Transaction Documents.

If no Special Administrator is appointed by the Trustee pursuant to the Transaction Documents, in the event of the Issuer's insolvency or resolution, the Bank of Greece may appoint a Special Administrator.

The Special Administrator (if any) will be obliged to comply with the duties set out in Article 21 of the Covered Bond Law and to service (or procure the servicing of) the Loan Assets in accordance with the terms of the Servicing and Cash Management Deed. The statutory duties of the Special Administrator, as set out in Article 21(3) of the Covered Bond Law are:

- (a) ensuring that the obligations relating to the Covered Bonds are met;
- (b) managing and liquidating the Cover Pool including, if there is an opportunity to do so, transferring the assets comprising the Cover Pool, together with the obligations under the Covered Bonds (and any Hedging Agreements and/or other contractual obligations relating to the Covered Bonds and the Cover Pool) to another bank that is a covered bond issuer regulated in accordance with the Covered Bond Law and the Secondary Covered Bond Legislation;
- (c) ensuring that any receipts or recoveries received in respect of the Cover Pool are made available to pay the obligations and liabilities arising under the Covered Bonds, any Hedging Agreements and any other obligations secured by the Statutory Pledge, in accordance with the terms of the Programme; and
- (d) carrying out the proper management of the assets comprising the Cover Pool, monitoring the Cover Pool to ensure that it continues to be sufficient to meet the liabilities and obligations arising

under and in respect of the Covered Bonds and the other Transaction Documents (including for these purposes monitoring the ongoing compliance of the Cover Pool with the Statutory Tests), initiation of proceedings in order to return to the Cover Pool from the insolvency estate of the Issuer any Cover Assets that have been transferred from the Cover Pool to the insolvency estate of the Issuer, and following the redemption in full of all Covered Bonds and the satisfaction of all liabilities arising under or in respect of the Transaction Documents, to transfer to the Issuer (or its insolvency estate or as directed by any relevant resolution authority) all remaining assets in or representing the Cover Pool.

Subject to certain conditions, the Special Administrator may transfer the assets comprising the Cover Pool, together with the obligations under the Covered Bonds (and any Hedging Agreements and/or other contractual obligations relating to the Covered Bonds and the Cover Pool) to another Credit Institution that is a covered bond issuer regulated in accordance with the Covered Bond Law and the Secondary Covered Bond Legislation. Subject to certain conditions, the Special Administrator may also sell all or any part of the Cover Pool to raise proceeds for the purposes of meeting obligations due to Covered Bondholders and/or other counterparties under the Transaction Documents in accordance with the conditions of the Covered Bonds and the terms of the Transaction Documents. The proceeds from any such sale will be credited to the Transaction Account and applied in accordance with the Priority of Payments. There is no guarantee that the Special Administrator will be able to generate sufficient funds from the Loan Assets that would enable all amounts to be paid in full under the Covered Bonds. There can also be no assurance that an appointment of a Special Administrator (or any delay in making such appointment) would not cause delays in payment on the Covered Bonds and Covered Bondholders might suffer loss as a result. See also "*Insolvency of the Issuer*" below.

No representations or warranties to be given if Loan Assets are to be sold following an Issuer Event

Following the occurrence of an Issuer Event, subject to certain conditions, either the Servicer or the Special Administrator (if one has been appointed) may sell the Loan Assets to third party purchasers (subject in certain circumstances to a right of pre-emption in favour of the Issuer) pursuant to the terms of the Servicing and Cash Management Deed. In respect of any sale of Loan Assets to third parties, however, there is no assurance that any of the Issuer, the Servicer or the Special Administrator will (or will be able to) give representations and warranties or indemnities in respect of those Loan Assets. Any representations and warranties previously given by the Issuer in respect of the Loan Assets in the Cover Pool may not have value for a third party purchaser if the Issuer is then insolvent. Accordingly, there is a risk that the realisable value of the Loan Assets could be adversely affected by the lack of representations and warranties or indemnities. See "*Description of the Transaction Documents – The Servicing and Cash Management Deed*".

Reliance on Hedging Counterparties

To provide a hedge against possible variances in the rates of interest payable on the Loans in the Cover Pool (which may, for instance, include discounted rates of interest, fixed rates of interest or rates of interest

which track a base rate and other variable rates of interest), the Issuer may enter into an Interest Rate Swap with the Interest Rate Swap Provider in respect of each Series of Covered Bonds under the Interest Rate Swap Agreement. Where the Cover Pool contains CHF Loans, the Issuer may enter into one or more FX Swaps under the FX Swap Agreement in respect of such loans to provide a currency hedge against the amounts received on such loans and the euro payments to be made by the Issuer under the Interest Rate Swap or the Covered Bonds if there is no Interest Rate Swap.

In addition, to provide a hedge against interest rate, currency and/or other risks in respect of amounts a) received by the Issuer under the Loans in the Cover Pool and the Interest Rate Swaps and b) amounts payable by the Issuer under the Covered Bonds the Issuer may enter into a Covered Bond Swap with a Covered Bond Swap Provider in respect of a Series of Covered Bonds under the Covered Bond Swap Agreement.

If the Issuer fails to make timely payments of amounts due under any Hedging Agreement, then it will have defaulted under that Hedging Agreement. A Hedging Counterparty is only obliged to make payments to the Issuer as long as the Issuer complies with its payment obligations under the relevant Hedging Agreement. If the Hedging Counterparty is not obliged to make full payment of amounts due to the Issuer under the relevant Hedging Agreement, the Issuer will be exposed to any changes in the relevant currency exchange rates to Euro and to any changes in the relevant rates of interest. Unless a replacement swap is entered into, the Issuer may have insufficient funds to make payments under the Covered Bonds.

If a Hedging Agreement terminates, then the Issuer (or the Servicer on its behalf) may be obliged to make a termination payment to the relevant Hedging Counterparty. There can be no assurance that the Issuer (or the Servicer on its behalf) will have sufficient funds available to make a termination payment under the relevant Hedging Agreement, or that the Issuer will be able to enter into a replacement swap agreement, or that if one is entered into, that the then credit rating of the replacement swap counterparty will be sufficiently high to prevent a downgrade of the then current ratings of the Covered Bonds by the Rating Agencies.

If the Issuer is obliged to pay a termination payment under any Hedging Agreement, such termination payment will rank pari passu with amounts due on the Covered Bonds (in respect of the Covered Bond Swaps and Interest Rate Swaps), except where default by, or downgrade of, the relevant Hedging Counterparty has caused the relevant Swap Agreement to terminate.

The termination of a Hedging Agreement therefore might have an adverse impact on the ability of the Covered Bond to be repaid.

Conflicts of Interest

Certain parties to the Transaction Documents act in more than one capacity. The fact that these entities fulfil more than one role could lead to a conflict between the rights and obligations of these entities in one capacity and the rights and obligations of these entities in another capacity. In addition, this could also lead to a conflict between the interests of these entities and the interests of the Covered Bondholders. Any

such conflict may adversely affect the ability of the Issuer to make payments of principal and/or interest in respect of the Covered Bonds.

Differences in timings of obligations of the Issuer and the Covered Bond Swap Provider under the Covered Bond Swaps

With respect to each of the Covered Bond Swaps, if any, the Issuer (or the Servicer on its behalf) will, periodically, pay or provide for payment of an amount to each corresponding Covered Bond Swap Provider based on the relevant rate for deposits for the agreed period. The Covered Bond Swap Provider may not be obliged to make corresponding swap payments to the Issuer under a Covered Bond Swap until amounts are due and payable by the Issuer under the Covered Bonds. If a Covered Bond Swap Provider does not meet its payment obligations to the Issuer under the relevant Covered Bond Swap Agreement or such Covered Bond Swap Provider does not make a termination payment that has become due from it to the Issuer under the Covered Bond Swap Agreement, the Issuer may have a larger shortfall in funds with which to make payments under the Covered Bonds than if the Covered Bond Swap Provider's payment obligations coincided with the Issuer's payment obligations under the Covered Bond Swap. Hence, the difference in timing between the obligations of the Issuer and the obligations of the Covered Bond Swap Providers under the Covered Bond Swaps, if any, may affect the Issuer's ability to make payments with respect to the Covered Bonds. A Covered Bond Swap Provider may be required, pursuant to the terms of the relevant Covered Bond Swap Agreement, to post collateral with the Issuer if the relevant rating of the Covered Bond Swap Provider is downgraded by a Rating Agency below the rating specified in the relevant Covered Bond Swap Agreement.

Change of counterparties

The parties to the Transaction Documents who receive and hold moneys pursuant to the terms of such documents (such as the Account Bank) are required to satisfy certain criteria in order that they can continue to receive and hold moneys.

These criteria include requirements in relation to the long-term issuer default rating by S&P. If the party concerned ceases to satisfy the applicable criteria, including the ratings criteria referred to above, then the rights and obligations of that party (including the right or obligation to receive moneys on behalf of the Issuer) may be required to be transferred to another entity which does satisfy the applicable criteria. In these circumstances, the terms agreed with the replacement entity may not be as favourable as those agreed with the original party pursuant to the relevant Transaction Document.

In addition, should the applicable criteria cease to be satisfied, then the parties to the relevant Transaction Document may agree to amend or waive certain of the terms of such document, including the applicable criteria, in order to avoid the need for a replacement entity to be appointed. The consent of Covered Bondholders may not be required in relation to such amendments and/or waivers.

Factors which are material for the purpose of assessing the market risks associated with Covered Bonds issued under the Programme

The Covered Bonds may not be a suitable investment for all investors

Each potential investor in the Covered Bonds must determine the suitability of that investment in light of its own circumstances. In particular, each potential investor should:

- (i) have sufficient knowledge and experience to make a meaningful evaluation of the Covered Bonds, the merits and risks of investing in the Covered Bonds and the information contained or incorporated by reference in this Base Prospectus and any applicable supplement and/or Final Terms;
- (ii) have access to, and knowledge of, appropriate analytical tools to evaluate, in the context of its particular financial situation, an investment in the Covered Bonds and the impact the Covered Bonds will have on its overall investment portfolio;
- (iii) have sufficient financial resources and liquidity to bear all of the risks of an investment in the Covered Bonds, including Covered Bonds with principal or interest payable in one or more currencies, or where the currency for principal or interest payments is different from the potential investor's currency;
- (iv) understand thoroughly the terms of the Covered Bonds and be familiar with the behaviour of any relevant indices and financial markets; and
- (v) be able to evaluate (either alone or with the help of a financial adviser) possible scenarios for economic, interest rate and other factors that may affect its investment and its ability to bear the applicable risks.

Some Covered Bonds are complex financial instruments. Sophisticated institutional investors generally do not purchase complex financial instruments as stand-alone investments. They purchase complex financial instruments as a way to reduce risk or enhance yield with an understood, measured, appropriate addition of risk to their overall portfolios. A potential investor should not invest in Covered Bonds which are complex financial instruments unless it has the expertise (either alone or with a financial adviser) to evaluate how the Covered Bonds will perform under changing conditions, the resulting effects on the value of the Covered Bonds and the impact this investment will have on the potential investor's overall investment portfolio.

Risks related to the Covered Bonds

Extendable obligations under the Covered Bonds

Unless previously redeemed as provided in the Conditions, the Covered Bonds of each Series will be redeemed at their Principal Amount Outstanding on the relevant Final Maturity Date. If the Covered Bonds are not redeemed in full at 100 per cent of the nominal amount of the Covered Bonds on the relevant Final Maturity Date or (as described below) where the Covered Bonds are subject to an Extended Final Maturity Date, on the relevant Extended Final Maturity Date, then the Trustee shall serve a Notice of Default on the

Issuer pursuant to the Conditions. Following the service of a Notice of Default: (a) any Covered Bond which has not been redeemed on or prior to its Final Maturity Date or, as applicable, Extended Final Maturity Date shall remain outstanding at its Principal Amount Outstanding, until the date on which such Covered Bond is cancelled or redeemed; and (b) interest shall continue to accrue on any Covered Bond which has not been redeemed on its Final Maturity Date or, as applicable, Extended Final Maturity Date and any payments of interest or principal in respect of such Covered Bond shall be made in accordance with the relevant Priority of Payments until the date on which such Covered Bond is cancelled or redeemed.

The applicable Final Terms may provide that the Issuer's obligations under the relevant Covered Bonds to pay the Principal Amount Outstanding on the relevant Final Maturity Date may, subject to certain conditions set out in Condition 7.1 (Final redemption) be deferred past the Final Maturity Date until the Extended Final Maturity Date (as specified in the Final Terms) (such date the "**Extended Final Maturity Date**"). In such case, such deferral will occur automatically if the Issuer fails to pay any amount representing 100 per cent of the nominal amount of the Covered Bonds due on the Final Maturity Date (taking into account the 7 Athens Business Day grace period), subject to any purchase and cancellation or early redemption thereof as set out in the Final Terms (the "**Final Redemption Amount**") in respect of the relevant Series of Covered Bonds on their Final Maturity Date provided that, any amount representing the Final Redemption Amount due and remaining unpaid on the Final Maturity Date may be paid by the Issuer on any Interest Payment Date thereafter up to (and including) the relevant Extended Final Maturity Date. Interest will continue to accrue and be payable on any unpaid amounts on each Interest Payment Date up to the Extended Final Maturity Date in accordance with the Conditions and the Issuer (or the Servicer on its behalf) will make payments on each relevant Interest Payment Date and Extended Final Maturity Date.

Risks in relation to Pass-Through Covered Bonds

As a result of (a) the occurrence of an Issuer Event (other than an Issuer Insolvency Event) and breach of the Amortisation Test or (b) the occurrence of an Issuer Insolvency Event and (i) non-payment of any Final Redemption Amount on the Final Maturity Date and payment of such amount is deferred pursuant to Condition 7.1; or (ii) a breach of the Amortisation Test, all Series of Covered Bonds become Pass-Through Covered Bonds with an Extended Final Maturity Date.

Additionally, if a Series of Covered Bonds is not redeemed in full, within a period of 7 Athens Business Days after the Final Maturity Date, such relevant Series of Covered Bonds will become Pass-Through Covered Bonds with an Extended Final Maturity Date.

If any (or all) Series of Covered Bonds become Pass-Through Covered Bonds, the Issuer shall redeem any (or all) Series of Covered Bonds (as applicable) on each Interest Payment Date until the Extended Final Maturity Date, in accordance with and subject to the relevant Priority of Payments and there is a risk that Covered Bondholders of such series receive principal repayments earlier or later than expected, which may result in a lower yield on such Covered Bondholders' investment than expected and a delay in the repayment of their investment in the Covered Bonds.

There is a risk that, as a consequence of all Covered Bonds becoming Pass-Through Covered Bonds, the speed of repayment of such Pass-Through Covered Bonds will be reduced, because the available funds for repayment will be divided pro rata with respect to all Covered Bonds. In such case, it is likely that the repayment of such Covered Bonds will take longer. Covered Bondholders should be aware that the period in which the Issuer can repay Covered Bonds on a pass-through basis is designed to match the underlying maturities of the loans comprising the Cover Pool and as a result the Pass-Through Covered Bonds may take a considerable time to be redeemed in full.

Ratings of the Covered Bonds

The credit ratings assigned to the Covered Bonds address:

- (i) the probability of default and loss given default; and
- (ii) the likelihood of ultimate payment of principal in relation to Covered Bonds on the Final Maturity Date or Extended Final Maturity Date thereof.

The expected credit ratings of the Covered Bonds are set out in the relevant Final Terms for each Series of Covered Bonds. Any Rating Agency may lower its rating or withdraw its rating if, in the sole judgment of the Rating Agency, the credit quality of the Covered Bonds has declined or is in question. If any credit rating assigned to the Covered Bonds is lowered or withdrawn, the market value of the Covered Bonds may reduce. A security rating is not a recommendation to buy, sell or hold securities and may be subject to revision, suspension or withdrawal at any time.

Credit ratings may not reflect all risks

One or more independent credit rating agencies may assign credit ratings to an issue of Covered Bonds. The ratings may not reflect the potential impact of all risks related to structure, market, additional factors discussed above, and other factors that may affect the value of the Covered Bonds. A credit rating is not a recommendation to buy, sell or hold securities and may be revised or withdrawn by the rating agency at any time.

In addition, rating agencies may assign unsolicited ratings to the Covered Bonds. In such circumstances, there can be no assurance that the unsolicited rating(s) will not be lower than the comparable solicited ratings assigned to the Covered Bonds, which could adversely affect the market value and liquidity of the Covered Bonds.

In general, European regulated investors are restricted under the CRA Regulation from using credit ratings for regulatory purposes in the EEA, unless such ratings are issued by a credit rating agency established in the EEA and registered under the CRA Regulation (and such registration has not been withdrawn or suspended), subject to transitional provisions that apply in certain circumstances whilst the registration application is pending. Such general restriction will also apply in the case of credit ratings issued by third country non-EEA credit rating agencies, unless the relevant credit ratings are endorsed by an EEA-registered credit rating agency or the relevant third country rating agency is certified in accordance with

the CRA Regulation (and such endorsement action or certification, as the case may be, has not been withdrawn or suspended, subject to certain transitional provisions that apply in certain circumstances). The list of registered and certified rating agencies published by ESMA on its website in accordance with the CRA Regulation is not conclusive evidence of the status of the relevant rating agency included in such list, as there may be delays between certain supervisory measures being taken against a relevant rating agency and the publication of the updated ESMA list. Certain information with respect to the credit rating agencies and ratings is set out on the cover of this Base Prospectus.

Investors regulated in the UK are subject to similar restrictions under the UK CRA Regulation. As such, UK regulated investors are required to use for UK regulatory purposes ratings issued by a credit rating agency established in the UK and registered under the UK CRA Regulation. In the case of ratings issued by third country non-UK credit rating agencies, third country credit ratings can either be: (a) endorsed by a UK registered credit rating agency; or (b) issued by a third country credit rating agency that is certified in accordance with the UK CRA Regulation. Note this is subject, in each case, to (a) the relevant UK registration, certification or endorsement, as the case may be, not having been withdrawn or suspended, and (b) transitional provisions that apply in certain circumstances. In the case of third country ratings, for a certain limited period of time, transitional relief accommodates continued use for regulatory purposes in the UK, of existing pre-2021 ratings, provided the relevant conditions are satisfied.

If the status of the rating agency rating the Covered Bonds changes for the purposes of the CRA Regulation or the UK CRA Regulation, relevant regulated investors may no longer be able to use the rating for regulatory purposes in the EEA or the UK, as applicable, and the Covered Bonds may have a different regulatory treatment, which may impact the value of the Covered Bonds and their liquidity in the secondary market. Certain information with respect to the credit rating agencies and ratings will be disclosed in the applicable Final Terms.

Rating Agency Confirmation in respect of Covered Bonds

The terms of certain of the Transaction Documents provide that, in certain circumstances, the Issuer must, and the Trustee may, obtain confirmation from one or more of the Rating Agencies that any particular action proposed to be taken by the Issuer, the Servicer or the Trustee will not adversely affect or cause to be withdrawn the then current ratings of the Covered Bonds (a “**Rating Agency Confirmation**”).

By acquiring the Covered Bonds, investors will be deemed to have acknowledged and agreed that, notwithstanding the foregoing, a credit rating is an assessment of credit and does not address other matters that may be of relevance to Covered Bondholders, including, without limitation, in the case of a Rating Agency Confirmation, whether any action proposed to be taken by the Issuer, Servicer, the Trustee or any other party to a Transaction Document is either (i) permitted by the terms of the relevant Transaction Document, or (ii) in the best interests of, or not prejudicial to, some or all of the Covered Bondholders. In being entitled to have regard to the fact that one or more of the Rating Agencies have confirmed that the then current ratings of the Covered Bonds would not be adversely affected or withdrawn, each of the Issuer, the Trustee and the other Secured Creditors (including the Covered Bondholders) is deemed to have

acknowledged and agreed that the above does not impose or extend any actual or contingent liability on the Rating Agencies to the Issuer, the Trustee, the Secured Creditors (including the Covered Bondholders) or any other person or create any legal relations between the Rating Agencies and the Issuer, the Trustee, the Secured Creditors (including the Covered Bondholders) or any other person whether by way of contract or otherwise.

Any such Rating Agency Confirmation may or may not be given at the sole discretion of each Rating Agency. It should be noted that, depending on the timing of delivery of the request and any information needed to be provided as part of any such request, it may be the case that a Rating Agency cannot provide a Rating Agency Confirmation in the time available or at all, and the Rating Agency will not be responsible for the consequences thereof. Such confirmation, if given, will be given on the basis of the facts and circumstances prevailing at the relevant time, and in the context of cumulative changes to the transaction of which the securities form part since the issuance closing date. A Rating Agency Confirmation represents only a restatement of the opinions given, and is given on the basis that it will not be construed as advice for the benefit of any parties to the transaction.

Covered Bonds not in physical form

Unless the Bearer Global Covered Bonds or the Registered Global Covered Bonds are exchanged for Bearer Definitive Covered Bonds or Registered Definitive Covered Bonds, respectively, which exchange will only occur in the limited circumstances set out under "Forms of the Covered Bonds – Bearer Covered Bonds" and "Forms of the Covered Bonds – Registered Covered Bonds" below, the beneficial ownership of the Covered Bonds will be recorded in book-entry form only with Euroclear and Clearstream, Luxembourg. The fact that the Covered Bonds are not represented in physical form could, among other things:

- result in payment delays on the Covered Bonds because distributions on the Covered Bonds will be sent by or on behalf of the Issuer to Euroclear or Clearstream, Luxembourg instead of directly to Covered Bondholders;
- make it difficult for Covered Bondholders to pledge the Covered Bonds as security if Covered
- Bonds in physical form are required or necessary for such purposes; and
- hinder the ability of Covered Bondholders to resell the Covered Bonds.

Because the Covered Bonds are held on behalf of Euroclear and Clearstream, Luxembourg, investors will have to rely on their procedures for transfer, payment and communication with the Issuer

Covered Bonds issued under the Programme may be represented by one or more Global Covered Bonds issued under the Programme. Such Covered Bonds will be deposited with a common depositary or a common safekeeper for Euroclear and Clearstream, Luxembourg. Except in the circumstances described in the relevant Global Covered Bond, investors will not be entitled to receive definitive Covered Bonds. Euroclear and Clearstream, Luxembourg will maintain records of the beneficial interests in the Global

Covered Bonds. While the Covered Bonds are represented by one or more Global Covered Bonds, investors will be able to trade their beneficial interests only through Euroclear and Clearstream, Luxembourg.

While the Covered Bonds are represented by one or more Global Covered Bonds, the Issuer will discharge its payment obligations under the Covered Bonds by making payments to the common depositary or common safekeeper for Euroclear and Clearstream, Luxembourg for distribution to their account holders. A holder of a beneficial interest in a Global Covered Bond must rely on the procedures of Euroclear and Clearstream, Luxembourg to receive payments under the relevant Covered Bonds. The Issuer has no responsibility or liability for the records in relation to, or payments made in respect of, beneficial interests in the Global Covered Bonds.

Holders of beneficial interests in the Global Covered Bonds will not have a direct right to vote in respect of the relevant Covered Bonds. Instead, such holders will be permitted to act only to the extent that they are enabled by Euroclear and Clearstream, Luxembourg to appoint appropriate proxies. Similarly, holders of beneficial interests in the Global Covered Bonds will not have a direct right under the Global Covered Bonds to take enforcement action against the Issuer in the event of a default under the relevant Covered Bonds.

Covered Bonds issued under the Programme

Covered Bonds issued under the Programme will either be fungible with an existing Series of Covered Bonds or have different terms to an existing Series of Covered Bonds (in which case they will constitute a new Series). All Covered Bonds will rank *pari passu* and rateably without any preference or priority among themselves, irrespective of their Series, except for their respective Issue Dates, Interest Commencement Dates and/or Issue Prices.

Following the occurrence of an Event of Default and service by the Trustee of a Notice of Default, the Covered Bonds of all outstanding Series will become immediately due and payable against the Issuer.

Further Issues

In order to ensure that any further issue of Covered Bonds under the Programme does not adversely affect existing Covered Bondholders:

- (i) the Statutory Tests will be required to be met both before and immediately after any further issue of Covered Bonds; and
- (ii) on or prior to the date of issue of any further Covered Bonds, the Issuer will be obliged to notify the Rating Agencies.

Obligations under the Covered Bonds

The Covered Bonds will not represent an obligation or be the responsibility of any of the Arranger, the Dealer(s), the Trustee or any other party to the Programme, their officers, members, directors, employees, security holders or incorporators, other than the Issuer. The Issuer will be liable solely in its corporate capacity for their obligations in respect of the Covered Bonds and such obligations will not be the obligations of their respective officers, members, directors, employees, security holders or incorporators.

The Trustee may agree to modifications to the Transaction Documents without the Covered Bondholders' or Secured Creditors' prior consent

Pursuant to the terms of the Trust Deed and the Deed of Charge, the Trustee may, without the consent or sanction of any of the Covered Bondholders or any of the other Secured Creditors (other than the Swap Providers in respect of modification to the Pre-Event of Default Priority of Payments, the Post-Event of Default Priority of Payments, the Conditions of the Covered Bonds, the Individual Eligibility Criteria or the Servicing and Cash Management Deed which in each case adversely affects their interests (such consent not to be unreasonably withheld or delayed)), concur with the Issuer or any person in making or sanctioning any modification to the Transaction Documents and the Terms and Conditions of the Covered Bonds:

- (i) (other than in respect of a Series Reserved Matter) provided that the Trustee is of the opinion that such modification, waiver or authorisation will not be materially prejudicial to the interests of any of the Covered Bondholders; or
- (ii) which in the sole opinion of the Trustee is of a formal, minor or technical nature or is to correct a manifest error,

and in each case, the Issuer has confirmed in writing to the Trustee that such modification will not adversely affect the then current ratings of the Covered Bonds.

Certain decisions of Covered Bondholders taken at Programme level

Any Extraordinary Resolution to direct the Trustee to take any enforcement action must be passed at a single meeting of the holders of all Covered Bonds of all Series then outstanding.

Absence of secondary market and limited liquidity for the market of Covered Bonds

There is not, at present, an active and liquid secondary market for the Covered Bonds issued under this Programme, and no assurance is provided that a secondary market for the Covered Bonds issued under this Programme will emerge. The Arranger is not obliged to and does not intend to make a market for the Covered Bonds issued under this Programme. None of the Covered Bonds issued or that may be issued under this Programme has been, or will be, registered under the Securities Act or any other applicable securities laws and they are subject to certain restrictions on the resale and other transfer thereof as set forth under "Subscription and Sale and Transfer and Selling Restrictions". If a secondary market does emerge, it may not continue for the life of the Covered Bonds issued under this Programme or it may not provide Covered Bondholders with liquidity of investment with the result that a Covered Bondholder may

not be able to find a buyer to buy its Covered Bonds readily or at prices that will enable the Covered Bondholder to realise a desired yield.

General legal investment considerations

The investment activities of certain investors are subject to legal investment laws and regulations, or review or regulation by certain authorities. Each potential investor should consult its legal advisers to determine whether and to what extent (1) Covered Bonds are legal investments for it, (2) Covered Bonds can be used as collateral for various types of borrowing and (3) other restrictions apply to its purchase or pledge of any Covered Bonds. Financial institutions should consult their legal advisors or the appropriate regulators to determine the appropriate treatment of Covered Bonds under any applicable risk-based capital or similar rules.

The circumstances in which the resolution authority may exercise the bail-in tool or other resolution tools pursuant to Greek law 4335/2015 or other future statutes or regulatory acts are vague and such uncertainty may have an impact on the value of the Covered Bonds

The conditions for the submission of a credit institution to resolution and the respective activation of the relevant powers of the competent resolution authority, are set in article 32 of the BRRD and Greek transposing law 4335/2015. Such conditions include the determination by the resolution authority that (a) the credit institution is failing or is likely to fail; (b) no reasonable prospect exists that any alternative private sector measures (including the write-down) would prevent the failure; and (c) a resolution action is necessary in the public interest, whilst the resolution objectives would not be met to the same extent by the special liquidation of the credit institution pursuant to normal insolvency.

Such conditions, however, are not further specified in the applicable law and so their satisfaction is left to the determination and discretion of the competent resolution authority. Such uncertainty may impact on the market perception as to whether a credit institution meets or not such conditions and as such it may be subjected to resolution tools. This may have a material adverse impact on the present value of the Covered Bonds and other securities of the Issuer's listed on organised markets.

In addition, if any Greek bail-in action is taken, interested parties, such as creditors or shareholders, may raise legal challenges. If any litigation arises in relation to Greek bail-in actions (whether actually, or purported to be taken) and such actions are declared void or ineffective and additional actions need to be taken, including reversal of any Greek bail-in action that is challenged, this may negatively affect liquidity and valuation, and increase the price volatility of the Issuer's securities (including the Covered Bonds).

Risks related to the structure of a particular issue of Covered Bonds

A wide range of Covered Bonds may be issued under the Programme. A number of these Covered Bonds may have features which contain particular risks for potential investors. Set out below is a description of the most common such features:

Covered Bonds subject to optional redemption by the Issuer

An optional redemption feature of Covered Bonds, if applicable, is likely to limit their market value. During any period when the Issuer may elect to redeem Covered Bonds, the market value of those Covered Bonds generally will not rise substantially above the price at which they can be redeemed. This may also be true prior to any redemption period.

The Issuer may be expected to redeem Covered Bonds when its cost of borrowing is lower than the interest rate on the Covered Bonds. At those times, an investor generally would not be able to reinvest the redemption proceeds at an effective interest rate as high as the interest rate on the Covered Bonds being redeemed and may only be able to do so at a significantly lower rate. Potential investors should consider reinvestment risk in light of other investments available at that time.

If the Issuer has the right to convert the interest rate on any Covered Bonds from a fixed rate to a floating rate, or vice versa, this may affect the secondary market and the market value of the Covered Bonds concerned

If the Issuer has the right to convert the interest rate on any Covered Bonds from a fixed rate to a floating rate, or vice versa, this may affect the secondary market and the market value of the Covered Bonds concerned. Fixed/Floating Rate Covered Bonds may bear interest at a rate that converts from a fixed rate to a floating rate, or from a floating rate to a fixed rate. Where the Issuer has the right to effect such a conversion, this will affect the secondary market and the market value of the Covered Bonds since the Issuer may be expected to convert the rate when it is likely to produce a lower overall cost of borrowing. If the Issuer converts from a fixed rate to a floating rate in such circumstances, the spread on the Fixed/Floating Rate Covered Bonds may be less favourable than then prevailing spreads on comparable Floating Rate Covered Bonds tied to the same reference rate. In addition, the new floating rate at any time may be lower than the rates on other Covered Bonds. If the Issuer converts from a floating rate to a fixed rate in such circumstances, the fixed rate may be lower than then prevailing market rates.

Covered Bonds which are issued at a substantial discount or premium may experience price volatility in response to changes in market interest rates

The market values of securities issued at a substantial discount (such as Zero Coupon Covered Bonds) or premium to their principal amount tend to fluctuate more in relation to general changes in interest rates than prices for more conventional interest-bearing securities. Generally, the longer the remaining term of such securities, the greater the price volatility as compared to conventional interest-bearing securities with comparable maturities.

The regulation and reform of “benchmarks” may adversely affect the value of Covered Bonds linked to or referencing such “benchmarks”

Interest rates and indices which are deemed to be “benchmarks” (such as, in the case of Floating Rate Covered Bonds or a Reference Rate) are the subject of national and international regulatory guidance and

proposals for reform. Some of these reforms are already effective whilst others are still to be implemented. These reforms may cause such benchmarks to perform differently than in the past, to disappear entirely, or have other consequences which cannot be predicted. Any such consequence could have a material adverse effect on any Covered Bonds linked to or referencing such a benchmark.

Regulation (EU) 2016/1011 (the “**EU Benchmarks Regulation**”) applies to the provision of benchmarks, the contribution of input data to a benchmark and the use of a benchmark within the EU. Among other things, it (i) requires benchmark administrators to be authorised or registered (or, if non-EU-based, to be subject to an equivalent regime or otherwise recognised or endorsed) and (ii) prevents certain uses by EU supervised entities (such as the Issuer) of benchmarks of administrators that are not authorised or registered (or, if non-EU based, not deemed equivalent or recognised or endorsed). Regulation (EU) 2016/1011 as it forms part of UK domestic law by virtue of the EUWA (the “**UK Benchmarks Regulation**”) among other things, applies to the provision of benchmarks and the use of a benchmark in the UK. Similarly, it prohibits the use in the UK by UK supervised entities of benchmarks of administrators that are not authorised by the FCA or registered on the FCA register (or, if non-UK based, not deemed equivalent or recognised or endorsed).

The EU Benchmarks Regulation and/or the UK Benchmarks Regulation, as applicable, could have a material impact on any Covered Bonds linked to or referencing a benchmark, in particular, if the methodology or other terms of the relevant benchmark are changed in order to comply with the requirements of the EU Benchmarks Regulation and/or the UK Benchmarks Regulation, as applicable. Such changes could, among other things, have the effect of reducing, increasing or otherwise affecting the volatility of the published rate or level of the relevant benchmark.

More broadly, any of the international or national reforms, or the general increased regulatory scrutiny of benchmarks, could increase the costs and risks of administering or otherwise participating in the setting of a benchmark and complying with any such regulations or requirements.

Such factors may have the following effects on certain benchmarks: (i) discourage market participants from continuing to administer or contribute to the benchmark; (ii) trigger changes in the rules or methodologies used in the benchmark or (iii) lead to the disappearance of the benchmark. Any of the above changes or any other consequential changes as a result of international or national reforms or other initiatives or investigations, could have a material adverse effect on the value of and return on any Covered Bonds linked to or referencing a benchmark.

Investors should consult their own independent advisers and make their own assessment about the potential risks imposed by the Benchmarks Regulation reforms in making any investment decision with respect to any Covered Bonds linked to or referencing a benchmark.

Future discontinuance of certain benchmark rates (for example, EURIBOR) may adversely affect the value of Floating Rate Covered Bonds which are linked to or which reference any such benchmark rate

The working group on euro risk-free rates has recommended Euro Short-term Rate (“€STR”) as the new risk-free rate for the euro area. €STR was first published on October 2, 2019. Although EURIBOR has been reformed in order to comply with the terms of the EU Benchmarks Regulation, it remains uncertain as to how long it will continue in its current form, or whether it will be further reformed or replaced with €STR or an alternative benchmark. In addition, on January 21, 2021, the working group published a paper indicating, among other things that continuing to reference EURIBOR in relevant contracts (without robust fallbacks) may increase the risk to the euro area financial system and setting out a set of guiding principles for fallback provisions in new euro denominated cash products (including bonds). On May 11, 2021, the working group published recommendations relating to fallback trigger events and fallback rates for contracts and financial instruments referring to EURIBOR which follow the guiding principles.

Investors should be aware that, if a benchmark rate were discontinued or otherwise unavailable, the rate of interest on Floating Rate Covered Bonds which are linked to or which reference such benchmark rate will be determined for the relevant period by the fall-back provisions applicable to such Covered Bonds. The Terms and Conditions provide for certain fallback arrangements in the event that a published benchmark, such as EURIBOR, (including any page on which such benchmark may be published (or any successor service)) becomes unavailable.

If the circumstances described in the preceding paragraph occur in the case of Floating Rate Covered Bonds Replacement is specified in the applicable Final Terms as being applicable and Screen Rate Determination is specified in the applicable Final Terms as the manner in which the rate of interest is to be determined, such fallback arrangements will include the possibility that the relevant rate of interest (or, as applicable, component thereof) could be set or, as the case may be, determined by reference to a Successor Reference Rate or an Alternative Reference Rate (as applicable) determined (A) by an Independent Adviser or, (B) if the Issuer is unable to appoint an Independent Adviser or the Independent Adviser appointed by the Issuer fails to make such determination, the Issuer. An Adjustment Spread shall be determined by the relevant Independent Adviser or the Issuer (as applicable) and shall be applied to such Successor Reference Rate or Alternative Reference Rate, as the case may be.

In addition, the relevant Independent Adviser or the Issuer (as applicable) may also determine (acting in good faith and in a commercially reasonable manner) that other amendments to the Terms and Conditions of the Covered Bonds are necessary in order to follow market practice in relation to the relevant Successor Reference Rate or Alternative Reference Rate and to ensure the proper operation of the relevant Successor Reference Rate or Alternative Reference Rate (as applicable).

No consent of the Covered Bondholders shall be required in connection with effecting any relevant Successor Reference Rate or Alternative Reference Rate (as applicable) or any other related adjustments and/or amendments described above.

In certain circumstances, the ultimate fallback of interest for a particular Interest Period or Interest Accrual Period (as applicable) may result in the rate of interest for the last preceding Interest Period or Interest Accrual Period (as applicable) being used. This may result in the effective application of a fixed rate for

Floating Rate Covered Bonds based on the rate which was last observed on the Relevant Screen Page for the purposes of determining the rate of interest in respect of an Interest Period or an Interest Accrual Period (as applicable). In addition, due to the uncertainty concerning the availability of Successor Reference Rates and Alternative Reference Rates and the involvement of an Independent Adviser, the relevant fallback provisions may not operate as intended at the relevant time.

Any such consequences could have a material adverse effect on the value of and return on any such Covered Bonds. Moreover, any of the above matters or any other significant change to the setting or existence of any relevant rate could affect the ability of the Issuer to meet its obligations under the Floating Rate Covered Bonds or could have a material adverse effect on the value or liquidity of, and the amount payable under, the Floating Rate Covered Bonds. Investors should note that, in the case of such instruments, the relevant Independent Adviser or the Issuer (as applicable) will have discretion to adjust the relevant Successor Reference Rate or Alternative Reference Rate in the circumstances described above. Any such adjustment could have unexpected commercial consequences and there can be no assurance that, due to the particular circumstances of each Covered Bondholder, any such adjustment will be favourable to each Covered Bondholder.

Investors should consider all of these matters when making their investment decision with respect to the relevant Floating Rate Covered Bonds.

The market continues to develop in relation to €STR as a reference rate for Covered Bonds

Where the applicable Final Terms for a Series of Covered Bonds specifies that the interest rate for such Covered Bonds will be determined by reference to €STR, interest will be determined on the basis of €STR (as defined in the Terms and Conditions of the Covered Bonds). The interest rate in respect of Covered Bonds with €STR as a Reference Rate will be determined on the basis of Compounded Daily €STR (as defined in the Terms and Conditions of the Covered Bonds), which is a backwards-looking, compounded near risk-free overnight rate.

Investors should be aware that the market continues to develop in relation to €STR as a reference rate in the capital markets and its adoption as an alternative to EURIBOR. Furthermore, the market or a significant part thereof may adopt an application of €STR that differs significantly from that set out in the Terms and Conditions and the Issuer may in the future issue Covered Bonds referencing €STR that differ materially in terms of interest determination when compared with any previous €STR referenced Covered Bonds issued by it. The nascent development of Compounded Daily €STR as an interest reference rate for bond markets, as well as continued development of €STR-based rates for such markets and the market infrastructure for adopting such rates, could result in reduced liquidity or increased volatility or could otherwise affect the market price of Covered Bonds with €STR as a Reference Rate. Similarly, if €STR does not prove to be widely used in securities such as the Covered Bonds, investors may not be able to sell the Covered Bonds at all or the trading price of the Covered Bonds may be lower than those of securities linked to indices that are more widely used.

The interest rate for Covered Bonds with €STR as a Reference Rate is only capable of being determined at the end of the relevant Interest Period and immediately prior to the relevant Interest Payment Date. It may be difficult for investors in Covered Bonds with €STR as a Reference Rate to estimate reliably the amount of interest which will be payable on the Covered Bonds, and some investors may be unable or unwilling to trade such Covered Bonds without changes to their IT systems, both of which factors could adversely affect the liquidity of such Covered Bonds. Further, if such Covered Bonds become due and payable prior to their stated maturity, the final interest rate payable in respect of such Covered Bonds shall only be determined immediately prior to the date on which the Covered Bonds become due and payable.

€STR is published by the ECB, as administrator of €STR, and there can be no guarantee that €STR will not be discontinued or fundamentally altered in a manner that is materially adverse to the interest of investors in Covered Bonds with €STR as a Reference Rate. If the manner in which €STR is calculated is changed, that change may result in a reduction of the amount of interest payable on the Covered Bonds and the trading prices of the Covered Bonds. Furthermore, the manner of adoption or application of €STR in the bond markets may differ materially compared with the application and adoption of €STR in other markets such as the derivatives and loan markets. Investors should carefully consider how any mismatch between the adoption of €STR across these markets may impact any hedging or other financial arrangements which they may put in place in connection with any acquisition, holding or disposal of such Covered Bonds.

To the extent the €STR Reference Rate is discontinued or is no longer published as described in the Terms and Conditions, the applicable rate to be used to calculate the interest rate on such Covered Bonds will be determined using the alternative methods described in Condition 5.03(iii)(E)(5) (“**€STR Fallbacks**”) or if these do not enable the rate of interest to be determined, Condition 5.11 (Benchmark Discontinuation) will apply (see “Benchmark reforms and Discontinuation - Benchmark Discontinuation” above). Any of these €STR Fallbacks may result in interest payments that are lower than, or do not otherwise correlate over time with, the payment that would have been made on the Covered Bonds if the €STR Reference Rate had been provided by the ECB in its form as at the Issue Date of the Covered Bonds. In addition, use of the €STR Fallbacks may result in a fixed rate of interest being applied to the Notes.

An investment in Covered Bonds with €STR as the Reference Rate may entail significant risks not associated with similar investments in conventional debt securities. Any investor should ensure it understands the nature of the terms of such Covered Bonds and the extent of its exposure to risk.

General risk factors

Set out below is a brief description of certain risks relating to the Covered Bonds generally:

The Conditions of the Covered Bonds contain provisions which may permit their modifications and waiver of any breach without the consent of all investors

The conditions of the Covered Bonds contain provisions for calling meetings of Covered Bondholders to consider matters affecting their interests generally. These provisions permit defined majorities to bind all

Covered Bondholders including Covered Bondholders who did not attend and vote at the relevant meeting and Covered Bondholders who voted in a manner contrary to the majority. Further, the conditions of the Covered Bonds contain provisions allowing the Trustee to agree to changes without the consent of any Covered Bondholder, including substitution of the Issuer pursuant to Condition 18 (*Substitution of the Issuer*).

Insurance

Under the terms and conditions of the Loan Documentation, each Borrower is required to obtain and maintain fire and earthquake insurance only, unless the property was built before 1 January 1960, in which case only fire insurance is available in the market. Accordingly, a claim under such policy for damage to the relevant property can be made only if the damage results from the occurrence of a fire or earthquake. However, this is not inconsistent with the terms and conditions of loans similar to the Loans made by other mortgage lenders in Greece who also only require borrowers to obtain and maintain fire and earthquake insurance. In addition, certain Borrowers, at their option, take out life insurance policies, with the Issuer as the primary loss payee, to secure their obligations under the relevant Loans.

Enforcement Proceedings under Greek law

Enforcement against Borrowers is a court-driven process which can be significantly delayed or suspended. Enforcement proceedings are usually commenced against a Borrower in respect of a Loan once it becomes 180 Days in Arrears, at which point the Loan is terminated. The process is commenced by service of the order for payment and a demand to pay on the Borrower, with the ultimate target being the collection of the proceeds of the auction of the relevant property securing the Loan. For further details, see "*The Mortgage and Housing Market in Greece - Enforcing Security*" and "*Restrictions on Enforcement of Granted Collateral*" below.

Prior to the enactment Greek Law 4335/2015, significantly amending the Greek Code of Civil Procedure, the Borrowers were entitled to challenge the compulsory enforcement at any stage of the process. However, by virtue of Greek Law 4335/2015 the debtor is entitled to oppose defects of the compulsory enforcement procedure only in two stages of the process while additional reforms of the Greek Civil Procedure Code by virtue of Greek Law 4472/2017 and Greek Law 4512/2018 aimed at accelerating and further facilitating the conducting of enforcement proceedings. For further details, see "*The Mortgage and Housing Market in Greece - Enforcing Security*" and "*Restrictions on Enforcement of Granted Collateral*" below. However, the length and complexity of enforcement procedures in Greece may still lead to substantial delays in recovering any amounts due under any defaulted or delinquent loan, especially due to the existing backlog of the courts, which may adversely affect the ability of the Issuer to enforce its claims against delinquent debtors.

Auction Proceeds

The proceeds of an auction following enforcement against a property securing a Loan must be allocated in accordance with the provisions of the Greek Civil Procedure Code. These articles require the notary

public which acted as the auction clerk to deduct from the proceeds the expenses (including legal, bailiff's and notarial fees) incurred in connection with the enforcement proceedings. Following such deduction, the proceeds are allocated among participating creditors, depending on their classification. In addition, the Issuer, as holder of a first ranking pre-notation could be limited to receiving 65 per cent of the proceeds raised by an auction of a property securing a Loan if creditors by operation of law and unsecured creditors co-exist. In such case, the proceeds may not be sufficient to discharge the amount that is owed by the Borrower under the Loan and in turn this may affect the Issuer's ability to meet its obligations under the Covered Bonds. For further details, see "*The Mortgage and Housing Market in Greece - Allocation of auction's proceeds*".

However, given that the loans are given a maximum 80 per cent LTV indexed value for the purpose of calculating the Statutory Tests and the Amortisation Test, the value of the property securing a Loan should exceed the Outstanding Principal Balance of that portion of the Loan accredited value for the purposes of the Statutory Tests. Accordingly, the possibility that the Issuer will not receive sufficient proceeds following the enforcement against a property securing a Loan to discharge the amounts that are owed to it by the relevant Borrower is reduced.

Special Insolvency Schemes

In addition to the standard enforcement and bankruptcy procedures, a series of special insolvency schemes were enacted over the last years for individuals or businesses resulting in a fragmented and complex insolvency framework in Greece.

On 15 November 2014, the Hellenic Parliament introduced a set of measures (Greek Law 4307/2014) for the restructuring of debts of viable small businesses and other professionals towards the State, social security organisations and banks, consisting of (a) write-offs and/or settlement of debts, coupled with a tax incentive for the banks implementing the new law and (b) new pre-bankruptcy proceedings that, among others, allow the banks to take control of the borrower through the appointment of an administrator.

On 3 August 2010, Greek Law 3869/2010 was put in force with respect to the settlement of amounts due by indebted individuals. The law allowed the settlement of amounts due, inter alia, to credit institutions by individuals evidencing permanent and general inability (without intention) to repay their due debts, by arranging the partial repayment of their due debts and writing off the remainder of their debts, provided the terms of settlement are observed. All individuals, both consumers and professionals, were subject to the provisions of Greek Law 3869/2010, with the exception of individuals who could be declared bankrupt. In the case of a Loan which is secured by property which is such debtor's primary residence, a debtor in the process of Greek Law 3869/2010 could request, until 28 February 2019, the exemption from liquidation of its primary residence provided that specific conditions were met. For further information see "*The Mortgage and Housing Market in Greece - Settlement of amounts due by over-indebted individuals*".

Due performance by the debtor of the obligations imposed by the relevant court decision allows the discharge of all the remaining outstanding debts of the debtor against its creditors, even against those who have not announced their claims. This debt discharge could have negative implications for the Issuer in its

capacity as creditor and could have a material adverse effect on its financial results, which may adversely affect the timing and amount of payments received on the Covered Bonds.

Greek Law 4605/2019 introduced a new procedure for the protection of individuals' primary residence from enforcement procedures. Greek Law 4605/2019 entitled individual debtors with banking debts secured by the debtor's primary residence to request the protection of such primary residence through the settlement of their debts. The procedure included two steps, namely, an extrajudicial amicable settlement procedure conducted through an e-platform; and, in case of failure to reach a settlement with all eligible creditors, an in court procedure. Greek Law 4605/2019 came into force on 30 April 2019, however the e-platform to submit an application was set-up on 1 July 2019. Individuals were entitled to submit an application until 31 July 2020. In case a settlement was agreed, according to the provisions of Greek Law 4605/2019, either through the e-platform or by virtue of a court decision, the primary residence of the applicant is protected against enforcement procedures by all creditors (including the Greek State) throughout the period of the settlement, with certain exceptions provided in Greek Law 4605/2019. This protection may affect the ability of the Issuer to proceed to enforcement procedures in respect of the relevant Loans.

Further, the instalments to be set through the procedures could be subsidised by the Greek State, provided that all eligible debt was restructured. The State Subsidy and the primary residence protection may be terminated upon the occurrence of certain events, including non-compliance with the settlement plan. Upon compliance of the debtor with the settlement plan, any remaining debt of the debtor is written-off and the relevant encumbrance over the primary residence of the debtor is lifted. This debt discharge could affect the Issuer's ability to meet its obligations in respect of the Covered Bonds. For further information see "*The Mortgage and Housing Market in Greece*".

In addition, Greek Law 4469/2017 introduced an out-of-court mechanism for the settlement of debts owed by a debtor to its creditors stemming from the business activity of the debtor or from any other reason, provided that the settlement is considered necessary in order to ensure the viability of the debtor.

Greek Law 4469/2017 applied to: (i) individuals who could be declared bankrupt according to the Greek Bankruptcy Code; and (ii) legal entities which earned income from business activity pursuant to articles 21 and 47 of the Greek Tax Income Code and have a tax residence in Greece. Subject to several conditions set out in the law and consecutive extensions granted through amendments to the Greek Law, the aforesaid persons could submit an online application until 30 April 2020 in order to be placed under the beneficial provisions of the new law. For further details, see "*The Mortgage and Housing Market in Greece – "Out-of court settlement of business debts"*".

These laws may have an adverse effect on the timing and amount of collections under certain loans concluded with borrowers that fall under the scope and make use of their respective provisions, which may in turn affect the Issuer's ability to meet its obligations in respect of the Covered Bonds.

In 2020, Greek Law 4738/2020 was enacted introducing a new bankruptcy regime for individuals and legal entities, which entered into force on 1 March 2021. Upon the new law coming into force, debtors are no longer able to apply for submission to the procedures under Greek Law 4307/2014, whereas submission

to the procedures under Greek Law 3869/2010 is no longer available as of 1 June 2021; thus the concerns raised above in relation to those procedures will be relevant only for procedures already commenced prior to such date. In parallel, proceedings pending before Greek courts under the previous legal frameworks will continue to run under such frameworks which result in a fragmented and complex insolvency framework in Greece and this may render the process of liquidating and collecting under the Loans a costly and lengthy process. For further details, see *“The Mortgage and Housing Market in Greece” – “Settlement legislative tools affecting the Enforcement of Security”*

Greek Covered Bond Legislation

In November 2019, the European Parliament and the Council adopted the legislative package on covered bond reforms made up of a new covered bond directive (Directive (EU) 2019/2162) (the **“Covered Bond Directive”**) and a new regulation (Regulation (EU) 2019/2160) (the **“Article 129 Regulation”**), which entered into force on 7 January 2020 with the deadline for application of 8 July 2022 (both texts have relevance for the EEA and are to be implemented in due course in other countries in the EEA, and, for these purposes, the EEA includes the UK). The Covered Bond Directive replaces the former article 52(4) of Directive 2009/65/EC (the **“UCITS Directive”**), establishes a revised common base-line for issue of covered bonds for EU regulatory purposes (subject to various options that members states may choose to exercise when implementing the new directive through national laws). The Covered Bond Directive does not have direct effect in EEA jurisdictions and will need to be implemented in the relevant jurisdiction by national legislation. In Greece, this has been effected by way of the Greek Covered Bond Legislation. The Article 129 Regulation is directly applicable in Member States from 8 July 2022 and it amends article 129 of the CRR (and certain related provisions) and further strengthens the criteria for covered bonds that benefit from preferential capital treatment under the CRR regime. As the CRR permits the exercise of certain national discretion, the implementation may be subject to some level of national variation.

The Covered Bond Law implemented into Greek law the Covered Bond Directive and is the primary legal basis for covered bond issuance in Greece. On 9 February 2023 the Executive Committee of the Bank of Greece issued decision nr. 215/03.02.2023 on the basis of the provisions and authorisations of the Covered Bond law which together with the Covered Bond Law, shall constitute the Greek Covered Bond Legislation. The Covered Bonds are expected to be fully compliant with the CRR and therefore qualify for a 20 per cent. risk weighting in eligible European jurisdictions. However, the Issuer cannot be certain as to how any of the regulatory developments described above or other regulatory changes not currently known to the Issuer will impact the treatment of the Covered Bonds for investors.

In addition, it should be noted that the Covered Bond Directive and the Covered Bond Law provides for permanent grandfathering with respect to certain requirements of the new regime for article 52(4) UCITS Directive-compliant covered bonds issued before 8 July 2022 and includes an option for the Member States to allow tap issues with respect to grandfathered covered bonds (for up to 24 months after 8 July 2022), provided such tap issues comply with certain prescribed requirements.

The transactions contemplated in this Base Prospectus are based, in part, on the provisions of the Greek Covered Bond Legislation. For further information on the Greek Covered Bond Legislation, see “*Overview of the Greek Covered Bond Legislation*”. There are a number of aspects of Greek law which are referred to in this Base Prospectus with which potential Covered Bondholders are likely to be unfamiliar. Particular attention should be paid to the sections of this Base Prospectus containing such references.

Prospective investors should therefore make themselves aware of the changes (and any corresponding national implementing measures) in addition to any other applicable regulatory requirements with respect to their investment in the Covered Bonds.

Insolvency proceedings and subordination provisions

There is uncertainty as to the validity and/or enforceability of a provision which (based on contractual and/or trust principles) subordinates certain payment rights of a creditor to the payment rights of other creditors of its counterparty upon the occurrence of insolvency proceedings relating to that creditor. In particular, recent cases have focused on provisions involving the subordination of a Hedging Counterparty's payment rights in respect of certain termination payments upon the occurrence of insolvency proceedings or other default on the part of such counterparty.

The UK Supreme Court has affirmed that a subordination provision of similar effect is valid under English law: *Belmont Park Investments Pty Limited v BNY Corporate Trustee Services Ltd and Lehman Brothers Special Financing Inc.*, [2011] ULSC38. The U.S. Bankruptcy Court held, in respect of proceedings to the Belmont decision that subordination provision is unenforceable under US bankruptcy law and that any action to enforce such provision would violate the automatic stay which applies under such law in the case of a US bankruptcy of the counterparty. The implications of these conflicting judgments of the UK Supreme Court and the U.S. Bankruptcy Court are not yet known.

If a creditor of the Issuer (such as a Hedging Counterparty) or a related entity becomes subject to insolvency proceedings in any jurisdiction outside England and Wales (including but not limited to the US), and it is owed a payment by the Issuer, a question arises as to whether the insolvent creditor or any insolvency official appointed in respect of that creditor could successfully challenge the validity and/or enforceability of subordination provisions included in the English law governed Transaction Documents (such as a provision of the Priorities of Payments). In particular, based on the decision of the US Bankruptcy Court referred to above, there is a risk that such subordination provisions would not be upheld under US bankruptcy laws. Such laws may be relevant in certain circumstances with respect to a range of entities which may act as Hedging Counterparty, including US established entities and certain non-US established entities with assets or operations in the US (although the scope of any such proceedings may be limited if the relevant non-US entity is a bank with a licensed branch in a US state).

In general, if a subordination provision included in the Transaction Documents was successfully challenged under the insolvency laws of any relevant jurisdiction outside England and Wales and any relevant foreign judgment or order was recognised by the English courts, there can be no assurance that such actions

would not adversely affect the rights of the Covered Bondholders, the market value of the Covered Bonds and/or the ability of the Issuer to satisfy its obligations under the Covered Bonds.

Lastly, given the general relevance of the issues under discussion in the judgments referred to above and that the Transaction Documents will include terms providing for the subordination of certain payments, there is a risk that the final outcome of the dispute in such judgments (including any recognition action by the English courts) may result in negative rating pressure in respect of the Covered Bonds. If any rating assigned to the Covered Bonds is lowered, the market value of the Covered Bonds may reduce.

Changes of law

The structure of the issue of the Covered Bonds and the ratings which are to be assigned to them are based on English and Greek law, respectively, in effect as at the date of this Base Prospectus. No assurance can be given as to the impact of any possible change to English or Greek law or administrative practice in the UK or Greece after the date of this Base Prospectus.

Covered Bonds where denominations involve integral multiples: definitive Covered Bonds

In relation to any issue of Covered Bonds that have denominations consisting of a minimum Specified Denomination plus one or more higher integral multiples of another smaller amount, it is possible that such Covered Bonds may be traded in amounts that are not integral multiples of such minimum Specified Denomination. In such a case, a Covered Bondholder who, as a result of trading such amounts, holds an amount which (after deducting integral multiples of such minimum Specified Denomination) is less than the minimum Specified Denomination in his account with the relevant clearing system at the relevant time may not receive a definitive Covered Bond in respect of such holding (should definitive Covered Bonds be printed) and would need to purchase a principal amount of Covered Bonds such that its holding amounts to a Specified Denomination.

If definitive Covered Bonds are issued, Covered Bondholders should be aware that definitive Covered Bonds that have a denomination that is not an integral multiple of the minimum Specified Denomination may be illiquid and difficult to trade.

Exchange rate risks and exchange controls

The Issuer (or the Servicer on its behalf) will pay principal and interest on the Covered Bonds in the Specified Currency. This presents certain risks relating to currency conversions if an investor's financial activities are denominated principally in a currency or currency unit other than the Specified Currency (the "**Investor's Currency**"). These include the risk that exchange rates may significantly change (including changes due to devaluation of the Specified Currency or revaluation of the Investor's Currency) and the risk that authorities with jurisdiction over the Investor's Currency may impose or modify exchange controls. An appreciation in the value of the Investor's Currency relative to the Specified Currency would decrease (1) the Investor's Currency equivalent yield on the Covered Bonds, (2) the Investor's Currency-equivalent value of the principal payable on the Covered Bonds and (3) the Investor's Currency-equivalent market

value of the Covered Bonds. As a result, investors may receive less interest or principal than expected, or no interest or principal (in an Investor's currency-equivalent basis).

Government and monetary authorities may impose (as some have done in the past) exchange controls that could adversely affect an applicable exchange rate. As a result, investors may receive less interest or principal than expected, or no interest or principal.

Taxation

Potential investors of Covered Bonds should consult their own tax advisers as to which countries' tax laws could be relevant to acquiring, holding and disposing Covered Bonds and receiving payments of interest, principal and/or other amounts or delivery of securities under the Covered Bonds and the consequences of such actions under the tax laws of those countries.

Words and expressions defined in the "Terms and Conditions of the Covered Bonds" below or elsewhere in this Base Prospectus have the same meanings in this summary.

Account Bank

HSBC Bank plc at 8 Canada Square, London E14 5HQ has agreed to act as account bank (the "**Account Bank**") pursuant to the Bank Account Agreement.

In the event that the Account Bank ceases to be an Eligible Institution, the Servicer will be obliged to transfer the Transaction Accounts to a credit institution with the appropriate minimum ratings.

"**Eligible Institution**" means any bank whose long-term issuer default rating is rated at least BBB- by S&P (or such other ratings that may be agreed by the parties to the Bank Account Agreement and the Rating Agencies from time to time), provided always that such ratings are sufficient for deposits in the Transaction Account to comply with Article 129(1)(c) of the CRR.

The Issuer may issue Covered Bonds without the prior consent of the Covered Bondholders pursuant to Condition 16 (*Further Issues*). See "*Conditions Precedent to the Issuance of a new Series or Tranche of Covered Bonds*" below.

As used herein, "**Tranche**" means Covered Bonds which are identical in all respects (including as to listing and admission to trading) and "**Series**" means a Tranche of Covered Bonds together with any further Tranche or Tranches of Covered Bonds which are (a) expressed to be consolidated and form a single series and (b) identical in all respects (including as to listing and admission to trading) except for their respective Issue Dates, Interest Commencement Dates and/or Issue Prices.

Final Terms

Final terms (the "**Final Terms**") will be issued and published in accordance with the terms and conditions set out herein under "*Terms and Conditions of the Covered Bonds*" (the "**Conditions**") prior to the issue of each Series or Tranche detailing certain relevant terms thereof which, for the purposes of that Series only, complete the Conditions and the Base Prospectus and must be read in conjunction with the Conditions and the Base Prospectus.

The terms and conditions applicable to any particular Series are the Conditions as completed by the relevant Final Terms.

The applicable Final Terms may provide that certain Covered Bonds will bear interest at a fixed rate ("**Fixed Rate Covered Bonds**"), which will be payable on each Interest Payment Date and on the applicable redemption date and will be calculated on the basis of such Day Count Fraction as may be agreed between the Issuer and the relevant Dealer(s) (as set out in the applicable Final Terms).

Floating Rate Covered Bonds

The applicable Final Terms may provide that certain Covered Bonds bear interest at a floating rate ("**Floating Rate Covered Bonds**"). Floating Rate Covered Bonds will bear interest at a rate determined:

- (a) on the same basis as the floating rate under a notional interest rate swap transaction in the relevant Specified Currency governed by an agreement incorporating the ISDA Definitions; or
- (b) on the basis of a reference rate appearing on the agreed screen page of a commercial quotation service,

as set out in the applicable Final Terms.

The margin (if any) relating to such floating rate (the "**Margin**") will be agreed between the Issuer and the relevant Dealer(s) for each issue of Floating Rate Covered Bonds, as set out in the applicable Final Terms.

Other provisions in relation to Floating Rate Covered Bonds

In the event that the Rate of Interest of Floating Rate Covered Bonds is less than zero for an Interest Period, the Rate of Interest for that Interest Period shall be deemed to be zero. Floating Rate Covered Bonds may also have a Maximum Rate of Interest, a Minimum Rate of Interest (other than zero, as described in this paragraph) or both (as indicated in the applicable Final Terms). Interest on Floating Rate Covered Bonds in respect of each Interest Period, as agreed prior to issue by the Issuer and the relevant Dealer(s), will be payable on such Interest Payment Dates, and will be calculated on the basis of such Day Count

Fraction, in each case as may be agreed between the Issuer and the relevant Dealer(s) (as set out in the applicable Final Terms).

Zero Coupon Covered Bonds

The applicable Final Terms may provide that Covered Bonds, bearing no interest ("**Zero Coupon Covered Bonds**"), may be offered and sold at a discount to their nominal amount.

Ranking of the Covered Bonds

All Covered Bonds will rank *pari passu* and rateably without any preference or priority among themselves, irrespective of their Series, for all purposes except for their respective Issue Dates, Interest Commencement Dates and/or Issue Prices.

Taxation

All payments of principal, interest and other proceeds (if any) on the Covered Bonds will be made free and clear of any withholding or deduction for, or on account of, any taxes, unless the Issuer or any intermediary that intervenes in the collection of interest and other proceeds on the Covered Bonds is required by applicable law to make such a withholding or deduction. In the event that such withholding or deduction is required by law, the Issuer will not be required to pay any additional amounts in respect of such withholding or deduction.

Status of the Covered Bonds

The Covered Bonds are covered bonds that could be eligible for the label "European Covered Bond (Premium) (in Greek "Ευρωπαϊκό Καλυμμένο Ομόλογο (Ανωτέρας Ποιότητας)" subject to the final assessment of the Programme by the Bank of Greece, certifying the label and are issued on an unconditional basis and in accordance with Articles 1-33 of Greek Law 4920/2022, (the "**Covered Bond Law**") and the decision nr. 215/03.02.2023 of the Executive Committee of the Bank of Greece issued pursuant to the Covered Bond Law (the "**Secondary Covered Bond Legislation**" and, together with the Covered Bond Law, the "**Greek Covered Bond Legislation**"). The Covered Bonds are backed by assets forming the Cover Pool of the Issuer and to the extent that such assets are governed by Greek law, have the benefit of a statutory pledge established by operation of law pursuant to Article 14(2) of the Covered Bond Law (the "**Statutory Pledge**") See also "*Overview of the Greek Covered Bond Legislation*" below.

Payments on the Covered Bonds

Payments on the Covered Bonds will be direct and unconditional obligations of the Issuer.

Prior to an Issuer Event and prior to service of a Notice of Default on each Cover Pool Payment Date, the Servicer will apply any funds available to it (including, but not limited to, funds arising in relation to the assets comprised in the Cover Pool) to pay all items which are listed in the Pre-Event of Default Priority of Payments.

After the occurrence of an Issuer Event (but prior to service of a Notice of Default) on each Cover Pool Payment Date, the Servicer or the Special Administrator (as the case may be) will apply the Covered Bonds Available Funds in accordance with the Pre-Event of Default Priority of Payments.

After the service of a Notice of Default, all funds deriving from the Cover Pool Assets, the Transaction Documents and standing to the credit of the Transaction Accounts shall be applied on any Athens Business Day in accordance with the Post-Event of Default Priority of Payments.

Security for the Covered Bonds

In accordance with the Greek Covered Bond Legislation, by virtue of the Transaction Documents and pursuant to any Registration Statement, the Cover Pool will be available both prior to and following an insolvency or resolution of the Issuer, to satisfy the obligations of the Issuer to the Covered Bondholders and the other Secured Creditors in priority to the Issuer's obligations to any other creditors, until the repayment in full of the Covered Bonds.

In accordance with the Deed of Charge, security will be created for the benefit of the Trustee on behalf of the Secured Creditors in respect of the Transaction Accounts, any Hedging Agreements and any other Transaction Documents governed by English law.

In accordance with the Collection Accounts Pledge Agreement, security will be created for the benefit of the Trustee on behalf of the Secured Creditors in respect of the Collection Accounts and such security will be governed by Greek law.

"Secured Creditors" means the Covered Bondholders, the Couponholders, the Trustee, any Receiver, the Asset Monitor, the Account Bank, the Agents, the Servicer, the Replacement Servicer, the Special Administrator, the Hedging Counterparties

and any other creditor of the Issuer pursuant to any transaction document entered into in the course of the Programme having recourse to the Cover Pool (provided that where the Issuer performs any of the above roles, the Issuer will not be a Secured Creditor).

"Receiver" means any person or persons appointed (and any additional person or persons appointed or substituted) as an administrative receiver, receiver, manager, or receiver and manager of the Charged Property by the Trustee pursuant to the Deed of Charge.

"Charged Property" means the property, assets and undertakings charged by the Issuer pursuant to Clause 3 of the Deed of Charge and property and assets subject to the pledge created by the Collection Accounts Pledge Agreement, in each case together with, where applicable, the property pledged pursuant to the Statutory Pledge.

"Agents" means the Paying Agents, the Registrar, the Transfer Agents and any Calculation Agent.

Cross-collateralisation and Recourse

By operation of the Covered Bond Law and in accordance with the Transaction Documents, the Cover Pool Assets shall form a single portfolio, irrespective of the date of assignment to the Cover Pool and shall be held for the benefit of the Covered Bondholders and the other Secured Creditors irrespective of the Issue Date of the relevant Series. The Covered Bondholders and the other Secured Creditors shall have recourse to the Cover Pool.

The Cover Pool Assets may not be seized or attached in any form by creditors of the Issuer other than by the Trustee on behalf of the Covered Bondholders and the other Secured Creditors.

In order to ensure that the Cover Pool is, at any time, sufficient to meet the payment obligations of the Issuer under the Covered Bonds, the Issuer shall be obliged, within certain limits and upon certain conditions, to effect certain changes to the Cover Pool Assets comprising the Cover Pool. See "*Optional Changes to the Cover Pool*" below.

Issue Price Covered Bonds of each Series may be issued at par or at a premium or discount to par on a fully-paid basis (in each case, the "**Issue Price**" for such Series or Tranche) as specified in the relevant Final Terms in respect of such Series.

Interest Payment Dates In relation to any Series of Covered Bonds, the Interest Payment Dates will be specified in the applicable Final Terms (as the case may be).

Cover Pool Payment Date The 20th day of each month and if such day is not an Athens Business Day the first Athens Business Day thereafter (the "**Cover Pool Payment Date**").

"**Athens Business Day**" means a day (other than a Saturday or Sunday) on which commercial banks are open for general business (including dealings in foreign exchange and foreign currency deposits) in Athens.

Final maturity and extendable obligations under the Covered Bonds The final maturity date for each Series (the "**Final Maturity Date**") will be specified in the relevant Final Terms as agreed between the Issuer and the relevant Dealer(s). Unless previously redeemed as provided in the Conditions, the Covered Bonds of each Series will be redeemed at their Principal Amount Outstanding on the relevant Final Maturity Date. If the Covered Bonds are not redeemed in full on the Final Maturity Date, within a period of 7 Athens Business Days, this will constitute an Issuer Event upon which the Covered Bonds will become Pass-Through Covered Bonds with an Extended Final Maturity Date. If the Covered Bonds are not redeemed in full on the Extended Final Maturity Date, then the Trustee shall serve a Notice of Default on the Issuer pursuant to Condition 10 (*Events of Default and Enforcement*). Following the service of a Notice of Default the Covered Bonds of each Series shall become immediately due and payable.

The applicable Final Terms may also provide that the Issuer's obligations under the relevant Covered Bonds to pay the Principal Amount Outstanding on the relevant Final Maturity Date may, subject to certain conditions set out in Condition 7.1 (*Final redemption*), be deferred past the Final Maturity Date until the extended final maturity date (as specified in the applicable Final Terms) (such date the "**Extended Final Maturity Date**"). In such

case, such deferral will occur automatically if the Issuer fails to pay any amount representing the amount due on the Final Maturity Date (taking into account the 7 Athens Business Day grace period) as set out in the Final Terms (the "**Final Redemption Amount**") in respect of the relevant Series of Covered Bonds on their Final Maturity Date, provided that any amount representing the Final Redemption Amount due and remaining unpaid on the Final Maturity Date may be paid by the Issuer on any Interest Payment Date thereafter up to (and including) the relevant Extended Final Maturity Date. Interest will continue to accrue and be payable on any unpaid amounts on each Interest Payment Date up to the Extended Final Maturity Date in accordance with Condition 5 (*Interest*) and the Issuer (or the Servicer on its behalf) will make payments on each relevant Interest Payment Date and Extended Final Maturity Date.

The Final Redemption Amount will not be less than the Principal Amount Outstanding of the relevant Covered Bonds.

Following service of a Notice of Default, any amount outstanding shall bear interest in accordance with Condition 7.9 (*Late Payment*).

Accumulation Covered Bonds

Following an Issuer Event, each Series of Covered Bonds where, on any relevant date, the Final Maturity Date is not more than 6 months following such date, shall be Accumulation Covered Bonds.

In relation to each Series of Accumulation Covered Bonds, the Issuer shall credit an amount equal to the relevant Pro-Rata Accumulation Amount to the relevant Accumulation Sub-Ledger on each Cover Pool Payment Date prior to the Final Maturity Date of such series of Covered Bonds. Amounts credited to the relevant Accumulation Sub-Ledger will be used to pay amounts due in respect of the Final Redemption Amount in respect of the relevant series of Accumulation Covered Bonds on their Final Maturity Date.

Pro Rata Accumulation Amount

Pro Rata Accumulation Amount means in respect of any relevant Series of Accumulation Covered Bonds on each Cover Pool Payment Date an amount equal to

$$A \times \frac{B}{C}$$

Where

A = the Covered Bonds Available Funds on such Cover Pool Payment Date minus (i) if the Pro Rata Accumulation Amount is being calculated to determine payments at paragraph (vi) of the Pre-Event of Default Priority of Payments, all amounts due in respect of items (i) to (v) of the Pre-Event of Default Priority of Payments or (ii) if the Pro Rata Accumulation Amount is being calculated to determine payments at paragraph (vii) of the Pre-Event of Default Priority of Payments, all amounts due in respect of items (i) to (vi) of the Pre-Event of Default Priority of Payments;

B = the Euro Equivalent of the Principal Amount Outstanding of the relevant Series of Accumulation Covered Bonds less any amount credited to the Accumulation Sub-Ledger in respect of such Series on such Cover Pool Payment Date; and

C = the aggregate of the Euro Equivalent of the Principal Amount Outstanding of all Pass-Through Covered Bonds and Accumulation Covered Bonds which are paid pari passu with the relevant Series of Accumulation Covered Bonds paid in accordance with either paragraph (g) or paragraph (h) of the Pre-Event of Default Priority of Payments, as applicable minus any amounts standing to the credit of the Accumulation Ledger on such Cover Pool Payment Date.

Pass-Through Covered Bonds

Those Covered Bonds in respect of which the Final Redemption Amount has not been paid in full on the Final Maturity Date (taking into account any grace periods) or, following a breach of the Amortisation Test that occurs on or after the occurrence of an Issuer Event (other than an Issuer Insolvency Event) or following the occurrence of an Issuer Insolvency Event and (i) any Final Redemption Amount is unpaid on the Final Maturity Date therefor and payment of such amount is deferred pursuant to Condition 7.1(ii); or (ii) a breach of the Amortisation Test, all outstanding

Series of Covered Bonds will become Pass-Through Covered Bonds.

Upon a Series of Covered Bonds becoming a Series of Pass-Through Covered Bonds, the Issuer will pay principal amounts on each such Series to the extent it has amounts available for the purpose in accordance with the Pre-Event of Default Priority of Payments on each Interest Payment Date until such Series is redeemed in full.

Ratings

Each Series issued under the Programme may be assigned a rating by each of the Rating Agencies as set out in the applicable Final Terms.

Listing and admission to trading

Application has been made to the Luxembourg Stock Exchange to approve this document as a base prospectus. Application has also been made to the Luxembourg Stock Exchange for Covered Bonds issued under the Programme after the date hereof to be admitted to trading on the Euro MTF Market of the Luxembourg Stock Exchange and to be listed on the official list of the Luxembourg Stock Exchange.

Covered Bonds may be unlisted or may be listed or admitted to trading, as the case may be, on other stock exchanges or markets agreed between the Issuer, the Trustee and the relevant Dealer(s) in relation to each issue. The Final Terms relating to each Tranche of the Covered Bonds will state whether or not the Covered Bonds are to be listed and/or admitted to trading and, if so, on which other stock exchanges or markets.

Clearing Systems

Euroclear Bank S.A./N.V. ("**Euroclear**"), and/or Clearstream Banking, *société anonyme* ("**Clearstream, Luxembourg**") in relation to any Series of Covered Bonds or any other clearing system as may be specified in the relevant Final Terms.

Selling Restrictions

There are restrictions on the offer, sale and transfer of the Covered Bonds in the United States, the European Economic Area (including the United Kingdom and the Hellenic Republic) and Japan and such other restrictions as may be required in connection with the offering and sale of a particular Tranche of Covered Bonds. See "*Subscription and Sale*" below.

United States Selling Restrictions Bearer Covered Bonds will be issued in compliance with U.S. Treasury Regulation §1.163-5(c)(2)(i)(D) (or any successor rules in substantially the same form that are applicable for purposes of Section 4701 of the U.S. Internal Revenue Code of 1986, as amended (the "**Code**") (the "**D Rules**"), unless (i) the relevant Final Terms state that the Bearer Covered Bonds are issued in compliance with U.S. Treasury Regulation §1.163-5(c)(2)(i)(C) (or any successor rules in substantially the same form that are applicable for purposes of Section 4701 of the Code) (the "**C Rules**"), or (ii) the Bearer Covered Bonds are issued other than in compliance with the D Rules or the C Rules but in circumstances in which the Bearer Covered Bonds will not constitute "registration required obligations" under the U.S. Tax Equity and Fiscal Responsibility Act of 1982 ("**TEFRA**"), which circumstances will be referred to in the relevant Final Terms as a transaction to which TEFRA is not applicable.

Greek Covered Bond Legislation The Covered Bonds will be issued pursuant to the Greek Covered Bond Legislation.

For further information on the Greek Covered Bond Legislation, see "*Overview of the Greek Covered Bond Legislation*" below.

Governing Law The Servicing and Cash Management Deed, the Trust Deed, the Deed of Charge, the Agency Agreement, the Asset Monitor Agreement, the Bank Account Agreement, the Programme Agreement, each Subscription Agreement and each Hedging Agreement (if any) will be governed by, and construed in accordance with, English law.

The Covered Bonds will be governed by and construed in accordance with English law, save that the Statutory Pledge referred to in Condition 3 (*Status of the Covered Bonds*) which, together with the Collection Accounts Pledge Agreement, will be governed by and construed in accordance with Greek law.

**CREATION AND
ADMINISTRATION OF THE
COVER POOL**

The Cover Pool The Statutory Pledge is created pursuant to the Greek Covered Bond Legislation and will create security over the Cover Pool

Assets, other than the Cover Pool Assets not governed by Greek law.

By virtue of the Registration Statement(s) filed with the Athens Pledge Registry on or prior to the Issue Date for the first Series of Covered Bonds, the Issuer shall segregate the Cover Pool in connection with the issuance of Covered Bonds for the satisfaction of the rights of the Covered Bondholders and the other Secured Creditors. See "*Description of the Transaction Documents*" – "*The Servicing and Cash Management Deed*".

CHANGES TO THE COVER POOL

Optional changes to the Cover Pool

The Issuer shall be entitled, subject to filing a Registration Statement so providing and subject to the satisfaction of the requirements in the Servicing and Cash Management Deed, to allocate to the Cover Pool Additional Cover Pool Assets and/or remove or substitute Cover Pool Assets.

Any further assets added to the Cover Pool at the option of the Issuer in accordance with the above shall form part of the Cover Pool.

Upon any addition to the Cover Pool of any Additional Cover Pool Assets where the relevant transfer date is also an Issue Date or the Issuer ceases to have the Minimum Credit Ratings, the Issuer shall deliver to the Trustee a solvency certificate stating that the Issuer is, at such time, solvent.

See "*Description of the Transaction Documents*" – "*The Servicing and Cash Management Deed*".

Disposal of the Loan Assets

Following the occurrence of an Issuer Event (where such Issuer Event is not an Issuer Insolvency Event) the Servicer or (where such Issuer Event is also an Issuer Insolvency Event) the Special Administrator (as the case may be) may sell in whole or in part the Loan Assets in accordance with the provisions of the Servicing and Cash Management Deed. The proceeds from any such sale will be credited to the relevant Transaction Account and applied in accordance with the relevant Pre-Event of Default Priority of Payments.

In certain circumstances the Issuer shall have the right to prevent the sale of Loan Assets to third parties by removing the Loan Assets made subject to any sale from the Cover Pool and transferring within ten Athens Business Days from the receipt of an offer letter, to the relevant Transaction Account, an amount equal to the price set forth in such offer letter, subject to the provision of a solvency certificate. See "*Description of the Transaction Documents – The Servicing and Cash Management Deed - Sale of Selected Loans and their Related Security following an Issuer Event (other than an Issuer Insolvency Event)*".

Following the occurrence of an Event of Default (where such Event of Default arises following the occurrence of an Issuer Event which is not also an Issuer Insolvency Event) and service of a Notice of Default, the Trustee may (and shall if so directed by the Covered Bondholders of each Series acting by way of Extraordinary Resolution and indemnified and/or secured and/or pre-funded to its satisfaction) be entitled to direct the Servicer to dispose of the Cover Pool. Following the occurrence of an Event of Default and service of a Notice of Default (where such Event of Default arises following the occurrence of an Issuer Event which is also an Issuer Insolvency Event) the Special Administrator appointed following such Issuer Insolvency Event may dispose of all or part of the Cover Pool, including the case where the Special Administrator transfers the obligations of the Issuer under the Covered Bonds to another bank (authorised as a covered bond issuer) and disposes to such bank the Cover Pool.

For the avoidance of doubt the Cover Pool Assets shall include any Selected Loans which have previously been selected pursuant to the Servicing and Cash Management Deed for disposal in relation to any Series of Covered Bonds which have not yet been sold

Undertakings of the Issuer in respect of the Cover Pool

Pursuant to the Transaction Documents, the Issuer undertakes to manage the Cover Pool in the interest of the Covered Bondholders and the other Secured Creditors and undertakes to take in a timely manner any actions required in order to ensure that the servicing of the Loan Assets is conducted in accordance

with the collection policy and recovery procedure applicable to the Issuer.

Representations and Warranties of the Issuer

Under the Servicing and Cash Management Deed, the Issuer has made and will make certain representations and warranties regarding itself and the Cover Pool Assets including, *inter alia*:

- (i) its status, capacity and authority to enter into the Transaction Documents and assume the obligations expressed to be assumed by it therein;
- (ii) the legality, validity, binding nature and enforceability of the obligations assumed by it;
- (iii) the existence of the Cover Pool Assets and the absence of any lien attaching to the Cover Pool Assets;
- (iv) its full, unconditional, legal title to the Cover Pool Assets; and
- (v) the validity and enforceability against the relevant debtors of the obligations from which the Cover Pool Assets arise.

Individual Eligibility Criteria

Each Loan Asset to be included in the Cover Pool shall comply with the Individual Eligibility Criteria. See "*Description of the Transaction Documents*" – "*The Servicing and Cash Management Deed*".

Monitoring of the Cover Pool

Prior to the occurrence of an Issuer Event, the Servicer shall verify on each Applicable Calculation Date that, as at the last calendar day of the calendar month immediately preceding such Applicable Calculation Date:

- (i) the Cover Pool satisfies the Nominal Value Test;
- (ii) the Cover Pool satisfies the NPV Test; and
- (iii) the Cover Pool satisfies the Interest Cover Test,

(collectively, the "**Statutory Tests**" and each a "**Statutory Test**").

"**Calculation Date**" means, the 10th day of each calendar month and if such day is not an Athens Business Day the first Athens Business Day thereafter.

"Applicable Calculation Date" means each Calculation Date which falls in April, July, October and January of each year.

Statutory Tests

Pursuant to the Greek Covered Bond Legislation, the Cover Pool is subject to the Statutory Tests set out in the Covered Bond Law and the Secondary Covered Bond Legislation. Failure of the Issuer to cure a breach of any one of the Statutory Tests within five Athens Business Days will result in the Issuer not being able to issue further Covered Bonds. See "*Description of the Transaction Documents*" – "*The Servicing and Cash Management Deed – Statutory Test*" for more information.

Breach of Statutory Tests

If on any Applicable Calculation Date any one or more of the Statutory Tests being tested on such Applicable Calculation Date are not satisfied, the Issuer must take immediate action to cure any breach(es) of the relevant Statutory Tests.

The Issuer or (where Eurobank is not the Servicer) the Servicer, as the case may be will immediately provide written notification to the Trustee of any breach of any of the Statutory Tests.

In the event that the Issuer breaches any Statutory Test, the Issuer will not be permitted to issue any further Covered Bonds until such time as such Statutory Test breach has been cured.

Amortisation Test

In addition to the Statutory Tests and pursuant to the Servicing and Cash Management Deed, after the occurrence of an Issuer Event and so long as an Event of Default has not occurred the Cover Pool will be subject to an amortisation test (the "**Amortisation Test**"). The Amortisation Test is intended to ensure that the Cover Pool Assets are sufficient to meet the obligations under all Covered Bonds outstanding together with senior expenses that rank in priority or *pari passu* with amounts due on the Covered Bonds.

The Amortisation Test will be tested by the Servicer on each Calculation Date following an Issuer Event. A breach of the Amortisation Test following the occurrence of an Issuer Event or an Issuer Insolvency Event will cause all Series of Covered Bonds to become Pass-Through Covered Bonds.

The Servicer will notify the Trustee of any breach of the Amortisation Test as soon as practicable after becoming aware of such breach.

Amendment to definitions

The Servicing and Cash Management Deed will provide that the definitions of Individual Eligibility Criteria, Cover Pool, Cover Pool Asset, Statutory Test and Amortisation Test may be amended by the Issuer from time to time as a consequence of, *inter alia*, including in the Cover Pool, Cover Pool Assets which have characteristics other than those pertaining to the Initial Assets and/or changes to the hedging policies or servicing and collection procedures of Eurobank and/or as a result of any updates, amendments or supplements to the Greek Covered Bond Legislation, without the consent of the Trustee provided that S&P has been notified and that the ratings on the Covered Bonds would not be adversely affected by, or withdrawn as a result of such amendment (and in the case of any other Rating Agency, such Rating Agency has been notified). The Servicing and Cash Management Deed shall set forth the conditions for any such amendment to be effected.

See "*Description of the Transaction Documents – The Servicing and Cash Management Deed – Amendment to Definitions*".

Issuer Events

If, prior to, or concurrent with the occurrence of an Event of Default, an Issuer Event occurs then (i) no further Covered Bonds will be issued, (ii) the Servicer (and the Issuer to the extent that the Issuer is no longer the Servicer) will procure that any and all payments due from Borrowers under the Cover Pool Assets (excluding any Subsidy Payments) are effected henceforth directly to the relevant Third Party Collection Account and that all such amounts (including the Subsidy Payments) are transferred into the corresponding Transaction Account within 1 Athens Business Day of receipt, (iii) all collections of principal and interest on the Cover Pool Assets will be dedicated exclusively to the payment of interest and repayment of principal on the Covered Bonds and to the fulfilment of the obligations of the Issuer *vis-à-vis* the Secured Creditors in accordance with the relevant Priority of Payments, (iv) all payments of interest on the Covered Bonds will be credited on the Accumulation Ledger pursuant to the Servicing and Cash Management Deed, (v) if

Eurobank is then the Servicer, its appointment as the Servicer will be terminated and a Replacement Servicer will be appointed pursuant to the terms of the Servicing and Cash Management Deed and the Secondary Covered Bond Legislation, (vi) if the Issuer Event is also an Issuer Insolvency Event, a Special Administrator will be appointed pursuant to the terms of the Servicing and Cash Management Deed and the Greek Covered Bond Legislation and (vii) if the Issuer Event is not an Issuer Insolvency Event, the Servicer, or as applicable the Replacement Servicer appointed pursuant to the Servicing and Cash Management Deed and the Covered Bond Legislation will be required to try to sell Selected Loans in accordance with the provisions of the Servicing and Cash Management Deed. See Condition 9 (*Issuer Events*) and "*Terms and Conditions of the Covered Bonds*" and "*Description of the Transaction Documents*" – "*The Servicing and Cash Management Deed*".

Liquid Assets

Pursuant to the Servicing and Cash Management Deed, the Servicer is entitled in its discretion prior to the occurrence of an Issuer Event to draw sums from time to time standing to the credit of the Transaction Accounts for effecting investments in Liquid Assets subject to any limits of the Greek Covered Bond Legislation, if applicable. See "*Description of the Transaction Documents*" – "*Servicing and Cash Management Deed*".

Servicing and collection

The Servicer will be responsible for the servicing of the Cover Pool, including, *inter alia*, for the following activities:

- (a) collection and recovery in respect of each Cover Pool Asset;
- (b) administration and management of the Cover Pool;
- (c) management of any judicial or extra judicial proceeding connected to the Cover Pool;
- (d) keeping accounting records of the amounts due and collected under the Loan Assets and the Hedging Agreements (if any);
- (e) preparation of monthly reports on the amounts due by debtors, and on the collections and recoveries made in respect of the Loan Assets and Hedging Agreements (if

any) and any other reports or other information provision requirements set in the Greek Covered Bond Legislation; and

- (f) carrying out the reconciliation of the amounts due and the amounts effectively paid by the debtors under the Loans on the relevant Cover Pool Payment Date.

ACCOUNTS AND CASH FLOW STRUCTURE:

Segregation Event and Collection Account

Prior to a reduction in the long-term unsecured, unsubordinated and unguaranteed credit rating of the Issuer to or below the Minimum Credit Rating (such occurrence, a "**Segregation Event**"), the Issuer will be entitled to draw sums from time to time standing to the credit of the Collection Accounts in addition to any funds available to it for any purpose including to make payments on the Covered Bonds.

Following the occurrence of a Segregation Event, and for so long as such Segregation Event remains outstanding, the Issuer shall only be entitled to withdraw from the Collection Accounts (i) amounts required to be transferred to the Transaction Accounts in accordance with the Servicing and Cash Management Deed or (ii) any Excess Amounts.

If the Issuer's rating(s) are reinstated above the level at which a Segregation Event occurs and so long as no Issuer Event has occurred and is continuing, then the Issuer will be entitled to draw sums standing to the credit of the Collection Accounts and make payments on the Covered Bonds using any funds available to it.

See "*Description of the Transaction Documents*" - "*The Servicing and Cash Management Deed*".

Transaction Accounts

On or about the Programme Closing Date, a separate Swiss franc denominated account was established with the Account Bank (the "**CHF Transaction Account**"), a separate Euro denominated account will be established with the Account Bank (the "**EUR Transaction Account**" and together with the CHF Transaction Account, "**Transaction Accounts**"). All moneys received from (without double counting) Substitution Assets, Liquid Assets and Marketable Assets, if any, included in the

Cover Pool will be deposited into the relevant Transaction Account. Prior to the occurrence of a Segregation Event or an Issuer Event, the Issuer will be entitled to withdraw amounts from time to time standing to the credit of the Transaction Accounts, if any, that are in excess of the sum of (i) any cash amounts required to satisfy the Statutory Tests and (ii) the Liquidity Buffer Reserve Ledger Required Amount. Following the occurrence of a Segregation Event, the Issuer shall no longer be entitled to withdraw moneys from the Transaction Accounts other than for purposes of making payments in accordance with the Pre-Event of Default Priority of Payments. If the Issuer's rating(s) are reinstated above the level at which a Segregation Event occurs, and so long as no Issuer Event has occurred, then the Issuer will be entitled to withdraw amounts from time to time standing to the credit of the Transaction Accounts, if any, that are in excess of the sum of (i) any cash amounts required to satisfy the Statutory Tests and (ii) the Liquidity Buffer Reserve Ledger Required Amount.

Following the occurrence of an Issuer Event (as defined above) which is continuing, (i) the Servicer (and the Issuer to the extent that Eurobank is no longer the Servicer) or the Special Administrator in case of an Issuer Event which is also an Issuer Insolvency Event shall transfer any amounts it receives in respect of any Cover Pool Assets (including any Subsidy Payments (as defined below)) to the Transaction Accounts within two Athens Business Days of receipt, all collections of principal and interest on deposit in the Collection Accounts (or the Third Party Collection Accounts) shall be transferred to the Transaction Accounts and (ii) provide notification to all Borrowers that any and all future payments due under the Cover Pool Assets (excluding any Subsidy Payments) are henceforth to be effected directly to a Swiss franc denominated bank account opened in the name of the Issuer with a Greek credit institution or a Greek branch of a foreign credit institution which is an Eligible Institution (the "**CHF Third Party Collection Account**") or a euro denominated bank account opened in the name of the Issuer with a Greek credit institution or a Greek branch of a foreign credit institution which is an Eligible Institution (the "**EUR Third Party Collection Account**") (as appropriate). The Servicer shall procure that all amounts deposited into the Third Party Collection Accounts shall

be transferred to the Transaction Accounts within three Athens Business Day of receipt and provide any requisite notice to procure that this occurs.

Following an Issuer Event, the Transaction Accounts will be used for the crediting of, *inter alia*, moneys received in respect of the Cover Pool Assets included in the Cover Pool or to effect a payment in respect of the Covered Bonds (See "*Description of the Transaction Documents – The Servicing and Cash Management Deed*").

"Subsidy Payments" means the aggregate of all amounts, which for the avoidance of doubt shall only be denominated in euro, actually received from the DYPA, the Greek State and any other Greek State owned entity representing the Subsidised Interest Amounts in respect of the Subsidised Loans comprised in the Cover Pool.

Event of Default

If one of the following events occurs and is continuing (an "**Event of Default**"):

- (a) on the Extended Final Maturity Date in respect of any Series of Covered Bonds or on any Interest Payment Date or any earlier date for redemption on which principal thereof is due and repayable, there is a failure to pay any amount of principal due on such Covered Bonds on such date and such default is not remedied within a period of 14 days from the due date thereof; or
- (b) on any Interest Payment Date, a default in the payment of the amount of interest due on any Series occurs and such default is not remedied within a period of 14 days from the due date thereof,

then the Trustee shall, upon receiving notice in writing from the Principal Paying Agent or any Covered Bondholder of such Event of Default, serve a notice (a "**Notice of Default**") on the Issuer.

Following the service of a Notice of Default, the Covered Bonds of each Series shall become immediately due and payable.

Following the occurrence of an Event of Default, the Trustee shall be entitled to direct the Servicer to dispose of the Cover Pool

Assets." See "*Description of the Transaction Documents – the Servicing and Cash Management" Deed*".

Issuer Event

Prior to, or concurrent with the occurrence of an Event of Default, if any of the following events (each, an "**Issuer Event**") occurs:

- (i) an Issuer Insolvency Event (as defined below) (except, for the avoidance of doubt, that the occurrence of any event specified under paragraph (v) of such definition shall not give rise to an Issuer Event);
- (ii) the Issuer fails to pay any amount of principal due and payable on the Covered Bonds of any Series (which shall for these purposes be deemed to include a failure by the Issuer to pay any amount representing the Final Redemption Amount on the Final Maturity Date of the Covered Bonds of that Series notwithstanding that the relevant Series of Covered Bonds has an Extended Final Maturity Date) within a period of seven Athens Business Days or if the Issuer fails to pay interest in respect of the Covered Bonds of any Series within a period of seven Athens Business Days from the due date thereof or if the Issuer fails to repurchase the Covered Bonds pursuant to Condition 7.5;
- (iii) the Issuer defaults in the performance or observance of any of its other obligations under or in respect of the Covered Bonds, Receipts or Coupons of any Series and such default has a materially prejudicial effect on the interests of the Covered Bondholders (in the opinion of the Trustee, acting reasonably) remains unremedied for 30 days after written notice thereof has been delivered by the Trustee to the Issuer requiring the same to be remedied;
- (iv) the repayment of any indebtedness owing by the Issuer is accelerated by reason of default and such acceleration has not been rescinded or annulled, or the Issuer defaults (after whichever is the longer of any originally applicable period of grace and 14 days after the due date) in any payment of any indebtedness or in the honouring of any guarantee or indemnity in respect of any indebtedness, provided that no such event shall constitute an Issuer Event unless the

indebtedness whether alone or when aggregated with other indebtedness relating to all (if any) other such events which shall have occurred and be continuing shall exceed €15,000,000 (or its equivalent in any other currency or currencies) or, if higher, a sum equal to 0.025 per cent. of the gross consolidated assets of the Issuer and its Subsidiaries as shown by the then latest published audited consolidated balance sheet of the Issuer and its Subsidiaries; or

- (v) there is a breach of a Statutory Test on an Applicable Calculation Date and such breach is not remedied within five Athens Business Days,

then (i) no further Covered Bonds will be issued, (ii) the Servicer (and the Issuer to the extent that the Issuer is no longer the Servicer) will procure that any and all payments due from the Borrowers under the Cover Pool Assets (excluding any Subsidy Payments) are effected henceforth directly into the relevant Third Party Collection Account and that all such amounts (including the Subsidy Payments) are transferred into the corresponding Transaction Account within three Athens Business Day of receipt, (iii) all collections of principal and interest on the Cover Pool Assets will be dedicated exclusively to the payment of interest and repayment of principal on the Covered Bonds and to the fulfilment of the obligations of the Issuer vis-à-vis the Secured Creditors in accordance with the relevant Priority of Payments, (iv) all payments of interest on the Covered Bonds will be credited on the Accumulation Ledger pursuant to the Servicing and Cash Management Deed, (v) if Eurobank is then the Servicer, its appointment as the Servicer will be terminated and a Replacement Servicer will be appointed pursuant to the terms of the Servicing and Cash Management Deed and the Secondary Covered Bond Legislation, (vi) if the Issuer Event is also an Issuer Insolvency Event, a Special Administrator will be appointed pursuant to the terms of the Servicing and Cash Management Deed and the Greek Covered Bond Legislation and (vii) if the Issuer Event is not an Issuer Insolvency Event, the Servicer or, as applicable, the Replacement Servicer appointed pursuant to the Servicing and Cash Management Deed and the Covered Bond Legislation will be required to try and sell Selected Loans

in accordance with the provisions of the Servicing and Cash Management Deed.

Issuer Insolvency Event

means, in respect of the Issuer:

- (i) any order shall be made by any competent court or resolution passed for the winding-up or dissolution of the Issuer (other than for the purpose of amalgamation, merger or reconstruction on terms approved by an Extraordinary Resolution of the Covered Bondholders of all Series taken together as a single Series and converted into Euro at either the relevant Covered Bond Swap Rate (if applicable) or the Established Rate); or
- (ii) the Issuer shall cease to carry on the whole or substantially the whole of its business (other than for the purpose of an amalgamation, merger or reconstruction on terms approved by an Extraordinary Resolution of the Covered Bondholders of all Series taken together as a single Series and converted into Euro at either the relevant Covered Bond Swap Rate (if applicable) or the Established Rate); or
- (iii) the Issuer shall stop payment or shall be unable to, or shall admit inability to, pay its debts as they fall due, or shall be adjudicated or found insolvent by a court of competent jurisdiction or shall make a conveyance or assignment for the benefit of, or shall enter into any composition or other arrangement with, its creditors generally; or
- (iv) a receiver, trustee or other similar official shall be appointed in relation to the Issuer or in relation to the whole or over half of the assets of the Issuer, or an interim supervisor of the Issuer is appointed or an encumbrancer shall take possession of the whole or over half of the assets of the Issuer, or a distress or execution or other process shall be levied or enforced upon or sued out against the whole or a substantial part of the assets of the Issuer and in any of the foregoing cases it or he shall not be discharged within 60 days; or

- (v) the assessment by the Bank of Greece that the conditions of article 32 of Greek law 4335/2015 apply or the imposition on the Issuer of resolution measures in accordance with articles 37ff of article 2 of Greek Law 4335/2015; or
- (vi) a supervisor (in Greek Epitropos) of the Issuer is appointed in accordance with article 137 of Greek Law 4261/2014 or Issuer is placed under special liquidation in accordance with article 145 of Greek Law 4261/2014; or
- (vii) any action or step is taken which has a similar effect to the foregoing,

in each case, other than where any of the events set out in (i) to (vii) above occurs in connection with a substitution in accordance with Condition 18 and Clause 20 of the Trust Deed.

Priority of Payments prior to the delivery of a Notice of Default

Pursuant to Condition 4 (*Priorities of Payments*), at any time upon or after the occurrence of any Issuer Event but prior to the delivery of a Notice of Default, the Servicer on behalf of the Issuer shall apply all the Covered Bonds Available Funds on each Cover Pool Payment Date in making the following payments and provisions in the following order of priority (the "**Pre-Event of Default Priority of Payments**") (in each case only if and to the extent that payments of a higher priority have been made in full):

- (i) *first*, in or towards satisfaction of all amounts then due and payable or to become due and payable prior to the next Cover Pool Payment Date to the Trustee or any Appointee (including, remuneration or amounts by way of indemnity payable to it) under the provisions of the Trust Deed, the Deed of Charge or any other Transaction Document together with interest and applicable VAT (or other similar taxes) thereon to the extent provided therein;
- (ii) *second, pari passu and pro rata* according to the respective amounts thereof to pay any additional fees, costs, expenses and taxes due and payable on the Cover Pool Payment Date, or to provide for all such amounts that will become due and payable prior to the next Cover Pool Payment Date, properly incurred by the Trustee or any

Appointee in respect of any notice to be given to any parties in accordance with any of the Transaction Documents or to the Covered Bondholders;

- (iii) *third, pari passu* and *pro rata* according to the respective amounts thereof, to pay all amounts due and payable on the Cover Pool Payment Date, or to provide for all such amounts that will become due and payable prior to the next Cover Pool Payment Date, to the Account Bank and the Agents under the Bank Account Agreement and the Agency Agreement, or any of the Transaction Documents, respectively;
- (iv) *fourth, pari passu* and *pro rata* according to the respective amounts thereof to, (i) to the Servicer any amount representing the cost of Levy in respect of such Loans received from Borrowers, such amount to be used by the Servicer towards satisfaction of the Issuer's obligation to pay any Levy; and (ii) to pay all amounts due and payable on the Cover Pool Payment Date, or to provide for all such amounts that will become due and payable prior to the next Cover Pool Payment Date (and for which payment has not been provided for elsewhere in the relevant Priorities of Payments), to any Secured Creditors other than the Covered Bondholders, Receiptholders, Couponholders, the Agents, the Account Bank, the Trustee and any Appointee and other than any amount due to be paid, or that will become due and payable prior to the next Cover Pool Payment Date, to the Hedging Counterparties under any Hedging Agreements;
- (v) *fifth, pari passu* and *pro rata*, according to the respective amounts thereof (a) to pay all amounts of interest due and payable on the Cover Pool Payment Date, or to provide for all such amounts that will become due and payable prior to the next Cover Pool Payment Date, on any Covered Bonds and (b) to pay any amounts due and payable on the Cover Pool Payment Date, or to provide for all such amounts that will become due and payable prior to the next Cover Pool Payment Date, under any Hedging Agreement other than Subordinated Termination Payments to any

Hedging Counterparties under any such Hedging Agreements;

- (vi) *sixth*, for so long as any Covered Bonds remain outstanding, to credit the Liquidity Buffer Reserve Ledger with an amount equal to the difference between the Liquidity Buffer Reserve Ledger Required Amount and the amount standing to the credit of the Liquidity Buffer Reserve Ledger after having made the payments under paragraphs (i) to (v) above;
- (vii) *seventh, pro rata and pari passu* in respect of (A) any Accumulation Covered Bonds which do not have an Extended Final Maturity Date, to credit the Accumulation Sub-Ledger with the Pro Rata Accumulation Amount and (B) any Series of Pass-Through Covered Bonds, to pay principal in respect of each Series of Pass-Through Covered Bonds then outstanding on the Cover Pool Payment Date, or to provide for all such amounts that will become due and payable prior to the next Cover Pool Payment Date (if any) on any Series of Pass-Through Covered Bonds in either case where such Series of Pass-Through Covered Bonds has an Extended Final Maturity Date that falls within 6 months of the relevant Cover Pool Payment Date;
- (viii) *eighth*, to pay *pari passu* and *pro rata* (A) principal in respect of each other Series of Pass-Through Covered Bonds then outstanding on the Cover Pool Payment Date, or to provide for all such amounts that will become due and payable prior to the next Cover Pool Payment Date (if any), on any other Series of Pass-Through Covered Bonds and (B) in respect of any Accumulation Covered Bonds (or any Series of Covered Bonds that will become Accumulation Covered Bonds prior to the next following Cover Pool Payment Date) to credit the relevant Accumulation Sub-Ledger with the Pro Rata Accumulation Amount (provided such amount has not already been credited to the Accumulation Sub-Ledger in accordance with paragraph (vii) above);

- (ix) *ninth*, for so long as any Covered Bonds remain outstanding, any remaining Covered Bonds Available Funds will remain standing to the credit of the Transaction Accounts, or, as applicable, be deposited in the Transaction Accounts;
- (x) *tenth*, to pay *pari passu* and *pro rata*, according to the respective amounts thereof, any amount due and payable on the Cover Pool Payment Date, or to provide for all such amounts that will become due and payable prior to the next Cover Pool Payment Date to any Hedging Counterparties which are Subordinated Termination Payments; and
- (xi) *eleventh*, to pay any excess to the Issuer.

"Subordinated Termination Payment" means, subject as set out below, any termination payments due and payable to any Hedging Counterparty under a Hedging Agreement where such termination results from (a) an Additional Termination Event "*Ratings Event*" as specified in the schedule to the relevant Hedging Agreement, (b) the bankruptcy of the relevant Hedging Counterparty, or (c) any default and/or failure to perform by such Hedging Counterparty under the relevant Hedging Agreement, other than, in the event of (a) or (c) above, the amount of any termination payment due and payable to such Hedging Counterparty in relation to the termination of such transaction to the extent of any premium received by the Issuer from a replacement hedging counterparty.

Covered Bonds Available Funds

"Covered Bonds Available Funds" means, at any time upon or after the occurrence of an Issuer Event, in respect of any Cover Pool Payment Date, as the case may be, the aggregate of:

- (a) all amounts standing to the credit of the Transaction Accounts at the immediately preceding Calculation Date other than amounts credited to the Accumulation Ledger;
- (b) all amounts (if any) paid or to be paid on or prior to such Cover Pool Payment Date by the Hedging Counterparties into the Transaction Accounts pursuant to the Hedging Agreement(s);

- (c) all amounts of interest paid on the Transaction Accounts during the Interest Period immediately preceding such Cover Pool Payment Date;
- (d) all amounts deriving from (without double counting) repayment at maturity or liquidation of any Marketable Assets, Liquid Assets or Substitution Assets on or prior to such Cover Pool Payment Date; and
- (e) any Excess Accumulation Receipts

For the avoidance of doubt:

- (i) should there be any duplication in the amounts included in the different items of the Covered Bonds Available Funds above, the Servicer shall avoid such duplication when calculating the Covered Bonds Available Funds; and
- (ii) the Covered Bonds Available Funds will not include any asset (including, without limitation, cash or securities) which is paid or transferred by any Hedging Counterparty to the Issuer as collateral to secure the performance by such Hedging Counterparty of its obligations under a Hedging Agreement together with any income or distributions received in respect of such asset and any equivalent or replacement of such asset into which such asset is transferred but which may not be applied at such time in satisfaction of the obligations of the relevant Hedging Counterparty under the terms of such Hedging Agreement (the "**Swap Collateral Excluded Amounts**").

Priority of Payments following delivery Notice Default

Pursuant to Condition 4 (*Priorities of Payments*) and the terms of the Deed of Charge, following delivery of a Notice of Default, all funds deriving from the Cover Pool Assets, the Transaction Documents or the enforcement of the Security and all other sums which are standing to the credit of the Transaction Accounts shall be applied on any Athens Business Day in accordance with the following order of priority of payments (the "**Post-Event of Default Priority of Payments**") and, together with the Pre-Event

of Default Priority of Payments, the "**Priorities of Payments**" and, each of them a "**Priority of Payments**") (in each case only if and to the extent that payments of a higher priority have been made in full) provided that any such amount has not been paid by the Issuer using funds not forming part of the Cover Pool:

- (i) *first*, to pay any Indemnity to which the Trustee or any Receiver or any Appointee is entitled pursuant to the Trust Deed, the Deed of Charge or any other Transaction Documents and any costs and expenses incurred by or on behalf of the Trustee or any Receiver or any Appointee (a) following the occurrence of a Potential Event of Default or any Issuer Event or an Event of Default or in connection with or as a result of serving on the Issuer a Notice of Default (to the extent that any such amounts have not yet been paid out of the Covered Bond Available Funds before the delivery of a Notice of Default) and (b) following the delivery of a Notice of Default in connection with or as a result of the enforcement or realisation of (A) the security granted under the Statutory Pledge, the Deed of Charge, the Collection Accounts Pledge Agreement and/or (B) any other right or remedy that the Trustee is entitled or required to pursue under or in connection with the Trust Deed, the Deed of Charge and the other Transaction Documents and/or the Covered Bonds for the purpose of protecting the interests of the Covered Bondholders and/or the other Secured Creditors;

- (ii) *second, pari passu and pro rata* according to the respective amounts thereof, (a) to pay all amounts of interest and principal due and payable on any Covered Bonds, (b) to pay any additional fees, costs, expenses and taxes due and payable in connection with any listing or deposit of the Covered Bonds or to any notice to be given to any parties in accordance with any of the Transaction Documents or to the Covered Bondholders, (c) to pay all amounts due and payable to the Account Bank and the Agents or any other Secured Creditors, other than the Covered Bondholders and (d) to pay any amounts due and payable under any Hedging Agreement other than the

Subordinated Termination Payments to any Hedging Counterparties under any such Hedging Agreements;

- (iii) *third*, to pay *pari passu* and *pro rata*, according to the respective amounts thereof, any amount due and payable to any Hedging Counterparties which are Subordinated Termination Payment; and
- (iv) *fourth*, following the payment in full of all items under (i) to (iii) above, to pay all excess amounts (if any) to the Issuer.

"Indemnity" means any indemnity amounts due to the Trustee pursuant to the Trust Deed, the Deed of Charge or any other Transaction Document, including (without limitation) Clause 14 of the Trust Deed. See "*Description of the Transaction Documents*" – "*Deed of Charge*".

Servicing and Cash Management Deed

Under the terms of the Servicing and Cash Management Deed entered into on the Programme Closing Date (as amended and restated or supplemented from time to time) between the Issuer, the Trustee and the Servicer (the "**Servicing and Cash Management Deed**"), the Servicer has been authorised, subject to the conditions specified therein, to administer the cash flows arising from the Cover Pool.

The Servicing and Cash Management Deed sets forth the terms and conditions upon which the Servicer shall be required to administer the Cover Pool Assets.

Pursuant to the Servicing and Cash Management Deed, the Servicer has undertaken to prepare and deliver certain reports in connection with the Loan Assets. Pursuant to the Servicing and Cash Management Deed, the Servicer will agree to perform certain obligations in connection with the management of the Cover Pool.

The Servicing and Cash Management Deed contains provisions under which the Issuer shall be obliged, upon the terms and subject to the conditions specified therein, to appoint an appropriate entity to perform the Servicing and Cash Management Activities to be performed by the Servicer as well

as provisions in relation to the substitution of the Servicer by a Replacement Servicer or a Special Administrator.

"Programme Closing Date" means 15 October 2018.

See *"Description of the Transaction Documents – The Servicing and Cash Management Deed"*.

Asset Monitor Agreement

Under the terms of the asset monitor agreement entered into on the Programme Closing Date between the Asset Monitor, the Servicer, the Issuer and the Trustee (the **"Asset Monitor Agreement"**), the Asset Monitor has agreed to act as cover pool monitor in accordance with the Greek Covered Bond Legislation and to carry out various testing and notification duties in relation to the calculations performed by the Servicer in relation to the Statutory Tests and, if required, the Amortisation Test.

Trust Deed

Under the terms of the Trust Deed entered into on the Programme Closing Date (such Trust Deed as modified and/or supplemented and/or restated from time to time, the **"Trust Deed"**) between the Issuer and the Trustee, the Trustee will be appointed to act as the Covered Bondholders' representative in accordance with Article 14(3) of the Covered Bond Law.

Deed of Charge

The Issuer shall assign its rights arising under the Hedging Agreements (if any) and any Transaction Document governed by English law to the Trustee (on trust for itself and on behalf of the Covered Bondholders and the other Secured Creditors) in accordance with a supplemental deed of charge (the **"Deed of Charge"**).

In addition, the Covered Bondholders and the other Secured Creditors have agreed that, upon the occurrence of an Issuer Event, all the Covered Bonds Available Funds will be applied in or towards satisfaction of all the Issuer's payment obligations towards the Covered Bondholders and the other Secured Creditors, in accordance with the terms of the Servicing and Cash Management Deed and the relevant Priority of Payments.

The Trustee has been authorised, in accordance with the Servicing and Cash Management Deed, subject to a Notice of Default being delivered to the Issuer following the occurrence of an Event of Default, to exercise, in the name and on behalf of the

Issuer, all the Issuer's rights arising out of the Transaction Documents to which the Issuer is a party.

The Deed of Charge shall be governed by English Law.

Agency Agreement

Under the terms of an agency agreement entered into on the Programme Closing Date between the Issuer, the Agents and the Trustee (the "**Agency Agreement**"), the Agents have agreed to provide the Issuer with certain agency services and the Paying Agents have agreed, *inter alia*, to make available for inspection such documents as may be required from time to time by the rules of the Luxembourg Stock Exchange and to arrange for the publication of any notice to be given to the Covered Bondholders.

Bank Account Agreement

Under the terms of the bank account agreement entered into on the Programme Closing Date between the Account Bank, the Servicer, the Issuer and the Trustee (the "**Bank Account Agreement**"), the Account Bank has agreed to operate the Transaction Accounts and any Swap Collateral Accounts opened in accordance with the terms of any Hedging Agreement and the Bank Account Agreement (together with the Transaction Accounts, the "**Bank Accounts**") in accordance with the instructions given by the Servicer.

Hedging Agreements

The Issuer may, from time to time during the Programme, enter into Interest Rate Swap Agreements, FX Swap Agreements and Covered Bond Swap Agreements (together the "**Hedging Agreements**") with one or more Hedging Counterparties for the purpose of, *inter alia*, protecting itself against certain risks (including, but not limited to, interest rate, liquidity, currency and credit) related to the Loan Assets and/or the Covered Bonds. In accordance with the terms set forth in the Servicing and Cash Management Deed, the Issuer may include the claims of the Issuer arising from the Hedging Agreements, together with the cash flows deriving therefrom, in the Cover Pool provided that, *inter alia*, the terms and conditions of such Hedging Agreements shall not adversely affect the ratings of the then outstanding Covered Bonds.

The Hedging Agreements shall be governed by English Law.

The Issuer's rights arising from any Hedging Agreement(s) will be included as part of the Cover Pool at the Issuer's discretion.

Transaction Documents

The Servicing and Cash Management Deed, the Programme Agreement, each Subscription Agreement, the Agency Agreement, the Trust Deed, the Deed of Charge, the Collection Accounts Pledge Agreement, the Bank Account Agreement, the Asset Monitor Agreement, the Master Definitions and Construction Schedule, each of the Final Terms, each Registration Statement, the Conditions, the Covered Bonds, the Coupons, the Hedging Agreements (if any), any agreement entered into with a new Servicer, together with any additional document entered into in respect of the Covered Bonds and/or the Cover Pool and designated as a Transaction Document by the Issuer and the Trustee, are together referred to as the "**Transaction Documents**".

"**Subscription Agreement**" means an agreement supplemental to the Programme Agreement (by whatever name called) in or substantially in the form set out in the Programme Agreement or in such other form as may be agreed between the Issuer and the Lead Manager or one or more Dealers (as the case may be).

Investor Report

On each Cover Pool Payment Date (each an "**Investor Report Date**"), the Servicer will produce an investor report (the "**Investor Report**"), which will contain the information regarding the Covered Bonds and the Cover Pool Assets required by Article 16 of the Covered Bond Law. Such report will be available to the prospective investors in the Covered Bonds and to Covered Bondholders at the offices of Paying Agent, on Bloomberg and on the website www.eurobank.gr

Except where the context otherwise requires, capitalised terms used and not otherwise defined in these Conditions shall bear the meanings given to them in the applicable Final Terms and/or the master definitions and construction schedule made between the parties to the Transaction Documents on or about the Programme Closing Date (the "**Master Definitions and Construction Schedule**"), a copy of each of which may be obtained as described above.

1 Form, Denomination and Title

The Covered Bonds are in bearer form or in registered form as specified in the applicable Final Terms and, in the case of Definitive Covered Bonds, serially numbered, in the currency (the "**Specified Currency**") and the Specified Denomination(s). Covered Bonds of one Specified Denomination may not be exchanged for Covered Bonds of another Specified Denomination and Bearer Covered Bonds may not be exchanged for Registered Covered Bonds and *vice versa*.

This Covered Bond may be a Fixed Rate Covered Bond, a Floating Rate Covered Bond or a Zero Coupon Covered Bond or a combination of any of the foregoing, depending upon the Interest Basis shown in the applicable Final Terms.

The Covered Bonds will be issued in such denominations as may be agreed between the Issuer and the relevant Dealer(s) and set out in the applicable Final Terms save that the minimum denomination of each Covered Bond will be at least €100,000 (or, if the Covered Bonds are denominated in a currency other than euro, at least the equivalent amount in such currency) or such other higher amount as is required from time to time by the relevant central bank (or equivalent body) or any laws or regulations applicable to the relevant Specified Currency.

It is a condition precedent to the issuance of a new Series or Tranche of Covered Bonds that (i) there is no Issuer Event or Event of Default outstanding and that such issuance would not cause an Issuer Event or Event of Default, (ii) such issuance would not result in a breach of any of the Statutory Tests, (iii) S&P Global Ratings, a division of S&P Global ("**S&P**") and any additional rating agency which may be appointed under the Programme from time to time to provide ratings for a specific issue of Covered Bonds or on an ongoing basis (together the "**Rating Agencies**" and each a "**Rating Agency**") have been notified of such issuance, (iv) such issuance has been notified to (or in the case of material amendments to the Programme) approved by the Bank of Greece in accordance with Article 20(4) of the Covered Bond Law and (v) if applicable, in respect of any Series or Tranche, a Hedging Agreement is entered into.

Bearer Definitive Covered Bonds are issued with Coupons attached, unless they are Zero Coupon Covered Bonds in which case references to Coupons and Couponholders in these Conditions are not applicable.

Subject as set out below, title to the Bearer Covered Bonds and Coupons will pass by delivery and title to the Registered Covered Bonds will pass upon registration of transfer in accordance with the provisions of the Agency Agreement. The Issuer, the Paying Agents and the Trustee will (except as otherwise required by law) deem and treat the bearer of any Bearer Covered Bond or Coupon and the registered holder of any Registered Covered Bond as the absolute owner thereof (whether or not overdue and notwithstanding any notice of ownership or writing thereon or notice of any previous loss or theft thereof) for all purposes but, in the case of any Global Covered Bond, without prejudice to the provisions set out in the next succeeding paragraph.

For so long as any of the Covered Bonds are represented by a Global Covered Bond held on behalf of or, as the case maybe, registered in the name of a common depository for, Euroclear Bank S.A./N.V. ("**Euroclear**") and/or Clearstream Banking, *société anonyme* ("**Clearstream, Luxembourg**"), each person (other than Euroclear or Clearstream, Luxembourg) who is for the time being shown in the records of Euroclear or of Clearstream, Luxembourg as the holder of a particular nominal amount of such Covered Bonds (in which regard any certificate or other document issued by Euroclear or Clearstream, Luxembourg as to the nominal amount of such Covered Bonds standing to the account of any person shall be conclusive and binding for all purposes save in the case of manifest error) shall be treated by the Issuer, the Paying Agents and the Trustee as the holder of such nominal amount of such Covered Bonds for all purposes other than with respect to the payment of principal or interest or other amounts on such nominal amount of such Covered Bonds, for which purpose the bearer or, as applicable, the registered holder of the relevant Global Covered Bond shall be treated by the Issuer, any Paying Agent and the Trustee as the holder of such nominal amount of such Covered Bonds in accordance with and subject to the terms of the relevant Global Covered Bond and the expressions **Covered Bondholder** and **holder of Covered Bonds** and related expressions shall be construed accordingly.

Covered Bonds which are represented by a Global Covered Bond will be transferable only in accordance with the rules and procedures for the time being of Euroclear and Clearstream, Luxembourg, as the case may be.

References to Euroclear and/or Clearstream, Luxembourg shall, whenever the context so permits, be deemed to include a reference to any additional or alternative clearing system specified in the applicable Final Terms or as may otherwise be approved by the Issuer, the Principal Paying Agent and the Trustee.

2 Transfers of Registered Covered Bonds

2.1 Transfers of interests in Registered Global Covered Bonds

Transfers of beneficial interests in Registered Global Covered Bonds will be effected by Euroclear or Clearstream, Luxembourg and, in turn, by other participants and, if appropriate, indirect

participants in such clearing systems acting on behalf of beneficial transferors and transferees of such interests. A beneficial interest in a Registered Global Covered Bond will, subject to compliance with all applicable legal and regulatory restrictions, be exchangeable for Registered Definitive Covered Bonds or for a beneficial interest in another Registered Global Covered Bond only in the authorised denominations set out in the applicable Final

Terms and only in accordance with the rules and operating procedures for the time being of Euroclear or Clearstream, Luxembourg, as the case may be, and in accordance with the terms and conditions specified in the Agency Agreement.

2.2 Transfers of Registered Covered Bonds in definitive form

Subject as provided in Conditions 2.3 and 2.4 upon the terms and subject to the conditions set forth in the Agency Agreement, a Registered Definitive Covered Bond may be transferred in whole or in part in the authorised denominations set out in the applicable Final Terms. In order to effect any such transfer (a) the holder or holders must (i) surrender the Registered Covered Bond for registration of the transfer of the Registered Covered Bond (or the relevant part of the Registered Covered Bond) at the specified office of the Registrar, with the form of transfer thereon duly executed by the holder or holders thereof or his or their attorney or attorneys duly authorised in writing, and (ii) complete and deposit such other certifications as may be required by the Registrar, and (b) the Registrar must, after due and careful enquiry, be satisfied with the documents of title and the identity of the person making the request.

Any such transfer will be subject to such reasonable regulations as the Issuer, the Trustee and the Registrar may from time to time prescribe (the initial such regulations being set out in the Agency Agreement).

Subject as provided above, the Registrar will, within 3 business days (being for this purpose a day on which banks are open for business in the city where the specified office of the Registrar is located) of the request (or such longer period as may be required to comply with any applicable fiscal or other laws or regulations), authenticate and deliver, or procure the authentication and delivery of, at its specified office to the transferee or (at the risk of the transferee) send by uninsured mail to such address as the transferee may request, a new Registered Definitive Covered Bond of a like aggregate nominal amount to the Registered Definitive Covered Bond (or the relevant part of the Registered Definitive Covered Bond) transferred.

In the case of the transfer of part only of a Registered Definitive Covered Bond, a new Registered Definitive Covered Bond in respect of the balance of the Registered Definitive

Covered Bond not transferred will (in addition to the new Registered Definitive Covered Bond in respect of the nominal amount transferred) be so authenticated and delivered or (at the risk of the transferor) sent by uninsured mail to the address specified by the transferor.

2.3 Registration of transfer upon partial redemption

For the avoidance of doubt, in the event of a partial redemption of Covered Bonds under Condition 7, the Issuer shall not be required to register the transfer of any Registered Covered Bond, or part of a Registered Covered Bond, which is partially redeemed.

2.4 Costs of registration

Covered Bondholders will not be required to bear the costs and expenses of effecting any registration of transfer as provided above, except for any costs or expenses of delivery other than by regular uninsured mail and except that the Issuer or Registrar may require the payment of a sum sufficient to cover any stamp duty, Taxes or any other governmental charge that may be imposed in relation to the registration.

3 Status of the Covered Bonds

The Covered Bonds are covered bonds that could be eligible for the label "European Covered Bond (Premium) (in Greek "Ευρωπαϊκό Καλυμμένο Ομόλογο (Ανωτέρας Ποιότητας)" subject to the final assessment of the Programme by the Bank of Greece, certifying the label and are issued on an unconditional basis and in accordance with Articles 1-33 of Greek Law 4920/2022, (the "**Covered Bond Law**") and the decision nr. 215/03.02.2023 of the Executive Committee of the Bank of Greece issued pursuant to the Covered Bond Law (the "**Secondary Covered Bond Legislation**" and, together with the Covered Bond Law, the "**Greek Covered Bond Legislation**"). The Covered Bonds constitute direct, unconditional and unsubordinated obligations of the Issuer secured by (i) the statutory pledge provided by Article 14(2) of the Covered Bond Law (the "**Statutory Pledge**") on the Greek law Cover Pool Assets, (ii) the Deed of Charge in respect of the other Cover Pool Assets and (iii) the Collection Accounts Pledge Agreement in respect of the Collection Accounts. The Covered Bonds will at all times rank *pari passu* without any preference among themselves.

4 Priorities of Payments

Notwithstanding the Deed of Charge Security but subject to Clause 8.1 (*Application*) of the Deed of Charge, at any time upon or after the occurrence of any Issuer Event but prior to the delivery of a Notice of Default, the Servicer on behalf of the Issuer shall apply all the Covered Bonds Available Funds on each Cover Pool Payment Date in making the following payments and provisions in the following order of priority (the "**Pre-Event of Default Priority of Payments**") (in each case only if and to the extent that payments of a higher priority have been made in full):

- (i) *first*, in or towards satisfaction of all amounts then due and payable or to become due and payable prior to the next Cover Pool Payment Date to the Trustee or any Appointee (including, remuneration or amounts by way of indemnity payable to it) under the provisions of the Trust Deed, the Deed of Charge or any other Transaction

Document together with interest and applicable VAT (or other similar taxes) thereon to the extent provided therein;

- (ii) *second, pari passu and pro rata* according to the respective amounts thereof to pay any additional fees, costs, expenses and taxes due and payable on the Cover Pool Payment Date, or to provide for all such amounts that will become due and payable prior to the next Cover Pool Payment Date, properly incurred by the Trustee or any Appointee in respect of any notice to be given to any parties in accordance with any of the Transaction Documents or to the Covered Bondholders;
- (iii) *third, pari passu and pro rata* according to the respective amounts thereof, to pay all amounts due and payable on the Cover Pool Payment Date, or to provide for all such amounts that will become due and payable prior to the next Cover Pool Payment Date, to the Account Bank and the Agents under the Bank Account Agreement and the Agency Agreement, or any of the Transaction Documents, respectively;
- (iv) *fourth, pari passu and pro rata* according to the respective amounts thereof to, (i) to the Servicer any amount representing the cost of Levy in respect of such Loans received from Borrowers, such amount to be used by the Servicer towards satisfaction of the Issuer's obligation to pay any Levy; and (ii) to pay all amounts due and payable on the Cover Pool Payment Date, or to provide for all such amounts that will become due and payable prior to the next Cover Pool Payment Date (and for which payment has not been provided for elsewhere in the relevant Priorities of Payments), to any Secured Creditors other than the Covered Bondholders, Receiptholders, Couponholders, the Agents, the Account Bank, the Trustee and any Appointee and other than any amount due to be paid, or that will become due and payable prior to the next Cover Pool Payment Date, to the Hedging Counterparties under any Hedging Agreements;
- (v) *fifth, pari passu and pro rata*, according to the respective amounts thereof (a) to pay all amounts of interest due and payable on the Cover Pool Payment Date, or to provide for all such amounts that will become due and payable prior to the next Cover Pool Payment Date, on any Covered Bonds and (b) to pay any amounts due and payable on the Cover Pool Payment Date, or to provide for all such amounts that will become due and payable prior to the next Cover Pool Payment Date, under any Hedging Agreement other than Subordinated Termination Payments to any Hedging Counterparties under any such Hedging Agreements;
- (vi) *sixth*, for so long as any Covered Bonds remain outstanding, to credit the Liquidity Buffer Reserve Ledger with an amount equal to the difference between the Liquidity Buffer Reserve Ledger Required Amount and the amount standing to the credit of

the Liquidity Buffer Reserve Ledger after having made the payments under paragraphs (i) to (v) above;

- (vii) *seventh, pro rata and pari passu* in respect of (A) any Accumulation Covered Bonds which do not have an Extended Final Maturity Date, to credit the Accumulation Sub-Ledger with the Pro Rata Accumulation Amount and (B) any Series of Pass-Through Covered Bonds, to pay principal in respect of each Series of Pass-Through Covered Bonds then outstanding on the Cover Pool Payment Date, or to provide for all such amounts that will become due and payable prior to the next Cover Pool Payment Date (if any) on any Series of Pass-Through Covered Bonds in either case where such Series of Pass-Through Covered Bonds has an Extended Final Maturity Date that falls within 6 months of the relevant Cover Pool Payment Date;
- (viii) *eighth, to pay pari passu and pro rata* (A) principal in respect of each other Series of Pass-Through Covered Bonds then outstanding on the Cover Pool Payment Date, or to provide for all such amounts that will become due and payable prior to the next Cover Pool Payment Date (if any), on any other Series of Pass-Through Covered Bonds and (B) in respect of any Accumulation Covered Bonds (or any Series of Covered Bonds that will become Accumulation Covered Bonds prior to the next following Cover Pool Payment Date) to credit the relevant Accumulation Sub-Ledger with the Pro Rata Accumulation Amount (provided such amount has not already been credited to the Accumulation Sub-Ledger in accordance with paragraph (vii) above);
- (ix) *ninth*, for so long as any Covered Bonds remain outstanding, any remaining Covered Bonds Available Funds will remain standing to the credit of the Transaction Accounts, or, as applicable, be deposited in the Transaction Accounts;
- (x) *tenth*, to pay *pari passu and pro rata*, according to the respective amounts thereof, any amount due and payable on the Cover Pool Payment Date, or to provide for all such amounts that will become due and payable prior to the next Cover Pool Payment Date to any Hedging Counterparties which are Subordinated Termination Payments; and
- (xi) *eleventh*, to pay any excess to the Issuer.

Following delivery of a Notice of Default, all funds deriving from the Cover Pool Assets, the Transaction Documents or the enforcement of the Security and all other sums which are standing to the credit of the Transaction Accounts shall be applied on any Athens Business Day in accordance with the following order of priority of payments (the "**Post-Event of Default Priority of Payments**" and, together with the Pre-Event of Default Priority of Payments, the "**Priorities of Payments**" and, each of them a "**Priority of Payments**") (in each case only if and to the extent

that payments of a higher priority have been made in full) provided that any such amount has not been paid by the Issuer using funds not forming part of the Cover Pool:

- (i) *first*, to pay any Indemnity to which the Trustee or any Receiver or any Appointee is entitled pursuant to the Trust Deed, the Deed of Charge or any other Transaction Documents and any costs and expenses incurred by or on behalf of the Trustee or any Receiver or any Appointee (a) following the occurrence of a Potential Event of Default or any Issuer Event or an Event of Default or in connection with or as a result of serving on the Issuer a Notice of Default (to the extent that any such amounts have not yet been paid out of the Covered Bond Available Funds before the delivery of a Notice of Default) and (b) following the delivery of a Notice of Default in connection with or as a result of the enforcement or realisation of (A) the security granted under the Statutory Pledge, the Deed of Charge and the Collection Accounts Pledge Agreement and/or (B) any other right or remedy that the Trustee is entitled or required to pursue under or in connection with the Trust Deed, the Deed of Charge and the other Transaction Documents and/or the Covered Bonds for the purpose of protecting the interests of the Covered Bondholders and/or the other Secured Creditors;
- (ii) *second, pari passu and pro rata* according to the respective amounts thereof, (a) to pay all amounts of interest and principal due and payable on any Covered Bonds, (b) to pay any additional fees, costs, expenses and taxes due and payable in connection with any listing or deposit of the Covered Bonds or to any notice to be given to any parties in accordance with any of the Transaction Documents or to the Covered Bondholders, (c) to pay all amounts due and payable to the Account Bank and the Agents or any other Secured Creditors, other than the Covered Bondholders and (d) to pay any amounts due and payable under any Hedging Agreement other than the Subordinated Termination Payments to any Hedging Counterparties under any such Hedging Agreements;
- (iii) *third*, to pay *pari passu and pro rata*, according to the respective amounts thereof, any amount due and payable to any Hedging Counterparties which are Subordinated Termination Payment; and
- (iv) *fourth*, following the payment in full of all items under (i) to (iii) above, to pay all excess amounts (if any) to the Issuer.

5 Interest

5.1 Interest on Fixed Rate Covered Bonds

Each Fixed Rate Covered Bond bears interest on its Principal Amount Outstanding from (and including) the Interest Commencement Date at the rate(s) per annum equal to the Rate(s) of

Interest. Interest will be payable in arrear on the Interest Payment Date(s) in each year up to (and including) the Final Maturity Date.

Except as provided in the applicable Final Terms, the amount of interest payable on each Interest Payment Date in respect of the Fixed Interest Period ending on (but excluding) such date will amount to the amount of interest payable on each Interest Payment Date in respect of the Fixed Interest Period ending on but excluding such date ("**Fixed Coupon Amount**"). Payments of interest on any Interest Payment Date will, if so specified in the applicable Final Terms, amount to the broken amount specified in the relevant Final Terms (the "**Broken Amount**") so specified.

As used in the Conditions, "**Fixed Interest Period**" means the period from (and including) an Interest Payment Date (or, if none, the Interest Commencement Date) to (but excluding) the next (or first) Interest Payment Date.

If interest is required to be calculated for a period other than a Fixed Interest Period, such interest shall be calculated by applying the Rate of Interest to each Specified Denomination, multiplying such sum by the applicable Day Count Fraction, and rounding the resultant figure to the nearest sub-unit of the relevant Specified Currency, half of any such sub-unit being rounded upwards or otherwise in accordance with applicable market convention.

5.2 *Floating Rate Covered Bond Provisions*

(a) Interest on Payment Dates

Each Floating Rate Covered Bond bears interest on its Principal Amount Outstanding from (and including) the Interest Commencement Date and such interest will be payable in arrear on either:

- (i) the Specified Interest Payment Date(s) in each year specified in the applicable Final Terms; or
- (ii) if no Specified Interest Payment Date(s) is/are specified in the applicable Final Terms, each date (each such date, together with each Specified Interest Payment Date, an "**Interest Payment Date**") which falls the number of months or other period specified as the "**Specified Period**" in the applicable Final Terms after the preceding Interest Payment Date or, in the case of the first Interest Payment Date, after the Interest Commencement Date.

Such interest will be payable in respect of each Interest Period. In these Conditions, the expression "**Interest Period**" shall mean the period from (and including) an Interest Payment Date (or, if none, the Interest Commencement Date) to (but excluding) the next (or first) Interest Payment Date.

(b) Rate of Interest

The Rate of Interest payable from time to time in respect of Floating Rate Covered Bonds will be determined in the manner specified in the applicable Final Terms.

(i) ISDA Determination for Floating Rate Covered Bonds

Where "**ISDA Determination**" is specified in the applicable Final Terms as the manner in which the Rate of Interest is to be determined, the Rate of Interest for each Interest Period will be the relevant ISDA Rate plus or minus (as indicated in the applicable Final Terms) the Margin (if any). For the purposes of this subparagraph (i), "**ISDA Rate**" for an Interest Period means a rate equal to the Floating Rate that would be determined by the Calculation Agent or other person specified in the applicable Final Terms under an interest rate swap transaction acting as Calculation Agent for that swap transaction under the terms of an agreement incorporating:

- (1) if the 2006 ISDA Definitions, is specified in the applicable Final Terms, the 2006 ISDA Definitions as amended and updated as of the Issue Date of the first Tranche of the Covered Bonds, as published by the International Swaps and Derivatives Association, Inc. (including any successor thereto, "**ISDA**"); or
- (2) if 2021 ISDA Definitions as specified in the applicable Final Terms, the latest version of the 2021 ISDA Interest Rate Derivatives Definitions (including each Matrix (as defined therein)) (and any successor thereto),

published by ISDA as at the Issue Date of the first Tranche of the Covered Bonds (the "**ISDA Definitions**"), and under which:

- (A) the Floating Rate Option (as defined in the ISDA Definitions) is as specified in the applicable Final Terms;
- (B) the Designated Maturity (as defined in the ISDA Definitions) is the period specified in the applicable Final Terms; and
- (C) the relevant Reset Date (as defined in the ISDA Definitions) is the day as specified in the applicable Final Terms
- (D) if the Floating Rate Option is an Overnight Floating Rate Option and Compounding Method is specified to apply in the applicable Final Terms, the Overnight Rate Compounding Method will be one of the following, as specified in the applicable Final Terms:
 - (x) Compounding with Lookback;
 - (y) Compounding with Observation Period Shift; or

- (z) Compounding with Lockout;
- (E) if the Floating Rate Option is an Overnight Floating Rate Option and Averaging is specified to apply in the applicable Final Terms, the Overnight Averaging Method will be one of the following, as specified in the applicable Final Terms:
 - (x) Averaging with Lookback;
 - (y) Averaging with Observation Period Shift; or
 - (z) Averaging with Lockout;
- (F) if the Floating Rate Option is a Compounded Index Floating Rate Option, the Index Method will be Compounded Index Method with Observation Period Shift as specified in the applicable Final Terms;
- (G) if the 2021 ISDA Definitions apply, (i) any tailbacks that would otherwise be required to be determined in accordance with Section 8.6 (Generic Fallback Provisions) of the 2021 ISDA Definitions shall not be so determined, but shall instead be determined in accordance with Condition 5.2(b)(iv) and (ii) if Administrator/Benchmark Event is specified in the Floating Rate Matrix in respect of the relevant Floating Rate Option, Condition 5.2(b)(iv) shall apply in place of the provisions relating to Administrator/Benchmark Event and the Administrator/ Benchmark Fallback in the 2021 ISDA Definitions. and the 2021 ISDA Definitions shall be construed accordingly;
- (H) if the 2021 ISDA Definitions apply, Period End Date / Termination Date adjustment for Unscheduled Holiday (as defined in the 2021 ISDA Definitions) will apply if specified in the applicable Final Terms to be applicable;
- (I) if the 2021 ISDA Definitions apply, Non-Representative (as defined in the 2021 ISDA Definitions) will apply if specified in the relevant Final Terms to be applicable; and
- (J) if the 2021 ISDA Definitions apply, Successor Benchmark and Successor Benchmark Effective Date (as defined in the 2021 ISDA Definitions) will be as specified in the applicable Final Terms.

Subject to (G) above, the ISDA Definitions contain provisions for determining the applicable Floating Rate (as defined below (including Supplement 70 to the 2006 ISDA Definitions and Section 9 of the 2021 ISDA Definitions (Bespoke Triggers and Fallbacks)) in the event that the specified Floating Rate is not available and such provisions shall apply to Floating Rate Covered Bonds as if incorporated in these Conditions.

For the purposes of this Condition 5.2(b)(i) "**Floating Rate**", "**Calculation Agent**", "**Floating Rate Option**", "**Floating Rate Matrix**", "**Designated Maturity**", "**Reset Date**", "**Overnight Floating Rate Option**", "**Overnight Rate Compounding Method**", "**Compounding with Lookback**", "**Compounding with Observation Period Shift**", "**Compounding with Lockout**", "**Averaging with Lookback**", "**Averaging with Observation Period Shift**", "**Averaging with Lockout**", "**Generic Fallback Provisions**", "**Compounded Index Floating Rate Option**", "**Index Method**" and "**Compounded Index Method with Observation Period Shift**" have the meanings given to those applicable terms in the ISDA Definitions.

(ii) Screen Rate Determination for Floating Rate Covered Bonds

Where Screen Rate Determination is specified in the applicable Final Terms as the manner in which the Rate of Interest is to be determined, the Rate of Interest will be determined as provided below, subject to condition 5.2(b)(iv) below.

If the applicable Final Terms specifies the EURIBOR as the Reference Rate applicable to the Covered Bonds they shall also specify which page (the "**Relevant Screen Page**") on the Reuters Screen or any other information vending service shall be applicable. If such a page is so specified, the Reference Rate applicable to the relevant Covered Bonds for each Interest Period shall be determined by the Calculation Agent on the following basis:

- (A) the Calculation Agent will determine the Reference Rate(s) which appears or appear, as the case may be, on the Relevant Screen Page (or, as the case may require, the arithmetic mean (rounded, if necessary, to the fifth decimal place, with 0.00005 being rounded upwards) of the Reference Rates) in the Specified Currency as specified in the applicable Final Terms for a period of the duration of the relevant Interest Period on the Relevant Screen Page as of the Specified Time on the relevant Interest Determination Date. If five or more offered quotations are available on the Relevant Screen Page, the highest (or, if there is more than one highest quotation, one only of those quotations) and the lowest (or, if there is more than one lowest quotation, one only of those quotations) shall be disregarded by the Calculation Agent for the purpose of determining the arithmetic mean (rounded as provided above) of the offered quotations;
- (B) if, on any Interest Determination Date, no such Reference Rate so appears (or, as the case may be, if one only or none of Reference Rates so appear) or if the Relevant Screen Page is unavailable, the Calculation Agent (on behalf of the Issuer) will request appropriate quotations to be provided to the Calculation Agent for the rates at which deposits in the Specified Currency are offered by

each of the Reference Banks, selected by the Issuer), at approximately the Specified Time on the Interest Determination Date to prime banks in the relevant interbank market, for a period of the duration of the relevant Interest Period and in an amount that is representative for a single transaction in the relevant market at the relevant time and the Calculation Agent will determine the arithmetic mean (rounded as aforesaid) of the rates so quoted;

- (C) if, on any Interest Determination Date, only two or three rates are so quoted, the Calculation Agent will determine the arithmetic mean (rounded as aforesaid) of the rates so quoted; or
- (D) if fewer than two rates are so quoted, the Calculation Agent will determine the arithmetic mean (rounded as aforesaid) of the rates quoted by three major banks in the Relevant Financial Centre (or in such financial centre or centres within the euro zone as the Issuer may select) selected by the Issuer and provided to the Calculation Agent at approximately 11.00 a.m. (Relevant Financial Centre time (or local time at such other financial centre or centres as aforesaid)) on the first day of the relevant Interest Period for deposits in the relevant currency to leading European banks or banks in the United Kingdom for a period of the duration of the relevant Interest Period and in an amount that is representative for a single transaction in the relevant market at the relevant time,

and the Reference Rate applicable to such Covered Bonds during each Interest Period will be the sum of the relevant Margin specified in the applicable Final Terms and the rate (or, as the case may be, the arithmetic mean (rounded as aforesaid) of the rates) so determined provided, however, that, if the Calculation Agent is unable to determine a rate (or, as the case may be, an arithmetic mean of rates) in accordance with the above provisions in relation to any Interest Period, the Reference Rate applicable to such Covered Bonds during such Interest Period will be the sum of the Margin and the rate (or, as the case may be, the arithmetic mean (rounded as aforesaid) of the rates) determined in relation to such Covered Bonds in respect of the last preceding Interest Period.

(iii) €STR Determination for Floating Rate Covered Bonds

Where the Reference Rate is specified in the applicable Final Terms as being ("**€STR**"), the Rate of Interest for each Interest Period will, as provided below (and subject to the €STR Fallbacks set out in (4) below), be Compounded Daily €STR for such Interest Period plus or minus (as indicated in the applicable Final Terms) the Margin, if any, as determined by the Calculation Agent. Compounded Daily €STR will be calculated in accordance with the lag observation method (the "**Observation Lookback Convention**") or the shift observation method (the "**Observation Shift Convention**" and each a "**Compounded Daily €STR**

Observation Convention"). The applicable Final Terms will indicate which Compounded Daily €STR Observation Convention is applicable.

"**Compounded Daily €STR**" means, with respect to an Interest Period, the rate of return of a daily compound interest investment (with the daily euro short-term rate as reference rate for the calculation of interest) and will be calculated by the Calculation Agent on the Interest Determination Date as follows, and the resulting percentage will be rounded, if necessary, to the fourth decimal place, with each 0.00005 per cent. being rounded upwards:

(1) Observation Lookback Convention:

where:

"**d**" is the number of calendar days in the relevant Interest Period;

"**d_o**", for any Interest Period, is the number of T2 Business Days (as defined below) in the relevant Interest Period;

"**€STR_{i-pTBD}**" means, for any day "i" in the relevant Interest Period, the €STR Reference Rate for the T2 Business Day falling "p" T2 Business Days prior to the relevant T2 Business Day "i";

"**i**" is a series of whole numbers from one to d_o, each representing the relevant T2 Business Day in chronological order from, and including, the first T2 Business Day in the relevant Interest Period;

"**n_i**" for any T2 Business Day "i" is the number of calendar days from, and including, such T2 Business Day "i" up to, but excluding, the following T2 Business Day;

"**Observation Lookback Period**" is as specified in the applicable Final Terms ; and

"**p**", for any Interest Period, is the number of T2 Business Days included in the Observation Look-back Period and which shall not be specified in the applicable Final Terms as less than five without the prior agreement of the Calculation Agent;

(2) Observation Shift Convention:

$$\left[\prod_{i=1}^{d_o} \left(1 + \frac{\text{€STR}_i \times n_i}{360} \right) - 1 \right] \times \frac{360}{d}$$

where:

"**d**" is the number of calendar days in the relevant Observation Period;

"**d_o**", for any Observation Period, is the number of T2 Business Days (as defined below) in the relevant Observation Period;

"**€STR_i**" means, in respect of any T2 Business Day "**i**" falling in the relevant Observation Period, the €STR Reference Rate for that T2 Business Day "**i**";

"**i**" is a series of whole numbers from one to **d_o**, each representing the relevant T2 Business Day in chronological order from, and including, the first T2 Business Day in the relevant Observation Period;

"**n_i**" for any T2 Business Day "**i**" is the number of calendar days from, and including, such T2 Business Day "**i**" up to, but excluding, the following T2 Business Day;

"**Observation Period**" means, in respect of an Interest Period, the period from, and including, the date falling "**p**" T2 Business Days prior to the first day of the relevant Interest Period (and the first Observation Period shall begin on and include the date falling "**p**" T2 Business Days prior to the Interest Commencement Date) and ending on, but excluding, the date falling "**p**" T2 Business Days prior to the Interest Payment Date for such Interest Period (or the date falling "**p**" T2 Business Days prior to such earlier date, if any, on which the Covered Bonds become due and payable);

"**p**", for any Interest Period, is the number of T2 Business Days included in the Observation Look-back Period, as specified in the applicable Final Terms and which shall not be specified in the applicable Final Terms as less than five without the prior agreement of the Calculation Agent.

(3) And, for each Compounded Daily €STR Observation Convention, the following definitions shall also apply:

"**ECB Recommended Rate Index Cessation Event**" means the occurrence of one or more of the following events:

- (a) a public statement or publication of information by or on behalf of the administrator of the ECB Recommended Rate announcing that it has ceased or will cease to provide the ECB Recommended Rate permanently or indefinitely, provided that, at the time of the statement or publication, there is no successor administrator that will continue to provide the ECB Recommended Rate; or
- (b) a public statement or the publication of information by the regulatory supervisor for the administrator of the ECB Recommended Rate, the central bank for the currency of the

ECB Recommended Rate, an insolvency official with jurisdiction over the administrator of the ECB Recommended Rate, a resolution authority with jurisdiction over the administrator of the ECB Recommended Rate or a court or an entity with similar insolvency or resolution authority over the administrator of the ECB Recommended Rate, which states that the administrator of the ECB Recommended Rate has ceased or will cease to provide the ECB Recommended Rate permanently or indefinitely, provided that, at the time of the statement or publication, there is no successor administrator that will continue to publish or provide the ECB Recommended Rate;

"ECB Recommended Rate Index Cessation Effective Date" means, in respect of an ECB Recommended Rate Index Cessation Event, the first date on which the ECB Recommended Rate would ordinarily have been provided and is no longer provided;

"€STR Index Cessation Event" means the occurrence of one or more of the following events:

- (a) a public statement or publication of information by or on behalf of the administrator of €STR announcing that it has ceased or will cease to publish or provide €STR permanently or indefinitely, provided that, at the time of the statement or publication, there is no successor administrator that will continue to provide €STR; or
- (b) a public statement or the publication of information by the regulatory supervisor for the administrator of €STR, the central bank for the currency of €STR, an insolvency official with jurisdiction over the administrator of €STR, a resolution authority with jurisdiction over the administrator of €STR or a court or an entity with similar insolvency or resolution authority over the administrator of €STR, which states that the administrator of €STR has ceased or will cease to provide €STR permanently or indefinitely, provided that, at that time, there is no successor administrator that will continue to publish or provide €STR;

"€STR Index Cessation Effective Date" means, in respect of €STR and an €STR Index Cessation Event, the first date on which €STR would ordinarily have been provided and is no longer provided;

"€STR Reference Rate" means in respect of any T2 Business Day, a reference rate equal to the daily euro short-term rate ("**€STR**") for such T2 Business Day as provided by the ECB, as administrator of such rate (or any successor administrator of such rate), on the website of the ECB, currently at <http://www.ecb.europa.eu>, or any successor website officially designated by the ECB (the "**ECB's Website**") (in each case, on or before 9:00 a.m. Central European Time on the T2 Business Day immediately following such T2 Business Day (or any amended publication time for €STR as specified by the administrator of €STR in the €STR benchmark methodology));

"T2 Business Day" or "**TBD**" Means a day on which T2 is open.

(4) €STR Fallbacks: If the €STR Reference Rate does not appear on a T2 Business Day as specified above, unless both an €STR Index Cessation Event and an €STR Index Cessation Effective Date (each as defined below) have occurred, the €STR Reference Rate shall be a rate equal to €STR in respect of the last T2 Business Day for which such rate was published on the ECB's Website.

If the €STR Reference Rate does not appear on a T2 Business Day as specified above, and both an €STR Index Cessation Event and an €STR Index Cessation Effective Date have occurred, the rate for each T2 Business Day occurring on or after such €STR Index Cessation Effective Date will be determined as if references to "€STR" were references to the rate (inclusive of any spreads or adjustments) that was recommended as the replacement for €STR by (i) the ECB (or any successor administrator of €STR) and/or by a committee officially endorsed or convened by the ECB (or any successor administrator of €STR) and/or the European Securities and Markets Authority, in each case for the purpose of recommending a replacement for €STR (which rate may be produced by the ECB or another administrator) and as provided by the administrator of that rate or, if that rate is not provided by the administrator thereof (or a successor administrator), published by an authorised distributor (the "**ECB Recommended Rate**"), provided that, if no such rate has been recommended before the end of the first T2 Business Day following the €STR Index Cessation Effective Date, then the rate for each T2 Business Day occurring on or after such €STR Index Cessation Effective Date will be determined as if references to €STR were references to the Eurosystem Deposit Facility Rate, the rate on the deposit facility that banks may use to make overnight deposits with the Eurosystem, as published on the ECB's Website (the "**EDFR**") on such TARGET Business Day plus the arithmetic mean of the daily difference between the €STR and the EDFR over an observation period of 30 T2 Business Days starting 30 T2 Business Days prior to the day on which the €STR Index Cessation Event occurs and ending on the T2 Business Day immediately preceding the day on which the €STR Index Cessation Event occurs (the "**EDFR Spread**"); provided further that, if both an ECB Recommended Rate Index Cessation Event and an ECB Recommended Rate Index Cessation Effective Date subsequently occur, then the rate for each T2 Business Day occurring on or after that ECB Recommended Rate Index Cessation Effective Date will be determined as if references to "€STR" were references to the EDFR on such T2 Business Day plus the arithmetic mean of the daily difference between the ECB Recommended Rate and the EDFR over an observation period of 30 T2 Business Days starting 30 T2 Business Days prior to the day on which the €STR Index Cessation Event occurs and ending on the T2 Business Day immediately preceding the day on which the ECB Recommended Rate Index Cessation Event occurs.

In the event that the Rate of Interest cannot be determined in accordance with the foregoing provisions, but without prejudice to Condition 5.2(b)(iv), (i) the Rate of Interest applicable to the Covered Bonds during such Interest Period will be the Rate of Interest last determined in relation to the Covered Bonds in respect of the last preceding Interest Period (though substituting, where

a different Margin or Maximum Rate of Interest or Minimum Rate of Interest is to be applied to the relevant Interest Period from that which applied to the last preceding Interest Period, the Margin or Maximum Rate of Interest or Minimum Rate of Interest relating to the relevant Interest Period, in place of the Margin or Maximum Rate of Interest or Minimum Rate of Interest relating to that last preceding Interest Period) or (ii) if there is no such preceding Interest Determination Date, the Rate of Interest shall be determined as if references to €STR for each T2 Business Day occurring on or after the €STR Index Cessation Effective Date were references to the latest published ECB Recommended Rate or, if the EDFR is published on a later date than the latest published ECB Recommended Rate, the latest published EDFR plus the EDFR Spread.

If an €STR Index Cessation Event occurs, the Issuer will promptly notify the Holders in accordance with Condition 15 and the Principal Paying Agent (and if there is a Calculation Agent appointed at such time, the Calculation Agent) of such occurrence.

(5) Early Redemption: If the relevant Series of Covered Bonds becomes due and payable in accordance with Condition 10, the final Interest Determination Date shall, notwithstanding any Interest Determination Date specified in the applicable Final Terms, be deemed to be the date on which such Covered Bonds become due and payable and the Rate of Interest on such Covered Bonds shall, for so long as any such Covered Bonds remains outstanding, be that determined on such date.

(iv) Reference Rate Replacement

This Condition 5.2(b)(iv) shall apply to all Original Reference Rates (but in the case of €STR only if Condition 5.2(b)(iii)(4) does not determine the Rate of Interest).

For greater certainty, this Condition 5.2(b)(iv) also applies to Condition 5.2(b)(i) to the extent that the ISDA Definitions do not provide for a successor rate or any successor rate also requires Benchmark Amendments or, in the case where the 2021 ISDA Definitions apply, where Section 8.6 (Generic Fallback Provisions) of the 2021 ISDA Definitions would otherwise apply. If the Issuer determines that a Benchmark Event has occurred when any Reference Rate (or component thereof) remains to be determined by reference to an Original Reference Rate, then the following provisions shall apply to the relevant Series of Covered Bonds:

- (A) the Issuer shall use reasonable endeavours, as soon as reasonably practicable, to appoint an Independent Adviser to determine:
- (i) a Successor Reference Rate; or
 - (ii) if such Independent Adviser fails so to determine a Successor Reference Rate, an Alternative Reference Rate,

and, in each case, an Adjustment Spread (in any such case, acting in good faith and in a commercially reasonable manner) no later than the relevant IA Determination Cut-off Date, for the purposes of determining the Reference Rate (or the relevant component part thereof) for all relevant future payments of interest on the Covered Bonds for which the Reference Rate (or the relevant component part thereof) was otherwise to be determined by reference to such Original Reference Rate (subject to the subsequent operation of, and adjustment as provided in, this Condition 5.2(b)(iii));

- (B) if the Issuer is unable to appoint an Independent Adviser, or the Independent Adviser appointed by the Issuer fails to determine a Successor Reference Rate or an Alternative Reference Rate (as applicable) prior to the relevant IA Determination Cut-off Date, the Issuer (acting in good faith and in a commercially reasonable manner) may determine:
 - (i) a Successor Reference Rate; or
 - (ii) if the Issuer fails so to determine a Successor Reference Rate, an Alternative Reference Rate,

and, in each case, an Adjustment Spread no later than the Issuer Determination Cut-off Date, for the purposes of determining the Reference Rate (or the relevant component part thereof) for all relevant future payments of interest on the Covered Bonds for which the Reference Rate (or the relevant component part thereof) was otherwise to be determined by reference to such Original Reference Rate (subject to the subsequent operation of, and adjustment as provided in, this Condition 5.2(b)(iii)). Without prejudice to the definitions thereof, for the purposes of determining any Alternative Reference Rate and the relevant Adjustment Spread, the Issuer will take into account any relevant and applicable market precedents as well as any published guidance from relevant associations involved in the establishment of market standards and/or protocols in the international debt capital markets;

- (C) if a Successor Reference Rate or, failing which, an Alternative Reference Rate (as applicable) and, in either case, an Adjustment Spread is determined by the relevant Independent Adviser or the Issuer (as applicable) in accordance with this Condition 5.2(b)(iii):
 - (i) such Successor Reference Rate or Alternative Reference Rate (as applicable) shall subsequently be used in place of the relevant Original Reference Rate to determine the Reference Rate (or the relevant component part thereof) for all relevant future payments of interest on the Covered Bonds for which the Reference Rate (or the relevant component part thereof) was otherwise to be determined by reference

to the relevant Original Reference Rate (subject to the subsequent operation of, and adjustment as provided in, this Condition 5.2(b)(iii));

- (ii) such Adjustment Spread shall be applied to such Successor Reference Rate or Alternative Reference Rate (as the case may be) for all such relevant future payments of interest on the Covered Bonds (subject to the subsequent operation of, and adjustment as provided in, this Condition 5.2(b)(iii)); and
- (iii) the relevant Independent Adviser or the Issuer (as applicable) (acting in good faith and in a commercially reasonable manner) may in its discretion specify:

- (A) changes to these Conditions in order to follow market practice in relation to such Successor Reference Rate or Alternative Reference Rate (as applicable), including, but not limited to (1) the Business Day, Business Day Convention, Day Count Fraction, Interest Determination Date, Relevant Financial Centre, Relevant Screen Page, and/or Specified Time applicable to the Covered Bonds and (2) the method for determining the fallback to the Reference Rate in relation to the Covered Bonds if such Successor Reference Rate or Alternative Reference Rate (as applicable) is not available; and

- (B) any other changes which the relevant Independent Adviser or the Issuer (as applicable) determines are reasonably necessary to ensure the proper operation and comparability to the relevant Original Reference Rate of such Successor Reference Rate or Alternative Reference Rate (as applicable), which changes shall apply to the Covered Bonds for all relevant future payments of interest (subject to the subsequent operation of, and adjustment as provided in, this Condition 5.2(b)(iii)),

which changes shall apply to the Covered Bonds for all relevant future payments of interest on the Covered Bonds which the Reference Rate (or the relevant component part thereof) was otherwise to be determined by reference to the relevant Original Reference Rate (subject to the subsequent operation of, and adjustment as provided in, this Condition 5.2(b)(iii)); and

- (D) promptly following the determination of any Successor Reference Rate or Alternative Reference Rate (as applicable) and the relevant Adjustment Spread, the Issuer shall give notice thereof and of any changes (and the effective date thereof) pursuant to Condition 5.2(b)(iii)(iii) to the Principal Paying Agent, the Calculation Agent and the Covered Bondholders in accordance with Condition 17.

For the avoidance of doubt, the Principal Paying Agent and any other agents party to the Agency Agreement shall, at the direction and expense of the Issuer, effect such consequential amendments to the Agency Agreement and these Conditions as may be required in order to give effect to the application of this Condition 5.2(b)(iii). No consent of the Covered Bondholders shall be required in connection with effecting the relevant Successor Reference Rate or Alternative Reference Rate (as applicable) and, in either case, the relevant Adjustment Spread as described in this Condition 5.2(b)(iii) or such other relevant changes pursuant to Condition 5.2(b)(iv)(iii), including for the execution of any documents or the taking of other steps by the Issuer or any of the parties to the Agency Agreement.

If a Successor Reference Rate or an Alternative Reference Rate and/or, in either case, an Adjustment Spread is not determined pursuant to the operation of this Condition 5.2(b)(iii) prior to the relevant Issuer Determination Cut-off Date, then the Reference Rate for the next relevant Interest Period (in the case of Floating Rate Covered Bonds) shall be determined by reference to the fallback provisions of Condition 5.2(b)(ii).

Notwithstanding any other provision of this Condition 5.2(b)(iii), the Calculation Agent shall not be obliged to concur with the Issuer or the Independent Adviser in respect of any changes or amendments as contemplated under this Condition 5.2(b)(iii) to which, in the sole opinion of the Calculation Agent, would have the effect of (i) exposing the Calculation Agent to any liability which it has not been indemnified and/or secured and/or prefunded to its satisfaction or (ii) increasing the obligations or duties, or decreasing the rights or protections, of the Calculation Agent in the Agency Agreement and/or these Conditions.

Notwithstanding any other provision of this Condition 5.2(b)(iii), if in the Calculation Agent's opinion there is any uncertainty between two or more alternative courses of action in making any determination or calculation under this Condition 5.2(b)(iii), the Calculation Agent shall promptly notify the Issuer and/or the Independent Adviser thereof and the Issuer shall direct the Calculation Agent in writing as to which alternative course of action to adopt. If the Calculation Agent is not promptly provided with such direction, or is otherwise unable to make such calculation or determination for any reason, it shall notify the Issuer and/or the Independent Adviser (as the case may be) thereof and the Calculation Agent shall be under no obligation to make such calculation or determination and shall not incur any liability for not doing so.

For the avoidance of doubt, the Calculation Agent shall not be obliged to monitor or inquire whether a Benchmark Event has occurred or have any liability in respect thereto.

(c) Minimum Rate of Interest and/or Maximum Rate of Interest

In the event that the Rate of Interest in respect of an Interest Period determined in accordance with the provisions of paragraph (b) above is less than zero, the Rate of Interest for that Interest Period shall be deemed to be zero, provided that if the applicable Final Terms for a Floating Rate Covered Bond specifies a Minimum Rate of Interest for any Interest Period, then, in the event that the Rate of Interest in respect of such Interest Period determined in accordance with the provisions of paragraph (b) above is less than such Minimum Rate of Interest, the Rate of Interest for such Interest Period shall be such Minimum Rate of Interest.

If the applicable Final Terms for a Floating Rate Covered Bond specifies a Maximum Rate of Interest for any Interest Period, then, in the event that the Rate of Interest in respect of such Interest Period determined in accordance with the provisions of paragraph (b) above is greater than such Maximum Rate of Interest, the Rate of Interest for such Interest Period shall be such Maximum Rate of Interest.

(d) Determination of Rate of Interest and calculation of Interest Amounts

The Calculation Agent, will at or as soon as practicable after each time at which the Rate of Interest is to be determined, determine the Rate of Interest for the relevant Interest Period.

The Calculation Agent will calculate the amount of interest (the Interest Amount) payable on the Floating Rate Covered Bonds for the relevant Interest Period by applying the Rate of Interest to:

- (i) in the case of Floating Rate Covered Bonds which are represented by a Global Covered Bond, the aggregate outstanding nominal amount of the Covered Bonds represented by such Global Covered Bond; or
- (ii) in the case of Floating Rate Covered Bonds in definitive form, the Calculation Amount,

and, in each case, multiplying such sum by the applicable Day Count Fraction, and rounding the resultant figure to the nearest sub-unit of the relevant Specified Currency, half of any such sub-unit being rounded upwards or otherwise in accordance with applicable market convention. Where the Specified Denomination of a Floating Rate Covered Bond or a Variable Interest Covered Bond in definitive form comprises more than one Calculation Amount, the Interest Amount payable in respect of such Covered Bond shall be the

aggregate of the amounts (determined in the manner provided above) for each Calculation Amount comprising the Specified Denomination without any further rounding.

(e) Notification of Rate of Interest and Interest Amounts

The Calculation Agent will cause the Rate of Interest and each Interest Amount for each Interest Period and the relevant Interest Payment Date to be notified to the Issuer, the Trustee and to any stock exchange or other relevant competent authority or quotation system on which the relevant Floating Rate Covered Bonds are for the time being listed, quoted and/or traded or by which they have been admitted to listing or trading and to be published in accordance with Condition 17 (*Notices*) as soon as possible after their determination but in no event later than the fourth Business Day (as defined in Condition 5.4) thereafter and in the case of any notification to be given to the Luxembourg Stock Exchange on or before the first Business Day of each Interest Period. Each Interest Amount and Interest Payment Date so notified may subsequently be amended (or appropriate alternative arrangements made by way of adjustment) without notice in the event of an extension or shortening of the Interest Period. Any such amendment or alternative arrangements will be promptly notified to the Trustee and each stock exchange or other relevant authority on which the relevant Floating Rate Covered Bonds are for the time being listed, quoted and/or traded or by which they have been admitted to listing or trading and to Covered Bondholders in accordance with Condition 17 (*Notices*).

(f) Linear Interpolation

Where Linear Interpolation is specified as applicable in respect of an Interest Period in the applicable Final Terms, the Rate of Interest for such Interest Period shall be calculated by the Calculation Agent by straight line linear interpolation by reference to two rates based on the relevant Reference Rate (where Screen Rate Determination is specified as applicable in the applicable Final Terms) or the relevant Floating Rate Option (where ISDA Determination is specified as applicable in the applicable Final Terms), one of which shall be determined as if the Designated Maturity were the period of time for which rates are available next shorter than the length of the relevant Interest Period and the other of which shall be determined as if the Designated Maturity were the period of time for which rates are available next longer than the length of the relevant Interest Period, provided however that if there is no rate available for a period of time next shorter or, as the case may be, next longer, then the Calculation Agent shall determine such rate at such time and by reference to such sources as it (in consultation with the Issuer) determines appropriate.

"Designated Maturity" means, in relation to Screen Rate Determination, the period of time designated in the Reference Rate.

(g) Certificates to be final

All certificates, communications, opinions, determinations, calculations, quotations and decisions given, expressed, made or obtained for the purposes of the provisions of this Condition 5.2, by the Calculation Agent shall (in the absence of manifest error) be binding on the Issuer, the Principal Paying Agent, the Calculation Agent, the other Paying Agents, the Trustee and all Covered Bondholders and Couponholders and (in the absence of wilful default or fraud) no liability to the Issuer, the Covered Bondholders or the Couponholders shall attach to the Principal Paying Agent or the Calculation Agent in connection with the exercise or non-exercise by it of its powers, duties and discretions pursuant to such provisions.

(h) Interest on Zero Coupon Covered Bonds

Zero Coupon Covered Bonds will be offered and sold at a discount to their nominal amount and will not bear interest. When a Zero Coupon Covered Bond becomes repayable prior to its Maturity Date it will be redeemed at the Early Redemption Amount calculated in accordance with Condition 7.6 (*Early Redemption Amounts*). In the case of late payment the amount due and repayable shall be calculated in accordance with Condition 7.9 (*Late Payment*).

5.3 *Accrual of interest*

Interest (if any) will cease to accrue on each Covered Bond (or in the case of the redemption of part only of a Covered Bond, that part only of such Covered Bond) on the due date for redemption thereof unless, upon due presentation thereof, payment of principal is improperly withheld or refused or unless default is otherwise made in respect of payment, in which event, interest will continue to accrue as provided in Condition 7.9 (*Late Payment*).

5.4 *Business Day, Business Day Convention, Day Count Fractions and other adjustments*

(a) In these Conditions, "**Business Day**" means:

- (i) a day on which commercial banks and foreign exchange markets settle payments and are open for general business (including dealing in foreign exchange and foreign currency deposits) in London and Athens and any Additional Business Centre specified in the applicable Final Terms; and
- (ii) either (A) in relation to any sum payable in a Specified Currency other than euro, a day on which commercial banks and foreign exchange markets settle payments and are open for general business (including dealing in foreign exchange and foreign currency deposits) in the principal financial centre of the country of the relevant Specified Currency (if other than Athens, London and any Additional Business

Centre) or as otherwise specified in the applicable Final Terms or (B) in relation to any sum payable in euro, a day on which the Trans-European Automated Real-Time Gross Settlement Express Transfer ("**T2**") System (the "**T2 System**") is open.

- (b) If a "**Business Day Convention**" is specified in the applicable Final Terms and (x) if there is no numerically corresponding day in the calendar month in which an Interest Payment Date should occur or (y) if any Interest Payment Date would otherwise fall on a day which is not a Business Day, then, if the Business Day Convention specified is:
- (i) in any case where Specified Periods are specified in accordance with Condition 5.2(a)(ii), the "**Floating Rate Convention**", such Interest Payment Date (1) in the case of (x) above, shall be the last day that is a Business Day in the relevant month and the provisions of (II) below shall apply mutatis mutandis, or (2) in the case of (y) above, shall be postponed to the next day which is a Business Day unless it would thereby fall into the next calendar month, in which event (I) such Interest Payment Date shall be brought forward to the immediately preceding Business Day, and (II) each subsequent Interest Payment Date shall be the last Business Day in the month which falls within the Specified Period after the preceding applicable Interest Payment Date occurred; or
 - (ii) the "**Following Business Day Convention**", such Interest Payment Date shall be postponed to the next day which is a Business Day; or
 - (iii) the "**Modified Following Business Day Convention**", such Interest Payment Date shall be postponed to the next day which is a Business Day unless it would thereby fall into the next calendar month, in which event such Interest Payment Date shall be brought forward to the immediately preceding Business Day; or
 - (iv) the "**Preceding Business Day Convention**", such Interest Payment Date shall be brought forward to the immediately preceding Business Day.
- (c) "**Day Count Fraction**" means, in respect of the calculation of an amount of interest for any Interest Period:
- (i) if "**Actual/Actual (ICMA)**" is specified in the applicable Final Terms:
 - (A) in the case of Covered Bonds where the number of days in the relevant period from (and including) the most recent Interest Payment Date (or, if none, the Interest Commencement Date) to (but excluding) the relevant payment date (the "**Accrual Period**") is equal to or shorter than the Determination Period (as defined in Condition 5.4(e)) during which the Accrual Period ends, the number of days in such Accrual Period divided by the product of (I) the number of days in such Determination Period and (II) the number of Determination

Dates (as specified in the applicable Final Terms) that would occur in one calendar year; or

- (B) in the case of Covered Bonds where the Accrual Period is longer than the Determination Period during which the Accrual Period ends, the sum of (I) the number of days in such Accrual Period falling in the Determination Period in which the Accrual Period begins divided by the product of (x) the number of days in such Determination Period and (y) the number of Determination Dates that would occur in one calendar year; and (II) the number of days in such Accrual Period falling in the next Determination Period divided by the product of (x) the number of days in such Determination Period and (y) the number of Determination Dates that would occur in one calendar year;
- (ii) if "**Actual/Actual**" or "**Actual/Actual (ISDA)**" is specified in the applicable Final Terms, the actual number of days in the Interest Period divided by 365 (or, if any portion of that Interest Period falls in a leap year, the sum of (i) the actual number of days in that portion of the Interest Period falling in a leap year divided by 366, and (ii) the actual number of days in that portion of the Interest Period falling in a non-leap year divided by 365);
- (iii) if "**Actual/365 (Fixed)**" is specified in the applicable Final Terms, the actual number of days in the Interest Period divided by 365;
- (iv) if "**Actual/365 (Sterling)**" is specified in the applicable Final Terms, the actual number of days in the Interest Period divided by 365 or, in the case of an Interest Payment Date falling in a leap year, 366;
- (v) if "**Actual/360**" is specified in the applicable Final Terms, the actual number of days in the Interest Period divided by 360;
- (vi) if "**30/360**", "**360/360**" or "**Bond Basis**" is specified in the applicable Final Terms, the number of days in the Interest Period divided by 360, calculated on a formula basis as follows:

$$\text{Day Count Fraction} = \frac{[360x(Y^2 - Y^1)] + [30x(M^2 - M^1)] + (D^2 - D^1)}{360}$$

where:

"Y¹" is the year, expressed as a number, in which the first day of the Interest Period falls;

"Y²" is the year, expressed as a number, in which the day immediately following the last day of the Interest Period falls;

"M¹" is the calendar month, expressed as a number, in which the first day of the Interest Period falls;

"M²" is the calendar month, expressed as a number, in which the day immediately following the last day of the Interest Period falls;

"D¹" is the first calendar day, expressed as a number, of the Interest Period, unless such number is 31, in which case D¹ will be 30; and

"D²" is the calendar day, expressed as a number, immediately following the last day included in the Interest Period, unless such number would be 31 and D¹ is greater than 29, in which case D² will be 30;

- (vii) if "**30E/360**" or "**Eurobond Basis**" is specified in the applicable Final Terms, the number of days in the Interest Period divided by 360, calculated on a formula basis as follows:

$$\text{Day Count Fraction} = \frac{[360x(Y^2 - Y^1)] + [30x(M^2 - M^1)] + (D^2 - D^1)}{360}$$

where:

"Y¹" is the year, expressed as a number, in which the first day of the Interest Period falls;

"Y²" is the year, expressed as a number, in which the day immediately following the last day of the Interest Period falls;

"M¹" is the calendar month, expressed as a number, in which the first day of the Interest Period falls;

"M²" is the calendar month, expressed as a number, in which the day immediately following the last day of the Interest Period falls;

"D¹" is the first calendar day, expressed as a number, of the Interest Period, unless such number would be 31, in which case D¹ will be 30; and

"D²" is the calendar day, expressed as a number, immediately following the last day included in the Interest Period, unless such number would be 31, in which case D² will be 30;

- (viii) if "**30E/360 (ISDA)**" is specified in the applicable Final Terms, the number of days in the Interest Period divided by 360, calculated on a formula basis as follows:

$$\text{Day Count Fraction} = \frac{[360x(Y^2 - Y^1)] + [30x(M^2 - M^1)] + (D^2 - D^1)}{360}$$

where:

"Y¹" is the year, expressed as a number, in which the first day of the Interest Period falls;

"Y²" is the year, expressed as a number, in which the day immediately following the last day of the Interest Period falls;

"M¹" is the calendar month, expressed as a number, in which the first day of the Interest Period falls;

"M²" is the calendar month, expressed as a number, in which the day immediately following the last day of the Interest Period falls;

"D¹" is the first calendar day, expressed as a number, of the Interest Period, unless (i) that day is the last day of February or (ii) such number would be 31, in which case D¹ will be 30; and

"D²" is the calendar day, expressed as a number, immediately following the last day included in the Interest Period, unless (i) that day is the last day of February but not the Final Maturity Date or (ii) such number would be 31 and D² will be 30; or

such **other** Day Count Fraction as may be specified in the applicable Final Terms.

- (d) "**Adjustment Spread**" means either (a) a spread (which may be positive, negative or zero) or (b) a formula or methodology for calculating a spread, in either case which is to be applied to the relevant Successor Reference Rate or Alternative Reference Rate (as applicable) and is the spread, formula or methodology which:
- (i) in the case of a Successor Reference Rate, is formally recommended in relation to the replacement of the relevant Original Reference Rate with the relevant Successor Reference Rate by any Relevant Nominating Body; or
 - (ii) in the case of an Alternative Reference Rate or (where (A) above does not apply) in the case of a Successor Reference Rate, the relevant Independent Adviser or the Issuer (as applicable) determines is recognised or acknowledged as being in customary market usage in international debt capital markets transactions which reference the

relevant Original Reference Rate, where such rate has been replaced by such Successor Reference Rate or such Alternative Reference Rate (as applicable); or

- (iii) (if the relevant Independent Adviser or the Issuer (as applicable) determines that neither (A) nor (B) above applies) the relevant Independent Adviser or the Issuer (as applicable) determines to be appropriate, having regard to the objective, so far as is reasonably practicable in the circumstances, of reducing or eliminating any economic prejudice or benefit (as the case may be) to the Covered Bondholders of the Covered Bonds or Coupons as a result of the replacement of the relevant Original Reference Rate with the relevant Successor Reference Rate or the relevant Alternative Reference Rate (as applicable).
- (e) **"Alternative Reference Rate"** means the rate that an alternative benchmark or screen the relevant Independent Adviser or the Issuer (as applicable) determines has replaced the relevant Original Reference Rate in customary market usage in the international debt capital markets for the purposes of determining rates of interest (or the relevant component part thereof) in respect of debt securities denominated in the Specified Currency and of a comparable duration of Floating Rate Covered Bonds, to the relevant Interest Periods or in any case, if such Independent Adviser or the Issuer (as applicable) determines that there is no such rate, such other rate as such Independent Adviser or the Issuer (as applicable) determines in its discretion is most comparable to the relevant Original Reference Rate.
- (f) **"Benchmark Event"** means, with respect to an Original Reference Rate:
 - (i) such Original Reference Rate ceasing to be published for at least five Business Days or ceasing to exist or be administered; or
 - (ii) the later of (a) the making of a public statement by the administrator of such Original Reference Rate that it will, on or before a specified date, cease publishing such Original Reference Rate permanently or indefinitely (in circumstances where no successor administrator has been appointed that will continue publication of such Original Reference Rate) and (b) the date falling six months prior to the specified date referred to in (ii)(a); or
 - (iii) the making of a public statement by the supervisor of the administrator of such Original Reference Rate that such Original Reference Rate has been permanently or indefinitely discontinued; or
 - (iv) the later of (a) the making of a public statement by the supervisor of the administrator of such Original Reference Rate that such Original Reference Rate will, on or before a specified date, be permanently or indefinitely discontinued and (b) the date falling six months prior to the specified date referred to in (iv)(a); or

- (v) the later of (a) the making of a public statement by the supervisor of the administrator of such Original Reference Rate that means such Original Reference Rate will be prohibited from being used or that its use will be subject to restrictions or adverse consequences, in each case on or before a specified date and (b) the date falling six months prior to the specified date referred to in (v)(a); or
 - (vi) it has or will prior to the next Interest Determination Date become unlawful for the Issuer, the Calculation Agent, any other party specified in the applicable Final Terms as being responsible for calculating the Reference Rate or any Paying Agent to calculate any payments due to be made to any Covered Bondholder of Covered Bonds or Coupons using such Original Reference Rate (including, without limitation, under Regulation (EU) 2016/1011 or, in relation to the UK, Regulation (EU) 2016/1011 as it forms part of domestic law of the UK by virtue of the EUWA (as amended from time to time), if applicable); or
 - (vii) the making of a public statement by the supervisor of the administrator of such Original Reference Rate announcing that such Original Reference Rate is no longer representative or may no longer be used.
- (d) "**Determination Date**" has the meaning given in the applicable Final Terms.
 - (e) "**Determination Period**" means each period from (and including) a Determination Date to (but **excluding**) the next Determination Date (including, where either the Interest Commencement Date or the final Interest Payment Date is not a Determination Date, the period commencing on the first Determination Date prior to, and ending on the first Determination Date falling after, such date).
 - (f) "**Fixed Interest Period**" means the period from (and including) an Interest Payment Date (or the Interest Commencement Date) to (but excluding) the next (or first) Interest Payment Date.
 - (g) "**IA Determination Cut-off Date**" means in any Interest Period, the date that falls on the fifth Business Day prior to the Interest Determination Date relating to the next succeeding Interest Period.
 - (h) "**Independent Adviser**" means an independent financial institution of international repute or other independent financial adviser experienced in the international debt capital markets, in each case appointed by the Issuer at its own expense.
 - (i) "**Interest Commencement Date**" means in the case of interest-bearing Covered Bonds, the date specified in the applicable Final Terms from (and including) which the relevant Covered Bonds will accrue interest.

- (j) "**Interest Payment Date**" means, in respect of Fixed Rate Covered Bonds, the meaning given in the applicable Final Terms and in respect of Floating Rate Covered Bonds, the meaning given in Condition 5.2, together the **Interest Payment Dates**.
- (k) "**Interest Period**" means the period from (and including) an Interest Payment Date (or the Interest Commencement Date) to (but excluding) the next (or first) Interest Payment Date.
- (l) "**Issuer Determination Cut-off Date**" means, in any Interest Period, the date that falls on the third Business Day prior to the Interest Determination Date relating to the next succeeding Interest Period;
- (m) "**Original Reference Rate**" means the originally-specified reference rate of the Covered Bonds used to determine the relevant Reference Rate (or any component part thereof) in respect of any Interest Period(s) (provided that if, following one or more Benchmark Events, such originally specified reference rate of the Covered Bonds (or any Successor Reference Rate or Alternative Reference Rate which has replaced it) has been replaced by a (or a further) Successor Reference Rate or Alternative Reference Rate and a Benchmark Event subsequently occurs in respect of such Successor Reference Rate or Alternative Reference Rate, the term "Original Reference Rate" shall include any such Successor Reference Rate or Alternative Reference Rate).
- (n) "**Principal Amount Outstanding**" means in respect of a Covered Bond on any day the principal amount of that Covered Bond on the relevant Issue Date thereof less principal amounts received by the relevant Covered Bondholder in respect thereof on or prior to that day provided that the Principal Amount Outstanding in respect of a Covered Bond that has been purchased and cancelled by the Issuer shall be zero.
- (o) "**Reference Banks**" means, the principal euro-zone office of three major banks in the euro-zone interbank market selected by the Issuer.
- (p) "**Reference Rate**", in respect of Floating Rate Covered Bonds to which Screen Rate Determination applies, has the meaning given to it in the applicable Final Terms
- (q) "**Relevant Financial Centre**" means in the case of a rate at which deposits are offered in the euro zone interbank market, Brussels or, in the case of Covered Bonds, such other financial centre or centres as may be specified in the applicable Final Terms.
- (r) "**Relevant Nominating Body**" means, in respect of an Original Reference Rate:
 - (i) the European Commission, the central bank, reserve bank, monetary authority or similar institution for the currency to which such Original Reference Rate relates, or any central bank or other supervisory authority which is responsible for supervising the administrator of such Original Reference Rate; or

- (ii) any working group or committee sponsored by, chaired or co-chaired by or constituted at the request of (a) the central bank, reserve bank, monetary authority or similar institution for the currency to which such Original Reference Rate relates, (b) any central bank or other supervisory authority which is responsible for supervising the administrator of such Original Reference Rate, (c) a group of the aforementioned central banks or other supervisory authorities, or (d) the Financial Stability Board or any part thereof.
- (s) "**Relevant Screen Page**" means such page, section, caption, column or other part of a particular information service as may be specified in the applicable Final terms or any successor or replacement page, section, caption, column or other part of a particular information service.
- (t) "**Specified Time**" means 11:00 a.m. in the Relevant Financial Centre, or such other time as may be specified in the applicable Final Terms.
- (u) If **adjusted** is specified in the applicable Final Terms against the Day Count Fraction, interest in respect of the relevant Interest Period shall be payable in arrear on the relevant Interest Payment Date and calculated from (and including) an Interest Payment Date (or the Interest Commencement Date) to (but excluding) the next (or first) Interest Payment Date, as such Interest Payment Date shall, where applicable, be adjusted in accordance with the Business Day Convention.
- (v) If **not adjusted** is specified in the applicable Final Terms against the Day Count Fraction, interest in respect of the relevant Interest Period shall be payable in arrear on the relevant Interest Payment Date and calculated from (and including) an Interest Payment Date (or the Interest Commencement Date) to (but excluding) the next (or first) Interest Payment Date, but such Interest Payment Dates shall not be adjusted in accordance with any Business Day Convention.
- (w) "**Sub-unit**" means, with respect to any currency other than euro, the lowest amount of such currency that is available as legal tender in the country of such currency and, with respect to euro, euro 0.01.

6 Payments

6.1 Method of payment

Subject as provided below:

- (i) payments in a Specified Currency other than euro will be made by credit or transfer to an account in the relevant Specified Currency (which, in the case of a payment in Yen to a non-resident of Japan, shall be a non-resident account) maintained by the

payee with, or, at the option of the payee, by a cheque in such Specified Currency drawn on, a bank in the principal financial centre of the country of such Specified Currency (which, if the Specified Currency is Australian dollars or New Zealand dollars, shall be Sydney and Auckland, respectively);

- (ii) payments will be made in euro by credit or electronic transfer to a euro account (or any other account to which euro may be credited or transferred) specified by the payee or, at the option of the payee, by a euro cheque; and
- (iii) payments in U.S. Dollars will be made by transfer to a U.S. Dollar account maintained by the payee with a bank outside of the United States (which expression, as used in this Condition 6, means the United States of America, including the State and the District of Columbia, its territories, its possessions and other areas subject to its jurisdiction), or by cheque drawn on a United States bank.

In no event will payment in respect of Covered Bonds be made by a cheque mailed to an address in the United States. All payments of interest in respect of Covered Bonds will be made to accounts located outside the United States except as may be permitted by United States tax law in effect at the time of such payment without detriment to the Issuer.

Payments will be subject in all cases (i) to any fiscal or other laws and regulations applicable thereto in the place of payment and (ii) any withholding or deduction required pursuant to an agreement described in Section 1471(b) of the U.S. Internal Revenue Code of 1986 (the "**Code**") or otherwise imposed pursuant to Sections 1471 through 1474 of the Code, any regulations or agreements thereunder, any official interpretations thereof, an intergovernmental agreement between the United States and another jurisdiction facilitating the implementation thereof (or any law or regulation implementing such intergovernmental agreement). References to Specified Currency will include any successor currency under applicable law.

6.2 *Presentation of Definitive Covered Bonds, Receipts and Coupons*

Payments of principal and interest (if any) will (subject as provided below) be made in accordance with Condition 6.1 (*Method of payment*) only against presentation and surrender of Definitive Covered Bonds or Coupons (or, in the case of part payment of any sum due, endorsement of the Definitive Covered Bond (or Coupon)), as the case may be, only at a specified office of any Paying Agent outside the United States (which expression, as used herein, means the United States of America (including the States and the District of Columbia, its territories, its possessions and other areas subject to its jurisdiction)).

Fixed Rate Covered Bonds in definitive bearer form (other than Long Maturity Covered Bonds (as defined below)) should be presented for payment together with all unmatured Coupons appertaining thereto (which expression shall include Coupons falling to be issued on exchange of matured Talons), failing which an amount equal to the face value of any missing unmatured

Coupon (or, in the case of payment not being made in full, the same proportion of the amount of such missing unmatured Coupon as the sum so paid bears to the total amount due) will be deducted from the amount due for payment. Each amount so deducted will be paid in the manner mentioned above against surrender of the relative missing Coupon at any time before the expiry of ten years after the Relevant Date (as defined in Condition 11 (*Prescription*)) in respect of such principal (whether or not such Coupon would otherwise have become void under Condition 11 (*Prescription*)) or, if later, five years from the date on which such Coupon would otherwise have become due but in no event thereafter.

Upon amounts in respect of any Fixed Rate Covered Bond in definitive bearer form becoming due and repayable by the Issuer prior to its Final Maturity Date (or, as the case may be, Extended Final Maturity Date), all unmatured Talons (if any) appertaining thereto will become void and no further Coupons will be issued in respect thereof.

Upon the due date for redemption of any Floating Rate Covered Bond in definitive bearer form, all unmatured Coupons and Talons (if any) relating thereto (whether or not attached) shall become void and no payment or, as the case may be, exchange for further Coupons shall be made in respect thereof. A "**Long Maturity Covered Bond**" is a Fixed Rate Covered Bond (other than a Fixed Rate Covered Bond which on issue had a Talon attached) whose nominal amount on issue is less than the aggregate interest payable thereon provided that such Covered Bond shall cease to be a Long Maturity Covered Bond on the Interest Payment Date on which the aggregate amount of interest remaining to be paid after that date is less than the Principal Amount Outstanding of such Covered Bond.

If the due date for redemption of any Definitive Covered Bond is not an Interest Payment Date, interest (if any) accrued in respect of such Covered Bond from (and including) the preceding Interest Payment Date or, as the case may be, the Interest Commencement Date shall be payable only against presentation and surrender of the relevant Definitive Covered Bond.

6.3 *Payments in respect of Bearer Global Covered Bonds*

Payments of principal and interest (if any) in respect of Covered Bonds represented by any Bearer Global Covered Bond will (subject as provided below) be made in the manner specified above in relation to Bearer Definitive Covered Bonds and otherwise in the manner specified in the relevant Bearer Global Covered Bond against presentation or surrender, as the case may be, of such Bearer Global Covered Bond if the Bearer Global Covered Bond is not intended to be issued in new global covered bond ("**NGCB**") form at the specified office of any Paying Agent outside the United States. On the occasion of each payment, (i) in the case of any Bearer Global Covered Bond which is not issued in NGCB form, a record of such payment made on such Bearer Global Covered Bond, distinguishing between any payment of principal and any payment of interest, will be made on such Bearer Global Covered Bond by the Paying Agent and such record shall be prima facie evidence that the payment in question has been made and (ii) in the case of any

Global Covered Bond which is issued in NGCB form, the Paying Agent shall instruct Euroclear and Clearstream, Luxembourg to make appropriate entries in their records to reflect such payment.

No payments of principal, interest or other amounts due in respect of a Bearer Global Covered Bond will be made by mail to an address in the United States or by transfer to an account maintained in the United States.

6.4 Payments in respect of Registered Covered Bonds

Payments of principal in respect of each Registered Covered Bond (whether or not in global form) will be made against presentation and surrender of the Registered Covered Bond at the specified office of the Registrar or any of the Paying Agents. Such payments will be made in accordance with Condition 6.1 by transfer to the Designated Account (as defined below) of the holder (or the first named of joint holders) of the Registered Covered Bond appearing in the register of holders of the Registered Covered Bonds maintained by the Registrar (the "**Register**") at the close of business on the business day ("**business day**" being for the purposes of this Condition 6.4 a day on which Euroclear and Clearstream, Luxembourg are open for business) before the relevant due date. Notwithstanding the previous sentence, if (i) a holder does not have a Designated Account, or (ii) the principal amount of the Covered Bonds held by a holder is less than U.S.\$250,000 (or its approximate equivalent in any other Specified Currency), payment will instead be made by a cheque in the Specified Currency drawn on a Designated Bank (as defined below). For these purposes, "**Designated Account**" means the account (which, in the case of a payment in Yen to a non-resident of Japan, shall be a non-resident account) maintained by a holder with a Designated Bank and identified as such in the Register and "**Designated Bank**" means (in the case of payment in a Specified Currency other than euro) a bank in the principal financial centre of the country of such Specified Currency and (in the case of a payment in euro) any bank which processes payments in euro.

Payments of interest and payments in respect of each Registered Covered Bond (whether or not in global form) will be made by a cheque in the Specified Currency drawn on a Designated Bank and mailed by uninsured mail on the business day immediately preceding the relevant due date to the holder (or the first named of joint holders) of the Registered Covered Bond appearing in the Register (i) where in global form, at the close of the clearing system business day (where "**clearing system business day**" means Monday to Friday inclusive except for December 25 and January 1) before the relevant due date, and (ii) where in definitive form, at the close of business on the fifteenth day (whether or not such fifteenth day is a clearing system business day) before the relevant due date (the "**Record Date**") at the holder's address shown in the Register on the Record Date and at the holder's risk. Upon application of the holder to the specified office of the Registrar not less than 3 business days before the due date for any payment of interest in respect of a Registered Covered Bond, the payment may be made by transfer on the due date in the manner provided in the preceding paragraph. Any such application for transfer shall be deemed

to relate to all future payments of interest (other than interest due on redemption) in respect of the Registered Covered Bonds which become payable to the holder who has made the initial application until such time as the Registrar is notified in writing to the contrary by such holder. Payment of the interest due in respect of each Registered Covered Bond on redemption will be made in the same manner as payment of the principal in respect of such Registered Covered Bond.

Holders of Registered Covered Bonds will not be entitled to any interest or other payment for any delay in receiving any amount due in respect of any Registered Covered Bond as a result of a cheque posted in accordance with this Condition arriving after the due date for payment or being lost in the post. No commissions or expenses shall be charged to such holders by the Registrar in respect of any payments of principal or interest in respect of the Registered Covered Bonds.

None of the Issuer, the Trustee or the Agents will have any responsibility or liability for any aspect of the records relating to, or payments made on account of, beneficial ownership interests in the Registered Global Covered Bonds or for maintaining, supervising or reviewing any records relating to such beneficial ownership interests.

6.5 General provisions applicable to payments

The bearer of a Global Covered Bond or, as provided in the Trust Deed, the Trustee shall be the only person entitled to receive payments in respect of Covered Bonds represented by such Global Covered Bond and the obligations of the Issuer will be discharged by payment to, or to the order of, the holder of such Global Covered Bond (or the Trustee, as the case may be) in respect of each amount so paid. Each of the persons shown in the records of Euroclear or Clearstream, Luxembourg as the beneficial holder of a particular nominal amount of Covered Bonds represented by such Global Covered Bond must look solely to Euroclear or Clearstream, Luxembourg, as the case may be, for his share of each payment so made by the Issuer to, or to the order of, the holder of such Global Covered Bond (or the Trustee, as the case may be). No person other than the holder of the relevant Global Covered Bond (or, as provided in the Trust Deed, the Trustee) shall have any claim against the Issuer in respect of any payments due on that Global Covered Bond.

Notwithstanding the foregoing provisions of this Condition, payments of principal and/or interest in respect of Bearer Covered Bonds in U.S. Dollars will only be made at the specified office of a Paying Agent in the United States if:

- (i) the Issuer has appointed Paying Agents with specified offices outside the United States with the reasonable expectation that such Paying Agents would be able to make payment in U.S. Dollars at such specified offices outside the United States of the full amount of principal and/or interest on the Bearer Covered Bonds in the manner provided above when due;

- (ii) payment of the full amount of such principal and interest at such specified offices outside the United States is illegal or effectively precluded by exchange controls or other similar restrictions on the full payment or receipt of principal and interest in U.S. Dollars; and
- (iii) such payment is then permitted under United States law without involving, in the opinion of the Issuer adverse tax consequences to the Issuer.

6.6 *Payment Day*

If the date for payment of any amount in respect of any Covered Bond or Coupon is not a Payment Day (as defined below), the holder thereof shall not be entitled to payment of the relevant amount due until the next following Payment Day and shall not be entitled to any interest or other sum in respect of any such delay. In this Condition (unless otherwise specified in the applicable Final Terms), "**Payment Day**" means any day which (subject to Condition 11 (*Prescription*)) is:

- (i) a day on which commercial banks and foreign exchange markets settle payments and are open for general business (including dealing in foreign exchange and foreign currency deposits) in:
 - (A) London;
 - (B) Athens; and
 - (C) any Additional Financial Centre specified in the applicable Final Terms; and
- (ii) either (i) in relation to any sum payable in a Specified Currency other than euro, a day on which commercial banks and foreign exchange markets settle payments and are open for general business (including dealing in foreign exchange and foreign currency deposits) in the principal financial centre of the country of the relevant Specified Currency (if other than Athens, London and any Additional Financial Centre) or as otherwise specified in the applicable Final Terms or (ii) in relation to any sum payable in euro, a day on which the T2 System is open.

6.7 *Interpretation of principal and interest*

Any reference in these Conditions to **principal** in respect of the Covered Bonds shall be deemed to include, as applicable:

- (i) any additional amounts which may be payable with respect to principal under Condition 8 (*Taxation*) or under any undertakings or covenants given in addition thereto, or in substitution therefor, pursuant to the Trust Deed;

- (ii) the Final Redemption Amount (as defined in the Final Terms) (the "**Final Redemption Amount**") of the Covered Bonds;
- (iii) the Early Redemption Amount of the Covered Bonds but excluding any amount of interest referred to therein;
- (iv) the Optional Redemption Amount(s) (if any) of the Covered Bonds;
- (v) in relation to Zero Coupon Covered Bonds, the Amortised Face Amount (as defined in Condition 7.6(ii)); and
- (vi) any premium and any other amounts (other than interest) which may be payable under or in respect of the Covered Bonds;

Any reference in these Conditions to interest in respect of the Covered Bonds shall be deemed to include, as applicable, any additional amounts which may be payable with respect to interest under Condition 8 (*Taxation*) or under any undertakings given in addition thereto, or in substitution therefor, pursuant to the Trust Deed.

6.8 *Redenomination*

Where redenomination is specified in the applicable Final Terms as being applicable, the Issuer may, without the consent of the Covered Bondholders and the Couponholders, on giving prior written notice to the Trustee and the Agents, Euroclear and Clearstream, Luxembourg and at least 30 days' prior notice to the Covered Bondholders in accordance with Condition 17 (*Notices*), elect that, with effect from the Redenomination Date specified in the notice, the Covered Bonds shall be redenominated in euro. In relation to any Covered Bonds where the applicable Final Terms provides for a minimum Specified Denomination in the Specified Currency which is equivalent to at least €100,000 and which are admitted to trading on a regulated market in the European Economic Area, it shall be a term of any such redenomination that the holder of any Covered Bonds held through Euroclear and/or Clearstream, Luxembourg must have credited to its securities account with the relevant clearing system a minimum balance of Covered Bonds of at least €100,000.

The election will have effect as follows:

- (i) the Covered Bonds shall be deemed to be redenominated in euro in the denomination of euro 0.01 with a nominal amount for each Covered Bond equal to the nominal amount of that Covered Bond in the Specified Currency, converted into euro at the Established Rate, provided that, if the Issuer determines, in consultation with the Agents that the then market practice in respect of the redenomination in euro of internationally offered securities is different from the provisions specified above, such provisions shall be deemed to be amended so as to comply with such

market practice and the Issuer shall promptly notify the Trustee, the Covered Bondholders, the competent listing authority, stock exchange and/or market (if any) on or by which the Covered Bonds may be listed and/or admitted to trading and the Paying Agents of such deemed amendments;

- (ii) save to the extent that an Exchange Notice has been given in accordance with paragraph (iv) below, the amount of interest due in respect of the Covered Bonds will be calculated by reference to the aggregate nominal amount of Covered Bonds presented (or, as the case may be, in respect of which Coupons are presented) for payment by the relevant holder and the amount of such payment shall be rounded down to the nearest euro 0.01;
- (iii) if Definitive Covered Bonds are required to be issued after the Redenomination Date, they shall be issued at the expense of the Issuer in the denominations of €100,000 and/or such higher amounts as the Agents may determine and notify to the Covered Bondholders and any remaining amounts less than €100,000 shall be redeemed by the Issuer and paid to the Covered Bondholders in euro in accordance with Condition 8 (*Taxation*);
- (iv) if issued prior to the Redenomination Date, all unmatured Coupons denominated in the Specified Currency (whether or not attached to the Covered Bonds) will become void with effect from the date on which the Issuer gives notice (the "**Exchange Notice**") that replacement euro-denominated Covered Bonds and Coupons are available for exchange (provided that such securities are so available) and no payments will be made in respect of them. The payment obligations contained in any Covered Bonds and Coupons so issued will also become void on that date although those Covered Bonds and Coupons will continue to constitute valid exchange obligations of the Issuer. New euro-denominated Covered Bonds and Coupons will be issued in exchange for Covered Bonds, Receipts and Coupons denominated in the Specified Currency in such manner as the Agents may specify and as shall be notified to the Covered Bondholders in the Exchange Notice. No Exchange Notice may be given less than 15 days prior to any date for payment of principal or interest on the Covered Bonds;
- (v) after the Redenomination Date, all payments in respect of the Covered Bonds and the Coupons, other than payments of interest in respect of periods commencing before the Redenomination Date, will be made solely in euro as though references in the Covered Bonds to the Specified Currency were to euro. Payments will be made in euro by credit or transfer to a euro account (or any other account to which euro may be credited or transferred) specified by the payee or, at the option of the payee, by a euro cheque;

- (vi) if the Covered Bonds are Fixed Rate Covered Bonds and interest for any period ending on or after the Redenomination Date is required to be calculated for a period ending other than on an Interest Payment Date, it will be calculated by applying the Rate of Interest to each Specified Denomination, multiplying such sum by the applicable Day Count Fraction, and rounding the resultant figure to the nearest sub-unit of the relevant Specified Currency, half of any such sub-unit being rounded upwards or otherwise in accordance with applicable market convention;
- (vii) (if the Covered Bonds are Floating Rate Covered Bonds), the applicable Final Terms will specify any relevant changes to the provisions relating to interest; and
- (viii) such other changes shall be made to this Condition (and the Transaction Documents) as the Issuer may decide, after consultation with the Trustee and the Agents and as may be specified in the notice, to conform it to conventions then applicable to instruments denominated in euro.

6.9 Definitions

In these Conditions, the following expressions have the following meanings:

"Accrual Yield" has, in relation to a Zero Coupon Covered Bond, the meaning given in the applicable Final Terms.

"Calculation Amount" has the meaning given in the applicable Final Terms.

"Earliest Maturing Covered Bonds" means, at any time, the Series of the Covered Bonds (other than any Series which is fully collateralised by amounts standing to the credit of the Transaction Accounts) that has or have the earliest Final Maturity Date as specified in the applicable Final Terms (ignoring any acceleration of amounts due under the Covered Bonds prior to an Event of Default).

"Early Redemption Amount" means the amount calculated in accordance with Condition 7.6 (*Early Redemption Amounts*).

"Established Rate" means the rate for the conversion of the relevant Specified Currency (including compliance with rules relating to roundings in accordance with applicable European Community regulations) into euro established by the Council of the European Union pursuant to Article 123 of the Treaty.

"euro" means the currency introduced at the start of the third stage of European economic and monetary union pursuant to the Treaty.

"Extraordinary Resolution" means a resolution of the Covered Bondholders passed as such under the terms of the Trust Deed.

"Minimum Rate of Interest" means in respect of Floating Rate Covered Bonds or Variable Interest Covered Bonds, the percentage rate per annum (if any) specified as such in the applicable Final Terms.

"Notice of Default" has the meaning given to it in Condition 10 (*Events of Default and Enforcement*).

"Optional Redemption Amount" has the meaning (if any) given in the applicable Final Terms.

"Potential Event of Default" means any condition, event or act which, with the lapse of time and/or the issue, making or giving of any notice, certification, declaration, demand, determination and/or request and/or the taking of any similar action and/or the fulfilment of any similar condition, would constitute an Event of Default.

"Rate of Interest" means the rate of interest payable from time to time in respect of Fixed Rate Covered Bonds and Floating Rate Covered Bonds, as determined in, or as determined in the manner specified in, the applicable Final Terms.

"Redenomination Date" means (in the case of interest bearing Covered Bonds) any date for payment of interest under the Covered Bonds or (in the case of Zero Coupon Covered Bonds) any date, in each case specified by the Issuer in the notice given to the Covered Bondholders pursuant to Condition 6.8 (*Redenomination*) above and which falls on or after the date on which the country of the relevant Specified Currency first participates in the third stage of European economic and monetary union.

"Reference Price" has, in respect of a Zero Coupon Covered Bond, the meaning given in the applicable Final Terms.

"Screen Rate Determination" means, if specified as applicable in the applicable Final Terms, the manner in which the Rate of Interest on Floating Rate Covered Bonds is to be determined in accordance with Condition 5.2(b)(ii).

"Secured Creditors" means the Covered Bondholders, the Couponholders, the Trustee, any Receiver, the Asset Monitor, the Account Bank, the Agents, the Servicer, the Replacement Servicer, the Special Administrator, the Hedging Counterparties and any other creditor of the Issuer pursuant to any Transaction Document entered into in the course of the Programme having recourse to the Cover Pool (provided that where the Issuer performs any of the above roles, the Issuer will not be a Secured Creditor).

"Treaty" means the Treaty establishing the European Community, as amended.

7 Redemption and Purchase

7.1 Final redemption

- (i) Unless previously redeemed in full or purchased and cancelled as specified below, each Covered Bond will be redeemed by the Issuer at its Final Redemption Amount specified in, the applicable Final Terms in the relevant Specified Currency on the Final Maturity Date.
- (ii) Without prejudice to Conditions 9 and 10, if an Extended Final Maturity Date is specified in the applicable Final Terms for a Series of Covered Bonds and the Issuer has failed to pay the Final Redemption Amount on the Final Maturity Date specified in the Final Terms (subject to the 7 Athens Business Days grace period), then the respective Series will become Pass-through Covered Bonds (subject as provided below) and payment of any unpaid Final Redemption Amount by the Issuer shall be deferred until the Extended Final Maturity Date, provided that any amount representing the Final Redemption Amount due and remaining unpaid on the Final Maturity Date shall be paid by the Issuer on any Interest Payment Date occurring thereafter up to (and including) the relevant Extended Final Maturity Date *pro rata* and *pari passu* in respect of all Pass-Through Covered Bonds, subject to the Issuer having funds available for such purpose in accordance with the relevant Priority of Payments and Condition 7.6 (*Early Redemption Amounts*).
- (iii) The Issuer shall use any amounts standing to the credit of the relevant Accumulation Sub-Ledger to redeem the relevant Series of Accumulation Covered Bonds on the Final Maturity Date.
- (iv) Following the occurrence of:
 - (a) an Issuer Event (other than an Issuer Insolvency Event) and breach of the Amortisation Test; or
 - (b) an Issuer Insolvency Event and (i) any Final Redemption Amount is unpaid on the Final Maturity Date therefore and payment of such amount is deferred pursuant to Condition 7.1(ii) above; or (ii) a breach of the Amortisation Test,all Series of Covered Bonds become Pass-Through Covered Bonds and the Issuer shall redeem all Series of Covered Bonds on each Interest Payment Date, in accordance with and subject to the relevant Priority of Payments.
- (v) The Issuer shall confirm to the relevant Covered Bondholders (in accordance with Condition 17), the Rating Agencies, any relevant Hedging Counterparty, the Trustee, the Registrar (in the case of a Registered Covered Bond), the Principal Paying Agent and the Bank of Greece as soon as reasonably practicable and in any event at least

five Athens Business Days prior to the Final Maturity Date of any inability of the Issuer to pay in full the Final Redemption Amount in respect of a Series of Covered Bonds on the Final Maturity Date. Any failure by the Issuer to notify such parties shall not affect the validity or effectiveness of the extension nor give rise to any rights in any such party.

- (vi) Where the applicable Final Terms for a relevant Series of Covered Bonds provides that such Covered Bonds are subject to an Extended Final Maturity Date, such failure to pay by the Issuer on the Final Maturity Date shall not constitute an Event of Default but shall constitute an Issuer Event under Condition 9(ii).
- (vii) Pursuant to Article 19(1)(e) of the Covered Bond Law, in the event of an Issuer Insolvency Event, the extension of the Final Maturity Date under this Condition 7.1 shall not affect the ranking of Covered Bond investors or amend the sequencing of the Covered Bonds original maturity schedule.
- (viii) Pursuant to Article 19(1)(f) of the Covered Bond Law, the extension of the Final Maturity Date under this Condition 7.1 shall not change the structural features of the Covered Bonds regarding dual recourse as referred to in Article 6 of the Covered Bond Law and bankruptcy remoteness as referred to in Article 7 of the Covered Bond Law.

7.2 Redemption for taxation reasons

The Covered Bonds may be redeemed at the option of the Issuer in whole, but not in part, at any time (if the relevant Covered Bond is not a Floating Rate Covered Bond) or on any Interest Payment Date (if the relevant Covered Bond is a Floating Rate Covered Bond), on giving not less than 30 nor more than 60 days' notice to the Trustee and, in accordance with Condition 17 (*Notices*), the Covered Bondholders (which notice shall be irrevocable), if the Issuer satisfies the Trustee immediately before the giving of such notice that on the occasion of the next date for payment of interest on the relevant Covered Bonds, the Issuer is or would be required to pay additional amounts as provided or referred to in Condition 8 (*Taxation*). Covered Bonds redeemed pursuant to this Condition 7.2 (*Redemption for taxation reasons*) will be redeemed at their Early Redemption Amount referred to in Condition 7.6 (*Early Redemption Amounts*) together (if appropriate) with interest accrued to (but excluding) the date of redemption.

7.3 Redemption at the option of the Issuer (Issuer Call)

If an issuer call is specified in the applicable Final Terms ("**Issuer Call**"), the Issuer may (to the extent funds are available for such purpose), having given:

- (i) not less than 15 nor more than 60 days' notice to the Covered Bondholders in accordance with Condition 17 below with a copy of such notice to be provided to the Trustee; and
- (ii) not less than 5 days before the giving of the notice referred to in (i), notice to the Trustee and the Principal Paying Agent,

which notice shall be irrevocable and shall specify the date fixed for redemption (the "**Optional Redemption Date**"), redeem all or some only of the Covered Bonds then outstanding on any Optional Redemption Date and at the "**Optional Redemption Amount(s)**" specified in, or determined in the manner specified in, the applicable Final Terms together, if applicable, with interest accrued to (but excluding) the relevant Optional Redemption Date. Upon expiry of such notice, the Issuer shall redeem the Covered Bonds accordingly. Any such redemption must be for an amount not less than the Minimum Redemption Amount and not more than the Maximum Redemption Amount (if any) as specified in the applicable Final Terms. In the case of a partial redemption of Covered Bonds, the Covered Bonds to be redeemed (the "**Redeemed Covered Bonds**") will be selected individually by lot, in the case of Redeemed Covered Bonds represented by Definitive Covered Bonds, and in accordance with the rules of Euroclear and/or Clearstream, Luxembourg, (to be reflected in the records of Euroclear and Clearstream, Luxembourg as either a pool factor or a reduction in nominal amount, at their discretion) in the case of Redeemed Covered Bonds represented by a Global Covered Bond, in each case, not more than 30 days prior to the date fixed for redemption (such date of selection being hereinafter called the "**Selection Date**"). In the case of Redeemed Covered Bonds represented by Definitive Covered Bonds, a list of the serial numbers of such Redeemed Covered Bonds will be published in accordance with Condition 17 (*Notices*) not less than 15 days (or such shorter period as may be specified in the applicable Final Terms) prior to the date fixed for redemption. The aggregate nominal amount of Redeemed Covered Bonds represented by Definitive Covered Bonds or represented by Global Covered Bonds shall, in each case, bear the same proportion to the aggregate nominal amount of all Redeemed Covered Bonds as the aggregate nominal amount of Definitive Covered Bonds or Global Covered Bonds outstanding bears, in each case, to the aggregate nominal amount of the Covered Bonds outstanding on the Selection Date, provided that such nominal amounts shall, if necessary, be rounded downwards to the nearest integral multiple of the Specified Denomination. No exchange of the relevant Global Covered Bond will be permitted during the period from (and including) the Selection Date to (and including) the date fixed for redemption pursuant to this Condition 7.3 and notice to that effect shall be given by the Issuer to the Covered Bondholders in accordance with Condition 17 (*Notices*) at least five days (or such shorter period as is specified in the applicable Final Terms) prior to the Selection Date.

7.4 Redemption at the option of the Covered Bondholders (Investor Put)

- (i) If an investor put is specified in the Final Terms (the "**Investor Put**"), then if and to the extent specified in the applicable Final Terms, upon the holder of this Covered

Bond giving to the Issuer not less than 30 nor more than 60 days' (or such other notice period specified in the applicable Final Terms) notice (which notice shall be irrevocable), the Issuer will, upon the expiry of such notice, redeem subject to, and in accordance with, the terms specified in the applicable Final Terms, such Covered Bond on the Optional Redemption Date and at the relevant Optional Redemption Amount as specified in, or determined in the manner specified in, the applicable Final Terms, together, if applicable, with interest accrued to (but excluding) the relevant Optional Redemption Date.

- (ii) (a) If this Covered Bond is in definitive form, to exercise the right to require redemption of this Covered Bond, the holder of this Covered Bond must deliver such Covered Bond, on any Business Day (as defined in Condition 5.4) falling within the above-mentioned notice period at the specified office of any Paying Agent, accompanied by a duly signed and completed notice of exercise of the Investor Put in the form (for the time being current) obtainable from any specified office of any Paying Agent (a "**Put Notice**") and in which the holder must specify a bank account (or, if payment is by cheque, an address) to which payment is to be made under this Condition 7.4; and (b) if this Covered Bond is represented by a Global Covered Bond or is in definitive form and held through Euroclear or Clearstream, Luxembourg, to exercise the right to require redemption of this Covered Bond the holder of this Covered Bond must, within the notice period, give notice to the Principal Paying Agent of such exercise in accordance with the standard procedures of Euroclear or Clearstream, Luxembourg (which may include notice being given on his instruction by Euroclear, Clearstream, Luxembourg or any depositary for them to the Principal Paying Agent by electronic means) in a form acceptable to Euroclear and Clearstream, Luxembourg from time to time.
- (iii) Any Put Notice given by a Covered Bondholder of any Covered Bond pursuant to this Condition shall be irrevocable.

It may be that before an Investor Put can be exercised, certain conditions and/or circumstances will need to be satisfied. Where relevant, the provisions will be set out in the applicable Final Terms.

7.5 Repurchase by the Issuer at the option of the Covered Bondholders (Investor Repurchase Put)

- (i) (a) If an investor Repurchase Put is specified in the Final Terms (the "**Investor Repurchase Put**"), then if and to the extent that the Issuer does not redeem the Covered Bonds in full on the Final Maturity Date (taking into account any applicable grace periods), upon the holder of this Covered Bond giving to the Issuer not less than 30 nor more than 60 days' notice (which notice shall be irrevocable), the Issuer will, upon the expiry of such notice, be required to purchase such Covered Bond on

the date specified in such notice (the "**Repurchase Date**") and at the relevant Optional Redemption Amount as specified in, or determined in the manner specified in, the applicable Final Terms, together, if applicable, with interest accrued to (but excluding) the relevant Repurchase Date.

(b) If this Covered Bond is in definitive form, to exercise the right to require redemption of this Covered Bond, the holder of this Covered Bond must deliver such Covered Bond, on any Business Day (as defined in Condition 5.5) falling within the above-mentioned notice period at the specified office of any Paying Agent, accompanied by a duly signed and completed notice of exercise of the Investor Repurchase Put in the form (for the time being current) obtainable from any specified office of any Paying Agent (a Put Notice) and in which the holder must specify a bank account (or, if payment is by cheque, an address) to which payment is to be made under this Condition 7.5.

(c) Any notice given by a Covered Bondholder of any Covered Bond pursuant to this Condition shall be irrevocable.

Any failure by the Issuer to repurchase Covered Bonds pursuant to this Condition shall not constitute an Event of Default (but, for the avoidance of doubt, will constitute an Issuer Event).

7.6 *Early Redemption Amounts*

For the purpose of Condition 7.1 (*Final redemption*), Condition 7.2 (*Redemption for taxation reasons*) and Condition 10 (*Events of Default and Enforcement*), each Covered Bond will be redeemed at the Early Redemption Amount calculated as follows:

- (i) in the case of a Covered Bond with a Final Redemption Amount equal to the Issue Price, at the Final Redemption Amount thereof;
- (ii) in the case of a Zero Coupon Covered Bond, at an amount (the "**Amortised Face Amount**") equal to the sum of:
 - (A) the Reference Price; and
 - (B) the product of the Accrual Yield (compounded annually) being applied to the Reference Price from (and including) the Issue Date of the first Tranche of the Covered Bonds to (but excluding) the date fixed for redemption or (as the case may be) the date upon which such Covered Bond becomes due and repayable.

Where such calculation in paragraph (ii) above is to be made for a period which is not a whole number of years, it shall be made (A) in the case of a Zero Coupon Covered Bond payable in a

Specified Currency other than euro, on the basis of a 360-day year consisting of 12 months of 30 days each, or (B) in the case of a Zero Coupon Covered Bond payable in euro, on the basis of the actual number of days elapsed divided by 365 (or, if any of the days elapsed falls in a leap year, the sum of (x) the number of those days falling in a leap year divided by 366 and (y) the number of those days falling in a non leap year divided by 365) or (C) on such other calculation basis as may be specified in the applicable Final Terms.

7.7 Purchases

The Issuer or any subsidiary of the Issuer may at any time purchase or otherwise acquire Covered Bonds (provided that, in the case of Bearer Definitive Covered Bonds, all unmatured Receipts, Coupons and Talons appertaining thereto are attached thereto or surrendered therewith) at any price in the open market either by tender or private agreement or otherwise. If purchases are made by tender, tenders must be available to all Covered Bondholders alike. Such Covered Bonds may be held, reissued, resold or, at the option of the Issuer or the relevant subsidiary, surrendered to any Paying Agent and/or the Registrar for cancellation.

7.8 Cancellation

All Covered Bonds which are redeemed will forthwith be cancelled (together with, in the case of Bearer Definitive Covered Bonds, all unmatured Coupons and Talons attached thereto or surrendered therewith at the time of redemption). All Covered Bonds so cancelled and any Covered Bonds purchased and surrendered for cancellation pursuant to Condition 7.7 (*Purchases*) and cancelled (together with, in the case of Bearer Definitive Covered Bonds, all unmatured Receipts, Coupons and Talons cancelled therewith) shall be forwarded to the Principal Paying Agent and cannot be reissued or resold.

7.9 Late Payment

If any amount payable in respect of any Covered Bond is improperly withheld or refused upon its becoming due and repayable or is paid after its due date, the amount due and repayable in respect of such Covered Bond (the "**Late Payment**") shall, save in the case of Compounded Daily €STR for the purpose of Condition 5.2(b)(iii)(5) itself accrue interest (both before and after any judgment or other order of a court of competent jurisdiction) from (and including) the date on which such payment was improperly withheld or refused or, as the case may be, became due, to (but excluding) the Late Payment Date in accordance with the following provisions:

- (i) in the case of a Covered Bond other than a Zero Coupon Covered Bond at the rate determined in accordance with Condition 5.1 (*Interest on Fixed Rate Covered Bonds*) or 5.2 (*Floating Rate Covered Bond*), as the case may be; and
- (ii) in the case of a Zero Coupon Covered Bond, at a rate equal to the Accrual Yield;

in each case on the basis of the Day Count Fraction specified in the applicable Final Terms or, if none is specified, on a 30/360 basis.

For the purpose of this Condition 7.9, the **Late Payment Date** shall mean the earlier of:

- (i) the date which the Principal Paying Agent determines to be the date on which, upon further presentation of the relevant Covered Bond, payment of the full amount (including interest as aforesaid) in the relevant currency in respect of such Covered Bond is to be made; and
- (ii) the seventh day after notice is given to the relevant Covered Bondholder (whether individually or in accordance with Condition 17 (*Notices*)) that the full amount (including interest as aforesaid) in the relevant currency in respect of such Covered Bond is available for payment,

provided that in the case of both (i) and (ii), upon further presentation thereof being duly made, such payment is made.

7.10 General

Prior to the publication of any notice of redemption pursuant to Condition 7.2 (Redemption for taxation reasons) or Condition 7.3 (Redemption at the option of the Issuer (Issuer Call)), and provided that the Issuer is not the sole Covered Bondholder of the Covered Bonds being so redeemed, the Issuer shall deliver to the Trustee a certificate signed by two authorised signatories (at the relevant time) of the Issuer stating that the Issuer is entitled or required to effect such redemption and setting forth a statement of facts showing that the conditions set out in Condition 7.2 (Redemption for taxation reasons) or Condition 7.3 (Redemption at the option of the Issuer (Issuer Call)) for such right or obligation (as applicable) of the Issuer to arise have been satisfied and that the Issuer will have the funds, not subject to the interests of any other persons, required to fulfil its obligations hereunder in respect of the Covered Bonds and any amounts required under the Servicing and Cash Management Deed and/or the Deed of Charge to be paid *pari passu* with, or in priority to, the Covered Bonds and the Trustee shall be entitled to accept the certificate as sufficient evidence of the satisfaction of the conditions set out above, in which event it shall be conclusive and binding on all Covered Bondholders and Couponholders.

8 Taxation

- (a) All payments of principal and interest (if any) in respect of the Covered Bonds, the Receipts and the Coupons (if any) by or on behalf of the Issuer shall be made free and clear of, and without withholding or deduction for, any taxes, duties, assessments or governmental charges of whatsoever nature imposed, levied, collected, withheld or assessed by the Hellenic Republic or any political subdivision or any authority thereof or therein having power to tax, unless such withholding or deduction is required by law. Neither the Issuer

nor any other entity shall be obliged to pay any additional amount to any Covered Bondholder on account of such withholding or deduction.

- (b) If the Issuer becomes subject at any time to any taxing jurisdiction other than the Hellenic Republic, references in the Conditions to the Hellenic Republic shall be construed as references to the Hellenic Republic and/or such other jurisdiction.

9 Issuer Events

Prior to, or concurrent with the occurrence of an Event of Default, if any of the following events (each, an "**Issuer Event**") occurs:

- (i) an Issuer Insolvency Event (as defined below) (except, for the avoidance of doubt, that the occurrence of any event specified under paragraph (v) of such definition shall not give rise to an Issuer Event);;
- (ii) the Issuer fails to pay any amount of principal due and payable on the Covered Bonds of any Series (which shall for these purposes be deemed to include a failure by the Issuer to pay any amount representing the Final Redemption Amount on the Final Maturity Date of the Covered Bonds of that Series notwithstanding that the relevant Series of Covered Bonds has an Extended Final Maturity Date) within a period of seven Athens Business Days or if the Issuer fails to pay interest in respect of the Covered Bonds of any Series within a period of seven Athens Business Days from the due date thereof or if the Issuer fails to repurchase the Covered Bonds pursuant to Condition 7.5;
- (iii) the Issuer defaults in the performance or observance of any of its other obligations under or in respect of the Covered Bonds, Receipts or Coupons of any Series and such default has a materially prejudicial effect on the interests of the Covered Bondholders (in the opinion of the Trustee, acting reasonably) remains unremedied for 30 days after written notice thereof has been delivered by the Trustee to the Issuer requiring the same to be remedied;
- (iv) the repayment of any indebtedness owing by the Issuer is accelerated by reason of default and such acceleration has not been rescinded or annulled, or the Issuer defaults (after whichever is the longer of any originally applicable period of grace and 14 days after the due date) in any payment of any indebtedness or in the honouring of any guarantee or indemnity in respect of any indebtedness, provided that no such event shall constitute an Issuer Event unless the indebtedness whether alone or when aggregated with other indebtedness relating to all (if any) other such events which shall have occurred and be continuing shall exceed €15,000,000 (or its equivalent in any other currency or currencies) or, if higher, a sum equal to 0.025 per cent. of the gross consolidated assets of the Issuer and its Subsidiaries as shown

by the then latest published audited consolidated balance sheet of the Issuer and its Subsidiaries; or

- (v) there is a breach of a Statutory Test on an Applicable Calculation Date and such breach is not remedied within five Athens Business Days,

then (i) no further Covered Bonds will be issued, (ii) the Servicer (and the Issuer to the extent that the Issuer is no longer the Servicer) will procure that any and all payments due from the Borrowers under the Cover Pool Assets (excluding any Subsidy Payments) are effected henceforth directly into the relevant Third Party Collection Account and that all such amounts (including the Subsidy Payments) are transferred into the corresponding Transaction Account within three Athens Business Day of receipt, (iii) all collections of principal and interest on the Cover Pool Assets will be dedicated exclusively to the payment of interest and repayment of principal on the Covered Bonds and to the fulfilment of the obligations of the Issuer *vis-à-vis* the Secured Creditors in accordance with the relevant Priority of Payments, (iv) all payments of interest on the Covered Bonds will be credited on the Accumulation Ledger pursuant to the Servicing and Cash Management Deed, (v) if Eurobank is then the Servicer, its appointment as the Servicer will be terminated and a Replacement Servicer will be appointed pursuant to the terms of the Servicing and Cash Management Deed and the Secondary Covered Bond Legislation, (vi) if the Issuer Event is also an Issuer Insolvency Event, a Special Administrator will be appointed pursuant to the terms of the Servicing and Cash Management Deed and the Greek Covered Bond Legislation and (vii) if the issuer Event is not an Issuer Insolvency Event, the Servicer or, as applicable, the Replacement Servicer appointed pursuant to the Servicing and Cash Management Deed and the Covered Bond Legislation will be required to try and sell Selected Loans in accordance with the provisions of the Servicing and Cash Management Deed.

"Issuer Insolvency Event" means, in respect of the Issuer:

- (i) any order shall be made by any competent court or resolution passed for the winding-up or dissolution of the Issuer (other than for the purpose of amalgamation, merger or reconstruction on terms approved by an Extraordinary Resolution of the Covered Bondholders of all Series taken together as a single Series and converted into Euro at either the relevant Covered Bond Swap Rate (if applicable) or the Established Rate); or
- (ii) the Issuer shall cease to carry on the whole or substantially the whole of its business (other than for the purpose of an amalgamation, merger or reconstruction on terms approved by an Extraordinary Resolution of the Covered Bondholders of all Series taken together as a single Series and converted into Euro at either the relevant Covered Bond Swap Rate (if applicable) or the Established Rate); or

- (iii) the Issuer shall stop payment or shall be unable to, or shall admit inability to, pay its debts as they fall due, or shall be adjudicated or found insolvent by a court of competent jurisdiction or shall make a conveyance or assignment for the benefit of, or shall enter into any composition or other arrangement with, its creditors generally; or
- (iv) a receiver, trustee or other similar official shall be appointed in relation to the Issuer or in relation to the whole or over half of the assets of the Issuer, or an interim supervisor of the Issuer is appointed or an encumbrancer shall take possession of the whole or over half of the assets of the Issuer, or a distress or execution or other process shall be levied or enforced upon or sued out against the whole or a substantial part of the assets of the Issuer and in any of the foregoing cases it or he shall not be discharged within 60 days; or
- (v) the assessment by the Bank of Greece that the conditions of article 32 of Greek law 4335/2015 apply or the imposition on the Issuer of resolution measures in accordance with articles 37ff of article 2 of Greek Law 4335/2015; or
- (vi) a supervisor (in Greek Epitropos) of the Issuer is appointed in accordance with article 137 of Greek Law 4261/2014 or Issuer is placed under special liquidation in accordance with article 145 of Greek Law 4261/2014; or
- (vii) any action or step is taken which has a similar effect to the foregoing,

in each case, other than where any of the events set out in (i) to (vii) above occurs in connection with a substitution in accordance with Condition 18 and Clause 20 of the Trust Deed.

"Subsidiary" means, in respect of the Issuer at any particular time, any other entity:

- (i) whose affairs and policies the Issuer controls or has the power to control, whether by ownership of share capital, contract, the power to appoint or remove members of the governing body of such entity or otherwise; or
- (ii) whose financial statements are, in accordance with applicable law and generally accepted accounting principles or standards, consolidated with those of the Issuer.

10 Events of Default and Enforcement

10.1 Events of Default

If any of the following events occurs, and is continuing:

- (a) on the Extended Final Maturity Date in respect of any Series of Covered Bonds or on any Interest Payment Date or any earlier date for redemption on which principal thereof is due and repayable, there is a failure to pay any amount of principal due on such Covered Bonds

on such date and such default is not remedied within a period of 14 days from the due date thereof; or

- (b) on any Interest Payment Date, a default in the payment of the amount of interest due on any Series of Covered Bonds occurs and such default is not remedied within a period of 14 days from the due date thereof,

then the Trustee shall, upon receiving notice in writing from the Issuer, the Principal Paying Agent or any Covered Bondholder of such Event of Default, serve a notice (a "**Notice of Default**") on the Issuer.

Following the service of a Notice of Default, the Covered Bonds of each Series shall become immediately due and payable.

10.2 Enforcement

The Trustee may at any time, at its discretion and without notice, take such proceedings or steps or exercise rights or powers under or in connection with the Trust Deed, the Deed of Charge, the Covered Bonds or any other Transaction Document against the Issuer and/or any other person as it may think fit to enforce the provisions of the Deed of Charge, the Trust Deed, the Covered Bonds or any other Transaction Document in accordance with its terms and the pledge created under the Greek Covered Bond Legislation and may, at any time after the Security has become enforceable, take such proceedings or steps as it may think fit to enforce the Security, but it shall not be bound to take any such proceedings or steps or exercise such rights or powers unless (i) (A) it shall have been so directed by an Extraordinary Resolution of the Covered Bondholders of all Series (with the Covered Bonds of all Series taken together as a single Series and converted into Euro at the relevant Covered Bond Swap Rate) or (B) a request in writing by the holders of not less than 25 per cent. of the aggregate Principal Amount Outstanding of the Covered Bonds of all Series then outstanding (with the Covered Bonds of all Series taken together as a single Series and converted into Euro at the relevant Covered Bond Swap Rate) (if applicable) or the Established Rate, and (ii) it shall have been indemnified and/or secured and/or pre-funded to its satisfaction.

In exercising any of its powers, trusts, authorities and discretions under this Condition 10.2 the Trustee shall only have regard to the interests of the Covered Bondholders of all Series taken equally and shall not have regard to the interests of any individual Covered Bondholders (whatever their number) or any other Secured Creditors.

No Covered Bondholder or Couponholder shall be entitled to proceed directly against the Issuer or to take any action with respect to the Trust Deed, any other Transaction Document, the Covered Bonds, the Coupons, or the Security unless the Trustee, having become bound so to proceed, (i) fails so to do within a reasonable period or (ii) is unable so to do and such failure or inability shall be continuing.

11 Prescription

Claims against the Issuer for payment of principal and interest in respect of the Covered Bonds (whether in bearer or registered form) will be prescribed and become void unless made, in the case of principal, within ten years or, in the case of interest, five years after the Relevant Date.

There shall not be included in any Coupon sheet issued on exchange of a Talon any Coupon the claim for paying in respect of which would be void pursuant to this Condition 11 or Condition 6 (*Payments*).

As used herein, the "**Relevant Date**" means the date on which payment in respect of the Covered Bond or Coupon first becomes due and payable but, if the full amount of the moneys payable on such date has not been received by the Principal Paying Agent on or prior to such date, the Relevant Date shall be the date on which such moneys shall have been so received and notice to that effect has been given to Covered Bondholders in accordance with Condition 17 (*Notices*).

12 Replacement of Covered Bonds, Coupons and Talons

If any Covered Bond or Coupon is lost, stolen, mutilated, defaced or destroyed, it may be replaced at the specified office of the Principal Paying Agent (in the case of Bearer Covered Bonds or Coupons) or the Registrar (in the case of Registered Covered Bonds), or any other place approved by the Trustee, of which notice shall be given to the Covered Bondholders in accordance with Condition 17 (and, if the Covered Bonds are then listed on any stock exchange which requires the appointment of an Agent in any particular place, the Paying Agent having its specified office in the place required by such stock exchange), subject to all applicable laws and stock exchange requirements, upon payment by the claimant of the expenses incurred in connection with such replacement and on such terms as to evidence, security, indemnity and otherwise as the Issuer may reasonably require. Mutilated or defaced Covered Bonds, Talons or Coupons must be surrendered before replacements will be issued.

13 Exchange of Talons

On and after the Interest Payment Date on which the final Coupon comprised in any Coupon sheet matures, the Talon (if any) forming part of such Coupon sheet may be surrendered at the specified office of the Principal Paying Agent or any other Paying Agent in exchange for a further Coupon sheet including (if such further Coupon sheet does not include Coupons to (and including) the final date for the payment of interest due in respect of the Covered Bond to which it appertains) a further Talon, subject to the provisions of Condition 11 (*Prescription*). Each Talon shall, for the purposes of these Conditions, be deemed to mature on the Interest Payment Date on which the final Coupon comprised in the relevant Coupon sheet matures.

14 Trustee and Agents

- (a) In acting under the Agency Agreement and in connection with the Covered Bonds and the Coupons, the Agents act solely as agents of the Issuer (or, in the circumstances specified in the Agency Agreement, the Trustee) and do not assume any obligations towards or relationship of agency or trust for or with any of the Covered Bondholders or Couponholders.
- (b) The initial Agents and their initial specified offices are set forth in the Base Prospectus and in the Master Definitions and Construction Schedule. If any additional agents are appointed in connection with any series, the names of such Agents will be specified in Part B of the applicable Final Terms. The initial Calculation Agent (if any) is specified in the relevant Final Terms. The Issuer reserves the right at any time with the prior written consent of the Trustee to vary or terminate the appointment of any Agent and to appoint a successor Principal Paying Agent or Calculation Agent and additional or successor paying agents *provided, however, that*:
 - (i) so long as the Covered Bonds are listed on the Official List of the Luxembourg Stock Exchange and admitted to trading on the Luxembourg Stock Exchange's Euro MTF market and/or any stock exchange or admitted to listing by any other relevant authority (not being any market in the EEA which has been designated as a regulated market for the purposes of MiFID II) there will at all times be a Paying Agent (which may be the Principal Paying Agent), in the case of Covered Bonds, with a specified office in such place as may be required by the rules and regulations of such stock exchange or other relevant authority;
 - (ii) if a Calculation Agent is specified in the relevant Final Terms, the Issuer (or following the occurrence of an Issuer Event, the Servicer) shall at all times maintain a Calculation Agent; and
 - (iii) if and for so long as the Covered Bonds are listed on the Official List of the Luxembourg Stock Exchange and admitted to trading on the Luxembourg Stock Exchange's Euro MTF market and/or any stock exchange (not being any stock exchange in the EEA which has been designated as a regulated market for the purposes of MiFID II) which requires the appointment of an Agent in any particular place, the Issuer (or following the occurrence of an Issuer Event, the Servicer) shall maintain an Agent having its specified office in the place required by such stock exchange.

Notice of any variation, termination, appointment or change in any of the Agents or in their specified offices shall promptly be given by the Issuer to the Covered Bondholders by the Issuer in accordance with Condition 17 (*Notices*).

- (c) Under the Trust Deed and the Deed of Charge, the Trustee is entitled to be indemnified and/or secured and/or pre-funded to its satisfaction and relieved from responsibility in certain circumstances and to be paid its remuneration, costs and expenses and all other liabilities in priority to the claims of the Covered Bondholders and the other Secured Creditors.
- (d) The Trustee will not be responsible for any loss, expense or liability, which may be suffered as a result of any Cover Pool Asset, or any deeds or documents of title thereto, being uninsured or inadequately insured or being held by organisations or their operators or by intermediaries such as banks, brokers or other similar persons on behalf of the Trustee. The Trustee will not be responsible for (a) supervising the performance of the Issuer, the Servicer or any other party to the Transaction Documents of their respective obligations under the Transaction Documents and the Trustee will be entitled to assume, until they each have written notice to the contrary, that all such persons are properly performing their duties; (b) considering the basis on which approvals or consents are granted by the Issuer or any other party to the Transaction Documents under the Transaction Documents; (c) monitoring the Cover Pool, including, without limitation, whether the Cover Pool is in compliance with the Statutory Tests or the Amortisation Test; or (d) monitoring whether Loan Assets satisfy the Eligibility Criteria. The Trustee will not be liable to any holder of the Covered Bonds or other Secured Creditor for any failure to make or to cause to be made on their behalf the searches, investigations and enquiries which would normally be made by a prudent charge in relation to the Security and have no responsibility in relation to the legality, validity, sufficiency and enforceability of the Security, the Covered Bonds and the Transaction Documents.

15 Meetings of Covered Bondholders, Modification and Waiver

- (a) *Meetings of Covered Bondholders:* The Trust Deed contains provisions for convening meetings of the Covered Bondholders of any Series to consider any matters affecting their interests, including the modification of any provision of these Conditions. Any such modification may be made if sanctioned by an Extraordinary Resolution. Such a meeting for the passing of a resolution which is not for the purpose of directing the Trustee to take enforcement action pursuant to Condition 10.2 (*Enforcement*) may be convened by the Issuer or the Trustee and shall be convened by the Issuer upon the request in writing signed by Covered Bondholders holding not less than one-tenth of the Principal Amount Outstanding of the Covered Bonds of the relevant Series. The quorum at any meeting convened to vote on an Extraordinary Resolution other than a Programme Resolution will be one or more persons holding or representing a clear majority of the aggregate Principal Amount Outstanding of the Covered Bonds of such Series or, at any adjourned meeting, one or more persons being or representing Covered Bondholders of such Series whatever the principal amount of the Covered Bonds of such Series held or represented; *provided,*

however, that Series Reserved Matters, as defined below and as described in the Trust Deed, may only be sanctioned by an Extraordinary Resolution passed at a meeting of Covered Bondholders of such Series at which one or more persons holding or representing not less than two-thirds of, or, at any adjourned meeting, not less than one-quarter, of the aggregate Principal Amount Outstanding of the Covered Bonds of such Series form a quorum. Any Extraordinary Resolution duly passed at any such meeting shall be binding on all the Covered Bondholders, Receiptholders and Couponholders of such Series, whether present or not.

Notwithstanding the provisions of the immediately preceding paragraph, any Extraordinary Resolution to direct the Trustee to take any enforcement action pursuant to Condition 10.2 (*Enforcement*) (each a "**Programme Resolution**") shall only be capable of being passed at a single meeting of the holders of the Covered Bonds of all Series then outstanding. Any such meeting to consider a Programme Resolution may be convened by the Issuer or the Trustee or by Covered Bondholders holding at least 25 per cent. of the aggregate Principal Amount Outstanding of the Covered Bonds of all Series then outstanding. The quorum at any such meeting for passing a Programme Resolution is one or more persons holding or representing a clear majority of the aggregate Principal Amount Outstanding of the Covered Bonds of all Series for the time being outstanding, or at any adjourned such meeting one or more persons holding or representing Covered Bonds whatever the nominal amount of the Covered Bonds of all Series then outstanding. A Programme Resolution passed at any meeting of the Covered Bondholders of all Series shall be binding on all Covered Bondholders of all Series, whether or not they are present at the meeting, and on all related Couponholders in respect of such Covered Bonds.

In connection with any meeting of the holders of Covered Bonds of more than one Series where any Series of such Covered Bonds is not denominated in Euro, the nominal amount of the Covered Bonds of such Series not denominated in Euro shall be deemed, for the purposes of such meeting, to be an amount in Euro equal to the Principal Amount Outstanding of such Covered Bonds converted into Euro at either the relevant Covered Bond Swap Rate (if applicable) or the Established Rate.

In addition, a resolution in writing signed by or on behalf of a clear majority of Covered Bondholders who for the time being are entitled to receive notice of a meeting of Covered Bondholders will take effect as if it were an Extraordinary Resolution. Such a resolution in writing may be contained in one document or several documents in the same form, each signed by or on behalf of one or more Covered Bondholders.

- (b) *Modification:* The Trustee may, without the consent or sanction of any of the Covered Bondholders or Couponholders of any Series, the related Receiptholders or any of the other Secured Creditors (other than the Hedging Counterparties in respect of a modification to the Pre-Event of Default Priority of Payments, the Post-Event of Default Priority of

Payments, the Conditions of the Covered Bonds, the Individual Eligibility Criteria or the Servicing and Cash Management Deed which in each case adversely affects their interests (such consent or sanction not to be unreasonably withheld or delayed)) at any time and from time to time concur with the Issuer and any other party in making or sanctioning any modification (i) (other than in respect of a Series Reserved Matter) of the terms and conditions applying to the Covered Bonds of one or more Series (including the Conditions), the related Receipts and/or Coupons, the Trust Presents and/or the other Transaction Documents provided that in the sole opinion of the Trustee such modification is not materially prejudicial to the interests of the Covered Bondholders of such Series or (ii) any modification of the terms and conditions applying to Covered Bonds of one or more Series (including the Conditions), the related Receipts and/or Coupons, the Trust Presents or the other Transaction Documents which in the sole opinion of the Trustee is of a formal, minor or technical nature or is to correct a manifest error, and, in each case, the Issuer has confirmed in writing to the Trustee that such modification will not adversely affect the then current ratings of the Covered Bonds.

In respect of a modification to the Pre-Event of Default Priority of Payments, the Post-Event of Default Priority of Payments, the Conditions of the Covered Bonds, the Individual Eligibility Criteria or the Servicing and Cash Management Deed, the Issuer shall be obliged to provide the Trustee with the prior written consent of the Swap Providers.

Any such modification may be made on such terms and subject to such conditions (if any) as the Trustee may determine, shall be binding upon the Covered Bondholders, the related Receiptholders and/or the Couponholders and the other Secured Creditors and, unless the Trustee otherwise agrees, shall be notified by the Issuer (i) to the Covered Bondholders in accordance with Condition 17 (Notices), (ii) to the Rating Agencies and (iii) each of the other Secured Creditors in accordance with the Deed of Charge as soon as practicable thereafter.

"Series Reserved Matter" means, in relation to Covered Bonds of a Series:

- (i) reduction or cancellation of the amount payable or, where applicable, modification of the method of calculating the amount payable or modification of the date of payment or, where applicable, modification of the method of calculating the date of payment in respect of any principal or interest in respect of the Covered Bonds other than in accordance with the terms thereof;
- (ii) alteration of the currency in which payments under the Covered Bonds, Receipts and Coupons are to be made other than in accordance with Condition 6.8 (*Redenomination*);
- (iii) alteration of the quorum or majority required to pass an Extraordinary Resolution;

- (iv) the sanctioning of any such scheme or proposal for the exchange or sale of the Covered Bonds for or the conversion of the Covered Bonds into, or the cancellation of the Covered Bonds in consideration of, shares, stock, covered bonds, bonds, debentures, debenture stock and/or other obligations and/or securities of the Issuer or any other company formed or to be formed, or for or into or in consideration of cash, or partly for or into or in consideration of such shares, stock, bonds, covered bonds, debentures, debenture stock and/or other obligations; and
 - (v) alteration of this proviso or the proviso to paragraph 6 of Schedule 3 (Provisions for Meetings of Covered Bondholders) of the Trust Deed; and
 - (vi) alteration of this definition of Series Reserved Matter.
- (c) The Trustee may without the consent of any of the Covered Bondholders of any Series, the related Receipholders and/or Couponholders and any Secured Creditors and without prejudice to its rights in respect of any subsequent breach, Issuer Event, Potential Event of Default or Event of Default from time to time and at any time but only if in so far as in its opinion the interests of the Covered Bondholders of any Series shall not be materially prejudiced thereby, waive or authorise any breach or proposed breach by the Issuer of any of the covenants or provisions contained in the Trust Presents or the other Transaction Documents or determine that any Issuer Event, Potential Event of Default or Event of Default shall not be treated as such for the purposes of the Trust Presents PROVIDED ALWAYS THAT the Trustee shall not exercise any powers conferred on it by this Condition 15(c) in contravention of any express direction given by Extraordinary Resolution or by a request under Condition 10 (*Events of Default*) but so that no such direction or request shall affect any waiver, authorisation or determination previously given or made. Any such waiver, authorisation or determination may be given or made on such terms and subject to such conditions (if any) as the Trustee may determine, shall be binding on the Covered Bondholders, the related Receipholders and/or the Couponholders and, if, but only if, the Trustee shall so require, shall be notified by the Issuer (i) to the Covered Bondholders in accordance with Condition 17 (*Notices*), (ii) to the Rating Agencies and (iii) each of the other Secured Creditors in accordance with the Deed of Charge as soon as practicable thereafter.

The Trustee shall be bound to waive or authorise any breach or proposed breach by the Issuer of any of the covenants or provisions contained in the Trust Presents or the other Transaction Documents or determine that any Issuer Event or Potential Event of Default or Event of Default shall not be treated as such for the purposes of the Trust Presents if it is (i) so directed by an Extraordinary Resolution (in the case of any such waiver, authorisation or determination, with the Covered Bonds of all Series taken together as a single Series as provided in the Trust Deed and, if applicable, converted into Euro at the relevant Covered Bond Swap Rate) or (ii) requested to do so in writing by the holders of not less than

twentyfive per cent. of the aggregate Principal Amount Outstanding of the Covered Bonds then outstanding (in the case of any such determination, with the Covered Bonds of all Series taken together as a single Series and, if applicable, converted into Euro as aforesaid), and at all times then only if it shall first be indemnified and/or secured and/or pre-funded to its satisfaction against all Liabilities to which it may thereby render itself liable or which it may incur by so doing.

- (d) Notwithstanding the provisions of this Condition 15, the Trustee shall be obliged, without any consent or sanction of the Covered Bondholders of any Series and/or the Couponholders and/or Receiptholders and without the consent of the Secured Creditors, to concur with the Issuer in making any modification (other than in respect of a Series Reserved Matter), for the avoidance of doubt irrespective of whether such modification is materially prejudicial to the interests of the Covered Bondholders of any Series, to the terms and conditions applying to the Covered Bonds of one or more Series (including the Conditions), the related Coupons or any Transaction Document for the purpose of complying with, or implementing or reflecting, any change in the criteria of one or more of the Rating Agencies which may be applicable from time to time, provided that in relation to any amendment under this Condition 15, the Issuer certifies in writing to the Trustee (upon which certificate the Trustee may rely without liability or inquiry) that such modification is necessary to comply with such criteria or, as the case may be, is solely to implement and reflect such criteria and the Issuer either:
- (i) has obtained from each of the Rating Agencies written confirmation (or certifies in writing to the Trustee (upon which certificate the Trustee may rely absolutely without liability or inquiry) that it has been unable to obtain written confirmation, but has received oral confirmation from an appropriately authorised person at each of the Rating Agencies) that such modification would not result in a downgrade, withdrawal or suspension of the then current ratings assigned to the Covered Bonds by such Rating Agency and would not result in any Rating Agency placing any Series of Covered Bonds on rating watch negative (or equivalent) and, if relevant, delivers a copy of each such confirmation to the Trustee; or
 - (ii) certifies in writing to the Trustee (upon which certificate the Trustee may rely absolutely without liability or inquiry) that the Rating Agencies have been informed of the proposed modification and none of the Rating Agencies has indicated that such modification would result in a downgrade, withdrawal or suspension of the then current ratings assigned to the Covered Bonds by such Rating Agency or such Rating Agency placing any Covered Bonds on rating watch negative (or equivalent).

16 Further Issues

The Issuer may from time to time, without the consent of the Covered Bondholders or the Couponholders or any other Secured Creditor, create and issue further Covered Bonds having the same terms and conditions as the Covered Bonds in all respects (or in all respects except for the first payment of interest thereon, issue date and/or issue price) so as to form a single series with the Covered Bonds provided that (i) there is no Issuer Event or Event of Default outstanding and that such issuance would not cause an Issuer Event or an Event of Default, (ii) such issuance would not result in a breach of any of the Statutory Tests, (iii) the Rating Agencies have been notified of such issuance, (iv) such issuance has been notified to or (in the case of material amendments to the Programme) approved by the Bank of Greece in accordance with Article 20(4) of the Covered Bond Law and (v) if applicable, in respect of any Series or Tranche, a Hedging Agreement is entered into.

17 Notices

All notices regarding the Bearer Covered Bonds will be valid if published in one leading English language daily newspaper of general circulation in London or any other daily newspaper in London approved by the Trustee and (for so long as any Bearer Covered Bonds are listed on the official list of the Luxembourg Stock Exchange) if published in a daily newspaper of general circulation in Luxembourg or on the website of the Luxembourg Stock Exchange www.luxse.com. It is expected that such publication will be made in the Financial Times in London and (in relation to Bearer Covered Bonds listed on the official list of the Luxembourg Stock Exchange) in the *Luxemburger Wort* or the *Tageblatt* in Luxembourg. The Issuer or, in the case of a notice given by the Trustee, the Trustee shall also ensure that notices are duly published in a manner which complies with the rules and regulations of the Luxembourg Stock Exchange and/or any stock exchange or any other relevant authority on which the Bearer Covered Bonds are for the time being listed. Any such notice shall be deemed to have been given on the date of first publication (or if required to be published in more than one newspaper, on the first date on which publication shall have been made in all the required newspapers or where published in such newspapers on different dates, the last date of such first publication). If publication as provided above is not practicable, notice will be given in such other manner, and will be deemed to have been given on such date, as the Trustee shall approve.

All notices regarding the Registered Covered Bonds will be deemed to be validly given if sent by first class mail or (if posted to an address overseas) by airmail to the holders (or the first named of joint holders) at their respective addresses recorded in the Register and will be deemed to have been given on the fourth day after mailing and, in addition, for so long as any Registered Covered Bonds are listed, quoted or traded on a stock exchange or are admitted to listing or trading by another relevant authority and the rules of that stock exchange or relevant authority so require, such notice will be published in a daily newspaper of general circulation in the place or places required by those rules. Any such notice will be deemed to have been given on the date of such

publication. If the giving of notice as provided above is not practicable, notice will be given in such other manner, and will be deemed to have been given on such date, as the Trustee shall approve.

Couponholders shall be deemed for all purposes to have notice of the contents of any notice given to the Bearer Covered Bondholders.

Notices to be given by any Covered Bondholder shall be in writing and given by lodging the same, together (in the case of any Covered Bond in definitive form) with the relevant Covered Bond or Covered Bonds, with the Principal Paying Agent.

Whilst the Covered Bonds are represented by Global Covered Bonds any notice shall be deemed to have been duly given to the relevant Covered Bondholder if sent to the Clearing Systems for communication by them to the holders of the Covered Bonds and shall be deemed to be given on the date on which it was so sent and (so long as the relevant Covered Bonds are admitted to trading on, and listed on the official list of, the Luxembourg Stock Exchange), any notice shall also be published in accordance with the relevant listing rules (which includes publication on the website of the Luxembourg Stock Exchange, www.luxse.com).

18 Substitution of the Issuer

- (a) If so requested by the Issuer, the Trustee may, without the consent of any Covered Bondholder or Couponholder or any other Secured Creditor, agree with the Issuer to the substitution in place of the Issuer (or of the previous substitute under this Condition) as the principal debtor under the Trust Presents and all other Transaction Documents (the "**New Company**") upon notice by the Issuer and the New Company to be given to the Covered Bondholders and the other Secured Creditors in accordance with Condition 17 (*Notices*), *provided that*:
- (i) the Issuer is not in default in respect of any amount payable under the Covered Bonds;
 - (ii) the Issuer and the New Company have entered into such documents (the "**Documents**") as are necessary, in the opinion of the Trustee, to give effect to the substitution and in which the New Company has undertaken in favour of each Covered Bondholder to be bound by these Conditions and the provisions of the Trust Deed as the debtor in respect of the Covered Bonds in place of the Issuer (or of any previous substitute under this Condition 18 (*Substitution of the Issuer*));
 - (iii) if the New Company is resident for tax purposes in a territory (the "**New Residence**") other than that in which the Issuer prior to such substitution was resident for tax purposes (the "**Former Residence**"), the Documents contain an undertaking and/or such other provisions as may be necessary to ensure that each Covered Bondholder

has the benefit of an undertaking in terms corresponding to the provisions of this Condition 18 (*Substitution of the Issuer*), with the substitution of references to the Former Residence with references to the New Residence;

- (iv) the New Company and the Issuer have obtained all necessary governmental approvals and consents for such substitution and for the performance by the New Company of its obligations under the Transaction Documents;
- (v) without prejudice to the rights of reliance of the Trustee under the immediately following paragraph (vi), the Trustee is satisfied that the relevant transaction is not materially prejudicial to the interests of the Covered Bondholders of any Series;
- (vi) if two directors of the New Company (or other officers acceptable to the Trustee) have certified that the New Company is solvent both at the time at which the relevant transaction is proposed to be effected and immediately thereafter (which certificate the Trustee can rely on absolutely), the Trustee shall not be under any duty to have regard to the financial conditions, profits or prospect of the New Company or to compare the same with those of the Issuer;
- (vii) the rights of the Covered Bondholders and the other Secured Creditors in respect of the Cover Pool shall continue in full force and effect in relation to the obligations of the New Company;
- (viii) legal opinions in form and substance satisfactory to the Trustee shall have been delivered to the Trustee (with a copy of such legal opinions also to be provided to the Rating Agencies) from lawyers of recognised standing in the jurisdiction of incorporation of the New Company, in England and in Greece as to matters of law relating to the fulfilment of the requirements of this Condition 18 (*Substitution of the Issuer*) and that the Covered Bonds and any Coupons and/or Talons are legal, valid and binding obligations of the New Company;
- (ix) if Covered Bonds issued or to be issued under the Programme have been assigned a credit rating by any Rating Agency and the relevant Rating Agency has been notified of the proposed substitution and the Rating Agencies have not downgraded the Covered Bonds outstanding as a result of such substitution;
- (x) each stock exchange on which the Covered Bonds are listed shall have confirmed that, following the proposed substitution of the New Company, the Covered Bonds will continue to be listed on such stock exchange;
- (xi) if applicable, the New Company has appointed a process agent in England to receive service of process on its behalf in relation to any legal proceedings arising out of or in connection with the Covered Bonds and any Coupons; and

- (xii) Any such substitution will be notified and approved (if applicable) by the Bank of Greece in accordance with the Covered Bond Law.
- (b) Upon such substitution the New Company shall succeed to, and be substituted for, and may exercise every right and power, of the Issuer under the Covered Bonds, any Coupons and the Trust Deed with the same effect as if the New Company has been named as the Issuer herein, and the Issuer shall be released from its obligations under the Covered Bonds, any Coupons and/or Talons and under the Trust Deed.

After a substitution pursuant to Condition 18(a), the New Company may, without the consent of any Covered Bondholder or Couponholder, effect a further substitution. All the provisions specified in Conditions 18(a) and 18(b) shall apply *mutatis mutandis*, and references in these Conditions to the Issuer shall, where the context so requires, be deemed to be or include references to any such further New Company.

After a substitution pursuant to Condition 18(a) or 18(c), any New Company may, without the consent of any Covered Bondholder or Couponholder, reverse the substitution, *mutatis mutandis*.

The Transaction Documents shall be delivered to, and kept by, the Principal Paying Agent. Copies of the Transaction Documents will be available free of charge during normal business hours at the specified office of the Principal Paying Agent.

19 Renominalisation and Reconventioning

If the country of the Specified Currency becomes or, announces its intention to become, a participating Member State, the Issuer may, without the consent of the Covered Bondholders and Couponholders, on giving at least 30 days' prior notice to the Covered Bondholders and the Paying Agents, designate a date (the "**Redenomination Date**"), being an Interest Payment Date under the Covered Bonds falling on or after the date on which such country becomes a participating Member State to redenominate all, but not some only, of the Covered Bonds of any series.

20 Governing Law and Jurisdiction

The Covered Bonds and any non-contractual obligations arising out of or in connection with the Covered Bonds are governed by, and shall be construed in accordance with, English law, save that the security under the Statutory Pledge referred to in Condition 3 (*Status of the Covered Bonds*) above and under the Collections Account Pledge Agreement, shall be governed by, and construed in accordance with Greek law.

21 Submission to Jurisdiction

Subject to Condition 21(c) below, the English courts have exclusive jurisdiction to settle any dispute arising out of or in connection with the Covered Bonds and the Coupons, including any dispute as to their existence, validity, interpretation, performance, breach or termination or the consequences of their nullity and any dispute relating to any non-contractual obligations arising out of or in connection with the Covered Bonds and the Coupons (a “**Dispute**”) and accordingly each of the Issuer and the Trustee and the Covered Bondholders or Couponholders in relation to any Dispute submits to the exclusive jurisdiction of the English courts.

For the purposes of this Condition 21, the Issuer waives any objection to the English courts on the grounds that they are an inconvenient or inappropriate forum to settle any Dispute.

To the extent allowed by law, the Trustee, the Covered Bondholders and the Couponholders may, in respect of any Dispute or Disputes, take (i) proceedings in any other court with jurisdiction; and (ii) concurrent proceedings in any number of jurisdictions.

22 Appointment of Process Agent

The Issuer irrevocably appoints Eurobank Private Bank Luxembourg S.A., London Branch at Eurobank Private Bank Luxembourg S.A., London Branch, at 2nd Floor, Devonshire House, 1 Mayfair Place, London W1J 8AJ, United Kingdom (Attn.: Mr. Alexandros Tsourinakis), Email: ATsourinakis@eurobankpb.co.uk), as its agent for service of process in any proceedings before the English courts in relation to any Dispute, and agrees that, in the event of Eurobank Private Bank Luxembourg S.A., London Branch being unable or unwilling for any reason so to act, it will immediately appoint another person approved by the Trustee as its agent for service of process in England in respect of any Dispute. The Issuer agrees that failure by a process agent to notify it of any process will not invalidate service. Nothing herein shall affect the right to serve process in any other manner permitted by law.

23 Third Parties

No person shall have any right to enforce any term or condition of this Covered Bond under the Contracts (Rights of Third Parties) Act 1999.

FORMS OF THE COVERED BONDS

The Covered Bonds of each Series will be in either bearer form, with or without interest coupons and/or talons attached, or registered form, without interest coupons and/or talons attached. Bearer Covered Bonds will be issued outside the United States in reliance on Regulation S and Registered Covered Bonds may be issued outside the United States in reliance on Regulation S.

Bearer Covered Bonds

Each Tranche of Bearer Covered Bonds will be in bearer form initially issued in the form of a temporary global covered bond without receipts and interest coupons attached (a "**Temporary Global Covered Bond**") which will:

- (a) if the Bearer Global Covered Bonds (as defined below) are issued in new global covered bond ("**NGCB**") form, as stated in the applicable Final Terms, be delivered on or prior to the issue date of the relevant Tranche to a common safekeeper (the **Common Safekeeper**) for Euroclear Bank S.A./N.V. ("**Euroclear**") and Clearstream Banking, *société anonyme* ("**Clearstream, Luxembourg**"); and
- (b) if the Bearer Global Covered Bonds are not issued in NGCB form, be delivered on or prior to the issue date of the relevant Tranche to a common depositary (the "**Common Depositary**") for Euroclear and Clearstream, Luxembourg.

Bearer Covered Bonds will only be delivered outside the United States and its possessions.

Where the Global Covered Bonds issued in respect of any Tranche are in NGCB form, the applicable Final Terms will also indicate whether such Global Covered Bonds are intended to be held in a manner which would allow Eurosystem eligibility. Any indication that the Global Covered Bonds are to be so held does not necessarily mean that the Bearer Global Covered Bonds of the relevant Tranche will be recognised as eligible collateral for Eurosystem monetary policy and intra-day credit operations by the Eurosystem either upon issue or at any times during their life as such recognition depends upon satisfaction of the Eurosystem eligibility criteria. The common Safekeeper for NGCBs will either be Euroclear or Clearstream Luxembourg or another entity approved by Euroclear and Clearstream, Luxembourg, as indicated in the applicable Final Terms. Whilst any Bearer Covered Bond is represented by a Temporary Global Covered Bond, payments of principal, interest (if any) and any other amount payable in respect of the Bearer Covered Bonds due prior to the Exchange Date (as defined below) will be made (against presentation of the Temporary Global Covered Bond if the Temporary Global Covered Bond is not issued in NGCB form) only to the extent that certification (in a form to be provided by Euroclear and/or Clearstream, Luxembourg) to the effect that the beneficial owners of interests in such Bearer Covered Bond are not U.S. persons or persons who have purchased for resale to any U.S. person, as required by U.S. Treasury regulations, has been received by Euroclear and/or Clearstream, Luxembourg and Euroclear and/or Clearstream, Luxembourg, as applicable, has given a like certification (based on the certifications it has received) to the Principal Paying Agent.

On and after the date (the "**Exchange Date**") which is 40 days after a Temporary Global Covered Bond is issued, interests in such Temporary Global Covered Bond will be exchangeable (free of charge) upon a request as described therein either for (a) interests in a permanent global covered bond without interest coupons attached (a "**Permanent Global Covered Bond**" and, together with the Temporary Global Covered Bonds, the "**Bearer Global Covered Bonds**" and each a Bearer "**Global Covered Bond**") of the same Series or (b) for Definitive Covered Bonds of the same Series with, where applicable, receipts, interest coupons and talons attached (as indicated in the applicable Final Terms and subject, in the case of Bearer Definitive Covered Bonds, to such notice period as is specified in the applicable Final Terms), in each case against certification of non-U.S. beneficial ownership as described above unless such certification has already been given. Purchasers in the United States and certain United States persons will not be able to receive Bearer Definitive Covered Bonds or interests in the Permanent Global Covered Bond. The holder of a Temporary Global Covered Bond will not be entitled to collect any payment of interest, principal or other amount due on or after the Exchange Date unless, upon due certification, exchange of the Temporary Global Covered Bond for an interest in a Permanent Global Covered Bond or for Definitive Covered Bonds is improperly withheld or refused.

Payments of principal, interest (if any) or any other amounts on a Permanent Global Covered Bond will be made through Euroclear and/or Clearstream, Luxembourg against presentation or surrender (as the case may be) of the Permanent Global Covered Bond (if the Permanent Global Covered Bond is not issued in NGCB form) without any requirement for certification.

The applicable Final Terms will specify that a Permanent Global Covered Bond will be exchangeable (free of charge), in whole but not in part, for Bearer Definitive Covered Bonds with, where applicable, receipts, interest coupons and talons attached upon either (a) provided the Covered Bonds have a minimum Specified Denomination, or integral multiples thereof, not less than 60 days' written notice from Euroclear and/or Clearstream, Luxembourg (acting on the instructions of any holder of an interest in such Permanent Global Covered Bond) to the Principal Paying Agent as described therein or (b) upon the occurrence of an Exchange Event. For these purposes, "**Exchange Event**" means that (i) the Issuer has been notified that both Euroclear and Clearstream, Luxembourg have been closed for business for a continuous period of 14 days (other than by reason of holiday, whether statutory or otherwise) or have announced an intention permanently to cease business or have in fact done so and no successor clearing system is available or (ii) the Issuer has or will become subject to adverse tax consequences which would not be suffered were the Bearer Global Covered Bond (and any interests therein) exchanged for Bearer Definitive Covered Bonds. The Issuer will promptly give notice to Covered Bondholders of each Series of Bearer Global Covered Bonds in accordance with Condition 17 (*Notices*) if an Exchange Event occurs. In the event of the occurrence of an Exchange Event, Euroclear and/or Clearstream, Luxembourg (acting on the instructions of any holder of an interest in such Permanent Global Covered Bond) or the Trustee may give notice to the Principal Paying Agent requesting exchange and, in the event of the occurrence of an Exchange Event as described in (b)(ii) above, the Issuer may also give notice to the Principal Paying Agent requesting exchange. Any such exchange shall occur not later than 45 days after the date of receipt of the first relevant notice by the Principal Paying Agent.

Bearer Global Covered Bonds, Bearer Definitive Covered Bonds and any Coupons, Talons or Receipts attached thereto will be issued pursuant to the Trust Deed.

The following legend will appear on all Bearer Covered Bonds (other than Temporary Global Covered Bonds) talons and interest coupons relating to such Bearer Covered Bonds where TEFRA D is specified in the applicable Final Terms:

"ANY UNITED STATES PERSON WHO HOLDS THIS OBLIGATION WILL BE SUBJECT TO LIMITATIONS UNDER THE UNITED STATES INCOME TAX LAWS, INCLUDING THE LIMITATIONS PROVIDED IN SECTIONS 165(j) AND 1287(a) OF THE INTERNAL REVENUE CODE."

The sections referred to provide that United States holders, with certain exceptions, will not be entitled to deduct any loss on Bearer Covered Bonds, talons or interest coupons and will not be entitled to capital gains treatment of any gain on any sale or other disposition in respect of such Bearer Covered Bonds, talons or interest coupons.

Covered Bonds which are represented by a Bearer Global Covered Bond will only be transferable in accordance with the rules and procedures for the time being of Euroclear or Clearstream, Luxembourg, as the case may be.

Registered Covered Bonds

Registered Global Covered Bonds will be (a) if the applicable Final Terms specify the Registered Global Covered Bonds are intended to be held in a manner which would allow Eurosystem eligibility (being the new safekeeping structure (NSS)), deposited on the relevant Issue Date with the Common Safekeeper; or (b) if the applicable Final Terms specify the Registered Global Covered Bonds are not intended to be held in a manner which would allow Eurosystem eligibility, deposited on the relevant Issue Date with a nominee or Common Depository for Euroclear or Clearstream, Luxembourg, as applicable.

Any indication that the Registered Global Covered Bonds are to be held in a manner which would allow Eurosystem eligibility does not necessarily mean that the Registered Global Covered Bonds of the relevant Tranche will be recognised as eligible collateral for Eurosystem monetary policy and intra-day credit operations by the Eurosystem either upon issue or at any times during their life as such recognition depends upon satisfaction of the Eurosystem eligibility criteria.

Payments of principal, interest and any other amount in respect of the Registered Global Covered Bonds will, in the absence of provision to the contrary, be made to the person shown on the Register (as defined in Condition 6.4) as the registered holder of the Registered Global Covered Bonds. INSOLVENCY OF THE ISSUER

The Greek Covered Bond Legislation contains provisions relating to the protection of the Covered Bondholders and other Secured Creditors upon the insolvency of the Issuer.

In the event of the insolvency or resolution of the Issuer, the Greek Covered Bond Legislation provides that the Cover Pool will at all times remain segregated from the insolvency estate of the Issuer until payment of any amounts due to the Covered Bondholders has been made in full. Upon registration of the Registration Statements with the public registry, the issue of the Covered Bonds, the creation of the Statutory Pledge and the security governed by foreign law (including pursuant to the Deed of Charge), the payments to Covered Bondholders and other Secured Creditors and the entry into of any agreement relating to the issue of Covered Bonds will not be affected by the insolvency or resolution of the Issuer. All collections from the Cover Pool Assets shall be applied solely towards payment of amounts due to the Covered Bondholders and other Secured Creditors.

Pursuant to the Greek Covered Bond Legislation, both before and after the commencement of insolvency or resolution proceedings in respect of the Issuer, the Cover Pool may be autonomously managed until full payment of the amounts due to the Covered Bondholders and the other Secured Creditors has been made. The Greek Covered Bond Legislation requires that, upon the commencement of insolvency or resolution proceedings in respect of the Issuer, the Trustee appoints a special administrator, subject to a positive opinion of the Bank of Greece, to (among other things) monitor compliance of the Issuer with its obligations under the Covered Bonds, service the Cover Pool and ensure that the bondholders' interests are not affected. The Bank of Greece may appoint the special administrator, if the Trustee does not do so. Such person shall be obliged to service (or procure the servicing of) the Cover Pool in accordance with the terms of the Servicing and Cash Management Deed.

The Special Administrator, the special liquidator or any other person appointed under the provisions of the Greek law 4261/2014 to undertake the management of the Issuer in the event of insolvency of the latter, will be required to treat the Cover Pool as a segregated pool of assets on the basis of the segregation provisions of Article 14 of the Covered Bond Law.

Following the placement of the Issuer under special liquidation in accordance with Article 145 of Greek Law 4261/2014, the Covered Bondholders and the other Secured Creditors shall be satisfied in respect of the portion of their claims that is not paid off from the Cover Pool from the remaining assets of the Issuer as unsecured creditors in accordance with Article 6 of the Covered Bond Law.

Furthermore, covered bonds are excluded from the liabilities that are subject to the bail-in tool of article 44 of Greek Law 4335/2015. Nevertheless, the resolution authority may exercise its power of conversion or write down, where appropriate, in relation to any part of a secured liability that exceeds the value of the security.

USE OF PROCEEDS

The net proceeds from each issue of Covered Bonds will be applied by the Issuer for its general corporate purposes.

OVERVIEW OF THE GREEK COVERED BOND LEGISLATION

The following is a summary of the provisions of the Greek Covered Bond Legislation relevant to the transactions described in this Base Prospectus and of which prospective Covered Bondholders should be aware. The summary does not purport to be, and is not, a complete description of all aspects of the Greek legislative and regulatory framework pertaining to covered bonds and prospective Covered Bondholders should also read the detailed information set out elsewhere in this Base Prospectus.

Introduction – Framework

The transactions described in this Base Prospectus are the subject of specific legislation, the Greek Covered Bond Legislation. As mentioned elsewhere in the Base Prospectus, the Greek Covered Bond Legislation includes the Covered Bond Law and the Secondary Covered Bond Legislation (as this may be supplemented by a decision of (the Bank of Greece to be issued pursuant to and on the basis of the Covered Bond Law) , which replaced the previous Greek legal framework on covered bonds (consisting of Article 152 of Greek Law 4261/2014, as supplemented by Act nr. 2620/28.8.2009 of the Governor of the Bank of Greece) and transposed the Directive (EU) 2019/2162 of the European Parliament and of the Council of 27 November 2019 on the issue of covered bonds and covered bond public supervision (which amended Directives 2009/65/EC and 2014/59/EU) (the “**Covered Bonds Directive**”). The Covered Bond Law entered into force on 8 July 2022, while covered bonds issued prior to such date continue in principle to be governed by Article 152 of Greek Law 4261/2014.

The Greek Covered Bond Legislation is supplemented by Greek Law 3156/2003 and Greek Law 4548/2018 “Reform of law on *sociétés anonymes*” (the “**Greek Company Law**”), to the extent that the Covered Bond Law cross-refers to these laws. The Covered Bond Law has been enacted, with a view, inter alia, to complying with the standards of the Covered Bonds Directive and Regulation (EU) 575/2013 (the “**Capital Requirements Regulation**” or the “**CRR**”) and strengthening the conditions for granting preferential capital treatment to covered bonds by adding further requirements and entitles credit institutions to issue covered bonds with preferential rights in favour of the holders thereof and certain other creditors over a cover pool comprised by certain assets discussed in further detail below.

The provisions of the Greek Covered Bond Legislation that are relevant to the Programme may be summarised as follows:

Structure of the issuer – bondholder agent

Contrary to the previously applicable framework on covered bonds (Art. 152 Greek Law 4261/2014), which permitted the issuance of covered bonds in two ways, either directly by a credit institution, or indirectly by a subsidiary of a credit institution, the Covered Bond Law only allows the direct issuance of covered bonds by credit institutions established in Greece. The segregation of the cover pool is achieved through a statutory pledge over the cover pool assets.

The bondholder agent may be a credit institution or an affiliated company, in accordance with article 32 of Greek law 4308/2014, of a credit institution entitled to provide services in the European Economic Area, within the meaning of point 27 of article 5 of Greek Covered Bond Law. The covered bond programme may also provide that more than one bondholder agents are appointed (separate bondholder agent per series of covered bonds or per issuance under the covered bond programme). Unless otherwise set out in the terms and conditions of the bonds, the bondholder agent is liable towards bondholders for wilful misconduct and gross negligence (Art. 14(3)).

Prerequisites for the issuance of covered bonds

According to the Covered Bond Law (Art. 20), covered bonds may be issued by credit institutions that meet the following requirements:

- an adequate programme of operations setting out the issue of covered bonds;
- adequate and documented policies, processes and methodologies for the approval, amendment, renewal and refinancing of loans included in the cover pool;
- management and staff dedicated to the covered bond programme which have adequate qualifications and knowledge regarding the issue of covered bonds and the administration of the covered bond programme;
- sufficient organisation and IT infrastructure for the management and monitoring of the cover pool assets, so as to meet the requirements of the Covered Bond Law and any secondary legislation issued pursuant to the Covered Bond Law;
- a risk mitigation policy and appropriate mechanisms to monitor and manage risks arising from the issuance of covered bonds; and
- a detailed description of the competence of the service units and the committees involved in the issuance of covered bonds.

The prior approval of the Bank of Greece is required for the issuance of a covered bond programme.

Cover Pool – composition of assets and valuation

The type of assets that may form part of the cover pool is regulated by Article 8 of the Covered Bond Law (transposing Article 6 of the Covered Bond Directive), as supplemented by the Secondary Covered Bond Legislation. Specifically, the Covered Bond Law provides for two categories of cover pool assets, i.e. (i) assets that are eligible pursuant to Article 129(1) of the CRR and (ii) other high-quality cover assets that meet the conditions of the Covered Bond Law and in addition belong to categories of assets that are specified as eligible in a decision of the Bank of Greece. The Secondary Covered Bond Legislation has not set conditions for other high-quality cover assets and the Bank of Greece has not

issued any other related decision and consequently it is currently only permitted that the cover pool assets are assets that are eligible pursuant to Article 129(1) of the CRR. It is worth noting that Article 8 of the Covered Bond Law has not transposed subparagraph (c) of Article 6(1) of the Covered Bond Directive and consequently cover assets do not include assets in the form of loans to or guaranteed by public undertakings. Further, the Bank of Greece may also limit the eligibility of certain cover assets under 129(1) of the CRR and designate the specific classes of cover assets that will be permitted to form part of the cover assets pool and be included in covered bond programme under the Covered Bond Law. In this respect, the Secondary Covered Bond Legislation provides, *inter alia*, that loans secured by residential and commercial real estate assets are only included in the cover assets if the real estate is located in Greece, real estate assets under construction may not exceed 10 per cent. of the cover assets and that exposures referred to in item (b) of Article 129(1) of the CRR which qualify for the credit quality step 2 are excluded from the cover pool even if they do not exceed 20% of the nominal amount of outstanding covered bonds. Securitised loans are not eligible to be part of the cover assets. The Secondary Covered Bond Legislation also provides that the limits referred to in paragraph 1a of Article 129 of the CRR shall not apply to exposures which are included in the cover assets to exclusively satisfy the liquidity requirements of the covered bonds.

Cover assets considered eligible according to Article 129(1) of the CRR are primarily residential mortgage loans, loans secured by a mortgage on commercial properties, loans secured by a mortgage on ships and exposures to or guaranteed by state entities. The loans may be secured by mortgage prenotations instead of full mortgages (as is the practice for cost reasons in Greece). In addition, exposures to credit institutions (which qualify for credit quality step 1) may be included in the cover pool up to a limit of 15 per cent. of the nominal value of the outstanding covered bonds. Exposures to credit institutions which qualify for credit quality step 2 and 3 may also be included in the cover pool but will be subject to differing limits as set out in paragraph 1a of Article 129 of the CRR. According to Article 13 of the Covered Bond Law, derivatives may also be included in the cover pool, subject to certain conditions, including the requirements that the derivative contracts are included in the cover pool exclusively for risk hedging purposes, they are sufficiently documented and can be segregated by the issuer in accordance with Article 14 of the Covered Bond Law and that the derivative contracts cannot be terminated upon the insolvency or reorganisation of the issuer. Furthermore, in accordance with Article 13 of the Covered Bond Law, the Bank of Greece may set out rules for derivative contracts in the cover pool. To this effect the Secondary Covered Bond Legislation provides that a hedging agreement is eligible to be included in the cover pool if the counterparty falls under certain categories.

Loans secured by residential mortgages are required to have a loan-to-value (“LTV”) ratio of 80 per cent. Loans with a higher LTV ratio may be included in the cover pool, but they are taken into account for the calculation of the statutory tests and other requirements of Articles 17 and 18 of the Covered Bond Law and Chapter III of the Secondary Covered Bond Legislation described below only up to the amount indicated by the maximum LTV ratio permitted for the type of asset over which such loan is secured.

The Bank of Greece has been authorised by the Covered Bond Law (Art. 8(4)(7)&(8)) to also set out specific rules for the valuation process of the cover pool assets and generally for the implementation of the Covered Bond Law, including in particular rules in relation to the risk diversification (especially in terms of granularity and material concentration) of the cover pool assets. The Secondary Covered Bond Legislation provides that derivative contracts are valued with the method of net present value. To this effect the Secondary Covered Bond Legislation provides that the evaluation of properties must be performed by an independent valuer and must be repeated on an annual basis in accordance with the valuation rules set out in Article 129(3) of the CRR.

The Secondary Covered Bond Legislation provides that derivative contracts are valued at their net present value.

The Cover Assets may be replaced or supplemented by Marketable Assets which count only towards the overcollateralisation portion of the Cover Pool.

Benefit of a prioritised claim by way of statutory pledge – segregation of cover assets

The cover assets are segregated from the remaining estate of the credit institution through a pledge constituted by operation of law (*statutory pledge*). In case of assets governed by a foreign law (which will typically include *inter alia* claims from derivative contracts), a security interest must be created in accordance with such foreign law. The statutory pledge and the foreign law security interest secure claims of the holders of covered bonds and may also secure (in accordance with the terms of the covered bonds) other claims connected with the issuance of the covered bonds, such as derivative contracts used for hedging purposes. The statutory pledge and any foreign law security interest are held by a bondholder agent for the account of the secured parties. The Secondary Covered Bond Legislation provides that in order for a foreign law asset, governed by an EU law that is not Greek law, to be included in the cover pool a legal confirmation that the established foreign law security is valid, in force and enforceable must be submitted to the Bank of Greece (along with other documents).

The claims constituting cover assets are identified by being listed in a document signed by the issuer and the bondholder agent. A summary of such document signed by the issuer and the bondholder agent must be registered in the pledge registry of the seat of the issuer in accordance with Article 3 of Greek law 2844/2000. The form of the Registration Statement has been defined by Ministerial Decree No. 95630/08-09-2008 of the Minister of Justice. Such summary document includes within its content a description of the assets that constitute the cover pool. Claims may be substituted and additional ones may be added to the cover pool through the same procedure.

Article 14 of the Covered Bonds Law creates an absolute priority of holders of covered bonds and other secured parties over the cover pool. Upon registration of the summary of the document listing the claims included in the cover pool, the issuance of the covered bonds, the establishment of the statutory pledge and the foreign law security interest and the entering into of all contracts connected with the issuance

of the covered bonds are not affected by the commencement of any insolvency proceedings against the Issuer.

According to the Covered Bond Law the cover assets may not be attached. This has the indirect result that the Greek law claims constituting cover assets are no longer subject to set-off, because, according to Article 451 of the Civil Code, claims which are not subject to attachment are not subject to set-off. This is important because under generally applicable law borrowers, under the loans that become cover assets would have had a right to set-off, which would (if such right of set-off could be exercised by them) reduce the value of the cover pool, for all counterclaims (including notably deposits) predating the creation of the pledge. Also, the issuer cannot dispose of the cover assets without the written consent of the trustee, unless otherwise set out in the terms and conditions of the covered bonds.

No specific provisions exist in relation to voluntary over-collateralisation. As a result, the segregation applies to all assets of the cover pool, even if their value exceeds the minimum required by law (although please see the section entitled "*The Secondary Covered Bond Legislation*" below regarding the maximum value of cover pools and the section entitled "*Insolvency of the Issuer*"). The remaining creditors of the credit institution will only have access to any remaining assets of the cover pool after the holders of the covered bonds and other creditors secured by the cover pool have been satisfied in full. On the other hand, in the event of special liquidation of the issuer, covered bondholders and other creditors secured by the statutory pledge shall be satisfied in respect of the portion of their claims that is not paid off from the cover pool in the same manner as unsecured creditors from the remaining assets of the issuer.

Bankruptcy remoteness of and impact of insolvency proceedings on covered bonds

According to Article 7 the Covered Bond Law, covered bonds do not automatically accelerate upon insolvency or resolution of the issuer.

As described in the section entitled "Insolvency of the Issuer" Article 21 of the Covered Bond Law, provides for the appointment of a Special Administrator in the insolvency or resolution of the issuer. According to Article 6(1) of the Covered Bond Law, in case of insolvency or resolution of the issuer, holders of covered bonds have dual recourse both to the cover pool as secured creditors and to the remaining assets of the credit institution ranking as unsecured and unsubordinated creditors.

Asset-liability management

Article 17 of the Covered Bond Law provides coverage requirements that must be met for the full duration of the covered bonds, including that all liabilities of the Covered Bonds shall be covered by claims for payment attached to the cover assets. More particularly, the Covered Bond Law provides that the aggregate nominal value of the cover assets must exceed by at least 5 per cent. The nominal value of the aggregate outstanding covered bonds.

The Covered Bond Law authorises the Bank of Greece to issue decisions specifying the coverage requirements (and potentially rendering them stricter, only in case of cover pool assets that consist of high-quality cover assets of Article 8(1)(ab)). Section G of Chapter III of the Secondary Covered Bond Legislation introduces a number of coverage requirements, including:

- (a) The net present value of the liabilities deriving from the Covered Bonds and the other liabilities secured through the cover assets must not exceed for the duration of the issuance the net present value of the cover assets including derivatives contracts used to hedge risks of such assets. This requirement must be satisfied even in the assumption of a parallel shifts of the yield curve by 200 basis points.
- (b) The amount corresponding to the payments of interest to the Covered Bondholders must not exceed the amount of interest that is expected to be collected during a period of twelve (12) months from the cover assets (including hedging agreements).

Any claims in the cover pool where the borrower is in default in accordance with Article 178 of the CRR and claims in the cover pool that are in default for more than ninety (90) days are not included in the calculations for the purposes of paragraphs (a) and (b) above.

See “*Description of Transaction Documents – the Servicing and Cash Management Deed – Statutory Tests*” for further details on coverage requirements.

Liquidity Buffer Reserve Ledger

Article 18 of the Covered Bond Law provides that the cover pool shall include at all times a liquidity buffer composed of liquid assets (as defined in paragraph 2 of Article 18 of the Covered Bond Law) available to cover the net liquidity outflow of the covered bond programme. Such cover pool liquidity buffer shall cover the maximum cumulative net liquidity outflow over the next one hundred eighty (180) days, using the extended maturity date for calculation purposes in the case of extendable maturity covered bonds.

Transparency

Currently, the issuer’s reporting obligations and the disclosure of the cover pool as conducted via the summary registered with the competent pledge registry for the establishment of a statutory pledge are the basic transparency tools provided under applicable covered bonds legislation. The label ‘European Covered Bond’ may be used only for covered bonds which meet the requirements of the Covered Bond Law. Furthermore, the label ‘European Covered Bond (Premium)’ may be used only for covered bonds which also meet the requirements of Article 129 of the CRR.

Asset monitor

The compliance of cover pool assets with the requirements of the Covered Bond Law and of the Secondary Covered Bond Legislation is monitored by an asset monitor that is an auditor independent from the issuer of the covered bonds and from the issuer's auditor (Art. 15 of the Covered Bond Law). In case the asset monitor finds that the cover pool assets do not comply with the requirements of the Covered Bond Law and of the Secondary Covered Bond Legislation, it shall immediately notify the issuer who must take action to remedy the default without delay. Section I of Chapter III of the Secondary Covered Bond Legislation , provides that the asset monitor shall monitor:

- (a) the observance of the limits of the cover assets and the coverage requirements for the duration of the issuance of Covered Bonds;
- (b) the accuracy and completeness of the coverage requirements of Article 17 of the Covered Bond Law and of Section H of Chapter III of the Secondary Covered Bond Legislation;
- (c) the accuracy of the cover assets and the observance of the provisions regarding valuation of such cover assets; and
- (d) the observance of maximum percentages, as determined at the issuance of the Covered Bonds, regarding the composition of the cover assets.

The Asset Monitor shall compose an annual report regarding, inter alia, the control procedures undertaken, the findings regarding the calculation of cover assets, an analysis of the cover assets verifying the observance of the coverage ratios, the re-valuation of real estate assets securing loans that are part of the cover assets and other information detailed in the Secondary Covered Bond Legislation. This report is based on data as of the end of December, submitted to the Bank of Greece by 31 March of each year.

Reporting duties of the issuer to the supervisor concerning covered bonds and cover pool

Credit institutions that issue covered bonds shall provide reports to the Bank of Greece containing information on the eligibility of assets and cover pool requirements, the segregation of cover assets, the functioning of the asset monitor, the coverage requirements, the cover pool liquidity buffer and the conditions for extendable maturity structures (Art. 22 of the Covered Bond Law).

Risk-weighting & compliance with European legislation

The risk-weighting of covered bonds (both Greek and foreign) is regulated by the Covered Bond Directive and Article 129 of the CRR.

According to article 129 of the CRR covered bonds as defined in point (1) of Article 3 of the Covered Bond Directive shall be eligible for the preferential treatment, provided they are collateralised by assets deemed eligible pursuant to that article and meet certain requirements set out in that Article. Since, the

Covered Bond Law faithfully transposes the Covered Bond Directive, covered bonds issued pursuant to it shall have the preferential treatment of article 129 CRR, provided they also meet the remaining conditions set by that article.

The Secondary Covered Bond Legislation

The Secondary Covered Bond Legislation was issued by the Bank of Greece on the basis of authorisations given by the Covered Bond Law, and adopted detailed and specific implementation rules of the Covered Bond Law, including rules, among others, in connection with the supervisory recognition of covered bonds; the requirements as to the issuer's risk management and internal control systems; the eligibility criteria as to the initial cover pool and the substitution and replacement of cover pool assets; the requirements in respect of the ratio between the value of the cover pool assets and the value of covered bonds, the ratio between the net present value of liabilities under the covered bonds and the net present value of the cover assets, the ratio between interest payments on covered bonds and interest payments on cover pool assets and the revaluation of the value of the real estate property mortgaged; the requirements for the performance of reviews and audits by the asset monitor; specific provisions regarding measures to be taken in the event of insolvency or resolution procedures in respect of the issuer; specific procedures for the submission of documents to obtain approval by the Bank of Greece in respect of the issuance of covered bonds; data reporting and disclosure requirements.

The Secondary Covered Bond Legislation also imposes a limit on the proportion of a covered bond issuer's "available assets" that may be segregated as part of the cover pool or cover pools securing the covered bonds issued by such covered bond issuer. Save in exceptional circumstances, and with the approval of the Bank of Greece, the total amount of the assets forming part of a cover pool or cover pools should not exceed 20% (twenty per cent) of the value of all of the covered bond issuer's "available assets" i.e. claims that have been transferred to a special purpose vehicle in accordance with Article 10 of Greek Law 3156/2003 on securitisation, such as assets that are subject to reverse repos agreements and assets attached in favour of third parties.

Administrative penalties and administrative measures

The Bank of Greece has a range of supervisory, investigatory and sanctioning powers under the Covered Bond Law, including the power to impose administrative penalties and other administrative measures on credit institutions who are in violation of the Covered Bond Law, including (for example) issuing covered bonds without obtaining the requisite permission in accordance with Article 21 of the Covered Bond Law or failure to comply with the requirements in Article 18 of the Covered Bond Law in respect of a liquidity pool buffer. Such administrative penalties and measures include withdrawal of permission for a covered bond programme, issuance of public statements, issuance of cease-and-desist orders and administrative pecuniary penalties.

Summary of the provisions of the CRR

Article 178 of the CRR

For the purposes of the section entitled "*Description of Transaction Documents – the Servicing and Cash Management Deed – Statutory Tests*", paragraphs 1 to 5 (inclusive) of Article 178 of the CRR is set out as follows:

"1. A default shall be considered to have occurred with regard to a particular obligor when either or both of the following have taken place:

- (a) the institution considers that the obligor is unlikely to pay its credit obligations to the institution, the parent undertaking or any of its subsidiaries in full, without recourse by the institution to actions such as realising security;
- (b) the obligor is more than 90 days past due on any material credit obligation to the institution, the parent undertaking or any of its subsidiaries. Competent authorities may replace the 90 days with 180 days for exposures secured by residential property or SME commercial immovable property in the retail exposure class, as well as exposures to public sector entities. The 180 days shall not apply for the purposes of point (m) Article 36(1) or Article 127.

In the case of retail exposures, institutions may apply the definition of default laid down in points (a) and (b) of the first subparagraph at the level of an individual credit facility rather than in relation to the total obligations of a borrower.

2. The following shall apply for the purposes of point (b) of paragraph 1:

- (a) for overdrafts, days past due commence once an obligor has breached an advised limit, has been advised a limit smaller than current outstandings, or has drawn credit without authorisation and the underlying amount is material;
- (b) for the purposes of point (a), an advised limit comprises any credit limit determined by the institution and about which the obligor has been informed by the institution;
- (c) days past due for credit cards commence on the minimum payment due date;
- (d) materiality of a credit obligation past due shall be assessed against a threshold, defined by the competent authorities. This threshold shall reflect a level of risk that the competent authority considers to be reasonable;
- (e) institutions shall have documented policies in respect of the counting of days past due, in particular in respect of the re-ageing of the facilities and the granting of extensions, amendments or deferrals, renewals, and netting of existing accounts. These policies shall be applied consistently over time, and shall be in line with the internal risk management and decision

processes of the institution.

3. For the purpose of point (a) of paragraph 1, elements to be taken as indications of unlikeliness to pay shall include the following:

- (a) the institution puts the credit obligation on non-accrued status;
- (b) the institution recognises a specific credit adjustment resulting from a significant perceived decline in credit quality subsequent to the institution taking on the exposure;
- (c) the institution sells the credit obligation at a material credit-related economic loss;
- (d) the institution consents to a distressed restructuring of the credit obligation where this is likely to result in a diminished financial obligation caused by the material forgiveness, or postponement, of principal, interest or, where relevant fees. This includes, in the case of equity exposures assessed under a PD/LGD Approach, distressed restructuring of the equity itself;
- (e) the institution has filed for the obligor's bankruptcy or a similar order in respect of an obligor's credit obligation to the institution, the parent undertaking or any of its subsidiaries;
- (f) the obligor has sought or has been placed in bankruptcy or similar protection where this would avoid or delay repayment of a credit obligation to the institution, the parent undertaking or any of its subsidiaries.

4. Institutions that use external data that is not itself consistent with the definition of default laid down in paragraph 1, shall make appropriate adjustments to achieve broad equivalence with the definition of default.

5. If the institution considers that a previously defaulted exposure is such that no trigger of default continues to apply, the institution shall rate the obligor or facility as they would for a non-defaulted exposure. Where the definition of default is subsequently triggered, another default would be deemed to have occurred."

Paragraphs 1(d) and 1(f) of Article 129 of the CRR

For the purposes of the section entitled "*Description of Transaction Documents – the Servicing and Cash Management Deed – Statutory Tests*", points (d) and (g) of paragraph 1 of Article 129 of the CRR is set out as follows:

"(d) loans secured by residential property up to the lesser of the principal amount of the liens that are combined with any prior liens and 80% of the value of the pledged properties;

...

(g) loans secured by commercial immovable property up to the lesser of the principal amount of the

liens that are combined with any prior liens and 60% of the value of the pledged properties. Loans secured by commercial immovable property are eligible where the loan-to-value ratio of 60% is exceeded up to a maximum level of 70% if the value of the total assets pledged as collateral for the covered bonds exceed the nominal amount outstanding on the covered bond by at least 10%, and the bondholders' claim meets the legal certainty requirements set out in Chapter 4. The bondholders' claim shall take priority over all other claims on the collateral;".

Paragraph 1(c) and 1a of Article 129 of the CRR

For the purposes of the section entitled "*Description of Transaction Documents – the Servicing and Cash Management Deed – The Cover Pool*" and the Hedging Agreement Tests, paragraphs 1(c) and 1(a) of Article 129 of the CRR is set out as follows:

"(c) exposures to credit institutions that qualify for credit quality step 1 or credit quality step 2, or exposures to credit institutions that qualify for credit quality step 3 where those exposures are in the form of:

(i) short-term deposits with an original maturity not exceeding 100 days, where used to meet the cover pool liquidity buffer requirement of Article 16 of Directive (EU) 2019/2162; or

(ii) derivative contracts that meet the requirements of Article 11(1) of that Directive, where permitted by the competent authorities;

...

1a. For the purposes of point (c) of the first subparagraph of paragraph 1, the following shall apply:

(a) for exposures to credit institutions that qualify for credit quality step 1, the exposure shall not exceed 15% of the nominal amount of outstanding covered bonds of the issuing credit institution;

(b) for exposures to credit institutions that qualify for credit quality step 2, the exposure shall not exceed 10% of the nominal amount of outstanding covered bonds of the issuing credit institution;

(c) for exposures to credit institutions that qualify for credit quality step 3 that take the form of short-term deposits, as referred to in point (c)(i) of the first subparagraph of paragraph 1 of this Article, or the form of derivative contracts, as referred to in point (c)(ii) of the first subparagraph of paragraph 1 of this Article, the total exposure shall not exceed 8% of the nominal amount of outstanding covered bonds of the issuing credit institution; the competent authorities designated pursuant to Article 18(2) of Directive (EU) 2019/2162 may, after consulting EBA, allow exposures to credit institutions that qualify for credit quality step 3 in the form of derivative contracts, provided that significant potential concentration problems in the Member States concerned due to the application of credit quality step 1 and 2 requirements referred to in this paragraph can be documented;

(d) the total exposure to credit institutions that qualify for credit quality step 1, 2 or 3 shall not exceed

15% of the nominal amount of outstanding covered bonds of the issuing credit institution and the total exposure to credit institutions that qualify for credit quality step 2 or 3 shall not exceed 10% of the nominal amount of outstanding covered bonds of the issuing credit institution."

EUROBANK S.A.

For the purposes of this section of the Base Prospectus, references to the "Group" shall be to the Issuer and its consolidated entities.

Overview

Eurobank is one of the four systemic banks in Greece operating in key banking product and service markets. As at 30 June 2023, the Group had €42.2 billion in gross loans and advances to customers and €55.9 billion in customer deposits, a network of 545 branches. The Issuer's registered office is at 8 Othonos Street, Athens 10557, Greece, its telephone number is +30 210 333 7000 and its website is <http://www.eurobank.gr>.

Eurobank offers a wide range of financial services to the Group's retail and corporate clients. The Issuer has a strategic focus in Greece in fee-generating activities, such as asset management, private banking, equity brokerage, treasury sales, investment banking, leasing, factoring, real estate and trade finance. The Issuer is also among the leading providers of banking services and credit to SMEs, small businesses and professionals, large corporates and households.

The Group has an international presence in four countries outside Greece, with operations in Bulgaria, Cyprus, Luxembourg and the United Kingdom, which, as at 30 June 2023, collectively represented 223 branches and 22 business centres. As at 30 June 2023, the Group's international operations had €9.8 billion in gross loans and €16.9 billion in customer deposits.

Strategy

The Group's main objective is to operate profitably while maintaining a strong capital base. Its primary target is to achieve sustainable profitability, through strong business growth, diversified and increasing earnings generation, continuing improvement in asset quality, improving operating efficiencies and strengthening profitability of its international operations.

The Issuer's vision is to be the leading bank in creating prosperity for its customers, employees, shareholders and society by offering pioneering solutions in its markets.

The key elements of the Group business model are:

- client-centric orientation with segmental approach and relationship based management
- "phygital" distribution networks and integrating traditional banking networks with digital channels, using advanced technologies
- organisation structured along key strategic business units (for example, retail, corporate and investment banking, wealth management and global markets, international) to align with client segments

- centralised internal controls through the Risk Management, Compliance and the Finance and Control departments, for independence and clear separation from business development activities
- centralised product factories with centralised marketing, driving commercial activities and supporting innovation
- centralised IT Operations and Development, Loan Administration and back-office, administrative functions for effective cost control; and
- a structured management system and best-in-class human capital with strong motivation and work ethics, and sophisticated remuneration framework and policies

In 2021, Eurobank launched its transformation plan named "Eurobank 2030" to pivot focus towards business growth, capitalize on the anticipated Greek economic recovery, and systematically address the major challenges faced by financial institutions globally.

The overarching goal of "Eurobank 2030" is to supercharge financial performance, underpinned by bold changes in the business and operational model, driven by the following key objectives:

- A Phygital Distribution Model: Advanced digital offering to reduce cost to serve clients, combined with physical touchpoint for high-value customer interactions
- Operational Effectiveness & Efficiency: Reduce time & cost to serve clients and increase employee productivity
- Customer Value & Satisfaction: Increase customer satisfaction and become their primary banking relationship to drive value
- Fee Business Acceleration: Broaden product and services offered and deepen client relationship across segments
- High-Value Lending Growth: Accelerated income growth, based on increasing market share in high priority value streams
- Short Time to Market: Reduce time to market for new products & services through technology and commercial focus
- Employee Engagement: Empower the workforce and increase collaboration across units to drive effectiveness and employee satisfaction

"Eurobank 2030" structures all transformation activities around eight major Pillars, as set out below. Six Pillars aim to increase profitability through both customer-oriented and internal simplification initiatives, while two pillars form the key enablers related to IT infrastructure and Human Capital.

1. **"Bank everywhere" Model:** enable revenue growth and achieve efficiencies by rethinking sales & servicing channels;
2. **Simplification 360°:** deliver improved efficiency and customer experience through organisational, product, process and journey simplification;
3. **Data Empowerment:** drive personalised, real-time commercial actions and underwriting capabilities by leveraging data and advanced analytics;
4. **Fee business acceleration:** develop new and improved products to enhance client offering and grow revenues from non-lending activities;
5. **Business Ecosystems:** generate new revenue streams with business clients and consumers by addressing end-to-end value chains;
6. **Market Growth Maker:** drive credit growth in high-return spots by reviewing risk appetite, service model and value proposition;
7. **Architecture & Infrastructure:** upgrade architecture and infrastructure towards a flexible model that will enable growth and efficiency; and
8. **People & Culture:** articulate, activate and embed a culture of agile collaboration, delegation and accountability.

The Issuer's ESG strategy is a core priority in the "Eurobank 2030" strategy underlies the objectives of each of the eight major pillars.

Commitment to sustainability

The Issuer is committed to investing in sustainable development and to consistently designing its actions to improve its environmental performance, social responsibility and corporate governance. Its strategic objective is to adapt its business and operation in a way that addresses climate change challenges, to accommodate social needs within its banking business model, and to safeguard prudent governance for itself and its counterparties, in accordance with supervisory initiatives and following international standards/ best practices.

Committed to actively contributing to the achievement of the United Nations Sustainable Development Goals (SDGs) and the 2030 Agenda goals, the Issuer has been a signatory of the UN Global Compact since 2008. According to the commitment to the UNEP FI Principles for Responsible Banking (PRB), in line with the SDGs and the Paris Agreement on Climate Change, the Issuer issued its 3rd Progress Report which was incorporated in the Annual Report 2022 Business & Sustainability.

The UNEP FI individual feedback report on the previous PRB Progress Report, set out (i) the strengths of the Bank (Impact analysis, Sustainable finance and green bond frameworks, employee training and

integrated reporting) and (ii) the way forward for the Bank to fully implement the Principles for Responsible Banking was set through the identification of the two areas the issuer has the most significant impacts, performance measurement and pertinent target setting.

The Issuer launched an initiative, called "Program Field", with an aim to implement its sustainability strategy, integrate climate risks, fulfil its UNEP FI signatory commitments as well as to ensure readiness to comply with upcoming sustainability-related regulations (i.e. "EU Green Deal", ECB Guide on climate-related and environmental risks, EU Taxonomy Regulation, etc.). Through this initiative, the issuer has identified, assessed and implements climate-related and environmental (CR&E) risk action plans within the three Lines of Defense.

The Issuer has designed, approved and is currently implementing its Sustainability Strategy related to its financing and other products, its internal environment and the way it is organised and operates.

The Sustainability Strategy includes targets and commitments along two key pillars:

A. Operational Impact Strategy: targets and commitments related to operational impact arising from the Issuer's operational activities and footprint

The Issuer's Operational Impact Strategy focuses on three strategic axes:

- Environmental impact (Operational net zero, paperless banking, circular economy);
- Social and business impact (Sustainable procurement, socio-economic effect, transparency); and
- Employer impact (Diversity and inclusion, wellbeing culture, innovative environment).

B. Financed Impact Strategy: targets and commitments related to financed impact resulting from lending and investing activities to specific sectors and clients.

The Issuer's Financed Impact Strategy focuses on:

- Clients' engagement and awareness to adapt their business so as to address climate change challenges,
- Actions for supporting customers in their transition efforts towards a more ESG-friendly economic environment,
- Enablers and tools such as frameworks and products to underpin Sustainable Financing,
- The risk assessment of climate-related material exposures

More specifically, the Issuer has set the following targets for sustainable disbursements in the following years:

- New Disbursements: € 2 billion new green disbursements to businesses until 2025 or 20% of the annual new corporate disbursements to be classified as Green/ Environmentally sustainable;
- Renewable Energy: 35% of new disbursements in Energy sector will be directed to RES financing;
- Green Buildings: 80% of disbursements related to construction of new buildings will be allocated to green buildings;
- Recovery and Resilience Facility (RRF): € 2,25 billion total green RRF funds contribution in the Greek economy until 2026;
- Green Stock / Exposure evolution: 20% stock of green exposures by 2027 (up from 11% in 2022); and
- Double Retail Green Gross Disbursements within 2023 compared to 2022.

The Operational and Financing elements of the Sustainability Strategy are combined to address the issuer's path towards Net Zero by 2050. Making progress along these pillars the Issuer aims to maximize its contribution to achieving the Paris Climate Agreement's targets and the United Nations (UN) Sustainable Development Goals. In line with the issuer's commitment to the UNEP FI Principles for Responsible Banking (and the 2022 UNEPFI individual feedback report), development of the Sustainability Strategy is aligned with the requirements for identifying the most significant positive and negative impacts on the societies and environment where it operates.

The Issuer has updated its governance structure by introducing and defining the roles and responsibilities in relation to climate related and environmental risks, embedding regulatory guidelines and market practices. The updated governance structure aims to further enhance the effective oversight of climate related and environmental risks at management/ board level, both for transition and physical risks.

The CR&E Risk Governance involves various key stakeholders (i.e., Business functions, Units, and Committees). The Issuer applies a model of defined roles and responsibilities regarding the management of CR&E risks across the 3 Lines of Defence.

Moreover, the Issuer's Board has assigned an executive member as the responsible Board member for climate-related and environmental risks. The relevant executive member is responsible for updating the Board Risk Committee (BRC), in alignment with the BRC Terms of Reference, and the Board of Eurobank Holdings and the Issuer on climate change and environmental related risks at least on a semi - annual basis.

The Issuer has also established the ESG Management Committee, chaired by the BoD member responsible for climate-related and environmental risks. As part of its duties, the Committee, among other things:

- Provides strategic direction on Sustainability initiatives
- Reviews the Sustainability Strategy prior to approval
- Integrates the elements of the Sustainability Strategy into the issuer's business model and operations
- Regularly measures and analyses the progress of the ESG goals and performance targets
- Ensures the proper implementation of ESG-related Policies and Procedures

Reviews and approves ESG-related reports and ensures that are in accordance with related standards and guidelines. The Issuer actively participates in internationally renowned ESG ratings to highlight the continuous improvement in its environmental, social and governance performance, upgrade the relevant disclosures, and further enhance investor confidence in its practices. The Issuer posted improvements in important ESG ratings from Sustainalytics, Vigeo Eiris - Moody's, S&P, Refinitiv and FTSE4Good, while the Issuer achieved the international "ESG Industry Top Rated" distinction and has been added to the "Sustainalytics' Top-Rated ESG Companies List"

The Issuer implements an Environmental and Social Management System (ESMS), aiming to mitigate potential credit risks arising from the operation of businesses that are financed by the Issuer. In this context, the Issuer also includes non-financial covenants in the contractual documentation at the point of loan origination, aiming to influence the clients' strategies to mitigate/reduce environmental and social risks.

Further information on the Issuer's Sustainability strategy (both operational and financing impact) , targets and risk management approach is provided in the Consolidated Pillar 3 Report, the EMAS Environmental Report, the UNEP FI Progress Report and the 2022 Annual Business and Sustainability Report and the first Climate-related and Environmental Risk Report in alignment with TCFD Recommendations on the Issuer's website.

Retail Banking

Overview

Eurobank is one of four systemic financial institutions in Greece with a significant role in the country's retail banking landscape, with 278 branches as at 30 June 2023. The Issuer offers its retail customers a broad range of deposit, loan, investment and bancassurance products, as well as other retail banking services.

Eurobank's current retail banking model is structured around its core customer segments, a multi-channel distribution platform and centralised, integrated product units. The Issuer's core segments cover

individuals (which includes affluent individuals, salary earners and mass clients), as well as small businesses. The Issuer's multi-channel distribution platform includes a nationwide network of branches with segment-oriented relationship managers, digital distribution channels (such as video banking (or “v-banking”), phone banking, e-banking and m-banking), the Greek postal offices network, as well as third party partners (such as automobile dealers and real estate brokers). The Issuer's centralised product units design and deliver the whole spectrum of retail banking products and services with a focus on customer relevance and efficiency.

In 2022, for the ninth consecutive year, World Finance Magazine recognised the Issuer's Retail Banking business as the “Best Retail Bank” in Greece. The Issuer has consistently differentiated itself from its competitors primarily through its customer-driven and technology-enabled innovation as well as its customer service. The Issuer's objective is to set its clients at the centre of its business model based on the principles of simplicity, transparency and seamlessness and to build solid, well-rounded banking relationships with its clients. In this connection, the Issuer's ongoing transformation from a product-centric to a customer-centric approach focuses on developing an end-to-end segment driven sales and service model with an efficient multi-channel distribution platform.

Eurobank's retail products and services include deposit and investment products, cards, lending products, transactional services and bancassurance products.

Mortgage lending

Eurobank has the leading position, in terms of mortgage loan portfolio among the Greek systemic banks. The Group's mortgage loan portfolio balance in the Greek market amounted to €7.9 billion as at 30 June 2023.

In September 2019, the Issuer launched a new innovative product into the Greek mortgage market offering for the first time fixed interest rates throughout the term of the loan. After three highly successful years in mortgage lending, the Issuer, despite the adverse new market conditions (namely increasing interest rates and the unstable macroeconomic environment), managed to attain a high level of new production by promoting in vast majority mortgage loans with fixed rates for an initial period and floating rates afterwards, along with flexible repayment options. Additionally, the Bank offered, innovative digital and phygital optional features in the process (including digital loan application, sales and support via video call, digital notifications and documentation).

Eurobank actively participated in the new government mortgage program “My Home” targeted at young borrowers who would like to purchase their first home with favourable terms. Additionally, the Bank launched a reward program for performing eligible customers to protect their instalment from the increasing floating interest rates for a year.

Consumer lending

Eurobank continues to offer consumer loans through tailored promotional activities directed towards existing low-risk - high-value customers.

Eurobank's strategy in the consumer loans business is to focus on purpose-specific loans, such as auto/durable goods loans and loans addressed to specific segment and subsegment customers, (Group Sales and Personal Banking) , while implementing a sophisticated multi-channel sales approach for both existing and prospective clients.

Having introduced a series of innovative new consumer loans products & services, the Issuer, aims to cover specific micro-segments demand through highly automated and simple procedures with an omni-channel approach, thereby optimising all available networks, both internal as well as external (i.e. retailers' digital stores). The Issuer operates successfully in the automobile financing business through an extended network of dealers, sustains valuable relationships with all the significant dealers and distributors in the Greek market and maintains a leading position among the Greek systemic banks.

Credit, debit and prepaid cards and acceptance services

Eurobank offers a wide variety of card products, both for retail and corporate customers. With over 3.45 million debit, credit and prepaid cards in the market and a POS turnover of €4.99 billion in the first half of 2023, the Issuer is a leader in the bank card business in the Greek market.

The Issuer was the first bank in the Greek market to offer the next generation of cards, made of eco-friendly biodegradable materials, having adopted the latest international environmental protocols, thereby demonstrating the Issuer's long-term commitment to promote environmentally friendly initiatives.

The Issuer currently offers an array of digital wallets (Apple Pay, Google Pay & Garmin Pay), catering to all cardholders' needs and allowing both iOS/Android device users to make payments using their Visa or MasterCard cards.

The Issuer continues to enhance its digital self-service solutions by offering users an end-to-end digital, omni-channel credit card application functionality via Eurobank Mobile App (being the first bank in Greece to introduce this service to eBanking users). In addition, the 'Cards Control' feature is available through the Issuer's online banking platform, allowing cardholders to manage a range of card functionalities, without the need to visit a branch or speak to a dedicated EuroPhone agent, a feature that proved very useful during the pandemic.

During the first half of 2023, a series of tailor-made campaigns were implemented, further rewarding cardholders for the day-to-day card spending, while simultaneously help boosting turnover.

Among the Issuer's strongest assets are its loyalty programmes, which continue to reward cardholders for their daily spending. Spearheading the programmes is €pistrofi, the most well established bank

loyalty programme in the Greek market, currently in its seventeenth year of operation. The programme is the only Greek cards loyalty programme to reward with euros (rather than points) and has had a significant impact in increasing card usage and safeguarding affiliated merchants' relationships in a competitive market. The programme's mobile application "€pistrofi App" enables the Issuer to conduct personalised marketing campaigns, using behavioural, geographical and transactional data.

The €pistrofi loyalty programme continued to facilitate the business bond between existing and prospective customers by rewarding their overall relationship with the Bank, achieving an increase in the value of transactions, despite the adverse conditions prevailing in the retail market. Since 2006, over €200m have been returned to clients through the €pistrofi loyalty programme.

Eurobank is constantly partnering with other companies to provide a diverse and complete offering to its customers.

Eurobank remains a leader in the field of co-branded credit cards, delivering value to customers' day-to-day transactions through exclusive partnerships with entities that include Greece's largest telecommunications provider (COSMOTE World MasterCard), the largest shopping malls in the country (YES Visa), a high-end retail store (Reward World MasterCard) and a major supermarket chain (Masoutis Visa).

The Group's consumer loans portfolio in the Greek market including both credit cards and consumer loans amounts to €1.7 billion as at 30 June 2023.

Merchant Services

Eurobank in collaboration with its partner Worldline Greece acts as a Merchant Servicer providing a variety of products and payment solutions according to the profile and the needs of each merchant. Such products are POS- new generation of Android terminals, EPOS, Payment Link, Live Pay and Smart POS covering each platform of customer service. Turnover as of 30 June 2023 is €5.80bn (+ 10% vs budget / + 16% YoY), with the Gross Merchant Commission (GMC) being €40.69mn (+ 4.6% vs budget / + 11,9% YoY) and the GMC percentage being 0,70% (+ 2 bps YoY).

Group sales

Group Sales relationships, namely the acquisition and cultivation of payroll clients and pensioners, play an important role in the Issuer's strategy. Focus is given to:

- leveraging existing relationships with high profile companies to which the Issuer does not yet offer payroll services:
- attracting public servants and senior citizens and pensioners with customised propositions; and
- developing the existing customer base under the principle "track the customers' income, capture the customers' spending".

The Issuer's holistic approach, deployed both at a company as well as at an individual employee level, aims to increase the number of Group Sales customers, enhance their loyalty to the Issuer and provide a unique customer experience, meet the whole array of customers' banking needs, while at the same time increasing the segment's profitability.

The Issuer has developed the "Privileged Payroll Account" for both private and public sector, its core special payroll package for employees who receive their payroll through the Issuer, and the "Integrated Pensioners Programme" for retirees who receive their retirement payments in the Issuer. Bundling several products and services, both programmes offer the Issuer's customers benefits and privileges in all key banking products and services. As at 30 June 2023, the Issuer's total client base with a payroll relationship exceeded 18,000 companies and public utilities and 771,000 individual customers (out of which 363,000 were private sector employees, 126,000 were public servants and 282,000 were retirees).

Personal Banking

Personal Banking ("PB") serves clients with funds under management over €50,000 each with at least four active products and services.

The Issuer offers a range of services to its Personal Banking customers, including dedicated physical and virtual relationship managers accredited by the Bank of Greece, "branded" branch space, global statements, newsletters, an exclusive phone banking line and lifestyle privileges, regarding travel and real estate.

The Issuer remains dedicated to its goal of providing top-class personal banking customer service. Personal Banking relationship managers focus on delivering an integrated client-centric approach to meet the needs of PB Top Prime & Prime customers, by informing them regularly about relevant products and services. Furthermore, adopting a holistic approach aiming at enhancing customer experience, the Issuer provides investment solutions, bancassurance products and loans, along with elite client events and premium offers that recognise their loyalty.

Personal Banking focuses on client acquisition, therefore contributing significantly to the Issuer's operational results

Retail Business Banking

Eurobank's strategy for small businesses focuses on companies with:

- an annual turnover of up to €5 million, which have shown operational resilience; and
- the potential for further growth in domestic and international markets, by maximising their competitiveness, increasing productivity, and introducing innovation in their operational and production process. The Issuer aims to be their partner in this effort, through a series of services

and strategic initiatives (including the eco-system of non-banking services, Business Check-Up, Exportgate, Trade Club and Digital Academy).

The loan portfolio for Retail Business Banking (“RBB”) amounted to €3.1 billion as of 30 June 2023.

The Retail Business Banking segment:

- is providing the market with liquidity, by participating in State and EU financial programmes, in collaboration with HDB (“Hellenic Development Bank”) and EIF (“European Investment Fund”);
- is implementing the initiative “Eurobank Anaptixi” (“Eurobank Development”), an integrated solution including consulting and lending, aiming to maximise RBB’s participation in the announced Development Programmes;
- is offering “Business Banking Tourism”, the business eco-system addressing the broader Tourism sector for the thirteenth year, providing both banking and a wide range of non-banking offerings, which significantly contributed to the increase of deposits, POS commissions and loans;
- streamlined access of smaller businesses to financing through the hybrid solutions POS Cash Advance and e-financing; and
- offered its RBB clients a one-stop digital solution in collaboration with Microsoft and Info Quest Technologies, within the framework of the Programme “Greece 2.0 – Digital Upgrade”.

Public Sector Segment

Eurobank’s offering of banking services to the public sector and non-profit organisations focus on supporting the government initiative for digital transformation in the public sector. The Public Sector Segment continues to support public hospitals in their effort to deal with the challenges created by the pandemic. In the context of cooperating with local authorities, the Public Sector Segment continued to support the Social Groceries and other initiatives, according to the priorities set by the local authorities.

Retail International Customers Segment

The Retail International Customers Segment, Eurobank’s One-Stop-Hub for clients residing outside Greece, continued to expand its offering on products and services. Through Eurobank’s digital and phygital channels, existing and new clients have access to a wide range of tailor made products and services such as mortgage loans via a fast-track application process which was launched in 2022. In the same year the Digital Customer Onboarding service was made available for residents of the European Union, Iceland, Norway and Switzerland, allowing them to become Eurobank clients from their country of residence through the Eurobank Mobile App.

Deposit products

Acquiring deposits is a key strategic priority for the Issuer. The Group's total customer deposits in Greece amounted to €39. billion as at 30 June 2023. The Issuer offers a comprehensive range of deposit products which include everyday, savings and time deposit accounts, coupled with special privileges and reward programmes. All deposit accounts provide additional value to the Issuer's clients by rewarding them for using their debit cards instead of cash while customers perform their everyday shopping. In March 2022, the Issuer launched the "Eurobank My Advantage Banking" programme for its Individual customer base. This programme consists of 3 new bundles, "my Silver", "my Gold" and "my Platinum", offering a set number of free e-transactions per month, various services (e.g., payment initiation, cards control) and non-banking benefits. As at 30 June 2023, retail customers held more than 142,000 packages.

Eurobank continues to support its customers and their saving efforts by offering a wide range of savings solutions for the entire family that reflects their needs and stage of life. In December 2022, the Issuer offered its new savings product, called "Saving Now", aiming to support clients who make the extra effort to save by providing incentives to regular savers and following its strategy to become the leading institution regarding savings in Greece. As at 30 June 2023, more than 225,000 savings accounts existed in Eurobank's accounts (named "Megalono", "Regular Savings" and "Saving Now" accounts).. Acknowledging customer loyalty and trust as major assets, the Issuer focuses on savings, supporting families and children.

Bancassurance

Eurobank, as Insurance Agent, in partnership with Eurolife FFH Life Insurance SA and Eurolife FFH General Insurance SA, offers Bancassurance products across all channels (physical, digital, alternative) and segments.

During the first half of 2023, Eurobank had achieved high performance results with Bancassurance activity reaching € 236m remaining the bancassurance market leader in Life Insurance.

Distribution channels

Retail banking network

Eurobank's retail banking network comprised 278 branches in Greece as at 30 June 2023. In addition to its retail banking network, the Issuer also has six private banking centres and 16 corporate banking centres in Greece.

Eurobank is party to a cooperation agreement with ELTA, Greece's national postal services provider ("ELTA"), which has a significant network of more than 610 branches in Greece. Through ELTA the Issuer provides extensive nationwide services to its customers, even in remote geographical areas of the country.

External Sales Networks

External Sales Networks have the responsibility to develop B2B cooperations and synergies, aiming to increase sales volumes mainly in the following sectors:

- financing of new and used vehicles
- mortgage & green loans
- loans to RBB's clients

Currently, the unit is managing relationships with more than 1.000 intermediaries, while maintaining its leading position in the auto market for the last decade.

Alternative Channels

Self Service Terminals (SSTs)

As at 30 June 2023, the Issuer's self-service terminals network comprised 1,528 points of sale, 342 automated teller machines ("ATMs") and 445 automated transaction centres located in branches of the Retail Banking network, as well as 627 ATMs located in non-Eurobank sites and 114 ATMs located in Hellenic Post Offices. During the first half of 2023 the SSTs usage share for cash deposits to branch deposits accounted for approximately 91 per cent of the Issuer's banking monetary transactions. Also approximately 98 per cent. of its total cash withdrawals were from ATMs over the same period. The Group's fleet of SSTs was enriched with 25 Business Corners, a new Self Service Cash Deposit machine for heavy usage customers. The replacement of both the off site ATM fleet and the automated transaction centre fleet with new technology machines was completed, while audio guidance for people with impaired vision, as launched at new technology ATM fleet.

Contact Centre (EuroPhone Banking)

EuroPhone Banking is a customer service and cross sales oriented banking contact centre and one of the key alternative channels for promoting the Issuer products and services. As a service channel, it offers every available communication touch point to clients, such as phone calls, emails, personal messages, Web forms and Click2Chat, as well as a large number of banking transactions 24/7, via both agents and automated system with natural language understanding technology. In this context and in line with the Bank's initiative to support employment in remote areas, approximately 45 agents were operating in Thrace, Northern Greece.

The contact centre's well-trained team also contributes to Eurobank's sales goals on Bancassurance products. For the half year ended 30 June 2023, in approximately 1.81 million contacts with over 200,000 unique Eurobank customers, 0.94 million monetary and platform transactions were processed via EuroPhone Banking, with an aggregate value of approximately € 39 million.

Based on results of automated customer surveys that were successfully launched throughout the first half 2023, total customer satisfaction from the services provided was high,. The percentage of customers stating “Very satisfied” and “Extremely satisfied” reached 74%, while the percentage of customers stating that they were served during the 1st call reached 80%.

Telemarketing

Telemarketing is an alternative channel, which promotes products and services to existing Eurobank customers' through outbound calls, in cooperation with IB, PB, RBB segments. Telemarketing offers direct, personal and two-way communication while sales process is completed either by phone and ebanking or at the customer's preferred location. The main products sold are credit cards, debit cards and small ticket bank assurance products. For the first half ended 30 June 2023, Telemarketing, among other activities, produced 2,680 credit cards and 4,129 debit cards

v-Banking

Eurobank's v-Banking exists from 2017 and it has been developed as one of the major channels of Eurobank. v-Banking effectively combines personalised contact and business counselling through interactive video communication, advanced technological functionalities and transactional service by a dedicated relationship manager. It exclusively serves about 30,000 customers (legal entities and individuals) from all customer segments (i.e small business, personal banking, individual banking and international) via video through which they can conduct all transactions/operations but cash.

Centralised complaints management

The Bank has established a centralized complaints handling process to ensure that every case is dealt with transparency and objectivity while complainants are provided with prompt and fair responses. At the same time, the Bank focuses on analysing the causes of complaints and continuously works towards improving the services offered and enhancing the customers' experience. The volume of complaints received in the first half of 2023 was reduced by 26 per cent versus the same period of 2022 while 49 per cent was resolved within two business days. The average resolution time reached 8.9 calendar days while at the same time, customer satisfaction rate for complaints handling reached 59 per cent versus 52 per cent of the same time period of 2022 .

Group Digital Banking

Eurobank leverages its high expertise to provide innovative and data driven financial products, make them easily accessible and deliver them in a simple and personalised manner focusing on customer value and bringing technology closer to everyone, acting as digital and phygital key enabler, and the Issuer's digital culture main ambassador. The Group continuously invests in tools and develops capabilities aiming to become a digital banking leader with innovative e-products, enhanced operational efficiency and customer service excellence. Special emphasis is placed on leveraging the wealth of data (through the use of advanced analytics and artificial intelligence technologies), on continuously improving user

experience and on embracing relevant ecosystems and establishing partnerships with third parties to deliver additional value to the Group's clients.

Digital initiatives and services

Eurobank's digital strategy focuses on the simplification of its operating model and the continuous development of innovative and user-friendly digital services in the following areas:

- complete digital offering of banking products and services that meets customer needs and expectations with seamless, personalised and cross-channel experience;
- end-to-end self-service digital platform with best-in-class user experience to fully cover daily transactional needs;
- scale-up of big data usage and advanced analytics capabilities; and
- internal processes redesign, optimal use of digital technology capabilities in the Issuer's day-to-day operations and way of working and eventual transition to a paperless bank.

Digital channels (e-banking, mobile app and open banking)

Eurobank's digital services offer a wide range of online transactions, advanced security mechanisms and interactive 24-hour support, as well as a number of innovative services including account aggregation, mobile wallet and end-to-end digital sales with the use of electronic signatures.

Eurobank's digital channel was awarded "Best Consumer Digital Bank in Western Europe" by the internationally renowned American magazine Global Finance (September 2022).

Eurobank received awards (August 2022) for the subcategories "Best Consumer Digital Bank in Greece for 2022", "Best Corporate Digital Bank in Greece for 2022" and "Best Open Banking APIs in Western Europe for 2022 (Consumer)", highlighting its role as the "Digital Bank that puts you first" and rewarding its comprehensive strategy to strengthen its digital offering and its contemporary digital culture.

Within the first half of 2023 a selected range of new products such as debit card issuing, a personalized needs-based loan selection mechanism, support for government issued virtual cards as well as customer requested and security related enhancements were introduced within Eurobank's digital ecosystem. Additionally, digital channels were upgraded with accessibility features as well as advanced click to chat, robochat facilities and new API Platform and revamped API Portal were launched.

Eurobank's digital banking channels continue to grow. Until 30 June 2023 YTD, 1,705,000. customers, individuals and businesses were serviced through these channels, an increase of 9.5per cent. in active users and 16 per cent. in transactions, compared to June 2022 YTD . The digital banking share of total Eurobank monetary transactions was 65 per cent. Until 30 June 2023 , whilst the digital banking share of total Eurobank transfers and payments was 94.4 per cent. in the same period. Furthermore, 1.19 million

customers accessed the Eurobank mobile application in the first six months of 2023, an 18 per cent increase of active mobile users compared to June 2022 YTD

As at 30 June 2023, open banking channel served 100,000 customers with 3,300.000 calls. Transaction volume was 3.3M €.

Digital presence – website management & digital analytics

As at 30 June 2023, the website www.eurobank.gr had 14.24 million visits (remaining at the same level compared to the same period in 2022), 7.6 million of which came organically from search engines. The total number of engagements (form submissions, calculators' usage, pdf downloads and redirects to App stores) was 379,652, (a noticeable increase of 25.0 per cent compared to the respective period in 2022). Thus, the website overall managed to attract more "targeted visitors" leading to an improved website conversion rate (from 2.1% to 2.7%).

New tools, sections and functionalities were built in order to facilitate business initiatives while increasing customer satisfaction and sales (namely a new mortgage calculator with credibility checks, a tool for calculation of instalments of future rate changes for mortgage loans, robochat – eurobank's digital assistant in retail section, redesign of loyalty calculators (yes visa, masoutis visa, reward mastercard, new pages for governmental vouchers (market pass, dentist pass), new sections for subsidized programs for small businesses, new pages for branch accessibility for people with autism, new pages for My Advantage programs.

Regarding digital analytics, the Issuer followed a similar strategy to previous years, focusing on analytics, tracking development across all main digital properties (e.g., Eurobank.gr, e/m banking) and upgrading to Google Analytics 4 and data migration for all websites. The objective is to collect data from all possible sources, in order to analyse key digital factors, such as user behaviour and key user actions (e.g., form submissions).

Eurobank's digital analytics team performed special testing to examine different scenarios on page designs, copies and functionalities, with the main driver being the increase of conversion rates. The results led to overall changes in page designs that affect the whole user experience on the Issuer's digital properties.

Digital presence - Social Media & Digital Engagement The Issuer has 10 active channels on different platforms, such as Facebook, LinkedIn, Instagram and YouTube, recording more than 162,199 interactions. Through these channels the Issuer managed both content production, with 483 content opportunities across social media platforms, and community management servicing 3,727 user comments. Community management across the Issuer's social media channels helps the Issuer forge

better customer relationships within the digital environment, but also introduces a new approach to the bank-customer relationship and digital sales.

The Issuer's LinkedIn presence became a [Global Case Study](#). Eurobank prepared and executed the first "LinkedIn Connect" event in Greece with 90 industry leaders and HR professionals from 40 companies hosted in Eurobank premises. Eurobank was ranked first in interactions and second in followers on LinkedIn and first in video views on YouTube across the banking sector. The loyalty page "Επιστροφι" on Facebook was first in interactions and video views across the Greek banking sector. Other highlights were the 30 native articles regarding 8 subject matters in 20 digital media news outlets, that further promoted the Issuer's products and campaigns during the year. The team has also generated more than 24 weekly and monthly digital monitoring reports that record the digital footprint of the Issuer and the competition on web, blogs and social media. The Issuer's in-house Creative hub team (Digital Copy & Designers) generated significant deliverables (776) of digital content for 162 projects for Group websites, 81 email campaigns and 22 new Digital Channels products, project flows, microcopy needs and robochat. For these projects the team aims to optimize deliverables by implementing new trends of HTML code, adopt a minimal content approach and utilize new personalization capabilities .

Digital presence – performance marketing

Performance marketing supports business growth through the utilisation of digital advertising platforms, such as Google Ads, DV 360, Meta ads (Facebook/Instagram), LinkedIn ads, Project Agora, Yahoo DSP, Spotify and Engageya. It helps business growth directly, supporting digital sales in achieving their sales targets, and indirectly through marketing campaigns aiming at increasing brand awareness. In the first half of 2023, 50 digital campaigns were executed, reaching 4m+ users with ~195m impressions, ~9m video views and ~2,5m+ clicks

User experience (UX Research & Design)

The Eurobank UX team is responsible for accelerating customer and employees' experiences across channels and touchpoints, based on data and user insights. Over time the team has sustainably increased UX research and design coverage across core channels (e.g., eBanking , the Eurobank mobile app, websites and ATMs) internal systems and back office applications and other initiatives.

Eurobank is leveraging its state-of-the-art UX Lab facilities, Digital Community and Digiators, to perform user research and update product development efforts at all stages. Through these research activities, we identified customers' insights and used them to design user friendly products and experiences.

Digital sales

Eurobank has set up an integrated portfolio of digital products, always aiming at providing optimal digital experience and service. The Issuer offers a range of digital products, such as e-Debit Card, e-credit card, e-prepaid, e-loans (e.g. "Fast loan", "Green Fast loan" "Personal Banking Loan", "Group Sales Loan", "My Fast Loan"), e-auto, e-safe pocket, e-Sweet Home Content, Cyber Protection, "Eurobank

My Advantage Banking” packages, e-term deposits, e-time deposits, Mutual Funds current & savings account opening, as well as Digital onboarding to non- customers. Additionally, the Issuer has already launched new capabilities and customer journeys, connecting the digital with the physical world (the “phygital” model). For example, through the Digital Safebox, the Issuer can sell a product remotely via phone, and the customer can review, accept and sign the product securely through e-Banking or the mobile app.

Furthermore, for convenience and ease of use, a customer can reach our representatives from the comfort of their home, by performing a video call through eurobank.gr. Our customers have the capability to be informed and apply for a mortgage loan.

Customer Journeys

The Bank aims to enhance customer experience by simplifying and redesigning major customer journeys. As a result, Eurobank has already achieved a Net Promoter Score (“NPS”) over 40 in all major customer journeys.

With regard to onboarding of new customers, Bank has revamped both customer and employee experience by using e-KYC services where possible, thus reducing the requirements for customer signatures by 80 per cent.

Consumer Lending: automated credit decisioning has reached a point of 80 per cent., resulting in process time improvement. More specifically, both “time to yes” for credit cards and “time to cash” for consumer loans have dropped in less than one and a half days.

Further automated credit decisioning has been achieved in retailers’ loans, depicting an average of more than 90 per cent. in automated decisions.

In Small Business lending, an OCR mechanism is applied, further simplifying the data input process. A substantial portion of loan contracts are generated automatically, reflecting reduced operational cost for the Bank. “POS Cash Advance” is the first small business lending product with full automated loan generation and automated disbursement in about one day.

In Bancassurance journeys, we have managed to reduce paper circulation by at least 70 per cent. in key products, achieving a release of -3 million pages per year. Customers can digitally sign contracts via digital safe box, enjoying an enhanced digital experience.

Advanced analytics and campaign management

The recommendation engine is continuously enriched with new machine learning models as well as business rules that predict the likelihood of a customer uptaking a specific service or product, providing at least one product recommendation for more than 65 per cent. of the total number of active transactional clients. Recent personalisation initiatives have contributed significantly to the sales uplift and have

demonstrated that the use of advanced analytics in promotional messages can significantly increase the efficiency of direct marketing.

Through the campaign management platform, more than 50 million contacts were carried out from all digital and physical communication channels. More than 30,000 executions were successfully managed with 90 per cent. automation.

Customer feedback has been enriched with more elements focusing on customers' moments of truth, such as transactions and product purchases which are accompanied by and analysed through customer surveys. Natural Language Processing is used to extract concepts and categories from customers' comments and specific close-the-loop actions have been automated for our customers based on their perceived value and response.

Finally, Advanced Analytics have been also applied to anti-money laundering investigations with the key deliverable being a comprehensive Graph Databases that helps in investigating high risk communities.

Eurobank's Net Promoter Score (NPS) and customer feedback are available to all consumers and decision-makers through visualisation and have become the main source for initiating actions for customer experience management.

Innovation centre

Eurobank's Innovation Centre mission is to provide fast paced and focused innovation for the Issuer and increase profitability and efficiency in accordance with the Issuer's strategy. Through the use of innovative methodologies, emerging technologies, open innovation and collaboration with Fintechs, its main objective is to create new and innovative solutions for the Issuer, improving customer experience and identifying streamlined solutions whilst being a reference in innovation and digital services.

The Innovation Centre with its established eXplore program is spearheading and promoting innovation across Eurobank, through small interdepartmental teams composed of the Issuer's employees experimenting with new ideas and developing concepts tested in potential clients, to assess concepts and ideas. A combination of tools from the Agile, Design Thinking and Lean Start-up methodologies is forging participants to adopt an Innovation and entrepreneurship culture, focusing on clients, identifying their needs, and developing new products and services while providing a better and more personalised customer experience.

The Innovation Centre with its Innovation & UX Labs encourages entrepreneurship, intrapreneurship and innovative thinking throughout Eurobank, connecting it to Fintech companies and improving customer experience.

The **Innovation Clinic** concept was also introduced, aiming to bring together and accelerate the best ideas and expertise from all units across the Bank, fostering collaboration and innovation in new product development through a dynamic and collective process.

Corporate and Investment Banking

Overview

The main objective of Corporate and Investment Banking (“**CIB**”) is to provide fully integrated business solutions and excellent customer service to its clients both in Greece and in South eastern Europe, who are large and complex corporate customers, medium sized enterprises and institutional clients. Furthermore, it is responsible for managing the liquidity and funding needs of the Bank, as well as handling of the trading and investment portfolio of the Bank. CIB’s structure is designed to be responsive to market conditions and to the expectations and needs of its sophisticated client base, ensuring efficient provision of services based on market and industry expertise and know-how.

Large corporate unit

LC is responsible for covering the rising and complex strategic, financial, structuring and banking needs of very large and sophisticated corporate clients with turnover of above €150 million and a presence in Greece and/or Southeastern Europe. LC serves as the main point of contact for all financial solutions and products included in the Issuer's portfolio for these clients. In total, the portfolio consists of more than 100 groups in Greece and is mainly focused on the energy, industrial, consumer and retail, services, health and construction sectors.

Commercial banking unit

CB’s strategy is to build a strong holistic relationship with mid-cap and medium-sized enterprises, through providing both standard and tailor-made financing solutions, as well as transaction banking, treasury and insurance services, in the most efficient manner. The calibre and drive of its experienced CB relationship management team are key to providing prompt delivery and quality service to the Issuer's clients.

The CB network oversees the relationship with medium-sized clients nationwide through a network of 11 business centres (three of which are flagship centres) and three business units.

This structure aims to ensure:

- proximity and quality of services offered to clients through better business understanding; and
- closer monitoring of clients’ performance and proactive action in order to mitigate risks and maintain the quality of the Issuer’s assets.

In co-ordination with the Group’s specialised CIB business units, CB offers a range of commercial banking products and services to clients, including a wide variety of funding solutions, treasury products, cash management and transaction services, investment banking and structured financing.

Structured finance

Structured Finance is responsible for providing specialised structured financing products and services and operates as a centre of expertise for Greece and all the countries of Southeastern Europe where the Group has a presence. All Structured Finance units focus on building long-term relationships with their clients, offering tailor-made financing solutions aimed at meeting customer needs, utilising their deep expertise in the respective fields. The focus is on maintaining strong relationships not only with the strategic players in the market, but with all types of investors, including private equity firms and funds. Structured Finance has five units, offering full and integrated services in the following areas:

Project finance

The Project Finance unit provides a broad range of services, primarily involving financial consulting, structuring and arrangement and provision of debt and derivative instruments for complex financing for major infrastructure and energy projects in Greece and other Southeastern European countries, as well as for public-private partnerships (“PPPs”). The unit also provides financial advisory services in relation to such projects. It combines solid experience and leading capabilities in the relevant sector. During 2022 and the first half of 2023 there was a significant expansion of the relevant portfolio.

Project Finance is expanding its lending portfolio in both infrastructure and energy sectors (green and transitional technologies); while non-performing loans amount historically to less than 1 per cent. of the portfolio.

A strong expansion of the relevant portfolio is expected in the green and – to a lesser extent – digital pillars, taking into account the opportunities resulting from the utilisation of the National Recovery and Resilience Plan “Greece 2.0”.

Commercial real estate finance

The Commercial Real Estate Finance (“CRE”) unit is a specialised unit involved in the structuring, arrangement and provision of debt instruments for all types of large commercial real estate, such as office buildings, malls, retail parks, logistic centres and mixed-used complexes and, to a lesser extent, industrial facilities, as well as large scale residential complexes, both during development as well as investment of assets. The portfolio is performing strongly, even after the COVID-19 crisis, and base interest rate increases without the need for any additional support of forbearance measures in addition to the state-provided moratoria and measures. Some additional focus is provided to green building development.

Mergers and acquisitions and sponsors financing & Mergers and acquisitions financing and structured solutions (collectively the “M&A Financing Units”)

The M&A Financing Units seek to establish dialogue as well as build and maintain relationships with the investor community in Greece and abroad focusing on the origination of new transactions in the M&A

Finance space. The M&A Financing Units specialise in structuring, arranging and financing acquisitions and “management buyout” transactions as well as complex structured financings. Furthermore they act as an internal advisor to other Eurobank units, when it comes to structured deals. Most recently, the units are providing products that support NPLs handling platforms in the achievement of their targets. The units, if not the only dedicated ones, are recognised as leading in the Greek market.

Hotels and leisure finance

The Hotels and Leisure unit was established in 2013 as a specialised unit aiming to provide integrated financing solutions and services and meet the specialised needs of corporate clients in the hotel industry.

The unit's loan portfolio focuses primarily on hotel capital and operating expenditure financing, cash management, hotel acquisition financing as well as balance sheet and operational restructurings. The unit's strategy is to capitalise on its long-term relationships in and knowledge of the hotel sector, being also a partner of SETE (the association of Greek tourism enterprises) since 2011, in order to provide appropriate solutions.

Hotels that receive financing from the Issuer are mainly located at the most popular holiday destinations for international tourists in Greece, including Crete, Dodecanese islands, Mykonos, Santorini, Paros and the Ionian islands and, to a lesser extent, in selective locations in the major city destinations.

During the COVID-19 crisis, hotels financed by the Issuer outperformed the market in terms of their results, with NPE / non-performing forborne reclassifications being fairly limited, whereas results for 2022 and indications for 2023 are strong.

A cautious expansion of the relevant portfolio is expected, taking into account the opportunities resulting from the utilisation of the NRRP “Greece 2.0”, increased M&A activity in the sector and solutions and services currently under development.

Shipping

Eurobank has 30 years of experience in shipping finance. Clientele consists of Greek shipping companies with long track record, as private traditional family companies or as parent companies. Shipping finance is extended only to companies of Greek beneficial ownership with an established presence and medium to large fleets, for financing purchases of either second hand or new-build vessels employed in transporting dry bulk cargo, wet cargo and containers.

The Shipping Division's primary objective is to maintain Group's leading position in the Greek shipping market as a strategic player offering a full range of shipping-related products and services. The Group seeks to maintain the high credit quality of its shipping portfolio, further develop its long standing relationships with its core client base and enter into new client relationships that meet its credit criteria.

The Shipping Division is based in Piraeus and acts also as a “Shipping Hub” for the Group, servicing Greek shipping companies through Eurobank Cyprus and Eurobank (Private) Bank Luxembourg S.A. The Group’s Greek shipping business is strategic due to the importance of shipping sector in the national economy and helps to cross-sell various banking products and strengthen the Group’s deposit base.

Investment Banking and Principal Capital Strategies

Investment Banking offers mergers and acquisitions advisory and capital markets services to a wide range of corporate clients, their shareholders and private equity firms. The M&A team provides customised solutions regarding mergers, acquisitions, divestitures and capital restructurings. In addition, the Capital Markets team offers advisory and underwriting services with respect to clients' capital raising needs.

Syndicated Debt Solutions

Syndicated Debt Solutions (“**SDS**”) acts as an expertise advisor in the organisation, structuring and executing for each client in large scale transactions. More specifically it is responsible for structuring and arranging a broad range of specialised and structured financing deals, including corporate syndicated loans and bond loans, leveraged buyout structures and convertible and exchangeable bonds.

SDS also manages secondary loan trading activity, liaising with international banks’ trading desks, funds and brokers aiming to optimise and enhance the Issuer’s portfolio and market position.

Other Businesses

Cash and Trade Services

CTS, has adopted an innovative Phygital model that combines cutting-edge technologies with the human factor in a balanced way, implementing an ambitious investment program in digital banking. The Global Transaction Banking Sector suite of services offers a holistic set of tools and services that facilitate the businesses’ daily operations, including electronic management and online processing of collections, execution of individual and/or bulk payments, as well as the secure processing of international trade transactions.

In Trade and Supply Chain Finance, which involves the financing and management of international trade transactions, including the financing of imports and exports, issuing and confirming of letters of credit, issuing of trade related letters of guarantee and the management of trade-related risks, CTS in cooperation with international and supranational banks like the European Bank for Reconstruction and Development (the “**EBRD**”) and the European Investment Bank (the “**EIB**”) helps businesses to navigate complex regulatory requirements and manage supply chain risks, enabling them to expand their global reach and compete in new markets.

At the same time, the Bank, has integrated the best international practices in connectivity and knowledge ecosystem initiatives that offer businesses reliable solutions to accelerate their digital transformation and enhance their extroversion and competitiveness. Among those are the award-winning international trade portal Exportgate, a valuable tool for Greek and Cypriot businesses, and the Digital Academy For Business a strategic initiative to boost the businesses' competitiveness.

Exportgate is a member of the Trade Alliance network, following the strategic agreement between Eurobank and Santander, and the platform provides Greek and Cypriot companies the opportunity to connect with reliable international counterparties in more than 60 countries and respond to international request from others. Trade Club Alliance is a unique digital global business network supported by 13 international banking groups.

Securities Services

Since its establishment in 1992, Eurobank has built a strategic presence in the securities services business. The Group's success in this area has been driven primarily by its long-standing commitment to high service standards and the provision of a full range of post-trade services in Greece, Cyprus, Luxembourg, and Bulgaria.

Eurobank is the only provider in Greece offering, the most comprehensive spectrum of services including local and global custody, clearing services (spot, derivatives and energy markets), funds administration, depository and middle-office services, issuer services, margin lending, and escrow services, to both local and foreign investors.

The continuous acknowledgement of the quality of the Issuer's regional custody services by the specialised industry magazines such as “Global Custodian” and “Global Finance” reflects the Issuer's

constant commitment towards its clients in particular, and the securities services industry in general.. The most recent awards received by the Issuer in this area are:

Leasing

Eurobank Leasing S.A., a 100 per cent. owned subsidiary of the Issuer, held a market share of 30,7 per cent. in new business volumes by 30 June 2023. (Source: Association of Greek Leasing Companies).

Eurobank Leasing has long and extensive experience in the Greek market and is present in all investment plans for productive equipment, having the capacity and expertise to participate in complex financial lease transactions. Eurobank Leasing operates as a separate product centre within the Group, thus enabling it to make use of important economic and cost synergies, while at the same time retaining an independence, which ensures flexibility and speed in dealing with key business, risk and legal aspects of leasing.

Eurobank Leasing's main goal is to provide financing mostly to export-oriented, productive companies in the form of leasing of production equipment, machinery, vehicles and selective real estate, either through standard leases, or connected with development laws.

Factoring

Eurobank Factors S.A., a wholly-owned subsidiary of Eurobank S.A., is the leading factoring company in Greece by market share (around 33% according to the Hellenic Factors Association), a two-time worldwide gold winner of Best Export Import Factor Award (2009 and 2011) and a silver and bronze medallist as Export Factor (2021 and 2017 respectively), granted by Factors Chain International, the largest world factoring association. The company's performance in 2022 reached new historical highs in terms of turnover and lending balances followed by an indication of equally solid profitability

Markets and Asset Management General Division

The Markets & Asset Management General Division (“**Markets**”) is engaged in five primary categories of activities:

- financial products and services to corporate, shipping, institutional, retail and private banking clients;
- wholesale funding origination for the bank syndicate of Greek corporate issuers;
- trading, risk and investment portfolio management;
- wholesale bank funding (secured/unsecured), liquidity and banking book asset-liability management; and
- interbank relations and payment services.

The Trading Division is a designated market maker for GGBs; the team actively trades global fixed income, foreign exchange, derivatives and several sophisticated products while providing market access and liquidity to the Issuer’s clients.

The Sales and Structuring Divisions offer a wide range of products across asset classes. The focus is on comprehensive client solutions using technology and automated (“**STP**”) booking processes. In house developed functionalities ensure timely and cost efficient offering, ranging from plain vanilla FX to bond primary market online participation.

Markets operates a centralised model based in Greece, where all positions and risks are consolidated, and offers an integrated approach to Greece and the other countries. In each country of the Group , Markets operations are standardised and report directly to Athens and to the local CEO.

The Group’s strategic goal is to retain and further expand its significant regional presence and business activities in the fields of asset liability management, foreign exchange, interest rates and fixed income, wealth management solutions and structured products offering to its clients.

Treasury is active in the wholesale funding capital markets, as well as the interbank market, in order to manage i) the interest rate and currency risks of the banking book, ii) the bank’s short term and long term liquidity needs and its funding cost and iii) the bank’s regulatory requirements (MREL, LCR, NSFR) as appropriate in the context of its established risk management framework and business objectives.

Treasury Sector also maintains a dedicated Correspondent Banking Division offering specialised relationship management for all its clients. The Issuer provides centralised payment services, enabling cost-effective payments, execution and optimal cash management solutions. The Issuer’s payment services are ISO 9001:2008 certified and have been recognised by the Citi Straight Through Processing

Excellence Award for U.S. dollar and euro payments and the Deutsche Bank's International Award for Operational Excellence in international payments in U.S. dollars and euro.

The Group sets strict limits for transactions that it enters into and these are monitored on a daily basis. Limits include exposures towards individual counterparties and countries, as well as VaR limits. The Group uses an automated transaction control system, which supports the dealing room in monitoring and managing positions and exposures.

Subsidiaries under Markets & Asset Management General Division's Supervision

Asset Management

The Group provides fund and portfolio management services in Greece and abroad through its specialised subsidiary, Eurobank Asset Management MFMC. Eurobank Asset Management MFMC holds the leading position with total assets under management and supervision amounting to over € 5,4 billion as at 30 June 2023.

Eurobank Asset Management MFMC managed €3.8 billion of assets in UCITS funds domiciled in Greece, Luxembourg and Cyprus and had a market share of 27,3 per cent., holding the 1st position among 14 Greek Asset Management Companies as of 30 June 2023 (Source: Hellenic Fund and Asset Management Association).

Eurobank Asset Management MFMC also offers portfolio management services to 21 Institutional clients, mainly Pension Funds in Greece and Cyprus, with a total of € 0,6 billion of assets and also provides Discretionary Portfolio Management Services to Eurobank Group Private Banking Clients with total Assets €0.6 billion of assets as of 30 June 2023.

Additionally, Eurobank Asset Management MFMC supports the distribution by the Bank of External Asset Managers' UCITS funds, by providing among others, analysis, ranking and model portfolios for Group Private Banking clients. As of 30 June 2023 distributed assets of External Asset Managers total €0.4 billion.

The Group also has presence in the Luxembourg Funds Industry, one of the major global funds' hub, through its 100% subsidiary, Eurobank Fund Management Company (LUX) S.A. Eurobank Fund Management Company (LUX) S.A offers a wide variety of UCITS funds under the umbrellas (LF) Funds, (LF) Fund of Funds and (TLF) Funds, that are distributed in Greece, Luxembourg, Bulgaria and Cyprus. The UCITS funds cover a broad range of all asset classes, with geographical diversification.

Eurobank Equities

Eurobank Equities S.A. provides a full range of trading and investment services to over 15,000 private, corporate and institutional clients in Greece and abroad. The firm has a dominant presence in the domestic capital markets, as showcased by its leading market position in terms of market share (ranked

first for 10 out of the last 14 years) and its recognition in the Pan European Institutional Investor Survey (formerly Extel) as one of the leading brokers in Greece (five times “Number One Broker” since 2014) and as a top Equity Research Provider for Greece post 2010 (six times Number One, six times Number Two).

Eurobank Equities’ award-winning Research division provides timely research and insights and covers more than 24 companies, accounting for more than 85% of market liquidity and more than 80% of market cap of the ATHEX capitalisation and 90 per cent. of the traded value. It also provides secondary coverage on the largest foreign markets and listed large cap names.

The firm's Institutional Sales and Trading desk offers sales and execution services to Greek and global institutional clients involved in domestic equities and derivatives by providing valuable local insight and idea-focused investment advice.

Through its broad sales network, Eurobank Equities also maintains a leading position in the retail brokerage segment, offering access to a full range of investment products, including trading in stocks, derivatives, bonds and mutual funds in both the Greek and international markets.

Eurobank Equities also provides market-making services in both the cash and derivatives market.

Private Banking

Group Private Banking unit offers a wide range of investments products and services (execution-only, advisory and discretionary) as well as wealth management and structuring services (credit facilities, family office structuring and fund administration services). Besides the Issuer’s in-house funds, the three Private Banking units in Greece, Luxembourg and Cyprus also distribute the UCITS Funds from 14 international fund managers, complementing the Issuer’s own local expertise with that of some of the most reputable managers in the world.

As at 30 June 2023, Private Banking was asset servicing more than 13,000 clients with assets under management reaching €10.6 billion, .

The Group’s “Next Generation” Private Banking model is based on a strategic country-wide homogenisation of operations and establishment of a single customer journey, which will be technologically supported by the newly acquired capabilities of the Temenos platform, already rolled out in Cyprus in April 2023 and expected to be launched in Luxembourg shortly .

International Operations

The Group has a presence in Cyprus, Luxembourg, the United Kingdom and Bulgaria. As at 30 June 2023, the Group’s international operations had total gross loans and advances to customers of €9.8 billion, total deposits of €16.9 billion, 223 branches and 22 business centres. A key priority of the Group

is to support businesses and households in these countries, thereby confirming its systemic role in the wider region.

The prospects for the performance of Group's International Operations remain positive despite the challenges in the global economic and geopolitical environment. International Operations business model and solid fundamentals allow to effectively respond to the challenges, safeguarding their profitability, promote sustainable prosperity in the local communities and create value for their clients, employees, shareholders, and the society at large

On 2 March 2023, the Group announced that it signed a binding share purchase agreement with AIK Banka a.d. Beograd (AIK) for the sale of its 70% shareholding in its subsidiary in Serbia, Eurobank Direktna a.d. Consequently, in March 2023 the subsidiary was classified as held for sale and its results are presented as discontinued operation. The transaction is expected to be completed within the second half of 2023

On 4 April 2023 the Group announced that, following the receipt of the relevant regulatory approvals, it has completed the acquisition from Wargaming Group Limited of an additional 13.41% holding in Hellenic Bank Public Company Limited ("Hellenic Bank"). Following that, the total holding in Hellenic Bank including the previously held participation of 15.8% on the above date, reached 29.2%.

Furthermore, on 30 August 2023 and following the announcements dated August 23rd and 25th, 2023, the Group announced that it has agreed to acquire in total 7.2% holding in Hellenic Bank Public Company Limited ("Transaction"). The completion of the acquisition is subject to customary regulatory approvals. The Group currently holds 29.2% in Hellenic Bank, therefore after the completion of (a) the Transaction and (b) the acquisition of the 17.3% stake from Poppy S. à r.l and the 1.6% stake from Senvest Management LLC that were announced on August 23rd and 25th respectively, its total holding in Hellenic Bank will amount to 55.3%.

Further to the announcement on 9 December 2022, Group announced on 1 June 2023 that the acquisition of BNP Paribas Personal Finance Bulgaria by Postbank, was completed on 31 May 2023, following the receipt of the approvals by all competent regulatory authorities.

Bulgaria

In Bulgaria, the Group operates through its wholly-owned subsidiary, Eurobank Bulgaria AD ("**Eurobank Bulgaria**"), known under its commercial brand "Postbank", which operated 223 branches and 12 business centres as at 30 June 2023. As at the same date, the Group in Bulgaria had total gross loans of €6.4 billion, of which 51 per cent. were retail (household) loans and 49 per cent. were business loans, and total deposits of €7.3 billion.

The Group's operations in Bulgaria reported a net profit before restructuring costs of €100.7 million in the first six months of 2023. Eurobank Bulgaria's capital adequacy ratio (regulatory capital over risk-

weighted assets) was 21.2 per cent. as at 30 June 2023, significantly higher than the Bulgarian Central Bank's minimum requirement of 16.5 per cent.

Eurobank Bulgaria is successful in attracting deposits, maintaining its cost of funds at low levels and a strong liquidity base reporting a net loans to deposits ratio of 85 per cent. as at 30 June 2023.

Eurobank Bulgaria is a universal bank offering a full range of products and services to both individual and corporate customers servicing its local and international needs. With regards to retail banking products in particular, Eurobank Bulgaria holds strong positions in mortgage lending, consumer lending, credit cards and deposit products. Eurobank Bulgaria has a strong culture in corporate banking, offering tailored made products to corporates ranging from small businesses to large international companies operating in Bulgaria.

The acquisition of BNP Paribas Personal Finance Bulgaria, which was completed on 31 May 2023, strengthens Postbank's position in the Bulgarian retail sector, while it also provides significant opportunities for cross-selling, given BNP Paribas Personal Finance Bulgaria's clientele of more than 300 thousand clients.

Cyprus

In Cyprus, the Group operates through its wholly-owned subsidiary, Eurobank Cyprus Ltd ("**Eurobank Cyprus**"), which operated eight banking centres as at 30 June 2023. As at the same date, the Group in Cyprus had total assets of €8.6 billion, total deposits of €7.3 billion and total gross loans of €2.6 billion, and a net loans to deposits ratio of 35 per cent. Eurobank Cyprus maintains a strong liquidity and capital base, a very good quality of loan portfolio, with surplus liquidity primarily invested in low-risk short-term assets.

The Group's operations in Cyprus reported a net profit of €89.7 million for the six months ended 30 June 2023. Eurobank Cyprus is strongly capitalised with a capital adequacy ratio (regulatory capital over risk-weighted assets) of 32.1 per cent. as at 30 June 2023, significantly higher than the minimum overall capital requirement set by the Cypriot central bank of 13.627 per cent.

Eurobank Cyprus has five main pillars of business namely, corporate banking, wealth management international business banking, capital markets and affluent banking.

Luxembourg and United Kingdom

The Group operates in Luxembourg through its wholly-owned subsidiary, Eurobank Private Bank Luxembourg S.A. ("**Eurobank Luxembourg**") which also operates a branch in London and a representative office in Athens. The representative office was converted into a branch in July 2023 having received all regulatory approvals. As at 30 June 2023, the Group in Luxembourg had total assets of €2.6 billion, total deposits of €2.3 billion and total gross loans of €0.8 billion. The Group's operations in Luxembourg reported a net profit before restructuring costs of €11.9 million in the six months ended

30 June 2023. Eurobank Luxembourg's Basel III capital adequacy was 23.9 per cent. (all CET 1) as at 30 June 2023, higher than the Luxembourg central bank's minimum requirement of 12.35 per cent.

Eurobank Luxembourg offers products and services to private banking customers, including fund management services, as well as tailor-made corporate banking services. Luxembourg is ranked as the Eurozone's top private banking centre and second biggest location for funds worldwide by Luxembourg for Finance.

As at 30 June 2023, Eurobank Luxembourg held private banking client assets under management of €3.5 billion.

Investment Property

The Group is active in the investment property market and controls a significant portfolio of high quality investment properties in Greece, as well as in Central and Eastern Europe, maintaining long-term rental agreements with companies and other property users. The portfolio is managed by experienced personnel with expertise in the Greek and international property markets.

The Group seeks to enhance its presence in the investment property market, with a particular focus on offices, commercial buildings, storage and industrial warehouses in key geographical markets with high growth potential; subject to the prevailing conditions in capital and property markets.

Based on the information currently available to it, the Group believes that there are no environmental restrictions which may have a potential impact on the use of its investment properties.

Management of NPEs

The Group, following a strategic partnership with doValue S.p.A. and the successful transition to a new operating model for the management of NPEs, implements the NPE Strategy Plan through doValue Greece's management of the assigned portfolio of NPEs and the execution of successful securitisation transactions.

The Remedial Servicing and Strategy Sector ("**RSS**") has the mandate to inter alia devise the NPE reduction plan and closely monitor the overall performance of the NPE portfolio as well as the relationship of the Issuer with doValue Greece. Furthermore, following the Issuer's commitments to prevent significant risk transfer ("**SRT**") through the monitoring of regulatory requirements pertaining to the Issuer's executed transactions, RSS has a pivotal role in ensuring that the relevant procedures are implemented smoothly and in a timely manner and that any shortcomings are appropriately resolved, while providing any required clarifications or additional information required by the regulatory authorities.

The Troubled Assets Committee (“**TAC**”) is the Eurobank approval body responsible for providing strategic guidance and monitoring the Issuer’s NPEs, ensuring independence from the business and compliance with the regulatory requirements.

TAC’s main responsibilities are:

- review internal reports regarding troubled assets management under the regulatory provisions;
- approve the available forbearance, resolution and closure solutions by loan sub- portfolio, and monitor their performance through key performance indicators (“**KPIs**”);
- define the criteria to assess the sustainability of credit and collateral workout solutions through the design and use of “decision trees”;
- approve, monitor and assess pilot modification programmes; and
- supervise and provide guidance and know-how to the respective troubled assets units of the Issuer’s subsidiaries abroad.

(i) **Operational targets for NPEs**

In accordance with regulatory requirements, the Issuer is required to submit to the Single Supervisory Mechanism (“**SSM**”) a set of NPE operational targets together with a detailed NPE management strategy with a three-year time horizon on an annual basis. The Issuer has fully embedded the NPEs strategy into its management processes and operational plan. The SSM reviews the Issuer’s progress in meeting its operational targets on a quarterly basis and has the power to request additional corrective measures if it deems them necessary.

In March 2023, the Group submitted its NPE Management Strategy for 2023-2025, along with the annual NPE stock targets at both Issuer and Group level. The plan envisaged the decrease of the Group’s NPE ratio to 5.2 per cent. at the end of 2023 and 4.5 per cent. in 2024. As at 31 December 2022, the Group’s NPE stock amounted to €2.3 billion driving the NPE ratio to 5.2 per cent., whilst the NPE coverage ratio stood at 74.6 per cent.

In addition, in the context of its NPE management strategy, the Group is contemplating an NPE securitisation transaction, as part of a joint initiative with the other Greek systemic banks initiated in 2018 (“**Project Solar**”). The participating banks have applied to include the Project Solar securitization under the Hellenic Asset Protection Scheme (“**HAPS**”), so that the senior note of the securitisation becomes entitled to the Greek State’s guarantee, which is subject to the accounting de-recognition of the securitised loan portfolio from the participating banks’ balance sheet. The Group’s contribution to the above securitization transaction would be a portfolio of corporate NPE of approximately €0.3 billion gross carrying value.

The transaction has been incorporated as Held For Sale in the Group's results of the second quarter of 2022.

Recent Developments/Bank Initiatives

Following the provisions of Code of Conduct Law (L. 4818/2021) the interbank project for the digital platform implementation was initiated in 2022. The digital platform will facilitate Bank's and applicants' communication resulting in the timely execution of the Code of Conduct procedural steps so as to achieve viable restructuring or closure solutions.

In 2022, a subsidy program addressed to borrowers with secured loans affected by the interest rates increase was announced and is offered exclusively by the four systemic Banks. The programme offers for 12 months a subsidy amount equal to 50% of the difference of the current month's instalment compared to the July 2022 reference instalment. In the event that an instalment is more than 30 days past due, during the subsidy period the subsidy will be suspended.

Disaster Recovery and Information Technology

The Group's operations are supported by three state-of-the-art fault-tolerant IT data centres that are designed and operating according to international best practices, utilising the private and public cloud, virtualisation, and environmental protection controls. The Groups' data centres fully meet information security standards and all criteria for seamless operation, including Disaster Recovery capabilities, and are certified to the ISO27001: (since 2004), ISO22301: (since 2013) and ISO9001: (since 2000) standards.

The Group's operations in Greece and its international subsidiaries in Central and Southeastern Europe leverage robust fault-tolerant application architecture. The Group's IT services offer rich core banking functionality integrated with omni-channel architecture, data analytics, information dissemination and risk management capabilities.

Group IT follows a modern IT service management operating model with ISO 20000:certification since 2013.

Cyber security remains a top priority for the Group, which proactively invests in up-to-date, efficient and cost-effective security technologies and controls to address the constantly evolving cyber security threats as well as related regulatory requirements. Cyber security is fully integrated into the Group's strategy, structure and operations, from the development of new digital services and products to the way IT systems, data and infrastructure are safeguarded.

Significant Shareholders and Subsidiaries

Eurobank Holdings is the sole shareholder of the Issuer.

Eurobank Management Team

Board of Directors

Legal Matters

As at 30 June 2023, there were a number of legal proceedings outstanding against the Group for which a provision of €26 million has been recorded, compared to a provision of €28 million as at 31 December 2022. See also note 30 to the 1H2023 Financial Statements.

REGULATION AND SUPERVISION OF BANKS IN THE HELLENIC REPUBLIC

Introduction

The Group is subject to various financial services laws, regulations, administrative actions and policies in each jurisdiction where its members operate, the EU regulatory framework, as implemented into Greek law, and supervision by the ECB through the SSM and the Bank of Greece. The ECB through the SSM and the support of the Bank of Greece is responsible for the licensing and supervision of credit institutions operating in Greece, such as the Issuer.

In addition, through the trading of the Eurobank Holdings shares on the Athens Exchange, Eurobank Holdings is also subject to applicable capital markets laws in Greece.

The ECB is the central bank for the euro area and manages the euro area's monetary policy. The ECB also has direct supervisory responsibility over "significant banks" in the Banking Union (i.e. euro area Member States and any other EU Member State wishing to participate under a close cooperation agreement). Significant banks include, among others, any euro area bank that has: (i) assets greater than €30 billion; (ii) assets constituting at least 20 per cent. of its home country's gross domestic product; (iii) total value of assets larger than €5 billion and ratio of cross-border assets/liabilities in more than one other participating Member State over total assets/liabilities above 20%; (iv) requested or received direct public financial assistance from the European Financial Stability Fund ("EFSF") or the ESM; or (v) is one of the three most significant credit institutions in its home country. The Issuer is a significant bank within this definition and so is directly supervised by the ECB.

Prudential supervision of financial holding companies

Approval of financial holding companies

In accordance with CRD IV, as in force, parent financial holding companies, such as Eurobank Holdings, should seek approval by their consolidating supervisor and, where different, the competent authority in the Member State where they are established.

Pursuant to article 22A of Greek Law 4261/2014 (the "**Banking Law**"), Eurobank Holdings have received approval by the ECB, as its consolidating supervisor, in accordance with the process stipulated in the Banking Law in order to act as the financial holding company of the Bank. Such approval was granted on 12 December 2021 as the following conditions were fulfilled:

- the internal arrangements and distribution of tasks within the group are adequate for the purpose of complying with the requirements imposed by the Banking Law and the CRR on a consolidated or sub-consolidated basis;
- the structural organisation of the group of which Eurobank Holdings is part does not obstruct or otherwise prevent the effective supervision of the subsidiary institutions as concerns the

individual, consolidated and, where appropriate, sub-consolidated obligations to which they are subject;

- the criteria set out in Article 14 and the requirements laid down in Article 114 of the Banking Law are complied with.

Where the ECB has established that the conditions set out above have ceased to be met, Eurobank Holdings shall be subject to appropriate supervisory measures to ensure or restore, as the case may be, continuity and integrity of consolidated supervision and ensuring compliance with the requirements that would be laid down in the Banking Law and in CRR on a consolidated basis. These supervisory measures may include:

- suspending the exercise of voting rights attached to the shares of the subsidiary institutions held by Eurobank Holdings;
- issuing injunctions or penalties against Eurobank Holdings or the members of the management body and managers, subject to the provisions of articles 57 – 64 of the Banking Law;
- giving instructions or directions to Eurobank Holdings to transfer to its shareholders the participations in its subsidiary institutions;
- designating on a temporary basis another financial holding company, mixed financial holding company or institution within the group as responsible for ensuring compliance with the requirements laid down in the Banking Law and in CRR on a consolidated basis;
- restricting or prohibiting distributions or interest payments to shareholders;
- requiring Eurobank Holdings to divest from or reduce holdings in institutions or other financial sector entities; and
- requiring Eurobank Holdings to submit a plan on return, without delay, to compliance.

Minimum requirements for own funds

As part of the SSM, the ECB supervises Eurobank Holdings and the Issuer in relation to the own funds requirements set forth in the CRR, as well as in relation to the requirement to establish a proper business organisation, which includes, *inter alia*, having in place appropriate risk management processes, internal control mechanisms, remuneration policies and practices and effective internal capital adequacy assessment processes, as set forth in the Banking Law. The Bank of Greece has certain remaining supervisory tasks in relation to the Issuer.

The CRR requires Eurobank Holdings to meet at all times, on a consolidated basis, a minimum amount of total own funds of 8 per cent. of the RWA and also imposes minimum requirements for Tier 1 capital of

6 per cent. and CET 1 capital of 4.5 per cent. of RWA (all within the meaning of the CRR). The Issuer is also subject to the above capital requirements at an individual level.

In addition, and on the basis of the annual SREP, the ECB has imposed on Eurobank Holdings an additional capital requirement (2.75 per cent. since January 2023 from 3.00 per cent in 2022), which is referred to as the "Pillar 2" requirement.

Institutions may meet parts of their Pillar 2 requirement with AT1 capital and Tier 2 capital. According to this provision, at least three quarters of such requirement shall be met with Tier 1 capital, of which at least three quarters shall be composed of CET1 capital. Eurobank Holdings must meet a Pillar 2 requirement of 2.75 per cent. own funds with at least 2.06 per cent. Tier 1 capital (of which at least 1.55 per cent. shall be CET1 capital), and may consequently use 0.52 per cent. AT1 capital and 0.69 per cent. Tier 2 capital to meet such requirement. The competent authority has the power to impose a higher share of CET1 capital to meet the Pillar 2 requirement, where necessary. The Issuer is not subject to a Pillar 2 requirement at an individual level.

In addition to both the minimum capital requirements set forth in CRR and the Pillar 2 requirement set by the ECB, certain capital buffer requirements must be met with CET1 capital. The respective CRD IV requirements have been implemented in Greece pursuant to the Banking Law which introduced the following capital buffers:

- (i) the capital conservation buffer;
- (ii) the institution-specific countercyclical capital buffer;
- (iii) the global systemically important institutions buffer (G-SII buffer) or, depending on the institution, the O-SII buffer; and
- (iv) the systemic risk buffer.

Insofar as these buffers are not set out in law, the Bank of Greece, as designated authority, has the power to set the buffer rates applicable to the Bank. In accordance with Article 5 (2) of the SSM Regulation, the ECB may, if deemed necessary, set higher buffer rates than those applied by the Bank of Greece. All applicable capital buffers are aggregated in a combined buffer requirement. In relation to the institution-specific countercyclical capital buffer it should be noted that it may fluctuate as it is calculated as a weighted average of the countercyclical capital buffer rates applicable in the various countries where the relevant credit exposures of the Group are located. The countercyclical capital buffers rates are normally set by the national authorities in their discretion and may differ from country to country. As more than half of the Group's RWA are located in Greece, any implementation of a national countercyclical capital buffer by the Bank of Greece will impact the CET1 requirement of the Group significantly. The Bank of Greece sets a national countercyclical capital buffer on a quarterly basis and the current rate is 0 per cent. which applies for the fourth quarter of 2023.

In addition, following the SREP, the ECB may communicate to institutions an expectation to hold further CET1 capital, the "Pillar 2 guidance". Although the Pillar 2 guidance is not legally binding and failure to meet the Pillar 2 guidance does not automatically trigger legal action, the ECB has stated that it expects banks to meet the Pillar 2 guidance.

Eurobank Holdings is required, on a consolidated basis, to maintain a CET1 capital ratio of at least 9.80 per cent. based on figures as of 30 June 2023. This CET1 capital requirement, includes the minimum Pillar 1 requirement (4.5 per cent.), the CET1 capital portion that is required to meet the Pillar 2 requirement (1.55 per cent.), the capital conservation buffer (2.5 per cent.), the countercyclical capital buffer (currently 0.25 per cent. mostly due to the exposures in Bulgaria, where a countercyclical buffer rate of 1.5 per cent. applies) and the requirement deriving from the Issuer's designation as an O-SII (1.0 per cent.).

Minimum requirements for own funds and eligible liabilities ("MREL")

On 15 May 2014, the European Parliament and the Council of the EU adopted the BRRD (Directive EU 2014/59) which was transposed in Greece pursuant to Greek Law 4335/2015, as amended and in force. For banks established in the euro area, such as the Issuer, which are supervised within the framework of the SSM, Regulation (EU) No 806/2014 (the "**SRM Regulation**") provides for a coherent application of the resolution rules across the euro area under responsibility of the SRB, which is an EU agency. With effect from 1 January 2016, this framework is referred to as the Single Resolution Mechanism (the "**SRM**").

Within the SRM, the SRB is responsible for adopting resolution decisions in close cooperation with the ECB, the EC, the Council of the EU and national resolution authorities in the event that a significant bank directly supervised by the ECB, such as the Issuer, is failing or likely to fail and certain other conditions are met. The national resolution authorities in the EU Member States concerned would implement such resolution decision adopted by the SRB in accordance with the powers conferred on them under the national laws transposing the BRRD. The national resolution authority competent for Greece is the Bank of Greece.

Pursuant to the European and Greek recovery and resolution legislation, banks are required to prepare and submit recovery plans to the competent authority and participate in the preparation of resolution plans by the resolution authority. The competent authority may trigger early intervention measures to confront a deteriorating financial situation. If the requirements for resolution are met, the resolution authority may take resolution action.

Furthermore, affected banks are required to meet their MREL, which is determined by the resolution authority for each bank and the group to which it belongs on an annual basis or at other intervals determined by the authority.

In line with BRRD and the SRB's MREL policy, the Greek banks have been granted an extension until 31 December 2025 to meet their respective final MREL targets. For the Bank, the interim binding MREL

target applicable from 1 January 2022 amounts to 14.51 per cent. of its total risk exposure amount, plus combined buffers, while an interim non-binding MREL target of 20.53 per cent., including combined buffers of 3.75 per cent., applies from January 2023. The fully calibrated MREL (final target) to be met by 31 December 2025 stands at 23.57 per cent. of its total risk exposure amount, plus combined buffers.

Other regulatory developments

On 27 October 2021, the European Commission adopted a proposal for the review of CRR and CRD IV. These new rules are often referred to as the Basel 3.1 or Basel IV framework and will ensure that EU banks become more resilient to potential future economic shocks, while contributing to Europe's recovery from the COVID-19 pandemic and the transition to climate neutrality. In particular, the new legislative proposals are not only implementing the Basel III framework but also contributing to sustainability (and the green transition in particular) and ensuring the sound management of EU banks. The European Commission proposes to give banks and supervisors additional time to properly implement the reform in their processes, systems and practices. In June 2023, the Council and the European Parliament reached a provisional agreement on the new framework, which will start applying from 1 January 2025 with longer transitional period for certain rules.

Compliance and Reporting Requirements

CRD IV, as in force, provides for certain compliance and reporting requirements for the financial institutions falling into the scope of the Directive. Further, according to article 166 of Greek Law 4261/2014, by which CRD IV was transposed into Greek Law, regulatory acts issued under Greek Law 3601/2007 (which was replaced in its entirety by Greek Law 4261/2014) will remain in force, to the extent that they are not contrary to the provisions of Greek Law 4261/2014 or the CRR, until replaced by new regulatory acts issued under Greek Law 4261/2014.

Under the current regulatory framework, credit institutions operating in Greece are required, among others, to:

- observe the liquidity ratios prescribed by the CRR;
- maintain efficient internal audit, compliance and risk management systems and procedures, as determined in the Bank of Greece Governor's Act 2577/2006, as supplemented and amended by subsequent decisions of the Governor of the Bank of Greece and of the Banking and Credit Committee of the Bank of Greece;
- disclose data regarding the credit institution's financial position and its risk management policy;
- provide the Bank of Greece and the ECB with such further information as they may require;
- in connection with certain operations or activities, notify or request the prior approval of the ECB acting in cooperation with the Bank of Greece; and
- permit the Bank of Greece and the ECB to conduct audits and inspect books and records of the credit institution.

The CRR imposes reporting requirements to the EU credit institutions. The respective provisions have been supplemented (as required by Part eight of CRR) by the Commission Delegated / Implementing Regulations. In addition, with respect to matters not governed by the CRR, periodic reporting requirements of credit institutions towards the Bank of Greece are also set out in relevant Acts of the Bank of Greece.

Eurobank Holdings and/or the Issuer submit to the Bank of Greece and/or the ECB regulatory reports both at individual and group level, on a daily, monthly, quarterly, semi-annually or annually basis.

Recovery and Resolution of Credit Institutions

The BRRD relies on a network of national authorities and resolution funds to resolve banks. Pursuant to Greek Law 4335/2015, with respect to Greek credit institutions, the Bank of Greece has been designated as the national resolution authority and the Resolution Branch of the Hellenic Deposit and Investment Guarantee Fund ("**HDIGF**") as the national resolution fund (For further details, see below "**Deposit and Investment Guarantee Fund**").

Recovery and resolution powers

The framework set out in Greek Law 4335/2015 applies in relation to credit institutions of all sizes, as well as investment firms that are subject to initial capital requirements in accordance with provisions of Article 9 of Directive 2019/2034/EU. The powers provided to the competent Greek authorities for credit institutions, the Bank of Greece and the resolution authority in Greek Law 4335/2015 in respect of credit institutions are divided into three categories:

- (a) *Preparation and prevention:* Greek Law 4335/2015 provides for preparatory steps and plans to minimise the risks of potential problems. Under Greek Law 4335/2015, credit institutions are required to prepare recovery plans while the resolution authority prepares a resolution plan for each credit institution. Greek Law 4335/2015 also reinforces authorities' supervisory powers to address or remove impediments to resolvability. Financial groups may also enter into intra group support agreements to limit the development of a crisis;
- (b) *Early intervention:* In the event of incipient problems, Greek Law 4335/2015 grants powers to the competent authority to arrest a bank's deteriorating situation at an early stage to avoid insolvency. Such powers include, among others, requiring an institution to implement its recovery plan, replace existing management, draw up a plan for the restructuring of debt with its creditors, change its business strategy and change its legal or operational structures. If such tools prove to be insufficient, new senior management or management body will be appointed subject to the approval of the competent authority which is also entitled to appoint one or more temporary administrators; and

- (c) *Resolution*: Resolution is the means to reorganise or wind down the bank in an orderly fashion outside insolvency while preserving its critical functions and limiting to the maximum extent any exposure of taxpayers to losses.

Resolution tools

When the trigger conditions for resolution are satisfied, Greek Law 4335/2015 sets out a minimum set of resolution tools that the resolution authority shall have the power to apply individually or in combination in line with the provisions of the BRRD. These tools are the following:

- (a) the sale of business tool, which enables the resolution authority to transfer the shares or other titles of ownership or all or any assets, rights or liabilities of the institution to a purchaser (that is not a bridge institution) on commercial terms without requiring the consent of the shareholders or complying with the procedural requirements that would otherwise apply except those procedural requirements set out in Greek Law 4335/2015;
- (b) the bridge institution tool, which enables the resolution authority to transfer shares or other titles of ownership or all or any assets, rights or liabilities of the institution to a bridge institution, a publicly controlled entity, without requiring the consent of the shareholders. The operations of the bridge institution are temporary, the aim being to sell the business to the private sector when market conditions are appropriate;
- (c) the asset separation tool, which enables the resolution authority to transfer assets, rights and liabilities, without obtaining the consent of shareholders of the institution under resolution to an asset management vehicle to allow them to be managed and worked out over time. Such a transfer may only be made either: (i) where the market situation for said assets is such that liquidation of said assets under normal insolvency proceedings could have an adverse effect on one or more financial markets, or (ii) the transfer is necessary to ensure the proper functioning of the institution under resolution or bridge institution, or (iii) the transfer is necessary to maximise liquidation proceeds. This tool may be used only in conjunction with other tools to prevent an undue competitive advantage for the failing institution; and
- (d) the bail in tool. Through this tool, the resolution authority has the power to write down eligible liabilities of a failing institution and/or to convert such claims to equity. The resolution authority may use this tool only (i) to recapitalise the institution to the extent sufficient to restore its ability to comply with the conditions for its authorisation, to continue to carry out the activities for which it is authorised and to restore the institution to financial soundness and long term viability or (ii) to convert to equity or reduce the principal amount of obligations or debt instruments that are transferred to a bridge institution (with a view to providing capital to such bridge institution) or that are transferred under the sale of business tool or the asset separation tool. Under BRRD, institutions and entities are required to include a contractual term by which the creditor or party to the agreement or instrument creating the liability recognises that the relevant liability may be

subject to the write down and conversion powers; BRRD establishes the sequence in which the resolution authority should apply the power to write down or convert obligations of an entity under resolution.

Certain liabilities are excluded from the bail-in tool, such as:

- (a) Covered deposits;
- (b) secured liabilities including covered bonds and liabilities in the form of financial instruments used for hedging purposes which form an integral part of the cover pool and which according to national law are secured in a way similar to covered bonds;

For the purposes of the bail in tool, institutions are required under Greek Law 4335/2015 to maintain at all times a sufficient aggregate amount of own funds and eligible liabilities, the aim of which is to ensure that banks have sufficient loss absorbing capacity. Such requirement is calculated as the amount of own funds and eligible liabilities expressed as a percentage of i) RWAs and ii) leverage exposure amount of the institution..

Resolution authority's powers

The resolution authority has a broad range of powers when applying resolution measures and tools. When applying the resolution tools and resolution powers, the resolution authority should take into account the resolution objectives, as described in the BRRD and the SRM Regulation, and choose those resolution tools and resolution powers which best achieve the pertinent resolution objectives.

Single Resolution Mechanism

The SRM applies to all banks supervised by the SSM. If a bank supervised by the SSM infringes or is likely to infringe in the near future capital or liquidity requirements (e.g. because of a rapidly deteriorating financial condition such as a deterioration of the liquidity situation, an increase of the level of leverage and non-performing loans), the ECB will have the power to impose early intervention measures. These measures include the power to require changes to the legal or operational structure of a bank, or the business strategy, and the power to require the managing board to convene a general meeting of shareholders, with the power of the ECB to set the agenda and require certain decisions to be considered for adoption by the general meeting.

All the banks in the participating Member States shall contribute to the SRF. The SRF is owned and administrated by the SRB. The establishment of the SRF and its national compartments corresponding to each participating Member State and decisions as to their use are regulated by the SRM Regulation, while the transfer of national funds into the SRF and the activation of the mutualisation of the contributions are provided for in an inter-governmental agreement signed between the participating Member States in the SRM on 21 May 2014 and ratified by the Greek Parliament on 30 November 2015, by virtue of Greek Law 4350/2015.

Environmental, Social and Governance (ESG) framework

Sustainable Financial Disclosure Regulation (Regulation (EU) 2019/2088, (“SFDR”))

Issuer is subject to the provisions of the SFDR, which imposes certain transparency obligations on financial market participants and financial advisers in relation to various sustainability aspects. For this purpose, distinct rules on sustainability disclosure apply at entity (i.e. the Bank) and product (i.e. the financial product offered, or for which advice is being given by the Bank) level. The provision of the relevant sustainability information is made either on Issuer’s website or in pre-contractual disclosures and periodic reports. In general, when providing portfolio management and/or investment advice services, Issuer shall publish:

- information about the policies it implements on the integration of sustainability risks (i.e. an environmental, social or governance event or condition that, if it occurs, could cause a negative material impact on the value of the investment) in their investment decision making process and/or investment and insurance advice;
- whether it takes into consideration principal adverse impacts and/or investment and insurance advice on sustainability factors meaning environmental, social and employee matters, respect for human rights, anti-corruption and anti-bribery matters;
- information on how its remuneration policies are consistent with the integration of sustainability risks;
- information about the manner in which sustainability risks are integrated into the aforementioned services as well as the result of the assessment of the likely impacts of sustainability risks on the returns of the financial products Issuer advises on; and
- additional information where the respective financial products either promote environmental or social characteristics or have sustainable investment as their objective. A sustainable investment within the meaning of the SFDR is an investment in an economic activity that contributes to an environmental objective, as measured, for example, by key resource efficiency indicators on the use of energy, renewable energy, raw materials, water and land, on the production of waste and greenhouse gas emissions, or on its impact on biodiversity and the circular economy, or an investment in an economic activity that contributes to a social objective, in particular an investment that contributes to tackling inequality or that fosters social cohesion, social integration and labour relations, or an investment in human capital or economically or socially disadvantaged communities, provided that such investments do not significantly harm any of those objectives and that the investee companies follow good governance practices, in particular with respect to sound management structures, employee relations, remuneration of staff and tax compliance.

Taxonomy Regulation (Regulation (EU) 2020/852, “TR”)

Although the TR primarily aims to establish a classification system of environmentally sustainable economic activities at EU level to be used as the basis for other economic and regulatory measures, it

also includes certain transparency rules to be followed by both Eurobank Holdings and the Issuer on a consolidated basis relating to the percentage of their activities which are “taxonomy aligned” while also supplementing certain disclosure requirements applicable to the Issuer under the SFDR. However, until the full application of the Commission Delegated Regulation (EU) 2021/2178 (“**Article 8 Taxonomy Disclosures Delegated Act**”), the implementation of the transparency rules applicable to all financial undertakings subject to the TR remains partial.

The Article 8 Taxonomy Disclosures Delegated Act specifying the content and presentation of information to be disclosed by financial and non-financial undertakings in their non-financial statements, provides for credit institutions, such as the Bank, to disclose for the first time, from 1 January 2024 a new key performance indicator, the called “Green Asset Ratio” (“**GAR**”). The GAR is to be prepared on the basis of the scope of its prudential consolidation and shall show the proportion of Issuer’s assets financing and investment in taxonomy-aligned economic activities compared to its total covered assets. The GAR should relate to Issuer’s main lending and investment business, including loans, advances and debt securities, and to its equity holdings to reflect the extent to which Issuer finance taxonomy-aligned activities.

Greek Climate Law

In accordance with article 20 of Greek Law 4936/2022 as in force (the so-called “**Greek Climate Law**”), credit institutions such as Eurobank shall submit for the first time by 31 October 2023 a report on their carbon footprint for the year 2022 in the related publicly available government electronic platform, subject to relevant availability of the platform. Such report shall include voluntary goals and actions aiming at the reduction or offset of carbon emissions. The report shall be updated and verified on an annual basis henceforth.

Deposit and Investment Guarantee Fund

The HDIGF is a private law legal entity and the universal successor of the former Hellenic Deposit Guarantee Fund. The provisions currently applicable to the HDIGF are set out in Greek Law 4370/2016 which transposed into Greek Law Directive 2014/49/EU aiming at strengthening the protection of citizens' deposits in case of bank failures and enhancing the role of deposit guarantee schemes in the financial safety net.

Pursuant to Greek Law 4370/2016, all credit institutions licensed to operate in Greece, with certain exemptions, and the local branches of credit institutions which have been established in non-EU Member States and are not covered by a guarantee scheme equivalent to that of the HDIGF mandatorily participate in the HDIGF. Greek branches of foreign credit institutions established in EU Member States may also become members of the investments cover scheme of HDIGF at their discretion.

The purpose of the HDIGF is (a) to indemnify depositors of the participating credit institutions that become unable to fulfil their obligations towards their depositors and finance resolution measures of credit institutions through the deposits cover scheme (the “**Deposits Cover Scheme**”) in accordance

with article 104 of Greek Law 4335/2015; (b) to indemnify investors who are clients of participating credit institutions which may become unable to fulfil their obligations towards their clients in connection with the provision of "covered" investment services through the investments cover scheme (the "**Investments Cover Scheme**"); and (c) to provide financing for resolution measures of credit institutions through the resolution scheme (the "**Resolution Scheme**"). The HDIGF guarantee schemes with respect to Greek credit Institutions also cover deposits of their branches in other EU Member States and deposits of their branches in non EU Member States as well as claims from covered investment services rendered by their branches in other EU Member States or third countries, provided that the relevant deposits (solely if such deposits are in branches of non EU Member States) or claims are not covered by a guarantee scheme equivalent to that of the HDIGF.

Under the Deposits Cover Scheme, the maximum coverage limit under Greek Law 4370/2016, for every depositor with deposits not falling in the "exempted deposits" category, taking into account the total amount of its deposits with a credit institution (and regardless of the number of accounts, the currency of such deposits or the place where the account(s) is/are held) minus any due and payable obligations of such depositor towards the relevant credit institution, subject to set off in accordance with Greek law, is €100,000. By way of exemption, the Deposits Cover Scheme covers deposits at an additional limit of up to a maximum amount of €300,000 deriving from specific activities (such as sale of a private property by an individual, payment of social security/insurance benefits, etc.) credited to the relevant accounts, subject to the time limits and other conditions specified in Greek Law 4370/2016. Under the Investments Cover Scheme, the maximum coverage limit is €30,000 for the total of claims of an investor client against the credit institution, irrespective of covered investment services, number of accounts, currency and place of provision of the service. Certain deposits and investment services are excluded from the HDIGF coverage.

Pursuant to Greek Law 4370/2016, the participation in the Deposits Cover Scheme involves ipso jure, the participation in the Resolution Scheme, while pursuant to Greek Law 4335/2015, the Resolution Scheme is empowered to collect from participating credit institutions, including from the local branches of credit institutions which have been established in non EU Member States, ex ante contributions and extraordinary ex post contributions.

The schemes of the HDIGF are clearly distinct from each other and each has its own assets. Each of the Deposits Cover Scheme and Investments Cover Scheme is funded mainly by the initial contributions, the annual/regular contributions and by extraordinary contributions which are mandatorily paid by the participating credit institutions, donations, the liquidation of claims and the revenues deriving from the management of its assets, while the Resolution Scheme is funded by the ex ante contributions and extraordinary ex post contributions referred to above and alternative funding means of the type contemplated in Article 105 of the BRRD.

ECONOMIC OVERVIEW

GREEK ECONOMIC ADJUSTMENT PROGRAMMES

Financial support following the Financial Crisis

Since May 2010, Greece has received financial support in the form of loans as part of three successive economic adjustment programmes agreed with the IMF, the EC, the ECB, and the ESM. The third economic adjustment programme commenced in August 2015 and was successfully completed three years later, in August 2018. According to the ESM, the total funds disbursed under the three programmes amounted to €265.8 billion out of a total funding capacity of €361 billion.

The Greek government has over the last decade undertaken significant measures and carried out extensive structural reforms prescribed by the above programmes to restore competitiveness and promote sustainable economic growth. In June 2018, certain debt relief measures were announced – namely the medium-term debt relief measures in respect of Greece's loan received under the second economic adjustment programme, which included a 10-year maturity extension, on top of the 2012 PSI+ debt relief measures. At the same time, an enhanced surveillance ("**ES**") scheme was established for Greece in August 2018 in view of the long-standing crisis and the challenges faced. ES's main purpose was to safeguard financial stability and continued implementation of structural reforms, aiming, among other matters, to boost domestic growth, increase competitiveness, create jobs, and modernise the public sector. It required, among other things, the implementation according to a specific schedule of certain key structural reforms and the achievement of certain fiscal targets for the duration of the surveillance. The achievement of certain fiscal targets was suspended for 2020, 2021 and 2022 due to the activation of the general escape clause by the EC in March 2020 that permitted the temporary departure from the adjustment path towards the medium-term budgetary objective (see paragraph "*Fiscal sector*" in "*Greek economy outlook for 2023 and 2024*" below). From 2023 onwards, however, Greece will be required to maintain a primary general government surplus of 2.2 per cent. of GDP on average until 2060 according to the debt sustainability assumptions of the 14th ES Review (May 2022). As scheduled, ES expired on 20 August 2022 after the successful completion of said review. Greece delivered the bulk of the key structural reforms and fiscal targets. The monitoring of Greece's economic, fiscal, and financial situation will continue in the context of the Post-Programme Surveillance ("PPS") and the European Semester. The PPS scheme is common for all post-programme countries and its aim is to ensure the return of the ESM/EFSF loans while continually assessing the economic, fiscal, and financial situation of each country. Exit from the PPS requires the repayment of at least 75 per cent. of the said loans. The European Semester is common for all EU member-states as it is the framework for the surveillance and coordination of economic and employment policies across the European Union. Subsequently, Greece has received €5.5 billion from the ES financial envelope in five disbursements: in May 2019 (€1.0 billion), in January 2020 (€0.8 billion), in July 2020 (€0.8 billion), in February 2021 (€0.8 billion), and in July 2021 (€0.8 billion), in December 2021 (€0.8 billion) and in July 2022 (€0.8 billion).

The last tranche of the said ES financial envelope amounted to €0.7 billion and was disbursed in early February 2023, following the decision of the Eurogroup on 5 December 2022.⁴

The COVID-19 pandemic in 2020 - 2022

In March 2020, the World Health Organisation declared the outbreak of the novel coronavirus disease (COVID-19) a global pandemic. Within a few short weeks, the virus had spread around the world, affecting peoples' health and well-being, but also impacting economies, households, businesses, and financial and commodity markets. The shock adversely affected production, disrupted supply chains, altered the demand patterns, increased uncertainty, and resulted in widespread volatility, which had not been seen since the most recent global financial crisis. The authorities in affected areas introduced several measures designed to contain the outbreak, including widespread business closures, travel restrictions, lockdowns, and bans on gatherings and public events. The lockdowns of economies globally resulted in significant reductions in output, demand and international trade of goods and services. Large corporates experienced demand and supply disruptions as global supply chains were challenged by the national lockdowns. Small and medium-sized corporates in vulnerable sectors, such as tourism and hospitality, experienced a sharp decline in demand, putting the viability of many of them at substantial risk. Governments, monetary authorities, regulators, and international organisations also took actions to mitigate the economic and social impact of the pandemic, which included implementing fiscal and monetary measures and regulatory initiatives to increase liquidity and support consumers, businesses and financial institutions.

Following the rollout of extensive vaccination campaigns in 2021, the majority of the population in most advanced economies had been vaccinated by the beginning of fall 2021, allowing for the gradual lift or relaxation of the pandemic-induced restrictions.

The Greek authorities introduced nationwide lockdowns to contain the first three waves of the pandemic (spring of 2020, late fall and winter of 2020, and winter and spring of 2021), which included movement restrictions, business closures, curfews, mandatory use of face masks, and encouraging social distancing. During the intervals between the nationwide lockdown periods (that is, summer to mid-fall of 2020 and Christmas Season of 2020), and occasionally even amid nationwide lockdowns, the severity of the measures was not harmonised across the country, with stricter restrictions temporarily introduced in regions or municipalities with high incidence of COVID-19 cases (the so-called dark red zones).

In mid-May 2021, the latest nationwide lockdown ended. All domestic (intra- and inter-regional) movement restrictions were lifted, except for municipalities or regions designated as dark red zones. Greece opened again its borders to most international travellers, provided that they could present proof of full

vaccination or recovery from COVID-19, or a recent negative result to a PCR or Rapid Antigen test. As of late February 2023, most of the restrictions had been repealed.

The energy crisis in 2022 as a result of the sanctions imposed to Russia for its invasion in Ukraine

According to the EC's Winter Forecast (February 2022) the Euro area real GDP growth for 2022 and 2023 was expected at 4.0 per cent. and 2.7 per cent. respectively, from 5.3 per cent. in 2021. Economic activity was further reinforced by the deployment of the Recovery and Resilience Facility ("**RRF**") funds (€807 billion in current prices). The Euro area inflation rate was expected at 3.5 per cent. and 1.7 per cent. in 2022 and 2023 respectively (from 2.6 per cent. in 2021). The inflation forecasts were increased mainly because of persistent post- COVID-19 logistic and supply bottlenecks in various commodities (including energy) and other items (for example semiconductors). It was assumed that these supply bottlenecks will fade away within 2022 and inflation in 2023 will return to levels below the ECB's medium term inflation target (2.0 per cent.). According to the EC's 2022 Winter Forecasts the real GDP growth for Greece was expected at 4.9 per cent. and 3.5 per cent. for 2022 and 2023 respectively, from 8.5 per cent. in 2021, while the inflation rate was expected at 3.1 per cent. and 1.1 per cent. for 2022 and 2023 respectively, from 0.6 per cent. in 2021.

The Russian invasion in Ukraine on 24 February 2022 together with the sanctions imposed by the EU on Russia changed the picture. New commodity price pressures, the heavy reliance of the EU on imported fossil fuels (gas and oil) of Russian origin together with the high integration of the Russian economy to the global supply chains negatively affected the European Union and Euro area outlook. According to the EC's 2023 Spring Forecasts and under the assumption of no large-scale interruptions in the supply of Russian oil and gas, the Euro area real GDP rate was estimated at 1.1 per cent. for 2023 and expected at 1.4 per cent. for 2024 respectively. The real GDP growth rate for 2022 was at 3.5 per cent. The HICP rate was estimated at 5.8 per cent. for 2023 and 2.8 per cent. for 2024. The HICP rate was at 8.4 per cent. in 2022.

Under the ECB's baseline scenario (September 2023), real GDP growth in the EA was estimated at 0.7 per cent. in 2023 (from 3.4 per cent. in 2022) and was expected at 1.0 per cent. and 1.5 per cent. in 2024 and 2025 respectively. At the same time, inflation in the EA was estimated at 5.6 per cent. in 2023, from 8.4 per cent. in 2022, and was expected at 3.2 per cent. and 2.1 per cent. in 2024 and 2025 respectively. According to Eurostat's provisional data (8 June 2023), the EA real GDP growth was at 5.4 per cent. and 3.3 per cent. in 2021 and 2022 respectively.

According to the EC's 2023 Spring Forecasts for Greece, the real GDP growth was expected at 2.4 per cent. for 2023 (from 5.9 per cent. in 2022) and was estimated at 1.9 per cent. for 2024. The inflation rate for Greece was expected at 4.2 per cent. for 2023 (from 9.3 per cent. in 2022) and was estimated at 2.4 per cent. for 2024.

Response of the Greek government, and monetary and regulatory authorities

Greece: In response to the COVID-19 outbreak, there has been unprecedented monetary, fiscal and regulatory support to the economy and the banking system by national governments and the EU institutions. Since March 2020, the Greek government has introduced a series of support measures aimed at mitigating the economic and social impact of the pandemic. According to the 2022 Budget (December 2021), the 2022 Stability and Growth Plan (April 2022) and the 2023 Budget (October 2023), the total size of the stimulus and relief package approaches €43.4 billion, with measures of €23.1 billion in 2020, €16.0 billion for 2021, and €4.3 billion extending into 2022 including: (i) benefits to wage earners under labour suspension, and other categories of individuals affected by the pandemic such as seasonal workers, artists, and performers, and labour protection schemes, (ii) liquidity support to firms via the "Advance Payment" schemes, (iii) temporary tax breaks to private sector employees and permanent tax rate cuts to firms, (vi) rent subsidies to individuals and businesses affected by the pandemic, and compensation to landlords taking part in pandemic rent-reduction schemes, and (v) loan repayment moratoria and bans on foreclosures. According to the 2023 Budget, the total cost of the measures aiming to address the COVID-19 pandemic in 2023 amounted to approximately €4.4 billion. In addition, according to the 2024 Draft Budget, the total budget cost of the support measures aiming to address the inflationary pressures stemming from the ongoing energy crisis amounted to €2.5 billion.

European Union: In July 2020, the European Council agreed on a recovery package amounting to €807 billion (in current prices) under EC's Next Generation EU ("NGEU") framework to support the recovery and resilience of the member states' economies. The sum available to Greece to finance its National Recovery and Resilience Plan ("NRRP") amounts to approximately €30.5 billion, divided into €17.7 billion in grants and €12.7 billion in low-interest loans. The majority of these funds (€30.5 billion) originate from NGEU's largest instrument, the RRF to finance projects and initiatives that will facilitate the green transition and digital transformation of its economy, boost competitiveness, attract private investments, and increase social cohesion. According to the Bank of Greece ("BoG"), completion of the projects, and implementation of the reforms financed by RRF, will permanently increase Greek GDP by 6.9 per cent. by 2026. A pre-financing of €4 billion (€2.3 billion in grants and €1.7 billion in loans) was disbursed in August 2021. As of early September 2023, a total of nearly €11.1 billion of RRF funds (€5.7 billion in grants and €5.4 billion in loans) out of the €30.5 billion available have been disbursed including two regular payments of €3.6 billion each in April 2022 and January 2023 respectively following the successful implementation of the required NRRP milestones. In May 2023, the Greek government applied for the third regular RRF payment. Note that the NRRP is expected to mobilise additional investment resources of €27 billion from the private sector. So far, 425 investment plans have been submitted by private firms while 178 of them have already been contracted as of end of May 2023. In March 2023, the Greek government applied for additional loans of €5.0 billion. The total budget for the Multiannual Financial Framework 2021-2027 ("MFF") amounts to €1.2 trillion (in current prices), out of which approximately €40 billion will be available to Greece. On top of the above, the liquidity support and backing of the Greek economy via the EC, ESM, EIB, and EIF initiatives, announced in 2020 and

2021, exceeded €15 billion and included, among others, labour market stimulus, SMEs loans, and financing for climate action and sustainable development.

ECB: On the monetary policy front, on 12 March 2020, the ECB announced measures to support the liquidity conditions in the Euro area (additional Long Term Financing operations, more favourable terms for the Targeted Long-Term Operations, a new Asset Purchase Programme of €120 billion), as well as a number of temporary capital and operational relief measures to ensure that its directly supervised banks can continue to fulfil their role in funding the real economy. Furthermore, on 24 March 2020, the ECB established the temporary Pandemic Emergency Purchase Programme (“**PEPP**”) with an initial envelope of €750.0 billion that was later (December 2020) increased to 1,850.0 billion. The PEPP purchases ended at the end of March 2022 but the maturing principal payments from securities purchased in the context of the PEPP (including securities issued by Greece) will be reinvested until the end of 2024 at least. Moreover, according to the ECB the purchases of Greek bonds will continue over and above redemptions, in the event of renewed market fragmentation in order to ensure the transmission of monetary policy to the Greek economy. Furthermore, the ECB’s Governing Council in its July 2021 meeting approved the Transmission Protection Instrument (“**TPI**”), a new tool that will also contribute to the effective transmission of monetary policy. As of the end of September 2023, net GGB purchases by the ECB through the PEPP amounted to €38.3 billion.

Greek economy outlook for 2023 and 2024

GDP: The global pandemic had a severe impact on the Greek economy, throwing it temporarily off its post-debt crisis recovery path in 2020. The adverse effects included, but were not limited to: (a) lower private consumption, especially of services, as a result of the lockdowns, (b) reduced demand for the manufacturing sector’s products, (c) lower tourism revenues and widening of the current account deficit, (d) adverse impact on public finances due to lower revenue and increased spending, (e) severe disruptions in the supply chains and (f) an abrupt decrease in shipping activity due to a decline in global trade. As a result, according to ELSTAT, real GDP contracted by 9.0 per cent. in 2020. Despite the ongoing pandemic and the continuation of the nationwide restrictions until late spring 2021, the Greek economy returned to a positive growth path. According to ELSTAT data the real GDP growth rate for 2021 and 2022 was at 8.4 per cent. and 5.9 per cent. respectively mainly as a result of the COVID-19 pandemic public support measures, the better-than-expected tourism revenues, the increase of industrial production, and the NRRP and Public Budget investments.

According to the 2024 Draft Budget, the real GDP growth rate for 2023 is estimated at 2.3 per cent. and expected at 3.0 per cent. for 2024 and it is driven mainly from consumption, investments, and exports of services. According to the EC’s 2023 Spring Forecasts (May 2023) for Greece, the real GDP growth rate was expected at 2.4 per cent. and 1.9 per cent. for 2023 and 2024 respectively. According to Focus Economics, a private sector firm, the market consensus for the 2023 and 2024 real GDP growth rate for Greece, in early October 2023, was at 2.2 per cent. and 2.0 per cent. respectively.

Inflation and unemployment: Owing to the VAT rate reductions included in the Greek government's stimulus and relief package, and the weaker demand, inflation crossed to negative territory, with the HICP rate in 2020 declining by 1.3 per cent. (from +0.5 per cent. in 2019). Based on the post-COVID-19 supply side bottlenecks (including energy prices), in 2021 the HICP rate increased by 0.6 per cent. According to ELSTAT, the HICP rate in 2021 and 2022 increased by 0.6 per cent. and 9.3 per cent. respectively. The 2022 developments were by large attributed to the energy price hikes from the war in Ukraine. According to ELSTAT most recent data, the HICP rate in August 2023 registered an increase of 3.5 per cent. on an annual basis, from 11.2 per cent. in August 2022. The average HICP rate for the first eight months of 2023 is 4.7 per cent. Despite the pandemic-induced lockdowns and the ensuing recession, unemployment decreased further to 16.3 per cent. in 2020 (from 17.3 per cent. in 2019) as a result of the support measures and the labour suspension schemes. Helped by the strong rebound in tourism and the public support measures against the COVID-19 pandemic, the unemployment rate dropped to 14.7 per cent. and 12.5 per cent. in 2021 and 2022 respectively. According to ELSTAT most recent data, the unemployment rate in August 2023 was at 10.9 per cent. from 12.3 per cent. in August 2022.

According to the 2024 Draft Budget, the HICP rate for 2023 is estimated at 4.0 per cent. and expected at 2.4 per cent. for 2024, under the assumption of the continuation of the energy crisis but with no outright cut-offs in the supply of oil and gas imports of Russian origin. According to the EC's 2023 Spring Forecasts, the annual inflation rate in Greece (measured using the Harmonized Index of Consumer Prices (HICP)) is expected at 4.5 per cent. and 2.4 per cent. for 2023 and 2024 respectively. According to Focus Economics, the market consensus for the 2023 and 2024 HICP rate for Greece, in early October 2023, was at 4.1 per cent. and 2.4 per cent. respectively.

According to the 2024 Draft Budget, the unemployment rate for Greece in 2023 is estimated at 9.5 per cent. and expected at 9.0 per cent. for 2024. According to the EC's 2023 Spring Forecasts, the unemployment rate was expected at 12.2 per cent. and 11.8 per cent. for 2023 and 2024 respectively. According to FE, the market consensus for the 2023 and 2024 unemployment rate in Greece, in early October 2023, was at 11.3 per cent. and 10.6 per cent. respectively.

Current account: According to the EC, Greece's current account deficit increased from 1.5 per cent. of GDP in 2019 to 6.6 per cent. of GDP in 2020. This was largely driven by a sharp fall in travel (tourism) receipts due to the pandemic (a reduction of 76.2 per cent. compared to 2019), with the services surplus contracting from 11.5 per cent. of GDP in 2019 to 4.4 per cent. of GDP in 2020. The current account balance in 2021 remained at elevated levels at €12.3 billion or 6.8 per cent. of GDP as a result of increased energy and commodity prices and the significant recovery of the economy activity.

The current account balance for 2022 registered a deficit of €20.1 billion or 9.7 per cent. of GDP; a deterioration of 64.1 per cent. year-on-year. This was mainly due to the increased deficit in the balance of goods which was at €39.0 billion in 2022 from a deficit of €26.7 billion in the same period in 2021; a deterioration of 46.0 per cent. year-on-year. This was in turn due to the increased deficit in the oil balance by 123.9 per cent. year-on-year and that of the balance of all other goods excluding oil by 24.1 per cent.

year-on-year. Both developments reflect increasing demand because of the inflationary pressures due to the aforementioned supply bottlenecks and the war in Ukraine and at a lesser extend to the further improvement of economic activity. On the other hand, the balance of services in the 12 months of 2022 registered a surplus of €19.4 billion from a surplus of €12.9 billion in the same period of 2021; an improvement of 78.5 per cent. This was mainly due to an increase in the travel (mainly tourism) receipts by 51.1 per cent. year-on-year in the said period. According to Bank of Greece, the current account balance registered a deficit of €7.3 billion for the period from January to July with the balance of goods at a deficit of €18.0 billion. The balance of services registered a surplus of €11.0 billion.

According to EC's 2023 Spring Forecasts, the current account deficit in Greece for 2023 and 2024 is expected at 9.2 per cent. and 7.8 per cent. of GDP respectively. According to FE, the market consensus for the 2023 and 2024 current account balance for Greece, in early October 2023, was for a deficit of 5.7 per cent. and 4.7 per cent. respectively.

Fiscal sector: According to ELSTAT, Greece's fiscal primary balance registered a primary deficit of 6.7 per cent. of GDP in 2020 in European System of National and Regional Accounts ("**ESA 2010**") terms, following the decrease in revenue and the pandemic support measures.⁵ The deviation of the 2020 primary fiscal outcome from the respective positive target of the ES – the first such outcome since 2015 – as already mentioned above was in the context EC's general escape clause (March 2020). The latter remained in place in 2021 and 2022 as well. The EC has proposed that the clause should be extended through 2023 and be deactivated in 2024. The primary fiscal balance for 2021 was again negative at 4.7 per cent. of GDP mainly because of the COVID-19 pandemic support measures. The 2022 primary fiscal balance turned positive – a primary surplus – at 0.1 per cent. of GDP mainly as a result of improved tax revenue and the registering of the SMP& ANFA income equivalent revenues.

At the same time, according to ELSTAT, the general government debt was at 341.2 billion or 206.3 per cent. of GDP in 2020 from 331.1 billion or 180.6 per cent. of GDP in 2019 in ESA 2010 terms, according to the Ministry of Finance. In 2021 the general government debt level increased to 353.4 billion because of the COVID-19 public support measures but decreased in terms of GDP at 194.6 per cent. due to the nominal growth, i.e. the increase in real economic activity and the increase in nominal GDP because of the increased inflation. The stock of public debt decreased further at 356.3 billion or 171.3 per cent. of GDP in 2022, again as a result of the increase of nominal growth. For comparison purposes, the general government debt was at 175.2 per cent. of GDP in 2011.

According to the 2024 Draft Budget, the primary fiscal balance is estimated to post a surplus of 1.1 per cent. for 2023 and estimated at 2.1 per cent. for 2024. The gross public debt-to-GDP ratio is estimated at 159.3 per cent. for 2023 from 171.4 per cent. in 2022. It is expected at 152.2 per cent. of GDP for 2024. Nevertheless, upside risks remain, as disruptions due to the widespread global uncertainty and the impact of persistently high inflation on household budgets and firm production costs may exert

additional pressure on government finances. According to FE, the market consensus for the 2023 and 2024 overall fiscal balance for Greece, in early October 2023, was for an overall fiscal balance at -1.6 per cent. for 2023 and 1.0 per cent. for 2024.⁶ The respective consensus figures for the 2023 and 2024 general government debt were at 162.0 per cent. and 156.0 per cent. of GDP respectively.

Debt issuance and sovereign ratings: According to the Ministry of Finance, the cash buffer that the Greek Government has gradually built up from 2018 onwards exceeded €33 billion at the end of March 2023. Generated by ESM loan disbursements and other sources, this buffer is intended to facilitate the country's access to the international markets. After the achievement of the investment grade – expected in late 2023 – the buffer will be liquidated at least partially and thus will improve the stock of public debt.

Reflecting the developments:

- Moody's rating improved from "Caa2" with a positive outlook in 2018 to "Ba1" with a stable outlook in September 2023, citing significant structural and economic reforms.
- DBRS's rating increased from "B(high)" in mid-2018 to "BBB(low)" with a stable outlook in September 2023, an investment-grade rating, due to ongoing reforms and fiscal responsibility.
- Fitch raised its rating from "B-" with a positive outlook at the start of 2018 to "BB+" with a stable outlook in June 2023.
- S&P elevated its rating from "B-" with a positive outlook in early 2018 to "BBB-" with a stable outlook in October 2023, an investment grade rating, with a noteworthy positive outlook adjustment due to enhanced growth and fiscal prospects.

As already mentioned above, Greece achieved investment credit grade rating in September 2023. In March 2020, the ECB removed the sovereign limits on the exposure of Greek banks (including Eurobank). The progress made from 2018 onwards, together with the inclusion of Greek government securities in PEPP in spring 2020, together with the ECB announcements over the reinvestment of the principal payments from maturing securities currently under the PEPP until at least the end of 2024, and the decisions over the TPI, led to a sharp decrease in the yield of the 10-year GGBs. The yield of the 10-year GGB was at 4.40 per cent, 1.45 per cent, 0.63 per cent and 1.34 per cent at the end of 2018, 2019, 2020 and 2021 respectively. The increase of the between 2020 and 2021 was mainly due to the increase in inflation. The average spread over the respective 10-year German title was at 175.6 bps and 120.2 bps for 2020 and 2021 respectively. The inflationary pressures increased during the course of 2022 and the ECB policy rate hikes followed. The yield of the 10-year GGB increased from 1.34 per cent. at the end of January 2022 – before the Russian invasion in Ukraine – to 4.58 per cent. at the end of December 2022, with the average year-to-end of December 2022 spread over the respective 10-year

German title at 224.3 bps, significantly higher compared to the two previous years but still significantly below its levels during the Greek Sovereign Debt Crisis. The yield of the 10-year GGB was at 4.36 per cent. on 29 September 2023 with the spread over the respective German title at 151.7 bps (average year-to-date spread over the respective German title was at 162.8 bps).

In this environment, in 2022, the Greek Public Debt Management Agency (“**PDMA**”) raised €8.3 billion with bonds of various maturities (7 to 10 years). The funding needs for 2023 were estimated at €5.5 billion at the end of December 2022 according to the 2023 Budget. The funding needs might change depending on the actual size of the final measures aiming to address the energy crisis related support measures in 2023. As of September 2023, the PDMA tapped the market for €10.7 billion with new issuances of 5-year, 10-year and 15-year bonds and re-opening of bonds of various maturities.

According to the Debt Sustainability Analysis, carried out by EC in first Post-Programme Surveillance Report (November 2022), short-run risks to Greek sovereign debt sustainability remain contained. However, the medium-term risks are significant, conditional upon a “no-fiscal policy change scenario”. The risks are assessed as medium in the long run which in turn is driven mainly by the projected decline in aging-related costs in the long run (lower population). Factors that positively affect the debt sustainability include (a) the large share of debt held by official lenders – according to the PDMA, about 75.5 per cent. of the total debt was under the control of the official sector at the end of December 2022; (b) the particularly long maturity of the Greek debt compared with peer countries – according to the PDMA (June 2023), the weighted average maturity of Greek debt was over 19 years. The respective weighted average maturity of the Euro area periphery was at 8.2 years.⁷

Banking sector: According to the EBA, Greek banks’ NPL ratio at the group level was at 4.7 per cent. in the first quarter of 2023 from 4.6 per cent. of the total loans in the fourth quarter of 2022, 4.9 per cent. in the third quarter of 2022, 5.2 per cent. in the second quarter of 2022 and 6.7 per cent. in the first quarter of 2022. The respective NPL ratio was at 7.0 per cent. at the end of 2021, 25.5 per cent. at the end of 2020 and 35.2 per cent. at the end of 2019. Nevertheless, it is still the highest rate among EU/EEA countries, and significantly above the EU/EEA average of 1.8 per cent. in 2023 (and on average 2.0 per cent. between the first quarter of 2021 and the first quarter of 2023). According to the BoG, Greek banks’ NPL ratio at solo level, was at 8.6 per cent. at the end of June 2023 from 8.8 per cent. in March 2023 and 8.7 per cent. in December 2022. Although the Greek banks have returned to pre-tax profitability since 2016, the high NPL stock in the economy remains among the main issues for the sector, and a drag on credit recovery, with further deleveraging planned to take place in the following months.

According to the BoG’s data, the private sector domestic credit balance at the end of August 2023 stood at €111.6 billion, from €112.9 billion at the end of August 2022, registering a gross annual decrease of 1.2 per cent. A significant part of this deleveraging was due to loan restructuring, write-offs, and securitisations as a part of the banks’ strategy to reduce their NPL stock through the “Hercules Asset

Protection Scheme”. Accounting thus for write-offs/write-downs, and reclassifications of loans, as well as foreign exchange valuation changes, domestic credit increased by 0.9 per cent. annually in August 2023.

On the other side of the ledger, private sector domestic deposits amounted to €189.4 billion at the end of August 2023 from €183.1 billion at the end of August 2022 according to the BoG, registering an annual increase of 3.4 per cent. Compared with their pre-pandemic level (end of 2019), the private sector deposits increased by €40.0 billion or 27.9 per cent. This strong increase in deposits is mainly attributed to the robust rebound of the Greek economy in 2021, in conjunction with the COVID-19 movement restrictions and lockdowns in the first half of that year that weakened consumption by households (involuntary saving), the uncertainty created by the pandemic environment (voluntary saving), the government transfers to the private sector through various stimulus and relief packages (including those for the current energy crisis) and the rebound of the economy in 2021, 2022 and the first six months of 2023. According to ELSTAT, the real GDP growth rate in the first and the second quarters of 2023 was at 2.0 per cent. and 2.7 per cent. respectively. As already mentioned above, according to the 2024 Draft Budget, the real GDP growth rate for 2023 is expected at 2.3 per cent.

Real estate market: The Greek real estate market was negatively impacted by the Financial Crisis. According to the BoG, the price of residential property (based on the apartment price index) declined by 42.3 per cent. between the end of 2007 and the end of 2017 as a result of contracting disposable income, increasing unemployment, limited access to credit and the excess supply of residential properties during the Financial Crisis. Residential real estate prices registered increases of 1.8 per cent., 7.2 per cent., 4.5 per cent., 7.6 per cent. and 11.7 per cent. in 2018, 2019, 2020, 2021 and 2022 respectively, mainly as a result of demand for tourist rentals, golden visa schemes, and the pick-up in economic activity. This increasing trend continued in 2023. According to the BoG’s most recent data, residential real estate prices in the first and second quarters of 2023 increased by 15.0 per cent. and 14.0 per cent. on an annual basis. The price of commercial real estate (based on the office price index) declined by 30.0 per cent. between 2010 (earliest available data) and the end of 2016. According to the BoG’s data, commercial real estate prices increased by 5.9 per cent., 6.2 per cent., 1.8 per cent., 3.2 per cent. and 5.2 per cent. in 2018, 2019, 2020, 2021 and 2022 respectively.

REGIONAL INTERNATIONAL ECONOMIC DEVELOPMENTS

Bulgaria

The Bulgarian economy expanded by 3.4 per cent. in 2022, from 7.6 per cent. in 2021, on the back of subdued investments, a trend that started in 2021 and persisted in 2022. GDP in the first quarter of 2023 expanded by 2.1 per cent. year-on-year with a mild deceleration in the second quarter of 2023 to 1.8 per cent. year-on-year, translating into a 2.0 per cent. year-on-year growth rate for the first half of 2023. According to the OECD's Economic Outlook (June 2023), the real GDP in Bulgaria is expected to grow by 1.9 per cent. while the CPI is expected at 9.5 per cent. in 2023. According to the EC's 2023 Spring Forecasts (May 2023), a further real GDP slowdown is expected at 1.5 per cent. in 2023 due to potential delays in the RRP implementation that could keep investments idle for another year and reduce exports due to weak global demand. A modest real GDP rebound at 2.4 per cent. is expected for 2024, supported by the bounce of exports in tandem with the recovery of global demand. Inflation that weighed on the economy in 2022 as the HICP rate averaged 13 per cent. with strong contribution from energy and food prices, has retreated sizably coming in at 7.8 per cent. year-on-year in July and having more than halved during the last eight months. It is expected to recede to 9.4 per cent. in 2023 and further to 4.2 per cent. in 2024, on account of the normalisation of commodity prices in 2023 compared to those of 2022. The course of inflation has led to the deferral of the Euro adoption for 12 months which is currently targeted for 2025. Despite the challenges ahead, Fitch Ratings Agency affirmed the "BBB" sovereign rating in mid-May and kept the outlook positive, grounding its decision on strong external and public balance sheets compared to other BBB peers and the credible policy framework.

Cyprus

According to the CYPSTAT, the Cypriot economy grew on an annual basis by 2.3 per cent. in the second quarter of 2023, from 3.2 per cent., 4.0 per cent. and 5.6 per cent. in the first quarter of 2023 and the fourth and the third quarters of 2022 respectively. On an annual basis, the real GDP growth rate posted an increase of 5.6 per cent. in 2022 from 6.6 per cent. in 2021, i.e., the robust growth momentum in 2021 weakened moderately in 2022. At the supply side, GDP growth in the second quarter of 2023 came from retail trade, tourism, the ICT sector and arts and entertainment sector. Stronger activity in these sectors pushed down the unemployment rate from 6.8 per cent. in the first quarter of 2023 to 5.9 per cent., a 12.5-year low, in the second quarter of 2023. After reaching all-time high in July 2022 (10.6 per cent. year-on-year), the HICP rate fell below the Eurozone average from September 2022 onwards, up to July 2023, standing at 2.4 per cent. year-on-year in the latter month, mainly due to a deceleration in Housing-Water Supply-Electricity-LPG prices. Weaker inflation, together with higher partial wage indexation from June 2023 onwards (66.7 per cent. instead of 50 per cent. previously), will support household consumption in the remainder of 2023 and the next year.

Cyprus maintains uninterrupted investment-grade status. In March 2023, S&P upgraded the sovereign credit rating by one notch, to BBB from BBB-, assigning a stable outlook, on the grounds of outperformance in public finances in 2022 and the economy's resilience to the external shocks brought

about by the war in Ukraine. In April 2023, Cyprus issued its first 10-year sustainable bond of €1 billion, with an annual yield of 4.219 per cent. The issuance was 11 times oversubscribed, indicating the very strong investor interest.

Further reduction of NPLs remains a challenge, despite past progress, as it continues to lie above EA levels. The NPL ratio stood at 8.7 per cent. in June 2023, from 9.5 per cent. in December 2022 and 11.0 per cent. in December 2021, mainly due to declining NPL ratios in households and large-sized enterprises. Monetary policy tightening, in order to tame inflationary pressures, weighs on credit expansion, which remains on negative territory from December 2022 onwards, albeit at a relatively stable pace from April to July 2022, at about 1.0 per cent. year-on-year, recording a small deceleration in August 2023 (-0.6 per cent. year-on-year). This trend has affected credit to non-financial businesses, which averages -2.7 per cent. year-on-year in January to August 2023. Regarding the trend in the capital adequacy of the banking sector, it is steadily improving, with the overall solvency ratio at 21.2 per cent. in December 2022, the highest level since at least the fourth quarter of 2010, 50 bps higher on an annual basis.

Overall, it appears that up to the first half of 2023, Cyprus had not been severely affected by the war in Ukraine. However, risks to the downside lie ahead and could materialise in the remainder of 2023 and 2024. These are mainly associated with the possibility of a contraction in the EU's GDP for some time in this period due to the implications of the war in Ukraine, through monetary policy tightening and persisting inflation, which will weigh on investment and consumption respectively. On the other hand, robust growth in the tourism and ICT sectors, which has already heated activity in the construction and real estate sectors, will likely be sustained in the medium term. The IMF, in its Article IV report (June 2023), kept unchanged its real GDP growth projections for Cyprus for 2023 and 2024 relative to its latest World Economic Outlook (April 2023), to 2.5 per cent. and 2.8 per cent. respectively. The European Commission, in its Spring Forecasts (May 2023), revised the growth projections upward for these two years to 2.3 per cent. and 2.7 per cent. from 1.6 per cent. and 2.1 per cent. foreseen in its Winter Forecasts (February 2023).

RISK MANAGEMENT

Due to its activities, the Group is exposed to a number of financial risks, such as credit risk, market risk (including currency and interest rate risk), liquidity and operational risks. The Group's risk management strategy in relation to the credit, market and liquidity risks that it faces is described in note 5.2 to the Group's 2022 Consolidated Financial Statements, which are incorporated by reference in this Base Prospectus. See "*Documents Incorporated by Reference*". In addition, the Group's operational risk management strategy is described below.

Operational Risk

Governance

Operational risk is embedded in every business activity undertaken by the Group. The primary goal of operational risk management is to ensure the integrity of the Group's operations and its reputation by mitigating its impact. However, by its nature, it cannot be fully eliminated. To best manage operational risk, the Group has established a formal Operational Risk Management Framework to define its approach to identifying, assessing, managing, monitoring and reporting operational risk.

Governance responsibility for operational risk management stems from the Board of Directors (the "**BoD**") through the Executive Board and Senior Management to the Heads and staff of every business unit. The BoD establishes the mechanisms by which the Group manages operational risk by setting the tone and expectations from the top and delegating authority. The Board Risk Committee (the "**BRC**") and the Audit Committee (the "**AC**") monitor the operational risk level and profile of the Group, including the level of operational losses, their frequency and severity.

The Group Chief Risk Officer is responsible for the Group's operational risk-related initiatives and ensures implementation of the Operational Risk Management Framework. The Group Chief Risk Officer has the overall responsibility and oversight of, the Operational Risk Units in the countries in which the Group operates.

The Operational Risk Committee is a management committee that assesses the operational risks arising from the activities of the Group, ensures that each business entity has appropriate policies and procedures for the control of its operational risk and that prompt corrective action is taken whenever a high risk area is identified.

Group Operational Risk Sector ("**GORS**") is responsible for establishing and maintaining the Group's Operational Risk Management Framework and for operational risk oversight. An Operational Risk Unit operates in every subsidiary of the Group and is responsible for implementing the Group's operational risk framework. GORS is responsible for:

- defining the methodology for the identification, assessment and reporting of operational risk;

- implementing regulatory requirements and Group guidelines;
- monitoring the operational risk level and profile and reporting thereon to the BRC; and
- defining and rolling out the methodology for the calculation of the regulatory capital charge for operational risk.

The Group applies the elements of the Three Lines of Defense Model for the management of operational risk. The Three Lines of Defense Model enhances risk management and control by clarifying roles and responsibilities within the organization. Under the oversight and direction of the Management Body, three separate groups within the organization are necessary for effective management of all types of operational risk. The responsibilities of each of these groups or lines of defense are:

- Line 1 - Own and manage risk and controls. The front line business and operations are accountable for this responsibility as they own the rewards and are the primary risk generators.
- Line 2 - Monitor risk and controls in support of Executive Management, providing oversight, challenge, advice and group-wide direction. These mainly include the Risk and Compliance Units
- Line 3 - Provide independent assurance to the Board and Executive Management concerning the effectiveness of risk and control management. This refers to Internal Audit.

The Heads of each business and functional unit (risk owners) have the primary responsibility for the day-to-day management of operational risk arising in their units and for the adherence to relevant controls. To this end, every business unit:

- identifies, evaluates and monitors its operational risks and implements risk mitigation controls and techniques;
- assesses the efficiency of control mechanisms;
- reports all relevant issues; and
- has access to and uses the common methods and tools introduced by GORS, in order to facilitate the identification, evaluation and monitoring of operational risk.

Each business unit has appointed an Operational Risk Partner (“**OpRisk Partner**”) or an Operational Risk Management Unit (“**ORMU**”), depending on the size of the business unit, which is responsible for coordinating the internal operational risk management efforts of the business unit. OpRisk Partners and ORMUs form the link between Line 1 and Line 2 for all operational risk matters. In addition, OpRisk Partners also exist at Units that are part of Line 2 and Line 3 to ensure the appropriate operational risk oversight in those functions.

THE MORTGAGE AND HOUSING MARKET IN GREECE

The first mortgage lending institution, the National Mortgage Bank of Greece, was established in 1927, followed by the National Housing Bank in 1930. Both institutions were under government control, but have since been merged with the National Bank of Greece. Since then, another three institutions under government control have become active in the field of mortgage lending: the Postal Savings Bank (*Tachydromiko Tamieftirio*) that was merged with Eurobank in 2014; the Consignment Deposits and Loans Fund (*Tamio Parakatathikon kai Daneion*); and the Agricultural Bank of Greece that was acquired by Piraeus Bank in 2012; the first two providing loans to civil servants and the latter providing loans mainly to farmers. In 1985 the state monopoly of mortgage lending was ended, allowing commercial banks to enter the market, provided that their mortgage financing did not exceed 2 per cent of their deposits. From the early 1990s onwards the mortgage loans market was rapidly deregulated. All the credit institutions are authorised in Greece under Greek Law 4261/2014 and the Directive 2013/36/EU.

Until the end of 2008, the residential mortgage market exhibited a remarkable growth. Lending acceleration took place against a backdrop of macroeconomic stability, rapidly declining interest rates (from 25 per cent in the early 1990s to less than 6 per cent in 2003 and to less than 5 per cent until the end of 2008), and strong residential construction activity. According to ELSTAT data, the investments in residential construction as part of the total investments, were on average at 36.0 per cent in the 2001-2007 period, in real terms.

From 2008 onwards, the residential mortgage market has started showing signs of deceleration, mainly as a result of the sovereign debt crisis. According to the EC, the cumulative fall in real GDP between 2008 and 2016 – the last year with a negative real GDP growth rate before the eruption of the COVID-19 pandemic – was at 26.5 per cent. The respective Euroarea figure was positive growth of 3.3 per cent. The total tax burden between 2007 and 2016 increased by 9.2 percentage points in terms of nominal GDP – from 33.4 in 2007 to 42.6 per cent of GDP in 2018 – as a result of the fiscal consolidation measures implemented, namely the various hikes in direct and indirect taxes and the introduction of a new property tax (ENFIA) from 2011 onwards. The respective Euro area figure between 2007 and 2018 was at 1.4 percentage points. The disposable income in nominal terms fell by 26.9 per cent between 2008 and 2016, due to the aforementioned developments. The disposable income in the Euro area increased by 12.2 per cent in the said period. At the same time, the gross savings of the private sector, a proxy for the households' proportion of disposable income not used for final consumption and the income of firms, i.e. the part of income available for investments in the housing market among others, decreased by 67.6 per cent between 2008 and 2018. Greek private sector gross savings reached a minimum (€10.8 billion) at the end of 2018. The gross savings of the private sector in the Euro area between 2008 and 2018 increased by 30.2 per cent. As a result of these negative developments and on the basis of ELSTAT data, the investments in residential construction as part of the total investments, fell from 40.5 per cent in 2007 to a minimum of 5.1 per cent in 2017, in real terms. A slow recovery of the said ratio started in the following year. Investments in residential construction as part of total investments posted an increase of 5.8 per cent., 6.7 per cent., 7.0 per cent. and 7.6 per cent. in 2018,

2019, 2020 and 2021. Furthermore, according to ELSTAT data, the real estate transactions based in notarial deeds were on average 159.3 K between 2000 and 2010, and fell to 58.3 K on average between 2011 and 2016, a decrease of 58.4 per cent. The real estate transactions increased on average by 85.1 K between 2017 and 2021.

According to the Bank of Greece, the balance of the housing credit reached a maximum within 2010 – the growth rate of the housing credit in nominal terms was at 12.0 per cent, 3.7 per cent and -0.1 per cent in 2008, 2009 and 2010 respectively. From then onwards the credit balances of the housing sector entered a downward spiral. The housing credit balances registered a 64.5 per cent decrease between the end of December 2010 and July 2023 (the latest available data). The interest rate on new housing loans was at 3.79 per cent. at the end of 2010 and at 4.2 per cent. at the end of July 2023. The latter increase was mainly due to the rise of the interest rates from the ECB hikes aiming to curb inflation.

At the same time, according to the Bank of Greece data, the non-performing loans of the residential sector, as percentage of total gross loans increased from 3.9 per cent at the end of the 4th quarter of 2007 to a maximum of 44.5 per cent at the end of the 3rd quarter of 2018. The most recent reading in the residential NPLs was at 10.6 per cent at the end of the 2nd quarter of 2023. The decrease is mainly due to the various measures that the Greek banks implemented for the reduction of their NPLs ratios and the debt moratoria implemented from mid-2020 onwards in order to address the effects of the COVID-19 pandemic.

The Greek real estate market was negatively impacted by the Financial Crisis. According to the Bank of Greece, the price of residential property (based on the apartment price index) declined by 42.3 per cent. between the end of 2007 and the end of 2017 as a result of contracting disposable income, increasing unemployment, limited access to credit and the excess supply of residential properties during the Financial Crisis. The price of commercial real estate (based on the office price index) declined by 30.0 per cent. between 2010 (earliest available data) and the end of 2016. According to BoG data, commercial real estate prices increased by 5.9 per cent., 6.2 per cent., 1.8 per cent., 3.2 per cent., and 5.2 per cent. in 2018, 2019, 2020, 2021 and 2022 respectively. Residential real estate prices registered increases of 1.8 per cent., 7.2 per cent., 4.5 per cent. 7.6 per cent. and 11.7 per cent., in 2018, 2019, 2020, 2021 and 2022 respectively, mainly as a result of demand for tourist rentals, golden visa schemes, and the pick-up in economic activity. This increasing trend continued in 2023. According to the most recent BoG data, residential real estate prices in the first quarter of 2023 increased by 12.8 per cent., on an annual basis. See –Economic Overview – Current Economic Environment in Greece –Real estate market)

The Greek Housing Market

According to the ELSTAT's 2011 Building census, the share of the number of residential buildings to the number of total buildings was at 79.1 per cent. One-residence buildings and two residence buildings are the prominent type of residencies and amount to 70.0 per cent. and 15.0 per cent. of the total residential buildings respectively. The remaining 15.0 per cent. consist of multi-residence buildings with three

apartments or more. The aforementioned one-residence percentage is significantly lower in major urban areas. For example in the Attiki region that includes Athens and the suburbs, the one residence share falls to 48.1 per cent. and in central Athens at just 16.9 per cent. of total residencies. In terms of the period constructed, 11.6 per cent. of the total residencies was built before 1945, 45.3 per cent. was built between 1946 and 1970, and the remaining 43.0 per cent. was built between 1971 and 2011. The total residencies built between 2001 and 2011, a subset of the 1971-2011 period, amount to 18.9 per cent. of the total buildings.⁸

According to Eurostat data, homeownership in Greece averaged 75.1 per cent of total residencies between 2007 and 2021 while the respective figure for the Euroarea was at 66.3 per cent. For the same period, home owners with a mortgage or a housing loan were at 14.0 per cent. and 28.2 per cent. for Greece and the Euro area respectively.

Security for Housing Loans

In Greece, security on real estate property, including security for housing loans, is created by establishing a mortgage or a pre-notation of a mortgage. A mortgage can be established by a notarial deed (or by a judicial decision, or by law in special cases). The establishment of a mortgage by notarial deed is quite costly and it is therefore not preferred among banks and borrowers. Instead, in most cases, banks obtain a pre-notation of a mortgage, which is less expensive and easier to record than a mortgage. Pre-notation of a mortgage is an injunction over the property entitling its beneficiary to convert it into a full mortgage within ninety (90) days from the final court judgment for the secured claim, but which is valid as of the date of the pre-notation. From the point of view of enforceability, ranking of the security and preferred right to the proceeds of the auction, there is no difference between a holder of a mortgage and a holder of a pre-notation of a mortgage, since the latter is treated as a secured creditor of the property. Both the holder of a pre-notation of a mortgage and a mortgagee need an enforcement right before commencing enforcement proceedings. The difference between them is that the pre-notation is a conditional security interest whose preferential treatment is subject to the un-appealable adjudication of the claim it purports to secure, whereas a mortgagee's claim is enforceable pursuant to the mortgage deed itself.

Establishing a pre-notation is the most common way of establishing security for mortgage lending in Greece.

The pre-notation is registered on virtue of a court decision (interim measures procedure) or a court payment order. The respective decision is issued either with the consent of the property's owner over which the pre-notation will be registered or without it after hearing both parties. The court payment order is issued without hearing of the debtor, based only on documents proving the claim, such as bounced

cheques, unpaid bills of exchange, invoices signed by the debtor, lease agreements, etc., and creditor may register a pre-notation of mortgage based on the payment order. The debtor has the right to file an opposition against the payment order issued (see below under "*Enforcing security*").

The procedures adopted by lenders of mortgage loans in practice has led to an arrangement whereby pre-notations are granted "by consent", where both the lending bank and the borrower appear before the competent court and consent to the establishment of the pre-notation on the specific real estate property. The court issues the decision immediately (in fact, the decision is drafted beforehand by the lending bank and is signed by the judge who hears the claim).

The Issuer's lawyer, after receiving a copy of the court decision and having prepared the summary of it and the respective petition, brings them to the Cadastre or the Land Registry, where registered, and after that the related certificates/sheets referring to the pre-notation are issued.

The certificates/sheets concern:

- (a) the ownership by the borrower of the mortgaged property;
- (b) the registration and class of the pre-notation;
- (c) the absence of (judicially raised) claims of third parties against the current and all previous owner(s) of the mortgaged property; and
- (d) any other mortgages, pre-notations or seizures preceding the pre-notation registered by the bank.

At the same time the Issuer's lawyer performs a titles search in the Cadastre or the Land Registry, in order to confirm the uncontested ownership and the connected burden on estate, if any, before the loan is disbursed.

Once the certificates are issued, they are reviewed by the Issuer's legal department and are included in the borrower's file. The legal review of both the ownership titles and the pre-notation registration is based on public documents, i.e. on notarial deeds and certificates issued by the competent land registries or cadastres. The history of the ownership titles for the previous twenty (20) years is examined (which is the period for adverse possession). Such a review together with a titles search in the Cadastre or the Land Registry precedes the approval of the loan. Upon registration of the pre-notation, a second titles search is made to confirm the status quo.

Enforcing security

Enforcement of security framework changed by virtue of article 1 of Greek Law 4335/2015 which brought significant amendments, *inter alia*, to the enforcement provisions of the Greek Code of Civil Procedure (the "**CCP**"), coming into effect as of 1 January 2016.

It is the Issuer's policy to commence enforcement proceedings once an amount remains unpaid under a loan for more than 180 days, at which point, the loan is terminated. Once a loan is in default and terminated, an extrajudicial notice is served on the borrower and on the guarantors, if any, informing them of this fact and requesting the persons indebted to an immediate payment of all amounts due. Following service and in the case of continued non-payment, an order of payment is obtained from the judge of the competent First Instance Court or Magistrate's Court to be served on the borrower together with a demand for immediate payment. Service of the payment order (*diatagi pliromis*) along with a demand for immediate payment is the first action of enforcement proceedings. Three (3) working days after serving the payment order and demand, the property can be seized and the auction process starts (see below for a description of the auction process).

The borrower, after being served the payment order, is granted fifteen (15) working days (or thirty (30) working days if the borrower is of an unknown address or resides abroad) to contest the validity of the order for payment, either on the merits of the case or on the ground of procedural irregularities. This can be done by filing an Annulment Petition before the Court of First Instance or Magistrate's Court pursuant to Article 632 of the CCP (in short, **632/Annul**). At the same time, the borrower can file a Suspension Petition pursuant to Article 632 of the CCP (in short, **632/Susp**) for the suspension of the enforcement proceedings as a provisional measure. At the time of filing 632/Susp, in most cases, immediate suspension is granted up until the hearing of the suspension petition following a separate petition for granting of a temporary order, of the borrower in this respect. In accordance with article 632 para. 3 of the CCP, the suspension does not prejudice the right of the creditor to take interim measures according to article 724 of the CCP namely conservative seizure of assets or pre-notation of mortgage on the basis of an order for payment.

If the court decides that the arguments in the Article 632/Susp are correct and reasonable and the lack of suspension will cause irreparable damage to the petitioner, the suspension of enforcement will be granted to the petitioner until the issuance of the final decision of the first instance court and at the latest, the issue of a final Court of Appeal's decision on the 632/Annul (following a separate petition of the borrower in this respect). If the court decides that the 632/Annul has no grounds and rejects this, the suspended enforcement procedures can continue. Suspension of enforcement against a borrower of an unknown address or residing abroad is granted by law during the thirty-day period to file an Article 632/Annul. Failure to contest the payment order or rejection of the 632/Annul by the competent court will result in the bank having a final deed of enforcement and then pre-notations, for the loans covered with, must be converted to mortgages. If the borrower has not filed a 632/Annul within fifteen (15) working days (or thirty (30) working days if the borrower is of an unknown address or resides abroad) after serving the payment order, then the bank according to Article 633 of the CCP may again serve the payment order whereby a second period of fifteen (15) working days is granted to the borrower to contest the payment order.

Creditors of the borrower having a legitimate interest and the borrower (being, in respect of a Loan Asset, the individual specified as such in the relevant mortgage terms together with each individual (if

any) who assumes from time to time an obligation to repay such Loan Asset (the "**Borrower**") or any part of it may file with the competent Court of First Instance or Magistrate's Court a Petition for Annulment pursuant to Article 933 of the CCP ("**933/Annul**") of certain actions of the foreclosure proceedings based on reasons pertaining to the validity of the order for payment or the relevant claims and to procedural irregularities. The hearing of the 933/Annul is scheduled within sixty (60) calendar days from the date of the filing of such petition and the relevant decision must be issued within sixty (60) calendar days from the hearing before the court. The time for the filing of 933/Annul varies, depending on the compulsory enforcement action that is being contested. Both 632/Annul and 933/Annul may be filed either concurrently or consecutively, but it should be noted that both petitions may not be based on reasons pertaining to the validity of the order for payment, once the order of payment has become final as mentioned above.

The ability of the Borrower to challenge the compulsory enforcement actions, which are carried out by the creditor, is significantly restricted. In particular, the Borrower is entitled to oppose to defects of the compulsory enforcement procedure in two stages: the first one is set before the auction (within forty-five (45) calendar days from seizure) and is related to any reason of invalidity of the claim and the compulsory enforcement actions carried out before the auction until the publication of the seizure report, whereas the second one (within thirty (30) days from the notary's auction report in case of auctioned movables and within sixty (60) days from the registration with the land registry or cadastre of the notary's auction report in case of auctioned real estate) is set after the auction and is related to any defects, which arose from the auction until the registration of the notary's auctioning report with the respective land registry or cadastre. The filing of a challenge does not lead in an automatic suspension of the enforcement process; the Borrower, following the filing of the respective challenge, must file a separate claim for suspension either of the enforceability of the payment order (632/Annul) or of the enforcement proceedings, the latter concerning only movable assets or immediate enforcement ("**938/Susp**"), such suspension to be granted if the Court considers that the challenge is likely to succeed and the debtor would suffer irreparable damages. This is the case for orders for payment served to debtors following the 1st of January 2022; for former payment orders no suspension provisions by the court of first instance apply (even for movables). Suspension of the enforcement proceedings over immovable properties may be granted only by the court of second instance; the debtor must request such suspension in the appeal against the decision rejecting the first challenge filed. Foreclosure proceedings may be suspended until the hearing of the 938/ Susp, which, in a normal case where the debtor seeks the suspension of the auction, should be filed at the latest five business days prior to the auction and the relevant decision is issued by 12.00 pm on the Monday prior to the auction. It should nevertheless be noted that such suspension is more difficult to obtain if the competent Court of First Instance has already rejected an 938/Susp based on similar reasons. The filing of the 933/Annul does not entitle the Borrower to file a petition for the suspension of the enforcement proceedings. The day of the auction is obligatorily set for immovable properties after a period of at least seven (7) months following the completion of seizure and in no case later than eight (8) months following the completion of seizure, during which period it is expected that a decision on the 933/Annul will have been issued by the Court.

The actual auction process is started with seizure of the property, which takes place three (3) working days after the order for payment is served on the borrower. The seizure statement that is issued by the bailiff who performs it, contains the auction date. At this point all mortgagees (including those holding a pre notation) are informed of the upcoming auction.

The initial auction price is determined within the statement of the court bailiff and cannot be less than the commercial value of the property (in accordance with para. 2 of article 993 of the CCP, in conjunction with article 995 of the CCP). The "commercial value" is calculated in accordance with Presidential Decree 59/2016 pursuant to which, the commercial value is determined by the relevant bailiff who appoints a certified appraiser (natural or legal person included in the Record of certified appraisers kept with the Ministry of Finance) for this purpose. The latter submits to the bailiff an appraisal report in accordance with the European or international recognised appraising standards and in accordance with the Code of Conduct issued by the Bank of Greece on the management of non-performing loans. Appraisal's fees are borne by the creditor initiating the enforcement proceedings but ultimately burden the Borrower. The initial auction price can be contested by the borrower or any other party having a legal interest at the latest fifteen (15) working days before the auction date. The relevant court's decision should be published at the latest by 12.00 p.m. eight (8) days before the auction date. In case the first auction is unsuccessful, a second auction is conducted with the same initial auction price; if such auction is also unsuccessful, the law provides for a process of two successive auctions with automatic decreases of the initial auction price, namely without court intervention.

Furthermore, according to article 1000 of the CCP, suspension of the auction for up to six (6) months may be sought by the borrower, through a petition to be filed at least fifteen (15) working days prior to the auction and it may be upheld through a judgment to be filed until 12:00 p.m. of the Monday preceding the auctioning day, provided that the borrower pays at least one quarter of the claimed capital and the enforcement expenses set out approximately in the judgment and also that there is no risk for the creditor's interests, on the grounds that the Borrower will be able to satisfy the enforcing party or that, following the suspension period, a better offer would be achieved at auction.

All auctions are conducted electronically through a special platform developed for this purpose.

An auction through electronic means may take place on a Wednesday, Thursday or Friday, from 10:00 am until 14:00 or from 14:00 until 18:00. The bids are submitted electronically and the amount of the bid has to be guaranteed, by depositing either a letter of credit of monthly duration or a bank's cheque or in cash or through a bank transfer and deposit of the amount to a special professional bank account of the person in charge of the auction, of an amount equal to the 30 per cent of the initial auction price. In case a bid is submitted from 13.59.00 to 13.59.59 or from 17.59.00 to 17.59.59, an extension of five (5) minutes is granted automatically. The extensions granted cannot exceed one (1) hour. Auctions may not take place between 1 and 31 August and the week before and after the date of any national, municipal or European elections.

If the procedure is cancelled or the immovable property is awarded to another bidder, the amount is returned to the unsuccessful bidder. Bidders must also submit two (2) working days before the date of the auction until 15.00 the power of attorney provided for in article 1003 CCP.

Allocation of auction's proceeds

In the auction, the property is sold to the highest bidder who shall pay within 10 business days at the latest following the date of the auction. Once the price of the property is paid, the notary public prepares a special deed listing all the creditors and allocating the proceeds of the auction. Each creditor must announce its claim, along with the documents substantiating its claim, to the notary public within fifteen (15) calendar days at the latest following the day of the auction.

Once the allocation of proceeds amongst the creditors of the Borrower has been determined pursuant to a deed issued by a notary public, the creditors of the Borrower may dispute the allocation and file observations or a petition contesting the deed pursuant to Article 979 of the CCP in conjunction with Article 933 of the CCP. The competent Court of First Instance adjudicates the matter but the relevant creditor is entitled to appeal against the decision to the Court of Appeal. This procedure may delay the collection of proceeds and the time at which the Issuer finally receives the proceeds of the enforcement of the relevant property. However, the law provides that a creditor is entitled to the payment of its claim even if its allocation priority is subject to a challenge, provided that such creditor provides a bank letter of guarantee on demand issued by a bank permanently established in Greece, securing repayment of the money in the event that such challenge is upheld. In addition, pursuant to Article 998, para. 2 of the CCP, there is a period of mandatory suspension for all enforcement procedures, including auctions, between 1 and 31 August of each year and the week before and after the date of any national, municipal or European elections.

The proceeds of an auction following enforcement against a property securing a Loan are allocated in accordance with articles 975, 976 and 977 CCP (for further details see *Distributional priorities before and after Insolvency*).

Settlement of amounts due by over-indebted individuals

Greek Law 3869/2010 on the "settlement of amounts due by over indebted individuals"(enacted on 3 August 2010 and subsequently modified mainly by Greek Laws 3996/2011, 4161/2013, 4336/2015, 4346/2015, 4366/2016 and 4745/2020) allowed over indebted debtors who had unintentionally come into an evidenced state of permanent and general inability to repay their due debts to file a petition for the settlement of their due debts by arranging a partial repayment of their debts and writing off the remainder of their due debts, provided the terms of settlement are complied with. All individuals, both consumers and professionals, were subject to the provisions of Greek Law 3869/2010, provided that they did not have the capacity to be declared bankrupt under the Bankruptcy Code (i.e. Greek Law 3588/2007), which applied to business undertakings (including sole traders) and unincorporated legal entities that pursue a financial purpose.

The purpose of the amendment of Greek Law 3869/2010 by Greek Law 4336/2015 was to make it more efficient by ensuring effective judicial protection to over indebted individuals, while at the same time protecting creditors from abuses of the proceedings by debtors. In addition to several amendments intended to expedite and standardise the proceedings, Greek Law 4336/2015 introduced: (a) a requirement for the debtor to act as a "cooperating borrower" both as a prerequisite to special court protection for small claims and as an ongoing general obligation throughout the proceedings; and (b) the concept of "reasonable living expenses", which is taken into account for the determination by the court of the instalments to be paid by the debtor. Further, Greek Law 4336/2015 introduced measures to address the large backlog of cases (e.g., by increasing the number of judges and judicial staff).

The amendments effected by Greek Law 4346/2015, among others, laid out the conditions for: (a) the protection of the primary residence of a debtor from forced sale, and (b) the partial funding by the Greek state of the amount of monthly payments set by court decision. In addition, it was provided that the debtor's obligation to act as a cooperating borrower also applies throughout the settlement plan period.

Pursuant to the amendments effected by virtue of Greek Law 4336/2015 the ambit of the law covered all debts to private parties (but excluding ascertained debts from torts caused by wilful misconduct or gross negligence, administrative fines and monetary sanctions and debts from alimony or child maintenance) and it had been extended to also cover debts to the Greek state, tax authorities, local government organisations of first and second degree as well as social security funds, under the condition that such debts co-exist with debts owed to private parties. In addition, the debtor could opt to include debts which at the date of filing of the petition are subject to an administrative, judicial or legal suspension or have been included in a restructuring or facilitation of partial payment which is still valid at the time of filing of the petition.

Debts must have arisen at least one year before the petition date and relief could be used only once. The procedure had three steps: (1) a discretionary out-of court mediation process; (2) an in court settlement; and (3) a judicial re-structuring of debts.

For the purposes of these proceedings, banks were obliged to deliver a full analysis of their claims (including capital, interest expenses, as well as the interest rate), charge free, within 30 working days from the debtor's request, and simultaneously inform the debtor of the amount that corresponds to the 10 per cent of the last performing instalment. Similarly, within the above time period, and following the submission of a relevant request by the debtor, the state, tax authorities, local government organisations of first and second degree and social security funds must provide the debtor with a full analysis of its certified debts towards such parties. The analysis produced by tax authorities must include liabilities arising from principal and default interest (including the default interest rate) and accretion.

For the commencement of the judicial proceedings, the debtor was obliged to apply to the local Magistrate's Court and present evidence regarding its property and its spouse's property, income, creditors, debts, any transfer of the debtor's rights in rem over property for the three year period prior to the date of filing of the petition, a settlement proposal or a request for a total discharge of the debt (where

available, in accordance with the amendment effected by Greek Law 4336/2015). Greek Law 4346/2015 introduced a requirement for petitions filed before its entry into force and not yet heard, obliging the debtor to submit updates of the above data; failure by the debtor to comply with that obligation constitutes a breach of the duty to make an honest disclosure.

As from the submission of the petition for settlement and until the issuance of the relevant judicial decision the debtor must pay a portion of his income to his or her creditors in monthly instalments. Specifically, the minimum amount paid by the debtor, subject to the occurrence of certain exceptional circumstances in respect of the debtor, shall not be less than 10 per cent of the aggregate monthly instalments, the debtor had to pay to all the creditors at the day of the filing of the petition (in any case, the minimum amount to be paid to all the creditors shall not be less than €40 per month). In case the debtor delays the payment of the set instalments in a way that the amount due is higher than the instalments corresponding to three months on an annual basis, the harmed creditor may serve an extrajudicial notice, requesting the payment of all amounts due within 30 (thirty) calendar days. In case of non-payment, the settlement plan is automatically revoked *erga omnes*, provided that (a) a respective declaration of non-payment is served to the other creditors and (b) the harmed creditor files a note to the competent court, which includes the above extrajudicial notice.

Until the "day of ratification" (when pre court mediation is ratified by the court or the issuance of a temporary order is discussed) or, in the case of an application for submission in the procedure for the fast settlement of small debts, until the hearing of such a petition, the taking of any enforcement measures against the debtor in relation to claims which have been included in the petition is prohibited and the same stands for any change in the actual and legal status of the debtor's assets. A temporary order for suspension of enforcement measures may also be issued on the "day of ratification". If the settlement proposal is not accepted by the creditors, or the requirements for the substitution of consent of the creditors who do not agree are not met, the procedures for the judicial debt discharge and restructuring are activated. In that case, the court proceeds with issuing its ruling on the petition. If, after taking into consideration the particular circumstances of the case, the court rules that the debtor's property and income are inadequate, it will specify an amount that the debtor has to pay directly to all its creditors (except if the court rules otherwise), on a monthly basis for a period of three years (three to five years under the previous regime).

If the court rules that liquidation of the property of the debtor is required, it appoints a liquidator. However, it is possible for the debtor to request the exemption of its primary residence (not only in case of full ownership but also in case of bare ownership and usufruct) from the property to be liquidated. In particular, under Greek Law 3869/2010 it is provided that:

The debtor was entitled, until 28 February 2019, to submit to the court a liquidation proposal and a settlement plan and also to apply for the exemption of its primary residence, irrespective of whether it is encumbered or not, provided that all of the following conditions are satisfied: (a) the specific property must be used as the debtor's primary residence, (b) the monthly available family income must not exceed the amount of reasonable living expenses as determined by Greek Law 3869/2010, increased

by 70 per cent, (c) the objective (or the commercial, upon specific request of any creditor or the debtor) value of the primary residence at the time of hearing of the petition must not exceed €180,000 for an unmarried debtor, increased by €40,000 for a married debtor and by €20,000 per child up to three children, and (d) the debtor must have acted as a cooperating borrower (within the meaning of the Code of Conduct). The debt settlement plan must provide for payments by the debtor to the full extent of the debtor's ability to repay and the amount payable by the debtor must be set so as not to result in the creditors being placed without their consent in a worse financial position than in the case of enforcement proceedings. Decision of the Bank of Greece no. 54/15.12.2015, which entered into force as of 1 January 2016, set out the procedure and the criteria for the determination of: (a) the debtor's maximum repayment ability and (b) the amount that the creditors would have received in case of enforcement proceedings, as well as the determination of creditors' potential losses.

Furthermore, the debtor was entitled, until 28 February 2019, to apply for contribution by the Greek state to the partial repayment of the monthly instalments, as long as the following conditions were cumulatively met: (a) the particular property is used as primary residence of the debtor; (b) the available monthly family income does not exceed the reasonable living expenses; (c) the objective value of the primary residence at the time of the hearing of the petition does not exceed €120,000 for an unmarried debtor, increased by €40,000 for a married debtor and by €20,000 per child up to three children; (d) the debtor is a cooperating borrower (within the meaning of the Code of Conduct); and (e) the debtor is unable to pay the monthly instalments as set in the debt settlement plan. The debtor must pay the maximum amount allowed by reference to the debtor's repayment ability and in any case not less than the minimum contribution of the debtor. The contribution of the Greek state may not extend beyond a three year period and is subject to the payment of the minimum contribution of the debtor. The conditions for setting the amount of contribution of the Greek state, the minimum contribution of the debtor and the procedure for the implementation of that economic support mechanism was determined by the Joint Ministerial Decision no. 130377. It is noted that if the debtor delays the payment of four consecutive monthly instalments or delays the payment of the set instalments in a way that the amount due is higher than the instalments corresponding to four months on an annual basis, the creditor may terminate the settlement and commence enforcement proceedings against the debtor's primary residence.

The servicing of the loan is done at an interest rate not exceeding the contractually applicable interest rate to a performing debt or the average floating interest rate for residential loans during the last month for which data is available (in accordance with the Bank of Greece bulletin) to be readjusted on the basis of the ECB refinancing interest rate, as reference interest rate, or, in case of a fixed interest rate, the average fixed interest rate for residential loans of a comparable term (again, in accordance with the Bank of Greece bulletin) and without compounding of interest. The amortisation period is determined taking into account the overall amount of the indebtedness as well as the economic ability of the debtor, and it may not exceed 20 years, unless the original loan term is longer than 20 years, in which case the court may set a longer period but in any event not more than 35 years. Creditors' claims are satisfied out of the payments by the debtor and articles 974 et seq. of the Greek CCP apply by analogy in this respect.

In case of a sale of the property during the settlement term, if the sale price exceeds the amount of the settlement plan amount (as determined by the court decision), then half of the difference is paid to secured and preferential creditors.

Due performance by the debtor of the obligations under the settlement plan automatically releases the debtor from any remaining unpaid balance of the claims, including claims of creditors who had not announced their claims. On application by the debtor, the court certifies such release. In case the debtor delays the payment of the set instalments in a way that the amount due is higher than the instalments corresponding to three months on an annual basis, the harmed creditor may serve an extrajudicial notice, requesting the payment of all amounts due within 30 (thirty) calendar days. In case of non-payment, the settlement plan is automatically revoked *erga omnes*, provided that (a) a respective declaration of non-payment is served to the other creditors and (b) the harmed creditor files a note to the competent court, which includes the above extrajudicial notice. A cancellation has the effect of restoring the claims to the amount prior to ratification of the settlement plan, subject to the deduction of any amount paid by the debtor.

The rights of creditors against co borrowers or guarantors of the debtor as well as rights in rem of the secured creditors are not affected, unless such co borrowers, guarantors or other beneficiaries are also subject to the same insolvency proceedings.. The rights of secured creditors over the secured assets are not affected.

In addition, a procedure for fast settlement of small debts is regulated by art. 5a of Greek Law 3869/2010. It applies to debts less than or equal to 20,000 Euros and debtors whose overall assets do not exceed 1,000 Euros. The debtor may be fully discharged of its debts following an initial supervision period of 18 months on condition that it submits information to the secretariat of the competent court, on a quarterly basis at the latest, on any change in the property or income condition of the debtor and the debtor's family.

Certain provisions were introduced by Greek Law 4745/2020, aiming at the swift resolution of the pending cases under Greek Law 3869/2010, among others, by setting strict deadlines within which the hearing of the latter shall be rescheduled and by providing for a special regime pursuant to which these are to be conducted.

Circular no. 1036/18.03.2016 issued by the Ministry of Finance provides further clarifications on the provisions of Greek Law 3869/2010, including details with respect to the requirements for the submission of an application related to the settlement of amounts due by over indebted individuals.

Greek Law 4605/2019 entitled individual debtors to request the protection of their primary residence through the settlement of their debts. Individuals were entitled to submit an application until 31 July 2020. Greek Law 4605/2019 applied to any individual with banking debts secured by the debtor's primary

residence, irrespectively of its bankruptcy capacity, provided that the following main conditions were met as well:

- (a) as of 31 December 2018, the debtor had outstanding debts towards financial institutions in arrears for at least ninety (90) days;
- (b) in case of debt stemming from business loans, the objective value of the primary residence sought to be protected must not exceed at the time of the application the amount of €175,000; in any other case, it must not exceed the amount of €250,000; it is noted that if the debt sought to be settled exceeds the amount of €20,000, the value of the immovable assets owned by the debtor, its spouse and dependents (except for its primary residence) along with the value of its transport vehicles must not exceed the amount of €80,000;
- (c) the yearly available income must not exceed the amount of €12,500 for an unmarried debtor, increased by the amount of € €8,500 for a married debtor and by the amount of €5,000 per child up to three children;
- (d) the outstanding debt must not exceed the amount of €130,000 per creditor or in case of debt stemming from business loans, the amount of €100,000;
- (e) the value of the deposits, financial instruments and precious metals owned by the debtor, its spouse and other dependents must not exceed the amount of €80,000.

The debtor could submit its application through an electronic platform. The law provided that the debtor was automatically notified by the electronic platform about its eligibility to continue with the process. The electronic platform subsequently notified the creditors referred to in the application, who were entitled to submit a settlement proposal, jointly or individually, within two months following the submission of the application at the latest. The law provides for specific terms regarding the settlement plan, namely, the debtor must pay an aggregate amount equal to 120 per cent of the commercial value of its primary residence (as registered in the books of the financial institution) in equal instalments, through an amortization period of 25 years. In case that the debt is below the above amount, the debt must be repaid in full. The settlement agreement bears interest at a per annum rate *equal to 3-month EURIBOR plus 2%* per annum. Further, the instalments to be set through the procedures could be subsidized by the Greek State, provided that all eligible debt was restructured.

The debtor was entitled to accept the settlement proposals within one month following their submission. In case of failure to reach a settlement with all eligible creditors and within a period of 15 working days following such failure, the debtor could apply to the local Magistrate's Court requesting the settlement of its debt. The hearing is scheduled within six (6) months from the date of the filing of such petition and the relevant decision must be issued within three (3) months from the hearing before the court.

As of the notification of the creditors regarding the submission of the debtor's application and until the expiry of the 15-working-days deadline to apply for settlement to the competent court, the auctioning of

the debtor's primary residence is automatically suspended. However, other enforcement proceedings, such as seizure of the debtor's primary residency, are not forbidden. In the case of a court petition regarding the settlement of debt and upon debtor's relevant request, the court may issue a temporary order for suspension of the auctioning of its primary residence and specify certain monthly instalments to be paid to the creditors during the term of the temporary order.

In case a settlement was agreed, either through the electronic platform or by virtue of a court decision, the primary residence of the debtor is protected against enforcement procedures by all creditors (including the Greek State) throughout the period of the settlement, with certain exceptions provided in Greek Law 4605/2019. The aforementioned exceptions apply mainly to non-eligible creditors, who may obtain a permission to commence enforcement proceedings against the debtor's primary residence, provided that the remaining assets of the debtor are insufficient in respect of their payment.

The settlement proposals approved by the debtor, or the court's decision regarding the settlement of the debt, constitute an enforcement title. In the event of non-payment of the debtor of an aggregate amount equal to three payment instalments or in the case that creditors are entitled to commence enforcement proceedings against the other assets of the debtor which are subject to liquidation, the enforcement title may be served to the debtor by the respective creditors, in order to initiate the relevant enforcement proceedings.

Upon compliance of the debtor with the settlement plan, any remaining debt of the debtor is written-off and the relevant encumbrance over the primary residence of the debtor is lifted.

Special Procedures for Over-Indebted Business Undertakings and Professionals

Greek Law 4307/2014 enacted on 15 November 2014 introduced a set of extraordinary temporary measures for the relief of debts owed by business undertakings and professionals to finance providers, the Greek state and social security funds. Greek Law 4307/2014 (articles 60 *et seq*) provides for:

- (a) the restructuring or write off of debts of qualifying small business undertakings and professionals by application to the relevant finance provider(s) not later than 30 September 2016, subject to certain criteria set out below;
- (b) an extraordinary procedure for the ratification of an agreement with a specified majority of creditors, for the restructuring or settlement of debts, available to business undertakings (having bankruptcy capacity) by application that had to be submitted to the court of the place of the debtor's business in Greece not later than 30 September 2016 (as extended by article 56 of Greek Law 4403/2016); and
- (c) an extraordinary procedure for the placement into special administration of business undertakings (with bankruptcy capacity) with their principal place of business in Greece, which was abolished by Greek Law 4738/2020 (For further details, see below *Settlement legislative tools affecting the enforcement of security*).

"Finance providers" within the meaning of Greek Law 4307/2014 are any credit institutions (including credit institutions under special liquidation), financial leasing companies and factoring companies, in each case subject to the supervision of the Bank of Greece.

In order for small businesses and professionals to qualify for the purposes of restructuring or write off of debts under Greek Law 4307/2014 (option (a) above):

- (i) they must not have filed a petition for submission to the provisions of Greek Law 3869/2010, or they have validly waived their respective petition until the date of submission of the application of Greek Law 4307/2014;
- (ii) they must not have been dissolved or ceased their activities;
- (iii) they must not have filed a petition for submission to any procedure provided for in Greek Law 3588/2007 or they have validly waived their respective petition;
- (iv) no final judgment must have been issued against them for tax evasion or fraud offences against the Greek state or social security funds; and
- (v) their turnover of the fiscal year 2013 must not exceed the limit of €2,500,000.

The eligible finance provider's claim for such restructuring or write off has to be overdue for a period of at least 90 days or under judicial procedures or restructured, in each case as at 30 June 2014. The finance provider's claim will be considered eligible for restructuring or write off, when the debtor either is unable to obtain tax and social security clearance owing to overdue debts or it has obtained clearance following settlement pursuant to the provisions of Greek Law 4305/2014. Also, the amount which is due to be settled or written off cannot exceed €500,000 per financing provider. The relevant finance provider may reject the debtor's application or propose a settlement or write off on different terms.

For the purposes of the court procedure of item (b) above, the debtor must have settled any outstanding amount owed to the tax authorities or the social security funds. The agreement with a qualifying majority of creditors representing at least 50.1 per cent of the total indebtedness (which must include at least 50.1 per cent of the secured indebtedness and represent at least 20 per cent of the debtor's total indebtedness) is submitted to the court of first instance in the jurisdiction of the place where the debtor has its registered seat, it is ratified under this procedure and it is binding on all creditors; however, subject to certain requirements, creditors who did not consent to the restructuring agreement and whose receivables have decreased due to such settlement are entitled to claim damages from the debtor.

The court procedure for the placement of a debtor into special administration (item (c) above) could be opened by one or more creditors (necessarily including at least one finance provider with claim(s) at least equal to 40 per cent of the aggregate debtor's indebtedness) by petition submitted to the court of first instance of the debtor's principal place of business. The application must specify the appointed special administrator, which must have accepted its appointment. For the purposes of the special

administration procedure, qualifying debtors must either: (a) be generally and permanently unable to pay their debts as they fall due; or (b) in respect of a debtor being a company limited by shares, meet the criteria for an application for dissolution of the company by court decision under article 165 paragraph 1 of Greek Law 4548/2018 for at least two consecutive financial years.

Following the filing of a petition before the competent Court for the borrower to be placed under special administration in accordance with articles 68 et seq. of Greek Law 4307/2014, the Court could, upon receipt of a relevant request by any person with legal interest, order the stay of enforcement proceedings against the borrower during the period running from the date of filing of the petition until the issuance of the court decision resolving upon the placement of the borrower into special administration and the prohibition on the disposal of the debtor's immovable assets and business machinery. Further, upon the borrower being placed under special administration in accordance with article 68 et seq. of Greek Law 4307/2014, all enforcement proceedings against the borrower were automatically suspended throughout the relevant proceedings, i.e. for a period up to 30 months as from the issuance of the relevant court decision. The competent Court appoints an administrator with a mandate to liquidate the debtor's assets by conducting a public auction for at least 90 per cent of the accounting value of debtor's business and assets. The results of such auction are then ratified by the Court. The creditors' claims are satisfied through the proceeds of the auction. In the event that the threshold of liquidation of at least 90 per cent of the debtor's business and assets is not fulfilled attained within a period of thirty (30) months at the latest from the date of issuance of the court decision initiating the special liquidation proceeding, and regardless of any substitution of the special liquidator in this period, the proceeding is de lege and ipso facto terminated and the special liquidator is obligated to initiate bankruptcy proceedings against the debtor.

Out-of court settlement of business debts

Greek Law 4469/2017 was published in the Government Gazette on 3 May 2017 introducing for the first time an out of court mechanism for the settlement of debts owed by a debtor to its creditors stemming from the business activity of the debtor or from any other reason, provided that the settlement is considered necessary in order to ensure the viability of the debtor.

The law applied to: (i) individuals who may be declared bankrupt according to the Greek Law 3588/2007; and (ii) legal entities which earned income from business activity pursuant to articles 21 and 47 of the Greek Tax Income Code and have a tax residence in Greece. The aforesaid persons could submit an application until 30 April 2020 in order to be placed under the beneficial provisions of the law, provided that the following main conditions were met:

- (a) as of 31 December 2018: (i) the debtor had outstanding debts towards financing institutions arising from loans or credits in arrears for at least ninety (90) days; or (ii) the debtor had debts settled after 1 July 2016; or (iii) the debtor had outstanding debts towards tax authorities or social security funds or other public law entities; or (iv) the issuance of bounced checks by the

debtor had been ascertained; or (v) payment orders or court judgments for outstanding debts had been issued against the debtor;

- (b) the total debts to be settled exceed €20,000; and
- (c) for debtors keeping double entry accounting books, the debtor has a positive EBITDA or a positive equity at least in one of the three financial years preceding the submission of the application and for debtors keeping single entry accounting books, the debtor has a positive net EBITDA at least in one of the three years preceding the submission of the application.

If other co-debtors were liable for the debts together with the debtor, they were obliged to file the application together with the debtor.

The out of court settlement mechanism involves, inter alia, the appointment of a coordinator of the procedure (selected from a registry kept with the Special Secretariat for the Management of Private Debt), who shall notify all creditors of the debtor referred to in the application within 2 days following receipt of a complete application. Within 10 days following their notification, the creditors should inform the coordinator about their intention to participate in the process and shall declare the exact amount of the debt owed to them by the debtor.

The parties may freely decide on the terms of the debt restructuring agreement subject to certain exemptions, the most important of which are: (a) the obligation not to render the financial situation of any creditor worse than the one it would be in the case of liquidation of the debtor's assets in the context of an enforcement procedure pursuant to the provisions of the CCP; (b) amounts or other considerations collected by the creditors whose claims are settled in the restructuring agreement, are at least equal to the amounts that they would collect in the case of liquidation of the debtor's and co debtors' assets during an enforcement procedure pursuant to the provisions of the CCP; (c) several restrictions regarding the write off and/or settlement of the claims of the State and the social security funds. The debtor or a participating creditor could submit the debt restructuring agreement for ratification to the Multi Member Court of First Instance of the place where the debtor has its registered seat (or residence, as the case may be). Greek Law 4469/2017 provided for the possibility (and not the obligation) of the Settlement Agreement's judicial ratification (by means of a court ruling issued by the Multi-member court of First Instance on the basis of *ex parte* proceedings). The judicial ratification is required in order for the Settlement Agreement to legally bind the non-contracting creditors. The court decision ratifying the Settlement Agreement constitutes an *ex lege* enforcement title.

For a time period of 90 days following notification of the creditors to participate in the procedure, any individual and collective enforcement measures against the debtor with respect to the claims for which the out of court settlement is sought, as well as any interim measures against the debtor, including registration of pre notation of mortgage, were suspended. The suspension is automatically lifted if the out of court settlement attempt is considered unsuccessful and as such is terminated or if a decision of the majority of creditors is taken to that respect. The same suspension applies during the time period

from the submission of the debt restructuring agreement for ratification to the competent Court until the issuance of the court decision. It should be noted that if the process is not concluded during the aforementioned period of 90 days due to requests for extension of the process submitted by creditors, the suspension of enforcement procedures is deemed to be still in force towards the respective creditors.

Greek Law 4469/2017 set out the consequences and measures applicable in case of non-compliance with the Settlement Agreement. In brief, in the event of non-payment of the debtor for a time period longer than ninety (90) days, any creditor may file an annulment petition before the court. Upon annulment, all claims revive while the Settlement Agreement's annulment constitutes a refutable presumption of the debtor's cessation of payments. Whereas, a Settlement Agreement with the Greek State/Social Security Funds is automatically revoked in case of (a) non-payment (or partial payment) of three (3) instalments; (b) failure to submit the required income tax and VAT statements within three (3) months from the lapse of their submission deadline; and (c) failure to pay or settle any subsequent debt obligations born after 31.12.2016 within ninety (90) days from the enactment or the ratification of the Settlement Agreement or, in case such debt obligations became due following the enactment or the ratification of the Settlement Agreement, within sixty (60) days from the payment time due.

Certain provisions have been introduced recently with respect to pending proceedings under Greek Law 4469/2017; in particular, Greek Law 4941/2022 provides that any pending applications under Greek Law 4469/2017 must be completed within 20 days following the enactment of such law in June 2022, in the sense that the relevant restructuring agreements must have been concluded by such date; in case of non – conclusion of the restructuring agreements, all pending out-of-court settlement procedures shall be considered unsuccessful.

Greek Legislation and Regulation Pertaining to Insolvency

The Greek bankruptcy code enacted by Greek Law 3588/2007 (the "**Bankruptcy Code**"), has been amended several times, including by Greek Laws 4446/2016, 4472/2017, 4491/2017 and 4512/2018 and, as of 1 March 2021, was replaced by Greek Law 4738/2020 (the "**New Bankruptcy Code**") (For further details see below *Settlement legislative tools affecting the enforcement of security*).

For proceedings initiated until 31 December 2020, the Bankruptcy Code only applied to business undertakings, which include sole traders, partnerships, companies and unincorporated legal entities that pursue a financial purpose and have the place of their main interests in Greece, but excluding certain regulated entities (such as credit institutions and insurance companies).

Under the Bankruptcy Code, the following insolvency proceedings were available for debtors meeting the insolvency criteria of the Bankruptcy Code:

- (a) bankruptcy, which was regulated by articles 1-98 of the Bankruptcy Code (except for the simplified bankruptcy proceedings in respect of small debtors (provided that at least two of the following criteria were met: (1) the value of the bankruptcy estate does not exceed €150,000; (2) net turnover of at least €200,000; (3) average number of persons occupied not exceeding

five, which were regulated by Articles 162-163 of the Bankruptcy Code, as replaced by article 62 of Greek Law 4472/2017, and Articles 163a–163c of the Bankruptcy Code, added through article 62 of Greek Law 4472/2017). Bankruptcy proceedings commenced by a declaration of the bankruptcy by the court on the application of any creditor, the debtor or the attorney general. Furthermore, the debtor itself was obliged to commence bankruptcy proceedings within 30 days of the date on which it became unable to repay its debts. From the declaration of bankruptcy a bankruptcy officer (*syndikos*) is appointed and is responsible for the administration of the debtor's assets for the purposes of liquidating and distributing the proceeds of liquidation to the creditors, in accordance with their respective rights of priority;

- (b) a rehabilitation agreement under the Bankruptcy Code (articles 99-106(f)) between a debtor and a qualifying majority of its creditors with the aim that the debtor satisfied (even partly) its creditors and remains operational following ratification of the agreement. The rehabilitation agreement proceedings were available on the application of the debtor, provided that there was evidence of an actual or foreseeable financial inability on the part of the debtor to pay its debts as they fell due in a general manner, or if the court forms the view that such financial inability is likely to occur. The court could also sustain the debtor's application if it assesses that the debtor is already in cessation of payments, provided that the debtor, at the same time, files for bankruptcy and also files an expert report. In such a case, the petition for the declaration of bankruptcy is examined by the court if the court rejects the ratification of the rehabilitation agreement. The rehabilitation agreement is ratified by a court decision and initiated following submission of an application to the competent court by (a) the insolvent debtor and provided that it has been concluded between the debtor and creditors representing 60 per cent of claims, at least 40 per cent of which must be of secured creditors, or (b) creditors representing 60 per cent of claims, at least 40 per cent of which must be of secured creditors, regarding the rehabilitation plan agreed between them and provided that the debtor is already in a status of cessation of payments. Upon ratification, the rehabilitation plan is binding upon all creditors, whose claims are regulated in such plan, including any non-participating creditors (but is not binding on creditors whose claims have arisen after the decision ratifying the rehabilitation plan); and
- (c) a restructuring plan under the Bankruptcy Code (articles 107-131) following its approval by the court and the creditors which could be initiated on the application to the court of:
 - (i) the debtor, either at the same time as its application to be declared bankrupt or within three months from the decision declaring bankruptcy (such period may be extended by the insolvency court for an additional period not exceeding one calendar month); or
 - (ii) creditors representing 60 per cent of claims, at least 40 per cent of which must be of secured creditors, along with the application for the declaration of bankruptcy.

Following the acceptance of the proposed restructuring plan by creditors representing at least 60 per cent of the total claims value, including 40 per cent of the claims of secured creditors, the plan was

submitted to the competent court for ratification. Upon ratification by the court the plan is binding upon all creditors of the debtor including any dissenting and non participating creditors. Thereafter, the bankruptcy proceedings are terminated and, unless otherwise provided in the restructuring plan, the debtor resumes administration of its business with a view to fulfilling the terms of the restructuring plan. The aforementioned proceeding has been abolished by the New Bankruptcy Code, as of 1 March 2021.

The Bankruptcy Code included detailed provisions on each of the above insolvency proceedings and the requirements that need to be met in respect of each proceeding, including the rights of creditors thereunder.

Settlement legislative tools affecting the enforcement of security

The New Bankruptcy Code on "*Debt settlement and second chance providence*" was introduced by the Greek Parliament transposing into Greek law EU Directive 2019/1023 on preventive restructuring frameworks and second chance, abolishing the Bankruptcy Code and codifying all debt settlement legislative tools. More specifically, the New Bankruptcy Code includes, inter alia, provisions regarding (a) out-of-court Settlement of Debts, which was first introduced via Greek Law 4469/2017 (see above *Out-of court settlement of business debts*), (b) the rehabilitation proceeding, (c) bankruptcy, whereas certain provisions are introduced regarding vulnerable debtors who have been declared bankrupt or whose primary residence runs the risk to be seized.

The provisions regarding bankruptcy under the New Bankruptcy Code apply to any natural and legal persons having bankruptcy capacity (regardless of whether they qualify as merchants or not).

The provisions of New Bankruptcy Code regarding rehabilitation and bankruptcy proceedings entered into force as of 1 March 2021, whereas the provisions regarding out-of-court settlement of debt and small scale bankruptcies entered into force as of 1 June 2021. Natural persons who do not qualify as merchants became eligible to bankruptcy as of 1 June 2021. However, upon decision of the creditors' assemblies it may apply to pending bankruptcy proceedings initiated pursuant to the existing regime of the Bankruptcy Code. As of the date of its enactment, submissions of new applications pursuant to art. 68-77 of Greek Law 4307/2014, on special administration, are no longer available, whereas submissions of new applications pursuant to Greek Law 3869/2010, on indebted households, are no longer available as of 1 June 2021. Therefore the concerns raised above in relation to those procedures will be relevant only for procedures already commenced until such date. It should be noted though that according to art. 72A of Greek Law 4307/2014, introduced by the New Bankruptcy Code, the debtor or its creditors may apply to the competent court requesting the subversion of the special administration, provided that they submit an application for the ratification of a rehabilitation agreement pursuant to the provisions of the new law. Moreover, the reorganisation proceeding described above (see section *Greek Legislation and Regulation Pertaining to Insolvency*) has also been abolished.

In particular, under the New Bankruptcy Code, the following debt settlement legislative tools are available:

(a) **Out-of-court Settlement of Debt**

The out-of-court Settlement of Debt provisions, which replaced the procedure of existing Greek Law 4469/2017, apply to individuals who may be declared bankrupt according to the New Bankruptcy Code. Therefore any individuals as well as any legal persons having an economic object or exercising economic activities may submit an application in order to be placed under the beneficial provisions of the new law, provided that the following main conditions are met:

- (i) the debtor has outstanding debts towards financial institutions, the Greek State and social security institutions as of the date upon which the application is submitted;
- (ii) the total debts to be settled exceed € 10,000.

The out-of-court settlement proceedings are held digitally to the Special Secretariat for the Administration of Private Debt through an electronic platform. The reformed procedure does not require any judicial intervention, and thus, it is anticipated to be concluded within 2 months.

The debtor's application shall be accompanied by data which will be mainly provided automatically from the platform. It is noted that the process may also be initiated by creditors with an invitation addressed to debtors to apply within a period of 45 working days.

Following the final submission of the application, the financial institutions which are participating creditors are entitled to file a settlement proposal. A restructuring agreement based on the aforementioned proposal is concluded, provided that it secures the consent of the debtor, the majority (in terms of the value of the claims concerned) of the financial institutions which are participating creditors and at least the participating secured creditors. The deadline for signing the restructuring agreement is two months following the date upon which the debtor's application was filed.

In respect of the participation of the Greek State and Social Security Institutions, it is noted that following the execution of the restructuring agreement between the financial institutions and the debtor, the restructuring agreement is disclosed to the Greek State and the Social Security Institutions through the electronic platform. The restructuring agreement is presumed to be accepted by the Greek State and the Social Security Institutions, provided that (a) the debt towards the latter does not exceed cumulatively (i) the amount of €1,500,000 and (ii) the total debt towards the financial institutions which are participating creditors; (b) the content of the restructuring agreement is in line with the special calculation tool set out in the New Bankruptcy Code and more specifically, the New Bankruptcy Code introduces a special calculation tool, which is left to the discretion of the financial institutions and may define the terms of the debt settlement, taking into account mostly the obligation not to render the financial situation of any creditor worse than the one it would be in the case of liquidation of the debtor's assets in the context of an enforcement procedure pursuant to the provisions of the CCP; (c) the conditions regarding several restrictions in respect of the write off and/or settlement of the claims of the State and the social security funds are met. In case that the conditions under (a)(i) and (ii) are not met, the consent of the Greek State and the Social Security Institutions may still be granted, provided that

the restructuring agreement has been executed by the majority of creditors as required by the law and that requirements under (c) are met.

The consent of the Greek State and the Social Security Institutions is presumed to be granted upon expiry of a period of 15 working days, starting from the disclosure of the restructuring agreement. The law also provides for an implied consent of the financial institutions in cases where the relevant creditor would not be entitled to any recoveries and the no-worse off principle is complied with in an objective manner as per the special calculation tool.

Following the filing of an out-of-court settlement application, any enforcement measures against the debtor with respect to the claims for which the out of court settlement is sought, as well as the process set out in the Code of Conduct, are suspended. The suspension is automatically lifted in case that a settlement proposal is not submitted and the respective decision is disclosed to the debtor or in any other case that the out of court settlement attempt is considered unsuccessful.

Further, out-of-court settlement of debt regime includes provisions regarding the protection of primary residence. More specifically, if the restructuring agreement concerns a loan secured with the debtor's primary residence or in case of a debtor with performing debts (who submitted the application), then a subsidy may be granted for instalments due for a period of five years under certain conditions, the most important of which are (a) the total debts exceed the amount of € 10,000, (b) the outstanding debt stemming from the loan secured with the debtor's primary residence does not exceed the amount of €135,000, increased by the amount of € 20,000 per family member and up to the amount of € 215,000 per creditor, (c) the loan has not been terminated within a period of 1 year following the submission of the application and (d) certain provisions regarding the decrease of the debtor's income are met.

In case that a debt settlement agreement is not executed by the debtor and the participating creditors within two months of the application submission date, the application will be rejected.

The New Bankruptcy Code sets out the consequences applicable in case of non-compliance with the restructuring agreement. More specifically, in the event of non-payment of the debtor of an aggregate amount equal either to three payment instalments or 3% of the total amount due under the restructuring agreement, any creditor may terminate the restructuring agreement. Upon termination, all claims towards the terminating creditor revive to the pre-settlement debt amount less any amount already paid under the settlement to that date. It is noted that the termination of the restructuring agreement does not have an erga omnes effect.

(b) The rehabilitation procedure

The rehabilitation procedure under the New Bankruptcy Code applies only to persons exercising business activity, who are in a present or future financial distress or likelihood to become insolvent. A rehabilitation agreement may be concluded between a debtor and a qualifying majority of its creditors representing, in principle, more than 50 per cent of the preferred claims and more than 50 per cent of

the rest claims, with the aim that the debtor satisfies (even partly) its creditors and remains operational following ratification of the agreement.

In the absence of debtor's consent, a rehabilitation agreement may be concluded between creditors, in cases where the debtor is in a general and permanent cessation of payments, the debtor's application shall be accompanied by a business plan, the term of which shall be equal to the term of the rehabilitation agreement, as well as an expert report. Furthermore, the New Bankruptcy Code introduces an expert registry.

The court may sustain the debtor's application if it assesses that the debtor is already in cessation of payments, provided that the debtor, at the same time, files for bankruptcy and also files an expert report. In such a case, if the court rejects the ratification of the rehabilitation agreement, the petition for the declaration of bankruptcy is examined. If a petition for the declaration of bankruptcy is not pending but the court assesses that the debtor is in cessation of payments, the rejection decision is served to the prosecutor in order that they may file a bankruptcy petition.

The rehabilitation agreement is ratified by a court decision following submission of an application to the competent court by (a) the insolvent debtor, provided that it has been concluded between the debtor and creditors representing more than 50 per cent of the preferred claims and more than 50 per cent of the rest claims, or (b) in case of absence of consent of one of the aforementioned categories of creditors, the rehabilitation agreement is ratified if it has been concluded between creditors representing 60 per cent of claims and 50 per cent of preferred claims, and it does not render the financial situation of these creditors worse than the one it would be in the case of the debtor's bankruptcy.

The New Bankruptcy Code provides also for the "implied consent" of the Greek State and the Social Security Institutions, as the latter are presumed to grant their consent to the rehabilitation agreement, provided that (a) the principal debt does not exceed the amount of €15,000,000, (b) according to the expert report, the rehabilitation agreement does not render the financial situation of these creditors worse than the one it would be in the case of the debtor's bankruptcy and (c) according to the expert report the overdue debt towards these creditors does not exceed the debt owed towards private creditors.

As regards the legal entities, in order to avoid resistance from shareholders, it is provided that the approval of the rehabilitation agreement shall be provided by its administrator or governing body, unless approval by its shareholders' or administrators' board is explicitly required by law.

Upon ratification, the rehabilitation plan is binding upon all creditors, whose claims are regulated in such plan, including any non-participating creditors (but is not binding on creditors whose claims have arisen after the decision ratifying the rehabilitation plan).

(c) **Bankruptcy**

Bankruptcy proceedings are regulated by articles 75-172 of the New Bankruptcy Code. As mentioned above, under the new law individuals not exercising business activity become eligible to bankruptcy. Bankruptcy proceedings commence by a declaration of the bankruptcy by the court on the application of any creditor, the debtor or the attorney general.

The objective pre-condition to be declared bankrupt is being in a state of cessation of payments in a stable and permanent manner. Under the New Bankruptcy Code, state of cessation of payments is presumed where the debtor does not pay due and payable claims towards the Greek State, social security institutions, credit or financial institutions which amount to at least 40% of its total due and payable claims for a period of six months, provided that such non-performing claims exceed the amount of €30,000. A selective performance of certain due and payable claims (cherry-picking) does not reserve the cessation of payments. A threatened inability to pay should also constitute a pre-condition for the declaration of bankruptcy if such declaration is made by the debtor. Furthermore, the debtor itself is obliged to commence bankruptcy proceedings within 30 days of the date on which it became unable to repay its debts.

Under the new law, the bankruptcy officer is not appointed upon the declaration of bankruptcy, but nominated in the bankruptcy application. The bankruptcy officer is responsible for the administration of the debtor's assets for the purposes of liquidating and distributing the proceeds of liquidation to the creditors, in accordance with their respective priority of rights.

In this respect, it is noted that the existing special administration procedures as set out in art. 68 et seq. of Greek Law 4307/2014 are merged with the New Bankruptcy Code. To that extent, in the case that the bankruptcy application is submitted by creditors representing at least 30 per cent of the total claims value, including 20 per cent of the claims of secured creditors and the bankruptcy is deemed to be large scale, the creditors are entitled to request that the debtor's assets are liquidated either as a whole or in operational parts.

The liquidation of the debtor's assets is conducted through a public auction without an initial auction price administered by the notary. Within one month following the e-auction process, the creditor assemblies shall decide upon the results of the auction, i.e. approving or not the transaction, and more precisely the selection process of the assets being sold as well as the completion of the transaction in each case.

In the event that the liquidation of the debtor's assets as a whole or in operational parts is not fulfilled within a period of eighteen (18) months from the date of court judgement of the insolvency declaration, the bankruptcy officer shall proceed to the piece meal liquidation process.

According to the provisions regarding the piece meal liquidation, an insolvent debtor's assets are liquidated separately through a public auction. The e-auction is conducted by a notary and the initial auction price is set as the average value of the assets, as defined by two certified appraisers and

gradually adjusted depending on the success of the auction. It is noted that after a third unsuccessful auction, the bankruptcy officer shall submit to the judge a request either for a reduction of the reserve price or for the approval of conducting the sale. In case that the assets are not sold within a period of 120 days following the judge's issuing regarding the reduction of the reserve price, the e-auction will be conducted without an initial price. The creditors' claims are satisfied through the proceeds of the auction. The respective provisions of art. 162-166 of the New Bankruptcy Code apply to debtors declared bankrupt after the enactment of the new law and to those declared bankrupt before the enactment as well, provided that the liquidation of the debtor's assets has not commenced or the relevant auction has been unsuccessful.

Furthermore, a digital insolvency registry has been introduced through which all announcements, creditors' communications and registrations of procedural actions shall be realised.

As regards the small scale bankruptcies, these are regulated by art. 173-191 of the New Bankruptcy Code. Legal entities meeting one of the 'micro' entities' criteria as set out in art. 2 of Greek Law 4308/2014, i.e. those not exceeding €350,000 in total assets, or €700,000 in net amount of turnover, or an average of ten employees, and individuals with assets up to €350,000, may be subject to a simplified bankruptcy process, which is conducted through the newly introduced Electronic Insolvency Registry. Furthermore, the court competency is transferred to the Magistrate Court.

The regime regarding the appointment of the insolvency practitioners ("*diaxeiristes aferegyotitas*" in Greek) for the purposes of bankruptcy and rehabilitation, which was first introduced via Greek Law 4335/2015, is reformed by the New Bankruptcy Code. The functions of a bankruptcy officer (*syndikos* in Greek) may be carried on by an individual or legal entity registered in a special register and qualified to act as insolvency practitioner.

Moreover, the protection of primary residences of debtors considered to be "vulnerable" under specific provisions of the New Bankruptcy Code is regulated by art. 217 et. seq. The new regime provides for a sale and lease back procedure for primary residences and the establishment of a new organisation to implement the aforesaid procedure. More specifically, in the case that a vulnerable debtor is declared bankrupt under the aforementioned provisions or in the case that enforcement proceedings against its primary residence have commenced, the debtor may submit a request to sale or lease their primary residence to the organisation established for this procedure. The first phase of the public tender for the establishment of the relevant legal entity has been completed in September 2022.

The debtor's residence is acquired from the organisation at a commercial value, which is determined by a certified valuator. The new organisation shall rent the property to the debtor for a period of twelve years. The monthly rent will be determined primarily based on the applicable housing loans' average interest rate. The debtor may be entitled to repurchase the residence at a price objectively determined under the provisions of the New Bankruptcy Code upon proper fulfilment of their rental payment obligations.

Distributional priorities before and after insolvency

The Bankruptcy Code, the New Bankruptcy Code, the CCP and the Code for the Collection of Public Revenues include specific provisions on the priority of claims of creditors. Further, Greek Laws 4335/2015, 4336/2015, 4446/2016, 4512/2018, 4842/2021, 4855/2021 and 4871/2021 introduced changes in the provisions on the distributional priorities, as well as extensive procedural changes, intended to standardise and expedite court and enforcement proceedings before and after insolvency, and to protect against abuses of the proceedings.

In relation to the priority of claims of the creditors, the Greek legislative framework distinguishes between: (1) claims with a general privilege (a general privilege applies by operation of law and concerns, among others, claims on account of VAT and other taxes, claims of public law entities, claims of employees and social security funds and, under the Bankruptcy Code, also concerns credit facilities granted as rescue funding after the opening of insolvency proceedings); (2) claims with a special privilege (which include those of secured creditors); and (3) unsecured claims. The distinction between claims with a general privilege, claims with a special privilege and unsecured claims is critical in the context of distribution of the proceeds of liquidation of the assets over which security has been created. Claims with a general or special privilege are satisfied in priority over unsecured claims.

The **general privileges** under article 975 of the CCP follow the ranking order set out below (the general privileges):

- (i) Medical and funeral expenses of the debtor and his family that arose within the last twelve (12) months prior to the day of the public auction or the declaration of bankruptcy and compensation claims (except claims for moral damages) due to disability exceeding eighty percent (80 per cent) or more that arose until the day of the public auction or the declaration of bankruptcy.
- (ii) Claims for the provision of necessary food vital for the support of debtor and his family that arose during the last six months before the day of the public auction or the declaration of bankruptcy.
- (iii) Claims based on salaried employment, claims from fees, expenses and compensation of lawyers paid under fixed regular remuneration, provided that they arose within the last two years prior to the day of the first public auction or the declaration of bankruptcy, compensation claims arising by reason of termination of employment arrangements and lawyers' compensation claims arising by reason of the termination of in-house employment arrangement, as well as law firms' claims provided that these arise within 1 year prior to the auction. The same rank also includes claims of the State arising out of the Value Added Tax (VAT) and any attributable or withholding taxes together with any increments and interests imposed on such claims, as well as claims of social security organisations, alimony claims in case of death of the person owing such alimony and compensation claims due to disability exceeding sixty seven percent (67 per cent) which arose up to the day of the public auction or the declaration of bankruptcy.

- (iv) Claims of farmers or agricultural cooperatives from the sale of agricultural products that arose within the last year prior to the day of the auction or the declaration of bankruptcy.
- (v) Claims of the State and municipal authorities arising out of any cause, together with any increments and interest imposed on such claims.
- (vi) Claims of the Athens Stock Exchange Members' Guarantee Fund (Syneggyitiko) against the debtor, insofar as such debtor is or was an investment services firm and the claims of such fund were born within the two (2) years preceding the day of the public auction or the declaration of bankruptcy.

The **special privileges** include claims secured by pledge, pre-notation or mortgage.

As regards enforcement proceedings initiated before 1 January 2016, it is noted that if claims with a general privilege co-exist with claims with a special privilege, claims with a general privilege are entitled to up to one third of the proceeds of liquidation, provided that certain claims with a general privilege (claims on account of VAT and claims of employees and social security funds) have absolute priority over all other claims without being restricted to one third of the proceeds of liquidation. Unsecured claims will only be satisfied pro rata out of any remainder of the proceeds of liquidation of the insolvency estate, following satisfaction of all claims with a general or special privilege. However, following the amendment of the provisions of the CCP by Greek Law 4335/2015 and the amendment of the Bankruptcy Code by Greek Laws 4336/2015, 4446/2016 and 4512/2018 on the ranking of creditors in enforcement and insolvency proceedings respectively, the aforementioned absolute priority of the above generally privileged claims does not apply for enforcement proceedings initiated from 1 January 2016 onwards and bankruptcies declared from 1 January 2016. This benefits secured creditors and also unsecured creditors. The latter are also entitled to a specific percentage of the enforcement proceeds, depending on whether generally privileged claims and secured claims co-exist with unsecured claims or not. In particular, (a) in case of concurrence of creditors' claims of general privilege, claims of special privilege and of non-privileged claims, creditors enjoying one or more general privileges are allocated 25 per cent of the auction/liquidation proceeds, creditors enjoying one or more special privileges are allocated 65 per cent of such proceeds, whereas the remaining 10 per cent of the auction/liquidation proceeds is allocated to non-privileged creditors; by amendment of the law it was clarified that creditors with secured claims and claims of a general privilege are not entitled to said 10% of the proceeds in cases where unsecured creditors exist; (b) in case of concurrence of special privileges claims and non-privileged ones, an amount of 90 per cent of the proceeds is allocated for the repayment of creditors enjoying special privileges, while the remaining 10 per cent of the auction/liquidation proceeds is allocated to the non-privileged creditors; (c) in case of concurrence of general privileges and non-privileged ones, an amount of 70 per cent of the proceeds is allocated for the repayment of creditors enjoying general privileges, while the remaining 30 per cent of the auction/liquidation proceeds is allocated to the non-privileged creditors; and (d) in case of concurrence of general privileges and special privileges, the general privileges will be satisfied up to one third of the auction proceeds, whereas the special privileges may be satisfied up to two thirds of the auction proceeds.

As regards bankruptcy proceedings initiated between 1 January 2016 and 1 March 2021, the claims arising from financing of any kind to the debtor aimed at ensuring the continuance of the operations of its business and payment of its obligations, subject to the conditions of art. 154(a) of the Bankruptcy Code, have a general privilege and an absolute priority over all other claims in the case of (a) and (c) above and the respective distributional percentages apply after full discharge of such claims.

Under the new regime introduced by the New Bankruptcy Code, which applies to bankruptcy proceedings initiated from 1 March 2021 onwards, the creditors ranking rules in case of bankruptcy are aligned with the relevant provisions (i.e. art. 975, 976, 977, 977A and 978) of the CCP. Further, senior general privileges are introduced in relation to claims arisen within the context of the rehabilitation procedure aiming to the continuation of the debtor's business. These claims arise from financing facilities and the provision of goods or services. Further, art. 263 of the New Bankruptcy Code provides that, irrespective of the creditors' assemblies decision regarding the application of the new law to pending bankruptcy proceedings, the creditors ranking shall be regulated by the provisions in force until the new procedure applied.

Additionally, Greek Law 4512/2018 (articles 176 and 177) introduced certain changes in the ranking order of creditors in enforcement proceedings (new articles 977A of the CCP and 156A of the Bankruptcy Code).

In particular, under article 977A of the CCP, in respect of any new claims arising after such provisions enter into force (i.e. on 17-01-2018) and which are secured by a pledge or mortgage over an asset which was not previously encumbered (both conditions need to apply cumulatively), the auction proceeds will be allocated, after deduction of the enforcement expenses as follows:

- (1) Claims of employees for salaries of up to six months, owed on the basis of salaried employment and arisen prior to the scheduled day of the auction, capped, per employee and per month, at the amount of the minimum monthly statutory salary for employees above 25 years old multiplied by 275 per cent. (super privilege);
- (2) Claims enjoying special privileges (i.e. secured by pledge or mortgage);
- (3) Claims enjoying general privileges (as per above); and
- (4) Claims of non-privileged creditors.

As regards bankruptcy proceedings regulated by the Bankruptcy Code, the ranking of creditors in insolvency proceedings under the article 156A of the Bankruptcy Code apply in respect of any new claims arising after such provisions enter into force (i.e. on 17-01-2018) and which are secured by a pledge or mortgage over an asset which was not previously encumbered (both conditions needs to apply cumulatively); in such case, the auction proceeds will be allocated, after deduction of the insolvency expenses as follows:

- (1) Claims enjoying super privileges, as per above under (1);
- (2) Claims arising from financing of any kind to the debtor aimed at ensuring the continuance of the operations of its business and payment of its obligations, subject to the conditions of art. 154(a) of the Bankruptcy Code;
- (3) Claims enjoying special privileges under art. 155 paragraph 1(a) and (b) including those secured by pledge or mortgage;
- (4) (remaining) claims enjoying general privileges as per art. 154 of the Bankruptcy Code and (remaining) claims enjoying special privileges; and
- (5) Claims of non-privileged debtors.

The opening of insolvency proceedings does not affect the priority ranking of validly created security (claims of item (2) above) and secured creditors (as opposed to unsecured creditors) can initiate individual enforcement proceedings for their secured claim following the opening of insolvency proceedings against the debtor. Under the Bankruptcy Code, upon filing of the bankruptcy application, enforcement proceedings against the debtor's assets could be suspended. However, according to the New Bankruptcy Code, secured creditors are entitled to commence enforcement proceedings against the debtor's encumbered assets, under the condition that the bankruptcy application does not include a request from creditors that the debtor's assets are liquidated either as a whole or in operational parts. Moreover, the newly introduced provisions of the New Bankruptcy Code, provide that within nine (9) months following the bankruptcy declaration, secured creditors are entitled to take individual enforcement measures against the debtor's encumbered assets.

Consumer Protection

Credit institutions in Greece are also subject to legislation that seeks to protect consumers from abusive terms and conditions, most notably Greek Law 2251/1994, as in force. Such legislation sets forth rules on the marketing and advertisement of consumer financial services, prohibits unfair and misleading commercial practices and includes penalties for violations of such rules and prohibitions. The abovementioned Greek Law 2251/1994 has been significantly amended by virtue of Greek Law 4512/2018 and has been codified by Ministerial Decision 5338/2018. The relevant amendments, including, amongst others, in the definition of consumer (which may only include individuals), the protection afforded to very small businesses and in the framework related to e-commerce, took effect on 18 March 2018.

At the same time, numerous consumer protection issues are regulated through administrative acts, such as Decision No. Z1 798/2008 of the Minister of Development on the prohibition of general terms which have been found to be abusive by final court decisions (as amended by Decisions Z1 21/2011 and Z1 74/2011 of the Deputy Minister of Labour and Social Insurance). Also, the Governor of the Bank of

Greece Act No. 2501/2002, as amended and supplemented, includes certain fundamental disclosure obligations relating to the provision of banking services by credit institutions operating in Greece.

Joint Ministerial Decision Z1 699/2010 transposed into Greek Law Directive 2008/48/EC of the European Parliament and of the Council on credit agreements for consumers and repealing Council Directive 87/102/EEC, as amended and in force. The said Joint Ministerial Decision provides for increased consumer protection in the context of consumer credit transactions and prescribes, among others, the inclusion of standard information in advertising and the provision of pre contractual and contractual information to consumers.

Joint Ministerial Decision Z1 699/2010 has been amended by Joint Ministerial Decision Z1 111/2012, which, among others, transposed into Greek law Directive 2011/90/EU as of 1 January 2013 and introduced additional criteria for the calculation of the real total annual interest rate.

In 2013, Greece also transposed Directive 2011/83/EU on consumer protection pursuant to Joint Ministerial Decision Z1 891/2013, which amended Greek Law 2251/1994 in many respects. Such decision, as amended and supplemented by Ministerial Decision 27764/2014, entered into force on 13 June 2014 and applies to consumer contracts entered into after that date.

In addition, Ministerial Decision 35935/2023, replacing Ministerial Decision 56885/2014, sets a code of conduct for the protection of consumers during sales, offer periods and promotional actions while Joint Ministerial Decision 70330/2015 transposed into Greek law Directive 2013/11/EU on alternative dispute resolution for consumer disputes and introduced supplementary measures for the application of Regulation EU 524/2013 on online dispute resolution for consumer disputes.

Furthermore, Ministerial Decision 5921/2015 (which entered into force on 19 January 2015) sets out the terms and the procedure for mediation of the consumer ombudsmen between credit institutions and debtors pursuant to the provisions of the Code of Conduct.

Finally, Presidential Decree No. 10/2017 introduced the "Code of Consumer Conduct" and set the principles to be applied to trade and the trading relations between suppliers and consumers and their associations and Ministerial Decision 31619/2017 introduced the "Code of Consumer Conduct for E-Commerce".

DESCRIPTION OF THE TRANSACTION DOCUMENTS

Servicing and Cash Management Deed

The Servicing and Cash Management Deed, made between the Issuer, the Trustee and the Servicer contains provisions relating to, *inter alia*:

- the Issuer's obligations when dealing with any cash flows arising from the Cover Pool and the Transaction Documents;
- the servicing, calculation, notification and reporting services to be performed by the Servicer, together with cash management services and account handling services in relation to monies from time to time standing to the credit of the Transaction Accounts, the Collection Accounts and the Third Party Collection Accounts (if any);
- the terms and conditions upon which the Servicer will be obliged to sell in whole or in part the Loan Assets;
- the Issuer's right to prevent the sale of a Loan Asset to third parties by removing the Loan Asset made subject to sale from the Cover Pool and transferring within 10 Athens Business Days from the receipt of the offer letter, to the relevant Transaction Account, an amount equal to the price set forth in such offer letter, subject to the provision of a solvency certificate;
- the covenants of the Issuer;
- the representations and warranties of the Issuer regarding itself and the Cover Pool Assets;
- the responsibilities of the Servicer following the service of a Notice of Default on the Issuer or upon failure of the Issuer to perform its obligations under the Transaction Documents; and
- the circumstances in which the Trustee will be obliged to appoint a Special Administrator to perform the Servicing and Cash Management Services.

Servicing

Pursuant to the Servicing and Cash Management Deed, the Issuer has agreed to be appointed as Servicer in respect of the Cover Pool and has agreed to service the Loans and their Related Security comprised in the Cover Pool and provide cash management services.

Consequently the Issuer will be required to administer the Loans and their Related Security in accordance with its administration, arrears and enforcement policies and procedures forming part of the Issuer's policy from time to time as they apply to those Loans.

The Servicer will have the power to exercise the rights, powers and discretions and to perform the duties of the Issuer in relation to the Loans and their Related Security that it is servicing pursuant to the terms of the Servicing and Cash Management Deed, and to do anything which it reasonably considers necessary, convenient or incidental to the administration of the Loans and their Related Security.

Right of delegation by the Servicer

The Servicer may from time to time subcontract or delegate the performance of its duties under the Servicing and Cash Management Deed, provided that it will nevertheless remain responsible for the performance of those duties to the Issuer and the Trustee and, in particular, will remain liable at all times for servicing the Loans and their Related Security and for the acts or omissions of any delegate or subcontractor. Any such subcontracting or delegation may be varied or terminated at any time by the Servicer.

Appointment of Replacement Servicer

Upon the occurrence of any of the following events (each a "**Servicer Termination Event**"):

- (a) where the Issuer and the Servicer are not the same entity:
 - (i) default is made by the Servicer in the payment on the due date of any payment due and payable by it under the Servicing and Cash Management Deed and such default continues unremedied for a period of three Athens Business Days after the earlier of the Servicer becoming aware of such default and receipt by the Servicer of written notice from the Trustee requiring the same to be remedied;
 - (ii) default is made by the Servicer in the performance or observance of any of its other covenants and obligations under the Servicing and Cash Management Deed, which is materially prejudicial to the interests of the Covered Bondholders and such default continues unremedied for a period of 20 Business Days after the Servicer becoming aware of such default, PROVIDED THAT where the relevant default occurs as a result of a default by any person to whom the Servicer has sub-contracted or delegated part of its obligations hereunder, such default shall not constitute a Servicer Termination Event if, within such period of 20 Business Days of awareness of such default by the Servicer, the Servicer terminates the relevant sub-contracting or delegation arrangements and takes such steps as the Trustee may approve to remedy such default;
 - (iii) the occurrence of an Insolvency Event in relation to the Servicer; or
- (b) where the Issuer and the Servicer are the same entity the occurrence of an Issuer Event, (with the exception of an Issuer Insolvency Event),

then the Trustee shall at any time after it receives notice of such Servicer Termination Event use its reasonable endeavours to by notice in writing to the Servicer terminate its appointment as Servicer under the Servicing and Cash Management Deed with effect from a date (not earlier than the date of the notice) specified in the notice. Upon the termination of Eurobank as Servicer, the Trustee shall use its reasonable endeavours to appoint an independent investment bank or commercial bank to identify an entity to act as replacement Servicer. Such entity must be either a servicer licensed under Greek law 4354/2015 or a credit institution duly licenced to provide services in Greece (an "**Eligible Servicer**") and have experience of administering residential mortgage loans in Greece and be willing to enter into a servicing agreement on substantially similar terms as the relevant provisions of the Servicing and Cash Management Deed. The Trustee will appoint such entity as replacement Servicer (the "**Replacement Servicer**"). The appointment of any such Replacement Servicer shall be subject to, inter alia, approval from the Covered Bondholders by an Extraordinary Resolution passed at a single meeting of the Covered Bondholders of all Series then outstanding.

"**Insolvency Event**" means in respect of the Servicer or the Special Administrator (as applicable):

- (a) an order that is made by any competent court or a resolution passed for the winding up or dissolution of the Servicer or the Special Administrator (as applicable) (other than for the purpose of amalgamation, merger or reconstruction); or
- (b) the Servicer or the Special Administrator (as applicable) ceases to carry on its business or substantially the whole of its business (other than for the purpose of an amalgamation, merger or reconstruction); or
- (c) the Servicer or the Special Administrator (as applicable) stops payment or is be unable to, or admits inability to, pay its debts as they fall due, or is to be adjudicated or found bankrupt or insolvent by a court of competent jurisdiction or makes a conveyance or assignment for the benefit of, or enters into any composition or other arrangement with, its creditors generally; or
- (d) a receiver, trustee or other similar official is appointed in relation to the Servicer or the Special Administrator (as applicable) or in relation to the whole or over half of the assets of the Servicer or the Special Administrator (as applicable), or an interim supervisor of the Servicer or the Special Administrator (as applicable) is appointed by the Bank of Greece in accordance with article 137 of the Greek law 4261/2014 or an encumbrancer takes possession of the whole or over half of the assets of the Servicer or the Special Administrator (as applicable), or a distress or execution or other process is levied or enforced upon or sued out against the whole or a substantial part of the assets of the Servicer or the Special Administrator (as applicable) and in any of the foregoing cases it or he is not discharged within 60 days; or

- (e) a creditor's collective enforcement procedure is commenced against the Servicer or the Special Administrator (as applicable) (as well as any procedure for the submission of the Servicer or the Special Administrator (as applicable) under special liquidation pursuant to Greek law 4261/2014 and any procedure under the New Bankruptcy Code); or
- (f) any action or step is taken which has a similar effect to the foregoing.

Appointment of Special Administrator

Upon the Trustee receiving notice in writing of the occurrence of an Issuer Insolvency Event, the Trustee shall, as soon as reasonably practicable, appoint in compliance with Article 21 of the Covered Bond Law a Credit Institution licensed to provide services in Greece and which is willing to enter into an agreement substantially in the same terms as the Servicing and Cash Management Deed, provided that such entity meets the requirements of Article 21(4) of the Covered Bond Law, to act as special administrator (the **Special Administrator**). The appointment of the Special Administrator shall be subject to the consent of the Bank of Greece.

In the event that the Trustee does not appoint a Special Administrator within a reasonable period of time, the Bank of Greece may appoint, pursuant to Article 21(2) of the Covered Bond Law, a Special Administrator, provided that an Issuer Insolvency Event has occurred.

The statutory duties of the Special Administrator, as set out in Article 21(3) of the Covered Bond Law are:

- (a) ensuring that the obligations relating to the Covered Bonds are met;
- (b) managing and liquidating the Cover Pool including, if there is an opportunity to do so, transferring the assets comprising the Cover Pool, together with the obligations under the Covered Bonds and any Hedging Agreements and/or other contractual obligations relating to the Covered Bonds and the Cover Pool to another bank that is a covered bond issuer regulated in accordance with the Covered Bond Law and the Secondary Covered Bond Legislation;
- (c) ensuring that that any receipts or recoveries received in respect of the Cover Pool are made available to pay the obligations and liabilities arising under the Covered Bonds, any Hedging Agreements and any other obligations secured by the Statutory Pledge, in accordance with the terms of the Prospectus; and
- (d) carrying out the proper management of the assets comprising the Cover Pool, monitoring the Cover Pool to ensure that it continues to be sufficient to meet the liabilities and obligations arising under and in respect of the Covered Bonds and the other Transaction Documents (including for these purposes monitoring the ongoing compliance of the Cover Pool with the Statutory Tests), initiation of proceedings in order to return to the Cover Pool from the insolvency estate of the Issuer any Cover Assets

that have been transferred from the Cover Pool to the insolvency estate of the Issuer; and following the redemption in full of all Covered Bonds and the satisfaction of all liabilities arising under or in respect of the Transaction Documents, to transfer to the Issuer (or its insolvency estate or as directed by any relevant resolution authority) all remaining assets in or representing the Cover Pool.

In addition to the above duties, the Special Administrator shall carry out the obligations of the Servicer under the Servicing and Cash Management Deed or appoint a duly qualified third party to do so. If the Special Administrator appoints a third party to carry out the obligations of the Servicer, it shall monitor the performance of such third party and take reasonable steps to ensure that such third party complies with the provisions of the Servicing and Cash Management Deed.

The Cover Pool

The cover pool may consist of the following assets, provided that each of them are either governed by Greek law or comply with Article 14(2) of the Covered Bond Law and/or paragraph 5 of Section A of Chapter III of the Secondary Covered Bond Legislation as applicable:

- (a) eligible assets set out in Article 8(1)(a) of the Covered Bond Law as further supplemented by Section A of Chapter III of the Secondary Covered Bond Legislation, including, but not limited to, claims deriving from loans and credit facilities of any nature comprising the aggregate of all principal sums, interest, costs, charges, expenses, additional loan advances and other moneys (including, in case of any Subsidised Loans, any Subsidised Interest Amount due and owing with respect to such Subsidised Loan) and including the amounts received from Borrowers which represent the cost to the Issuer of levy of Greek Law 128/1975 ("**Levy**") in respect of such Loans but excluding any third party expenses due or owing with respect to such loan and/or credit facilities provided that such loans and credit facilities are secured by residential real estate (the "**Loans**") together with any mortgages, mortgage pre-notations, guarantees or indemnity payments which may be granted or due, as the case may be, in connection therewith (the "**Related Security**", and together with the Loans the "**Loan Assets**");
- (b) [Intentionally left blank]
- (c) deposits with credit institutions (including any cash flows deriving therefrom) and any other Substitution Assets, provided that such deposits or Substitution Assets comply with Article 8 or Article 18 (if applicable) of the Covered Bond Law, as supplemented by Chapter III of the Secondary Covered Bond Legislation (excluding the Transaction Accounts and the Collection Accounts); and
- (d) Liquid Assets and Marketable Assets,

(each, together with the Transaction Accounts, a "**Cover Pool Asset**" and collectively the "**Cover Pool**").

The Issuer may substitute existing Cover Pool Assets in the Cover Pool with Additional Cover Pool Assets. The Cover Pool must at all times comply with the following tests in relation to any existing Cover Pool Assets and any Additional Cover Pool Assets which are Substitution Assets must meet the requirements of Article 8 of the Covered Bond Law and the related provisions in the Secondary Covered Bond Legislation. In particular:

- (a) such Substitution Assets must fall within the categories set out in, and comply with the requirements of, paragraph 1(c) of Article 129 of the CRR;
- (b) such Substitution Assets must comply with the limits set out in paragraph 1a of Article 129 of the CRR, provided that in respect of Substitution Assets falling within paragraph 1(c) of Article 129 of the CRR (i.e. derivative contracts), the Bank of Greece may, in accordance with Section A paragraph 8 of Chapter III of the Secondary Covered Bond Legislation, permit exposures to credit institutions classified in credit quality step 3;
- (c) the nominal value of such Substitution Assets in aggregate must not exceed the limits set out in Section H paragraph 3 of Chapter III of the Secondary Covered Bond Legislation.

For a summary of Article 129 of the CRR, please see the section entitled "*Overview of the Greek Covered Bond Legislation – Summary of the Provisions of the CRR*".

Pursuant to the Covered Bond Law a Statutory Pledge is created over the Cover Pool Assets, to the extent that they are subject to Greek law and held in Greece.

"Substitution Assets" means assets meeting the definition set out in Article 5(15) of the Covered Bond Law.

"Marketable Assets", as defined in the Act of the Monetary Policy Council of the Bank of Greece 54/27-2- 2004 as substituted by Act No. 96/22.04.2015 and which comply with the requirements for Eligible Investments, are allowed to be included in the Cover Pool only for the purposes of overcollateralisation and will be included in assessing compliance with the Statutory Tests.

By virtue of the Registration Statement(s) filed with the Athens Pledge Registry on or prior to the Issue Date for the first Series of Covered Bonds, the Issuer shall segregate the Cover Pool in connection with the issuance of Covered Bonds for the satisfaction of the rights of the Covered Bondholders and the other Secured Creditors.

The Issuer shall be entitled, subject to filing a Registration Statement so providing, to:

- (a) allocate to the Cover Pool Additional Cover Pool Assets provided that with respect to any New Asset Type, (i) such Additional Cover Pool Assets that are of a New Asset Type comply with the requirements of the Greek Covered Bond Legislation; (ii) the Rating Agency has provided confirmation in writing that the ratings on the Covered Bonds would not be adversely affected by, or withdrawn as a result of addition of the New Asset Type to the Cover Pool (and in the

case of any other Rating Agency, such Rating Agency has been notified of such addition); and
 (iii) the risk weighting of the Covered Bonds will not be negatively affected.

- (b) prior to the occurrence of an Issuer Event and provided that no breach of any Statutory Test would occur as a result of such removal or substitution (i) remove Cover Pool Assets from the Cover Pool or (ii) substitute Cover Pool Assets with Additional Cover Pool Assets, provided that for any substitution of Additional Cover Pool Assets which are New Asset Types, S&P has provided confirmation in writing that the ratings on the Covered Bonds would not be adversely affected by, or withdrawn as a result of such allocation (and in the case of any other Rating Agency, such Rating Agency has been notified of such substitution) and the Issuer may only allocate to the Cover Pool assets which comply with the requirements of the Covered Bond Law and the Secondary Covered Bond Legislation.

"Additional Cover Pool Assets" means further assets of the type referred to in the definition of Cover Pool which comply with the requirements for Cover Pool Assets under the Covered Bond Legislation and the Servicing and Cash Management Deed that are assigned to the Cover Pool by the Issuer for the purposes of issuing further Series of Covered Bonds, maintaining the initial rating(s) assigned to the Covered Bonds and/or complying with the Statutory Tests.

Any further assets added to the Cover Pool at the option of the Issuer in accordance with the above or by way of mandatory changes below shall form part of the Cover Pool.

"Minimum Credit Rating" means a long-term issuer credit rating of at least BB- by the Rating Agency.

The S&P ratings which correspond to credit quality step 1, credit quality step 2 and credit quality step 3 (for the purposes of references thereto in respect of the CRR, the Covered Bond Law and the Secondary Covered Bond Legislation) are set out in the table below:

Individual Eligibility Criteria

Each Loan Asset to be included in the Cover Pool shall comply with the following criteria (the **"Individual Eligibility Criteria"**):

- (i) It is an existing Loan, denominated in euro or Swiss francs and is owed by borrowers who are individuals;

- (ii) It is governed by Greek law and the terms and conditions of such Loan do not provide for the jurisdiction of any court outside Greece;
- (iii) Its nominal value remains a debt, which has not been paid or discharged;
- (iv) It is secured by a valid and enforceable first ranking mortgage and/or mortgage pre-notation over property located in Greece that may be used for residential purposes;
- (v) Notwithstanding (iv) above, if the mortgage and/or mortgage pre-notation is of lower ranking, the loans that rank higher have also been originated by the Issuer and are included in the Cover Pool;
- (vi) Only completed properties secure the Loan;
- (vii) (a) in the case of loans originated by the Issuer all lending criteria and preconditions applied by the Issuer's credit policy and customary lending procedures have been satisfied with regards to the granting of such Loan and (b) in the case of Loans acquired by the Issuer, each Loan has been administered by the Issuer from the date of acquisition according to the level of skill, care and diligence of a reasonable prudent mortgage lender;
- (viii) It is either a fixed or floating rate loan or a combination of both; and
- (ix) In relation to any Loans included in the Cover Pool, on the date on which such Loan is added in the Cover Pool it has a maturity of no longer than the day falling 7 years before the Extended Final Maturity Date of the Earliest Maturing Covered Bonds then outstanding.

In accordance with Section A paragraph 7 of Chapter III of the Secondary Covered Bond Legislation, the Issuer shall be obliged to have in place procedures to ensure that any Loans secured over real estate property are adequately insured against damages for the duration of such Loan.

The Issuer covenants that only loans secured over property that may be used for residential purposes will form Primary Assets (as defined in Section E paragraph 1(a) of Chapter III of the Secondary Covered Bond Legislation) for the purposes of the Programme. Accordingly, the provisions of Section E of Chapter III of the Secondary Covered Bond Legislation shall not apply to the Covered Bonds or the Programme.

Statutory Tests

Monitoring of the Cover Pool

Prior to the occurrence of an Issuer Event, the Servicer shall verify on each Applicable Calculation Date that, as at the last calendar day of the calendar month immediately preceding such Applicable Calculation Date, the Cover Pool satisfies the following aggregate criteria:

- (i) the Cover Pool satisfies the Nominal Value Test;
 - (ii) the Cover Pool satisfies the NPV Test; and
 - (iii) the Cover Pool satisfies the Interest Cover Test,
- (collectively, the "**Statutory Tests**" and each a "**Statutory Test**").

The Nominal Value Test

The "**Nominal Value Test**" is satisfied if the Nominal Value of the Cover Pool is equal to or greater than the product of (a) the sum of (i) 100% and (ii) the OC Percentage and (b) the aggregate of the Principal Amount Outstanding of all Series of Covered Bonds.

The "**Nominal Value**" of the Cover Pool is an amount equal to:

$$A + B + LB$$

Where, in each case calculating the relevant values and amounts as at the last calendar day of the immediately preceding calendar month:

"**A**" = the "**Adjusted Outstanding Principal Balance**" of each Loan in the Cover Pool, which shall be the lower of:

- (a) the Euro Equivalent of the actual Outstanding Principal Balance of the relevant Loan in the Cover Pool (as calculated in accordance with the provisions of the Servicing and Cash Management Deed), provided that, if the Euro Equivalent of the aggregate actual Outstanding Principal Balance of all Loans denominated in Swiss Francs exceeds twenty per cent of the Euro Equivalent of the aggregate actual Outstanding Principal Balance of all Loans comprising the Cover Pool, then such amount of the Euro Equivalent of the aggregate actual Outstanding Principal Balance of such Loans denominated in Swiss Francs as exceeds twenty per cent of the Euro Equivalent of the aggregate actual Outstanding Principal Balance of the Loans comprised in the Cover Pool will be given a value of zero;
- (b) the Euro Equivalent of the latest of either the physical valuation or the Residential Property Index of the Bank of Greece Valuation of the residential property securing that Loan multiplied by 0.80, less the Outstanding Principal Balance of any higher ranking Loan if such Loan is a second or lower ranking Loan, provided that such Loan can never be given a value of less than zero; and
- (c) if the relevant Loan is in arrear of more than 90 days or otherwise deemed to be in default in accordance with Article 178 of the CRR, zero.

"B" = outstanding principal balance of the Substitution Assets, Liquid Assets (other than any Liquid Assets standing to the credit of the Liquidity Buffer Reserve Ledger), the Marketable Assets included in the Cover Pool, in each case without double counting.

"LB" = the outstanding principal balance of all Liquid Assets standing to the credit of the Liquidity Buffer Reserve Ledger.

"OC Percentage" means the higher of (i) 0.05 and (ii) such percentage figure (expressed as a decimal) as selected by the Issuer (or the Servicer acting on its behalf) and notified to the Rating Agencies in accordance with the Servicing and Cash Management Deed in accordance with the methodologies published by the Rating Agencies (after procuring the required level of overcollateralisation in line with target rating).

In calculating the Nominal Value of the Cover Pool, the Servicer shall not take into account any Loan in respect of which the Issuer is in breach of the Representations and Warranties under the Servicing and Cash Management Deed and such Loan has not been removed from the Cover Pool by the Issuer.

In calculating the Nominal Value of the Cover Pool, the value of any non-euro assets comprised in the Cover Pool shall be converted into euro on the basis of relevant rates as at the last Athens Business Day of the calendar month immediately preceding the relevant Applicable Calculation Date.

The NPV Test

The **"NPV Test"** is satisfied if the Net Present Value of the Cover Pool is greater than the Net Present Value of the Covered Bond Liabilities.

The **"Net Present Value of the Cover Pool"** is an amount equal to:

$$A+B+LB$$

Where, in each case calculating the relevant values and amounts as at the last calendar day of the immediately preceding calendar month:

"A" = the net present value of Loans comprised in the Cover Pool, assuming for such purposes that each Loan has a nominal principal value equal to its Adjusted Outstanding Principal Balance.

"B" = net present value of any Substitution Assets, Liquid Assets (other than any Liquid Assets standing to the credit of the Liquidity Buffer Reserve Ledger), Marketable Assets and any Hedging Agreements included in the Cover Pool, in each case without double counting.

"LB" = the net present value of all Liquid Assets standing to the credit of the Liquidity Buffer Reserve Ledger.

The **"Net Present Value of the Covered Bond Liabilities"** is an amount equal to:

C+L

Where, in each case calculating the relevant values and amounts as at the last calendar day of the immediately preceding calendar month:

"C" = the net present value of all Series of Covered Bonds then outstanding.

"L" = the Lump Sum Amount.

"Lump Sum Amount" means the expected costs of the maintenance and management of the liquidation of the Programme as determined in accordance with Article G paragraph 1 of Chapter III of the Secondary Covered Bond Legislation.

The NPV Test must also be satisfied assuming a parallel shift of the yield curve by 200 basis points.

On each Applicable Calculation Date, the Servicer shall determine whether the Net Present Value of any Interest Rate Swap, any FX Swaps, any Covered Bond Swaps and the Transaction Accounts (if not held with the Issuer) are in aggregate less than or equal to limits applicable under paragraphs 1(c) and 1a of Article 129 of the CRR as at the last calendar day of the calendar month immediately preceding the relevant Applicable Calculation Date.

In calculating the Net Present Value of the Cover Pool, the Servicer shall not take into account any Loan in respect of which the Issuer is in breach of the Representations and Warranties under the Servicing and Cash Management Deed and such Loan has not been removed from the Cover Pool by the Issuer.

In calculating the Net Present Value of the Cover Pool, all amounts denominated in a currency other than euro shall be converted into euro on the basis of relevant rates as at the Athens Business Day of the calendar month immediately preceding the relevant Applicable Calculation Date.

The Interest Cover Test

The "**Interest Cover Test**" is satisfied if the Interest Income of the Cover Pool is greater than the Interest Liabilities of the Covered Bonds.

The "**Interest Income of the Cover Pool**" is an amount equal to:

$$A+B+LB$$

Where, in each case calculating the relevant values and amounts as at the last calendar day of the immediately preceding calendar month:

"A" = the interest expected to be received on the Adjusted Outstanding Principal Balances of the Loans comprised in the Cover Pool during the 12 months immediately following the last calendar day of the calendar month immediately preceding such Applicable Calculation Date.

"B" = the interest expected to be received during the 12 months immediately following the last calendar day of the calendar month immediately preceding such Applicable Calculation Date on any Substitution Assets, Liquid Assets (other than any Liquid Assets standing to the credit of the Liquidity Buffer Reserve Ledger), Marketable Assets and any Hedging Agreements included in the Cover Pool, in each case without double counting.

"LB" = the interest expected to be received during the 12 months immediately following the last calendar day of the calendar month immediately preceding such Applicable Calculation Date on all Liquid Assets standing to the credit of the Liquidity Buffer Reserve Ledger.

The **"Interest Liabilities of the Covered Bonds"** is an amount equal to:

$$C+D$$

Where, in each case calculating the relevant values and amounts as at the last calendar day of the immediately preceding calendar month:

"C" = the interest expected to be paid during the 12 months immediately following the last calendar day of the calendar month immediately preceding such Applicable Calculation Date on all Series of Covered Bonds then outstanding.

"D" = the interest expected to be paid under any Hedging Agreements during the 12 months immediately following the last calendar day of the calendar month immediately preceding such Applicable Calculation Date.

In calculating the Interest Income of the Cover Pool, all amounts denominated in a currency other than euro shall be converted into euro on the basis of relevant rates as at the last Athens Business Day of the calendar month immediately preceding the relevant Applicable Calculation Date.

For the purposes of the Statutory Tests set out above:

- (a) in accordance with Section A paragraph 3 of Chapter III of the Secondary Covered Bond Legislation, the limits referred to in paragraph 1a of Article 129 of the CRR shall not apply to exposures which are included in the Cover Pool to exclusively satisfy the liquidity requirements of the Covered Bonds. Notwithstanding this relaxation of the limits that would otherwise apply in respect of Substitution Assets, Section H paragraph 3 of Chapter III of the Secondary Covered Bond Legislation imposes an overall limit of 15% (of the nominal value of all outstanding Covered Bonds) on the value of Substitution Assets that may form part of the Cover Pool at any time, including any assets which form part of the balance standing to the credit of the Liquidity Buffer Reserve Ledger from time to time;
- (b) Loans secured by residential or commercial real estate property, as specified in points (d) and (f) of paragraph 1 of Article 129 of the CRR shall, if such properties are under construction, not

exceed 10 per cent. of the nominal value of the Cover Pool as at the last calendar day of the immediately preceding calendar month, in accordance with Section A paragraph 6 of Chapter III of the Secondary Covered Bond Legislation;

- (c) Section H paragraph 3 of Chapter III of the Secondary Covered Bond Legislation imposes an overall limit of 15% of the nominal value of all outstanding Covered Bonds on the value of Substitution Assets that may form part of the Cover Pool at any time, including any assets which represent the balance standing to the credit of the Liquidity Buffer Reserve Ledger from time to time;
- (d) in accordance with Section G paragraph 3 of Chapter III of the Secondary Covered Bond Legislation the value of each Hedging Agreement shall be determined on the basis of the net present value of each such Hedging Agreement and it shall be taken into account in conducting the Statutory Tests and the limits provided for in paragraph 1a of Article 129 of the CRR;
- (e) where a default in respect of a Cover Pool Asset has occurred pursuant to Article 178 of the CRR or a Cover Pool Asset has been in default for a period exceeding ninety (90) days, the value of such Cover Pool Asset shall not be included in the calculation of the value and cash inflows of the Cover Pool for the purposes of any of the Statutory Tests;
- (f) the exposures stated in paragraph 1(b) of Article 129 of the CRR that qualify for the credit quality step 2 stated in Chapter 2 of Title II of Part 3 of the CRR shall be excluded from the Cover Pool even if they do not exceed 20% of the Euro Equivalent of the Principal Amount Outstanding of all Series of Covered Bonds;
- (g) Marketable Assets are allowed to be included in the Cover Pool and may be taken into account for the purposes of the Statutory Tests only for the purposes of overcollateralisation;
- (h) any amounts received from Borrowers which represent the cost to the Issuer of Levy in respect of such Loans shall be excluded from the calculations of the Statutory Tests; and
- (i) for the avoidance of doubt, any cash amounts standing to the credit of the Collection Accounts shall not comprise part of the Cover Pool for the purposes of the Statutory Tests.

Hedging Agreement Tests

Where the Cover Pool includes any Hedging Agreements, the Hedging Agreements must comply with the following criteria (each a "**Hedging Agreement Test**" and collectively, the "**Hedging Agreement Tests**"):

- (i) each Hedging Agreement shall meet the requirements set out in Article 13 of the Covered Bond Law;
- (ii) each Hedging Agreement shall be used exclusively for hedging interest rate, currency

or liquidity risks in respect of the Cover Pool Assets and such purpose shall be evidenced in such Hedging Agreement;

- (iii) each Hedging Counterparty must belong to one of the categories set out in Section F paragraph 1(b) of Chapter III of the Secondary Covered Bond Legislation;
- (iv) each Hedging Agreement shall be accompanied by a legal opinion confirming the enforceability of such Hedging Agreement and each Hedging Agreement and the accompanying legal opinion must be submitted to the Banking Supervision Department of the Bank of Greece; and
- (v) any Hedging Agreements included in the Cover Pool must not contain terms providing for a termination in the event of a failure by the Issuer to repay its debts in the event of its insolvency or resolution.

The net present value of each Hedging Agreement shall be determined in accordance with Section G paragraph 3 of Chapter III of the Secondary Covered Bond Legislation and shall be taken into account in conducting the Statutory Tests and the limits provided for in paragraph 1a of Article 129 of the CRR.

For a summary of Article 129 and Article 178 of the CRR, please see the section entitled "*Overview of the Greek Covered Bond Legislation – Summary of the Provisions of the CRR*".

"Eligible Investments" means any marketable assets that are denominated in euro or CHF, provided that, in all cases:

- (a) such investments are immediately repayable on demand, disposable without penalty or have a maturity date falling on or before the next Cover Pool Payment Date;
- (b) such investments provide a fixed principal amount at maturity (such amount not being lower than the initially invested amount);
- (c) must not constitute a position in a securitisation (as the term "securitisation" is defined in Regulation (EU) 2017/2402); and
- (d) in the case of any Marketable Assets, each of such debt securities or other debt instruments comply with the criteria set out in the act of Monetary Policy Council of the Bank of Greece 54/27-2- 2004 as substituted by Act No. 96/22.04.2015.

For the purposes of calculating the Statutory Tests set out above, each Loan will be deemed to have an Outstanding Principal Balance of and bear interest on an amount equal to the lower of:

- (a) the Euro Equivalent of the actual Outstanding Principal Balance of the relevant Loan in the Cover Pool (as calculated in accordance with the provisions of the Servicing and Cash Management Deed), provided that, if the Euro Equivalent of the aggregate actual Outstanding

Principal Balance of all Loans denominated in Swiss Francs exceeds twenty per cent of the Euro Equivalent of the aggregate actual Outstanding Principal Balance of all Loans comprising the Cover Pool, then such amount of the Euro Equivalent of the aggregate actual Outstanding Principal Balance of such Loans denominated in Swiss Francs as exceeds twenty per cent of the Euro Equivalent of the aggregate actual Outstanding Principal Balance of the Loans comprised in the Cover Pool will be given a value of zero; and

- (b) the Euro Equivalent of the latest of either the physical valuation or the Residential Property Index of the Bank of Greece Valuation of the residential property securing that Loan multiplied by 0.80, less the Outstanding Principal Balance of any higher ranking Loan if such Loan is a second or lower ranking Loan, provided that such Loan can never be given a value of less than zero; and
- (c) if the relevant Loan is in arrear of more than 90 days or otherwise deemed to be in default in accordance with Article 178 of the CRR, zero,

and each Loan shall be deemed to bear interest on the lower of the amounts calculated in (a), (b) and (c) above.

In addition, in calculating such tests, all Loans that do not comply with the representations and warranties during the immediately preceding calculation period, shall be given a zero value.

"DYPA" means the Public Employment Service, previously named the Manpower Employment Organisation ("**OAED**"), which succeeded in full the Greek Workers Housing Association ("**OEK**") by virtue of Greek Law 4144/2013 and other relevant legislation.

"DYPA Subsidised Loans" means those Loans, which for the avoidance of doubt are only denominated in Euro, in respect of which the DYPA makes payment of Subsidised Interest Amounts pursuant to the applicable laws and the DYPA Framework Agreements.

"Residential Property Index of the Bank of Greece Valuation" means the index of movements in house prices issued by the Bank of Greece in relation to residential properties in Greece.

"Subsidised Loan" means either the DYPA Subsidised Loans, the State Subsidised Loans or the State/DYPA Subsidised Loan or loans subsidised by any additional Greek State owned entity, which for the avoidance of doubt are only denominated in euro.

"Subsidised Interest Amounts" means the interest subsidy amounts, which for the avoidance of doubt shall only be denominated in euro, due and payable from the Greek State in respect of the State Subsidised Loans and/or from the DYPA in respect of the DYPA Subsidised Loans and/or from any other Greek State owned entity in respect of any other Subsidised Loan (as the case may be).

"State Subsidised Loans" means those Loans, which for the avoidance of doubt are only denominated in euro, in respect of which the Hellenic Republic makes payment of Subsidised Interest Amounts pursuant to all applicable laws.

"State/DYPA Subsidised Loans" means those Loans, which for the avoidance of doubt are only denominated in euro, which are both State Subsidised Loans and DYPA Subsidised Loans.

Amortisation test

For so long as the Covered Bonds remain outstanding, the Servicer shall determine on or before each Calculation Date following an Issuer Event whether the Nominal Value will be in an amount at least equal to the sum of the Euro Equivalent of the aggregate Principal Amount Outstanding of the Covered Bonds plus an amount equal to the product of (A) the Euro Equivalent of the aggregate Principal Amount Outstanding of the Covered Bonds and (B) the Amortisation Test OC Level as calculated on the last day of the immediately preceding calendar month (the "**Amortisation Test**").

"Amortisation Test OC Level" means the product of 0.75 and the OC Percentage.

Sale of Selected Loans and their Related Security following an Issuer Event (other than an Issuer Insolvency Event)

Following the occurrence of an Issuer Event (other than an Issuer Insolvency Event), the Servicer, shall be obliged to try to sell Loans and their Related Security in the Cover Pool in respect of the relevant Series of Pass-Through Covered Bonds and Accumulation Covered Bonds on or before the First Refinance Date and on or before each Refinance Date thereafter having the Required Outstanding Principal Balance Amount (the "**Selected Loans**") in accordance with the Servicing and Cash Management Deed, subject to the rights of pre-emption in favour of the Issuer to remove the Selected Loans from the Cover Pool, in the case of the sale of Selected Loans following an Issuer Event and prior to a breach of the Amortisation Test, provided that where the Amortisation Test was met immediately prior to the proposed sale, that the Amortisation Test will continue to be met following any sale of Selected Loans or the removal of such Selected Loans from the Cover Pool and provided further that where the Amortisation Test has been breached prior to such Selected Loans being sold, the Servicer may sell Selected Loans where the Amortisation Test will not be satisfied after such sale provided that the amount by which the Amortisation Test is breached is not worsened or further reduced as a result of sale of such Selected Loans. Where the Servicer is not the same entity as the Issuer, the Issuer will provide the Servicer with such powers of attorney as the Servicer may require in order to allow the Servicer to discharge its obligations under the Servicing and Cash Management Deed.

Prior to the Servicer making any offer to sell Selected Loans and their Related Security to third parties, the Servicer will serve on the Issuer a loan offer notice in the form set out in the Servicing and Cash Management Deed (a "**Selected Loan Offer Notice**") giving the Issuer the right to prevent the sale by the Servicer of all or some of the Selected Loans to third parties, by removing all or some of the Selected Loans made subject to sale from the Cover Pool and transferring an amount equal to the then

Outstanding Principal Balance of the relevant portion of the Selected Loans and the relevant portion of the arrears of interest and accrued interest relating to such Selected Loans to the relevant Transaction Account. Any selection of Selected Loans by the Servicer from the Cover Pool in accordance with the Servicing and Cash Management Deed shall be binding on all parties in the absence of manifest error.

If the Issuer validly accepts the Servicer's offer to remove all or some of the Selected Loans and their Related Security from the Cover Pool by signing the duplicate Selected Loan Offer Notice in a manner indicating acceptance and delivering it to the Trustee and the Servicer within ten Athens Business Days from and including the date of the Selected Loan Offer Notice, the Servicer shall within three Athens Business Days of receipt of such acceptance, serve a selected loan removal notice on the Issuer substantially in the form set out in the Servicing and Cash Management Deed (a "**Selected Loan Removal Notice**"). Any removal of some of the Selected Loans and their Related Security pursuant to such Selected Loan Removal Notice must be in accordance with the requirements of the Servicing and Cash Management Deed.

The Servicer shall offer for sale the Selected Loans and their Related Security in respect of which the Issuer rejects or fails within the requisite time limit to accept the Servicer's offer to remove the Loans and their Related Security from the Cover Pool in the manner and on the terms set out in the Servicing and Cash Management Deed.

Upon receipt of the Selected Loan Removal Notice duly signed on behalf of the Servicer, the Issuer shall promptly and in any event within two Athens Business Days (i) sign and return a duplicate copy of the Selected Loan Removal Notice to the Servicer, (ii) deliver to the Servicer and the Trustee a solvency certificate stating that the Issuer is, at such time, solvent and shall remove from the Cover Pool the relevant portion of the Selected Loans (as specified in the signed Selected Loan Removal Notice) (and any other Loan secured or intended to be secured by that Related Security or any part of it) referred to in the relevant Selected Loan Removal Notice and, where that portion is less than all of the Selected Loans, the Loans and the Related Security in the portion that is to be removed shall be chosen from the Selected Loans on a random basis. Completion of the removal of all or part of the Selected Loans by the Issuer will take place on the date specified in the Selected Loan Removal Notice (provided that such date is not later than the earlier to occur of the date which is (a) ten Athens Business Days after receipt by the Servicer of the returned Selected Loan Removal Notice and (b) the Extended Final Maturity Date of the relevant Series of Covered Bonds) when the Issuer shall, prior to the removal from the Cover Pool of all or part of the relevant Selected Loans (and any other Loan secured or intended to be secured by that Related Security or any part of it) pay to the relevant Transaction Account an amount in cash equal to the price specified in the relevant Selected Loan Removal Notice.

On the date of completion of the removal of all or part of the Selected Loans and their Related Security in accordance with the above, the Issuer shall ensure that the Selected Loans are removed from the Registration Statement.

Upon such completion of the removal of all or part of the Selected Loans and their Related Security in accordance with the above procedure or the sale of all or part of the Selected Loans and their Related Security to a third party or third parties, the Issuer or the Servicer shall cease to be under any further obligation to hold any Customer Files or other documents relating to the relevant removed or sold Selected Loans and their Related Security to the order of the Trustee and, if the Trustee holds such Customer Files or other documents, it will send them to the Issuer at the cost of the Issuer.

"Earliest Maturing Covered Bonds" means, at any time, the Series of the Covered Bonds (other than any Series which is fully collateralised by amounts standing to the credit of the Transaction Accounts) that has or have the earliest Final Maturity Date as specified in the applicable Final Terms (ignoring any acceleration of amounts due under the Covered Bonds prior to service of a Notice of Default).

"Pass-Through Covered Bonds" means,

- (a) those Covered Bonds in respect of which the Final Redemption Amount has not been paid in full on the Final Maturity Date (taking into account any grace periods); and
- (b) following (i) a breach of the Amortisation Test that occurs on or after the occurrence of an Issuer Event (other than an Issuer Insolvency Event) or (ii) the occurrence of an Issuer Insolvency Event and (A) any Final Redemption Amount is unpaid on the Final Maturity Date therefor and payment of such amount is deferred pursuant to Condition 7.1(ii); or (B) a breach of the Amortisation Test, all outstanding Series of Covered Bonds.

Method of Sale of Selected Loans

If the Servicer elects to or is required to sell Selected Loans and their Related Security to third parties following an Issuer Event (other than an Issuer Insolvency Event) which is continuing, the Servicer will be required to ensure that before offering Selected Loans for sale:

- (a) (unless the Selected Loans comprise the entire Cover Pool):
 - (i) the Selected Loans have been selected from the Cover Pool on a random basis; and
 - (ii) following an Issuer Event (other than an Issuer Insolvency Event) but prior to a breach of the Amortisation Test, the Selected Loans to be sold in any sale together (i) constitute all Selected Loans in relation to the relevant Series of Pass-Through Covered Bonds and/or Series of Accumulation Covered Bonds, as applicable; or (ii) where not all Selected Loans in relation to all Series of Pass-Through Covered Bonds and/or Accumulation Covered Bonds, the Servicer has determined that the sale of such Selected Loans is beneficial to the Issuer having taken into account the costs that will be incurred as a result of the sale;

- (b) the Selected Loans have an aggregate Outstanding Principal Balance (subject in the case of Loans denominated in a currency other than Euro to the Euro Equivalent thereof as determined in accordance with the relevant FX Swap Agreement) in an amount (the "**Required Outstanding Principal Balance Amount**") which is as close as possible to the amount calculated as follows:

$$N \times \frac{\text{Outstanding Principal Balance of all Loans in the Cover Pool}}{\text{the Euro Equivalent of the Required Redemption Amount in respect of each Series of Covered Bonds then outstanding}}$$

where N is an amount equal to the Euro Equivalent of the Required Redemption Amount of the relevant Series of Covered Bonds (being each Series of Pass-Through Covered Bonds and any applicable Series of Accumulation Covered Bonds) less amounts standing to the credit of the Transaction Accounts (other than amounts standing to the credit of the Transaction Accounts representing part of the balance standing to the credit of the Liquidity Buffer Reserve Ledger) and (without double counting) the principal amount of any Marketable Assets, Substitution Assets or Liquid Assets (other than Liquid Assets representing part of the balance standing to the credit of the Liquidity Buffer Reserve Ledger) (excluding all amounts to be applied to pay or provide for higher ranking amounts in the Pre-Event of Default Priority of Payments and those amounts that are required to repay any Series of Covered Bonds which mature prior to or on the same date as the relevant Series of Covered Bonds and excluding any amounts standing to the credit of any Accumulation Ledger or which have been set aside to pay any Series of Covered Bonds) and all Sale Proceeds received from the sale of other Selected Loans or removal of Selected Loans under the right of pre-emption).

For the purposes hereof:

"Required Redemption Amount" means, in respect of any relevant Series of Covered Bonds, the amount calculated as follows:

the Principal Amount Outstanding of the relevant Series of Covered Bonds

multiplied by

(1 + Negative Carry Factor x (days to next Interest Payment Date on which the relevant Series can be redeemed (or, in respect of any Accumulation Bonds, the Final Maturity Date) /360))

Where "**Negative Carry Factor**" is a percentage calculated by reference to the weighted average margin of the Covered Bonds and will, in any event, not be less than 0.50 per cent

"Euro Equivalent" means, in relation to a Series of Covered Bonds which is denominated in (a) a currency other than Euro, the Euro equivalent of such amount ascertained using the relevant Covered Bond Swap Rate relating to such Series of Covered Bonds and (b) Euro, the applicable amount in Euro.

The Servicer will offer the Selected Loans for sale to third parties for the best price reasonably available but in any event for an amount not less than the Adjusted Required Redemption Amount.

The "**Adjusted Required Redemption Amount**" means the Euro Equivalent of the Required Redemption Amount, plus or minus (without double counting):

- (i) any swap termination amounts payable to or by the Issuer under any Covered Bond Swap Agreement in respect of the relevant Series of Covered Bonds less (where applicable) the principal balance of any Marketable Assets and Liquid Assets (excluding all amounts to be applied on the next following Cover Pool Payment Date to pay or repay higher ranking amounts in the Pre-Event of Default Priority of Payments and those amounts that are required to repay any Series of Covered Bonds which mature prior to or on the same date as the relevant Series of Covered Bonds and excluding any amounts standing to the credit of an Accumulation Ledger or which have been set aside to pay any Series of Covered Bonds) and all Sale Proceeds received from the sale of other Selected Loans or removal of Selected Loans under the right of pre-emption); plus
- (ii) any swap termination amounts payable to or by the Issuer under any Interest Rate Swap Agreement or any FX Swap Agreement in respect of the relevant Series of Covered Bonds; and
- (iii) reasonable costs and expenses associated with sale of Selected Loans and their Related Security and the reasonable costs and expenses of the Portfolio Manager connected with the sale of Selected Loans and their Security.

Following the occurrence of an Issuer Event (other than an Issuer Insolvency Event), if the Selected Loans have not been sold (in whole or in part) in an amount equal to the Adjusted Required Redemption Amount by the date which is six months prior to, as applicable, if the Earliest Maturing Covered Bonds are not subject to an Extended Final Maturity Date in accordance with the relevant Final Terms, the Final Maturity Date of the Earliest Maturing Covered Bonds or, if the Earliest Maturing Covered Bonds are subject to an Extended Final Maturity Date in accordance with the relevant Final Terms, the Extended Final Maturity Date in respect of the Earliest Maturing Covered Bonds, then the Servicer will offer the Selected Loans for sale for the best price reasonably available notwithstanding that such amount may be less than the Adjusted Required Redemption Amount.

Following the occurrence of the First Refinance Date, the Servicer will as soon as possible and in any event within one calendar month of the First Refinance Date and, if applicable within one month of the occurrence of any further Refinance Date (if applicable), appoint a Portfolio Manager of recognised standing, and which is not an affiliate of the Issuer, on a basis intended to incentivise the Portfolio Manager to achieve the best price for the sale of the Selected Loans (if such terms are commercially available in the market) via a market auction process and to advise it in relation to the sale of the

Selected Loans to third-party purchasers via a market auction process (except where the Issuer exercises its right of pre-emption).

In respect of any sale of Selected Loans and their Related Security following the occurrence of an Issuer Event which is continuing (other than an Issuer Insolvency Event), the Servicer will instruct the Portfolio Manager to use all reasonable endeavours to procure that Selected Loans are sold as quickly as reasonably practicable via a market auction process (in accordance with the recommendations of the Portfolio Manager) taking into account the market conditions at that time and, where relevant, the scheduled repayment dates of the Covered Bonds and the terms of the Servicing and Cash Management Deed.

The Trustee, or its authorised attorney, will not be required to release the Selected Loans and their Related Security from the Cover Pool unless the conditions for the release of such Security under applicable law (other than the Statutory Pledge) are satisfied.

Following the occurrence of an Issuer Event which is continuing (other than an Issuer Insolvency Event), if third parties accept the offer or offers from the Servicer (or the Portfolio Manager on behalf of the Servicer, if a Portfolio Manager has been appointed), then the Servicer will, subject to the foregoing paragraph, enter into a sale and purchase agreement with the relevant third-party purchasers which will require, inter alia, a cash payment from the relevant third-party purchasers. Any such sale will not include any representations and warranties from the Servicer, Portfolio Manager or the Issuer in respect of the Loans and their Related Security unless expressly agreed by the Servicer. Any Sale Proceeds received from the sale of the Selected Loans and their Related Security will be applied by the Servicer on the next following Cover Pool Payment Date as Covered Bond Available Funds.

Following the occurrence of an Event of Default (where such Event of Default arises following the occurrence of an Issuer Event which is not also an Issuer Insolvency Event) and service of a Notice of Default, the Trustee may (and shall if so directed by the Covered Bondholders of each Series acting by way of Extraordinary Resolution and indemnified and/or secured and/or pre-funded to its satisfaction) be entitled to direct the Servicer to dispose of the Cover Pool. Following the occurrence of an Event of Default and service of a Notice of Default (where such Event of Default arises following the occurrence of an Issuer Event which is also an Issuer Insolvency Event) the Special Administrator appointed following such Issuer Insolvency Event may dispose of all or part of the Cover Pool.

For the avoidance of doubt the Cover Pool Assets shall include any Selected Loans which have previously been selected pursuant to the Servicing and Cash Management Deed for disposal in relation to any Series of Covered Bonds which have not yet been sold.

For the purposes of this section:

“First Refinance Date” means the earlier to occur of (i) the date on which any Series of Covered Bonds becomes Pass-Through Covered Bonds or Accumulation Covered Bonds; or (ii) at any time after an

Issuer Event has occurred and is outstanding, the Athens Business Day falling six months before the Final Maturity Date of the Earliest Maturing Covered Bonds.

“Portfolio Manager” means a portfolio manager appointed by the Servicer (pursuant to the Servicing and Cash Management Deed), to sell Selected Loans and their Related Security on behalf of the Servicer.

“Refinance Date” means each of the First Refinance Date and each date falling at six monthly intervals thereafter.

“Sale Proceeds” means the cash proceeds realised from the sale of Selected Loans and their Related Security or their removal from the Cover Pool by the Issuer pursuant to Clause 6.3 (*Sale of Selected Loans and their Related Security*) and 6.4 (*Method of Sale of Selected Loans*) of the Servicing and Cash Management Deed, including where that removal is pursuant to the Issuer's right of pre-emption under Clause 6.3 (*Sale of Selected Loans and their Related Security*) of the Servicing and Cash Management Deed.

Amendment to definitions

Under the Servicing and Cash Management Deed, the parties have agreed that the definitions of Cover Pool, Cover Pool Asset, Individual Eligibility Criteria, Statutory Test and Amortisation Test may be amended by the Issuer from time to time without the consent of the Trustee as a consequence of inclusion in the Cover Pool of a New Asset Type and/or changes to the hedging policies or servicing and collection procedures of the Issuer and/or as a result of any updates, amendments or supplements to the Greek Covered Bond Legislation, provided that S&P has been notified and the ratings on the Covered Bonds would not be adversely affected by, or withdrawn as a result of such amendment (and in the case of any other Rating Agency rating the Covered Bonds, such Rating Agency has been notified of such amendment).

Liquidity Buffer Reserve Ledger

The Issuer has covenanted to hold Liquid Assets having a value equal to or greater than the Liquidity Buffer Reserve Ledger Required Amount.

The Issuer established a ledger on the EUR Transaction Account called the Reserve Ledger, which ledger has been renamed the Liquidity Buffer Reserve Ledger.

Notwithstanding any other provision in this Deed, the Servicer shall invest all amounts standing to the credit of the Liquidity Buffer Reserve Ledger in Liquid Assets.

Any credit interest received with regards to amounts corresponding to the Liquidity Buffer Reserve Ledger will also be credited and count towards the Liquidity Buffer Reserve Ledger.

On each Cover Pool Payment Date, the Servicer shall deposit to the relevant Transaction Account an amount equal to the Liquidity Buffer Reserve Ledger Required Amount, less the balance then standing to the credit of the Liquidity Buffer Reserve Ledger.

The Servicer shall invest all amounts standing to the credit of the Liquidity Buffer Reserve Ledger in Liquid Assets (which, for the avoidance of doubt, may include holding the same in the Transaction Accounts for so long as the Transaction Accounts qualify as Liquid Assets). Any interest received from a deposit corresponding to the Liquidity Buffer Reserve Ledger will be deposited into the Transaction Account of the same currency as such Liquid Assets and credited to the Liquidity Buffer Reverse Ledger prior to an Issuer Event.

The Asset Monitor shall monitor the accuracy and completeness of the coverage requirements of Articles 17 and 18 of the Covered Bond Law and of Section H of Chapter III of the Secondary Covered Bond Legislation, including the compliance with the prescribed Liquidity Buffer Reserve Ledger Required Amount

"Liquid Assets" consists of the following types of assets, segregated in accordance with Article 18 of the Covered Bond Law:

- (a) assets qualifying as level 1, level 2A or level 2B assets pursuant to the delegated Regulation (EU) 2015/61 (other than exposures to securitisations, as the term "securitisation" is defined in Regulation (EU) 2017/2402), that are valued in accordance with that delegated regulation, and are not issued by the credit institution issuing the covered bonds itself, its parent undertaking, other than a public sector entity that is not a credit institution, its subsidiary or another subsidiary of its parent undertaking; and
- (b) short-term exposures to credit institutions that qualify for credit quality step 1 or 2, or short-term deposits to credit institutions that qualify for credit quality step 1, 2 or 3, in accordance with point (c) of Article 129(1) of Regulation (EU) No 575/2013, provided that the Secondary Greek Covered Bond Legislation excludes from the Cover Pool exposures referred to in item (b) of Article 129(1) of Regulation (EU) No 575/2013 that qualify for the credit quality step 2 as set out in Chapter 2 of Title II of the third part of Regulation (EU) No 575/2013, even if they do not exceed 20 per cent. of the nominal amount of outstanding Covered Bonds,

provided that the same shall be denominated in Euro or CHF. It should be noted that Liquid Assets falling within paragraph (b) of the definition of Liquid Assets are subject to a 15% limit in aggregate with any other Substitution Assets, calculated as a percentage of the Principal Amount Outstanding of all Covered Bonds then outstanding.

For the purposes of the definition of Liquid Assets, where a default has occurred in relation to such asset pursuant to Article 178 of the CRR or an asset has been in default for a period exceeding ninety (90)

days, the value of such asset shall not be included for the purposes of the Liquidity Buffer Reserve Ledger Required Amount.

"Liquidity Buffer Minimum Required Amount" means, on each Calculation Date:

- (a) before the occurrence of a Segregation Event, zero; or
- (b) after the occurrence of a Segregation Event, the sum of (i) the amount of interest due on all Series of Covered Bonds over the next six months (calculated on a rolling basis), and (ii) the amounts due over the next six months under paragraphs (a) to (e) (both inclusive) of the Pre-Event of Default Priority of Payments (without double counting).

"Liquidity Buffer Reserve Ledger" means the ledger of such name on the Transaction Accounts maintained by the Servicer pursuant to the Servicing and Cash Management Deed.

"Liquidity Buffer Reserve Ledger Required Amount" means an amount equal to the higher of:

- (a) the Liquidity Buffer Minimum Required Amount; and
- (b) an amount calculated as at each Calculation Date equal to the maximum cumulative net liquidity outflow of the Programme (including all payment outflows falling due on such day, taking into account principal and interest payments and payments under any Hedging Agreements, net of all payment inflows falling due on the same day for claims related to the Cover Pool Assets) over the next one hundred and eighty (180) days following such Calculation Date, provided that for the purposes of calculating the maximum cumulative net liquidity outflows, the Principal Amount Outstanding of the Covered Bonds shall be deemed to be due on the relevant Extended Final Maturity Date (where applicable) and not on the relevant Final Maturity Date.

Liquid Assets

The Servicer shall invest all amounts standing to the credit of the Liquidity Buffer Reserve Ledger in Liquid Assets (which, for the avoidance of doubt, may include holding the same in the Transaction Accounts for so long as the Transaction Accounts qualify as Liquid Assets).

In the event that the Account Bank ceases to be an Eligible Institution, the Servicer will be obliged to transfer the amounts standing to the credit of the Liquidity Buffer Reserve Ledger (to the extent that the same are not already invested in Liquid Assets the obligor and/or holder of which is not the Account Bank) to a credit institution which is an Eligible Institution and whose obligations would satisfy the definition of Liquid Assets.

Collection Accounts

Prior to the occurrence of an Issuer Event, the Servicer will deposit within three Athens Business Day of receipt, all collections of interest, principal and any other monies it receives on the Cover Pool Assets (excluding any Subsidy Payments and any moneys received from Substitution Assets, Liquid Assets and Marketable Assets, if any, included in the Cover Pool) into, in respect of amounts denominated in Swiss francs, a segregated Swiss franc denominated account maintained at the Issuer (the "**CHF Collection Account**") and, in respect of amounts denominated in euro, a segregated euro denominated account maintained at the Issuer (the "**EUR Collection Account**" and together with the CHF Collection Account, "the **Collection Accounts**"). Prior to the occurrence of an Issuer Event, the Servicer shall procure that all Subsidy Payments received from the DYPA and/or the Greek State or any other Greek State owned entity in respect of the Subsidised Loans will be deducted from the applicable Subsidy Bank Account and paid into the EUR Collection Account within three Athens Business Day of receipt. The Issuer will not commingle any of its own funds and general assets with amounts standing to the credit of the Collection Accounts. For the avoidance of doubt, any cash amounts standing to the credit of the Collection Accounts shall not comprise part of the Cover Pool for purposes of the Statutory Tests.

Prior to a reduction in the long-term unsecured, unsubordinated and unguaranteed credit rating of the Issuer to or below the Minimum Credit Rating (such occurrence, a "**Segregation Event**"), the Issuer will be entitled to draw sums from time to time standing to the credit of the Collection Accounts in addition to any funds available to it for any purpose including to make payments on the Covered Bonds.

Following the occurrence of a Segregation Event, and for so long as such Segregation Event remains outstanding, the Issuer shall only be entitled to withdraw from the Collection Accounts (i) amounts required to be transferred to the Transaction Accounts in accordance with clauses 4.2(e), 4.2(f), 4.2(g), 4.2(k) and 4.2(l) of the Servicing and Cash Management Deed or (ii) any Excess Amounts. Following a Segregation Event, if the Issuer's rating(s) subsequently reinstated above the Minimum Credit Rating, and so long as no Issuer Event has occurred and is continuing, then Issuer will be entitled to withdraw any sums standing to the credit of the Collection Accounts at any time.

"Excess Amounts" means, on any Athens Business Day, the amount (if any) standing to the credit of the Collection Accounts that is in excess of the amount required to make all payments due by the Issuer in connection with any Covered Bonds issued under the Programme on the immediately following Cover Pool Payment Date.

If the Issuer's rating(s) are reinstated above the level at which a Segregation Event occurs and so long as no Issuer Event has occurred and is continuing, then the Issuer will be entitled to draw sums standing to the credit of the Collection Accounts and make payments on the Covered Bonds using any funds available to it.

Subsidy Payments means the aggregate of all amounts, which for the avoidance of doubt shall only be denominated in euro, actually received from the DYPA, the Greek State and any other Greek State owned entity representing the Subsidised Interest Amounts in respect of the Subsidised Loans comprised in the Cover Pool.

Transaction Accounts

On or about the Programme Closing Date, a segregated Swiss franc denominated account was established with the Account Bank (the "**CHF Transaction Account**") and a segregated euro denominated account established with the Account Bank (the "**EUR Transaction Account**" and together with the CHF Transaction Account, the "**Transaction Accounts**"). All moneys received from (without double counting) Substitution Assets, Liquid Assets and Marketable Assets, if any, included in the Cover Pool will be deposited into the relevant Transaction Account. Prior to the occurrence of a Segregation Event or an Issuer Event, the Issuer will be entitled to withdraw amounts from time to time standing to the credit of the Transaction Accounts, if any, that are in excess of the sum of (i) any cash amounts required to satisfy the Statutory Tests and (ii) the Liquidity Buffer Reserve Ledger Required Amount. Following the occurrence of a Segregation Event, the Issuer shall no longer be entitled to withdraw moneys from the Transaction Accounts other than for purposes of making payments in accordance with the Pre-Event of Default Priority of Payments. If the Issuer rating(s) are reinstated above the level at which a Segregation Event occurs, and so long as no Issuer Event has occurred, then the Issuer will be entitled from time to time to withdraw amounts standing to the credit of any of the Transaction Accounts equal to the amounts standing to the credit of such Transaction Account which are in excess of the sum of (i) any cash amounts required to satisfy the Statutory Tests and (ii) the Liquidity Buffer Reserve Ledger Required Amount.

Within two Athens Business Days of the occurrence of an Issuer Event which is continuing, the Issuer shall transfer all amounts it has received in respect of any Cover Pool Assets (including any Subsidy Payments) to the CHF Transaction Account or the EUR Transaction Account (as appropriate).

Following an Issuer Event which is continuing, the Servicer (and the Issuer to the extent that the Issuer is no longer the Servicer) shall procure that (i) payments in respect of the Cover Pool Assets (excluding any Subsidy Payments) are directed into a Swiss franc denominated bank account opened in the name of the Issuer with a Greek credit institution or a Greek branch of a foreign credit institution which is an Eligible Institution (the "**CHF Third Party Collection Account**") or a euro denominated bank account opened in the name of the Issuer with a Greek credit institution or a Greek branch of a foreign credit institution which is an Eligible Institution (the "**EUR Third Party Collection Account**") (as appropriate) and that all such amounts are transferred into the CHF Transaction Account or the EUR Transaction Account (as appropriate) within three Athens Business Day of receipt and provide any requisite notices to procure that this occurs; and (ii) that all Euro denominated Subsidy Payments received from the DYPA and/or the Greek State and/or any other Greek State owned entity in respect of any Subsidised Loans are deducted from the applicable DYPA Savings Account and paid into the EUR Transaction Account within three Athens Business Day of receipt and provide any requisite notices to procure that this occurs.

Following an Issuer Event the Transaction Accounts will be used for the crediting of, *inter alia*, moneys received in respect of the Cover Pool Assets included in the Cover Pool or to effect a payment in respect of the Covered Bonds, including the following amounts:

- (a) any amounts standing to the credit of the Collection Accounts (or the Third Party Collection Accounts);
- (b) all amounts required to be credited to the Liquidity Buffer Reserve Ledger;
- (c) any amount received by the Issuer or the Servicer in respect of the Loan Assets and the Substitution Assets, Liquid Assets or Marketable Assets;
- (d) all Subsidy Payments received from the DYPA and/or the Greek State or any other Greek State owned entity;
- (e) all amounts received by the Issuer (without double counting) for effecting payments on the Covered Bonds;
- (f) all amounts received by the Issuer to effect an optional substitution of Cover Pool Assets (including any amount deposited by the Issuer to prevent a sale of Loan Assets to a third party);
- (g) all amounts received in connection with the sale of a Cover Pool Asset;
- (h) all amounts received by the Issuer pursuant to any Interest Rate Swap, any FX Rate Swap and any Covered Bond Swaps (other than Swap Collateral Excluded Amounts (if any)); and
- (i) all amounts deriving from (without double counting) the maturity or liquidation of Marketable Assets, Liquid Assets and Substitution Assets.

Accumulation Ledger

The Servicer will establish a ledger on the Transaction Accounts to be called the “**Accumulation Ledger**”.

The Accumulation Ledger will have separate sub-ledgers (each an “**Accumulation Sub-Ledger**” related to each Series of Accumulation Covered Bonds.

Following the occurrence of an Issuer Event, the Servicer shall credit the relevant Accumulation Sub-Ledger with the amount allocated to the related Series of Accumulation Covered Bonds in accordance with the Priority of Payments.

Any amount standing to the credit of the relevant Accumulation Sub-Ledger on the Final Maturity Date (but prior to a breach of the Amortisation Test) of the relevant Series of Covered Bonds will be applied:

- (a) to pay (in whole or in part) the Final Redemption Amount in respect of the relevant Series; and
- (b) thereafter applied as Covered Bond Available Funds.

Following a breach of the Amortisation Test or the occurrence of an Event of Default all amounts credited to the relevant Accumulation Sub-Ledger will be applied as Covered Bond Available Funds (such amounts, together with amounts applied in (ii) above, the “**Excess Accumulation Receipts**”).

Law and Jurisdiction

The Servicing and Cash Management Deed is governed by English law.

Asset Monitor Agreement

The Issuer has appointed the Asset Monitor to monitor the Cover Pool in accordance with the requirements of Article 15 of the Covered Bond Law and Section I of Chapter III of the Secondary Covered Bond Legislation. The board of directors of the Issuer passed a board resolution to appoint the Asset Monitor to perform such role on 29 September 2023.

Under the Asset Monitor Agreement, the Asset Monitor is required to maintain its status as a chartered accountant and to be both independent of the credit institution issuing the covered bonds and of the chartered accountant who performs the statutory audit of the Issuer under Article 7 of Greek Law 4449/2017. The Asset Monitor is required to notify both the Issuer and the Bank of Greece should it cease to meet these requirements.

The Asset Monitor Agreement requires the Asset Monitor to monitor the Cover Pool to check whether it meets the requirements set out in Articles 8 to 14 and Articles 16 to 19 of the Covered Bond Law, as well the provisions of the Secondary Covered Bond Legislation. The Asset Monitor Agreement also requires the Asset Monitor to monitor the Amortisation Test, if the Amortisation Test is then required to be performed in accordance with the Servicing and Cash Management Deed. The Issuer (and following the occurrence of an Issuer Event, the Servicer or an Issuer Insolvency Event, the Special Administrator) shall provide the Asset Monitor with access to all information, documents, facilities, premises, employees, agents and systems as the Asset Monitor reasonably requires for the performance of the Asset Monitor's duties.

If, at any time while there are Covered Bonds outstanding, the Asset Monitor finds that the requirements set out in articles 8 to 14 and 16 to 19 of the Covered Bond Law and/or the requirements of the Secondary Covered Bond Legislation relating to those articles, are not met, the Asset Monitor will immediately inform the Issuer of such findings.

The Asset Monitor will report to the Issuer and the Bank of Greece in accordance with the requirements of the Greek Covered Bond Legislation as to the results of its monitoring of the Cover Pool on a quarterly basis.

In addition, the Asset Monitor has agreed to carry out the determinations and procedures provided for in Article 15 of the Covered Bond Law. The Asset Monitor will report on a quarterly basis, in April, July and October of each year, on its determinations in relation to the Statutory Tests and other matters required to be monitored in accordance with paragraph 2.1 of Section I of Chapter III of the Secondary Covered Bond Legislation (the "**Quarterly Asset Monitor Report**"). The Asset Monitor will report on an annual basis in accordance with paragraph 2.2 of Section I of Chapter III of the Secondary Covered Bond Legislation (the "**Asset Monitor Report**"). The Asset Monitor Report must be prepared by the Asset Monitor in relation to the annual period ending on 31st December each calendar year. The Asset Monitor shall also perform such additional calculations and tests as may be required by the Bank of Greece to be performed in connection with the Programme in accordance with the requirements of the Bank of Greece from time to time, subject to the Asset Monitor and the Servicer agreeing on the adjusted scope of the agreed upon procedures for such additional calculations or tests, and such additional calculations or tests will, if required, be outlined in the relevant Asset Monitor Report.

The Issuer or the Servicer will ensure that a copy of the Asset Monitor Report is sent to the Bank of Greece for the purposes of the Greek Covered Bond Legislation once per annum by no later than 31st March of the calendar year that immediately follows the end of the annual period in respect of which such Asset Monitor Report was prepared. The Quarterly Asset Monitor Report may also be sent to the Bank of Greece following the end of each quarter in respect of which such Quarterly Asset Monitor Report is prepared.

Following the Programme Closing Date, the Issuer or the Servicer, as applicable, will pay to the Asset Monitor a fee for the tests to be performed by the Asset Monitor.

The Issuer (or after the occurrence of an Issuer Event, the Servicer or, after the occurrence of an Issuer Insolvency Event, the Special Administrator) may, at any time, but subject to the prior written consent of the Trustee, terminate the appointment of the Asset Monitor by giving at least 30 days' prior written notice to the Asset Monitor, provided that such termination may not be effected unless and until a replacement asset monitor has been found by the Issuer (or after the occurrence of an Issuer Event, the Servicer or, after the occurrence of an Issuer Insolvency Event, the Special Administrator) (such replacement to be approved by the Trustee (such approval to be given if the replacement is an accountancy firm of international standing)) which agrees to perform the duties of the Asset Monitor set out in the Asset Monitor Agreement (or substantially similar duties). Prior to the occurrence of an Issuer Event, such notice of termination of the appointment of the Asset Monitor may only be given if approved or consented to by a resolution of the board of directors of the Issuer.

The Asset Monitor may, at any time, resign by giving at least 30 days' prior written notice to the Issuer and the Trustee (copied to the Rating Agency), and may resign by giving immediate notice in the event of a professional conflict of interest caused by the action of any recipient of its reports.

Upon the Asset Monitor giving 30 days' prior written notice of resignation, the Issuer (or after the occurrence of an Issuer Event, the Servicer or, after the occurrence of an Issuer Insolvency Event, the Special Administrator) shall immediately use all reasonable endeavours to appoint a replacement (such replacement to be approved by the Trustee (such approval to be given if the replacement is an accountancy firm of international standing)) which agrees to perform the duties of the Asset Monitor set out in the Asset Monitor Agreement. If a replacement is not appointed by the date which is 30 days prior to the date when tests are to be carried out in accordance with the terms of the Asset Monitor Agreement, then the Issuer (or after the occurrence of an Issuer Event, the Servicer or, after the occurrence of an Issuer Insolvency Event, the Special Administrator) shall use all reasonable endeavours to appoint an accountancy firm of national standing to carry out the relevant tests on a one-off basis, provided that such appointment is approved by the Trustee.

The Trustee will not be obliged to act as Asset Monitor in any circumstances.

Law and Jurisdiction

The Asset Monitor Agreement is governed by English law.

Trust Deed

The Trust Deed, originally made between the Issuer and the Trustee on the Programme Closing Date appoints the Trustee to act as trustee for the Covered Bondholders and the other Secured Creditors in accordance with Article 14(3) of the Covered Bond Law. The Trust Deed contains provisions relating to, *inter alia*:

- (a) the constitution of the Covered Bonds and the terms and conditions of the Covered Bonds (as more fully set out under Terms and Conditions of the Covered Bonds above);
- (b) the covenants of the Issuer; including, *inter alia*, that for so long as any Covered Bonds are outstanding, the Issuer will comply with the provisions of the Covered Bond Law;
- (c) the enforcement procedures relating to the Covered Bonds; and
- (d) the appointment powers and responsibilities of the Trustee and the circumstances in which the Trustee may resign or be removed.

Law and Jurisdiction

The Trust Deed is governed by English law.

Agency Agreement

Under the terms of an Agency Agreement originally entered into on the Programme Closing Date between the Issuer, the Trustee, the Principal Paying Agent (together with any paying agent appointed from time to time under the Agency Agreement, the "**Paying Agents**") and the Registrar (the "**Agency Agreement**"), the Paying Agents have agreed to provide the Issuer with certain agency services and have agreed, *inter alia*, to make available for inspection such documents as may be required from time to time by the rules of the Luxembourg Stock Exchange and to arrange for the publication of any notices to be given to the Covered Bondholders.

For the purposes of Condition 5.2(b)(ii) of the Terms and Conditions, the Agency Agreement provides that if the applicable Final Terms specifies EURIBOR as the Reference Rate applicable to the Covered Bonds, they shall also specify which page (the "**Relevant Screen Page**") on the Reuters Screen or any other information vending service shall be applicable. If such a page is so specified, the Rate of Interest applicable to the relevant Covered Bonds for each Interest Period will, subject as provided below, be either:

- (A) the offered quotation (if there is only one quotation on the Relevant Screen Page); or
- (B) the arithmetic mean (rounded if necessary to the fifth decimal place, with 0.000005 being rounded upwards) of the offered quotations,

(expressed as a percentage rate per annum), for the Reference Rate(s) which appears or appear, as the case may be, on the Relevant Screen Page as at the Specified Time on the Interest Determination Date in question plus or minus (as indicated in the applicable Final Terms) the Margin (if any), all as determined by the Calculation Agent. If five or more offered quotations are available on the Relevant Screen Page, the highest (or, if there is more than one highest quotation, one only of those quotations) and the lowest (or, if there is more than one lowest quotation, one only of those quotations) shall be disregarded by the Calculation Agent for the purpose of determining the arithmetic mean (rounded as provided above) of the offered quotations.

If the Relevant Screen Page is not available or if, in the case of paragraph (A) above, no offered quotation appears or if, in the case of paragraph (B) above, fewer than three offered quotations appear, in each case as at the Specified Time, the Calculation Agent shall request each of the Reference Banks to provide the Calculation Agent with its offered quotation (expressed as a percentage rate per annum) for the Reference Rate at approximately the Specified Time on the Interest Determination Date in question. If two or more of the Reference Banks provide the Calculation Agent with offered quotations, the Rate of Interest for the Interest Period shall be the arithmetic mean (rounded if necessary to the fifth decimal place, with 0.000005 being rounded upwards) of the offered quotations plus or minus (as appropriate) the Margin (if any), all as determined by the Calculation Agent.

For the purposes of Condition 5.2(b)(ii) of the Terms and Conditions, the Agency Agreement also provides that if on any Interest Determination Date one only or none of the Reference Banks provides

the Calculation Agent with an offered quotation, the Rate of Interest for the relevant Interest Period shall be the rate per annum which the Calculation Agent determines as being the arithmetic mean (rounded if necessary to the fifth decimal place, with 0.000005 being rounded upwards) of the rates, as communicated to (and at the request of) the Calculation Agent by the Reference Banks or any two or more of them, at which such banks were offered, at approximately the Specified Time on the relevant Interest Determination Date, deposits in the Specified Currency for a period equal to that which would have been used for the Reference Rate by leading banks in the Euro-zone inter-bank market (if the Reference Rate is EURIBOR) plus or minus (as appropriate) the Margin (if any) or, if fewer than two of the Reference Banks provide the Calculation Agent with offered rates, the offered rate for deposits in the Specified Currency for a period equal to that which would have been used for the Reference Rate, or the arithmetic mean (rounded as provided above) of the offered rates for deposits in the Specified Currency for a period equal to that which would have been used for the Reference Rate, at which, at approximately the Specified Time on the relevant Interest Determination Date, any one or more banks (which bank or banks is or are in the opinion of the Issuer suitable for the purpose) informs the Calculation Agent it is quoting to leading banks in the Euro-zone inter-bank market (if the Reference Rate is EURIBOR) plus or minus (as appropriate) the Margin (if any), provided that, if the Rate of Interest cannot be determined in accordance with the foregoing provisions of this Clause, the Rate of Interest shall be determined as at the last preceding Interest Determination Date (though substituting, where a different Margin is to be applied to the relevant Interest Period from that which applied to the last preceding Interest Period, the Margin relating to the relevant Interest Period in place of the Margin relating to that last preceding Interest Period).

Law and Jurisdiction

The Agency Agreement is governed by English law.

For the purposes of this section "Agency Agreement" any capitalised terms have the meanings given to them in the Terms and Conditions of the Covered Bonds above.

Deed of Charge

Pursuant to the terms of the Deed of Charge entered into on the Programme Closing Date by the Issuer, the Trustee and the other Secured Creditors, the Secured Obligations of the Issuer and all other obligations of the Issuer under or pursuant to the Transaction Documents to which it is a party are secured, *inter alia*, by the following security over the following property, assets and rights (the "**Deed of Charge Security**"):

- (a) an assignment by way of first fixed security over all of the Issuer's interests, rights and entitlements under and in respect of any Transaction Document to which the Issuer is a party and all other contracts, documents, agreements and deeds to which it is, or may become, a party;
- (b) a first fixed charge (which may take effect as a floating charge) over the rights and benefits of the Bank Accounts and all amounts standing to the credit of the Bank Accounts; and

- (c) a first fixed charge (which may take effect as a floating charge) over the rights and benefits of the Issuer in respect of all Substitution Assets, Liquid Assets and Marketable Assets (to the extent governed by English law) purchased from time to time from amounts standing to the credit of any Issuer Account.

In addition, to secure its obligations under the Covered Bonds the Issuer has, pursuant to Article 14(2) of the Covered Bond Law, created a pledge over the Cover Pool Assets to the extent governed by Greek Law (which consists principally of the Issuer's interest in the Loan Assets and certain Liquid Assets and a pledge over the Collection Accounts). The Deed of Charge will also provide that (other than in certain limited circumstances) only the Trustee may enforce the security created under the Deed of Charge or Article 14(2) and (6) of the Covered Bond Law. The proceeds of any such enforcement of the Deed of Charge or Article 14(2) and (6) of the Covered Bond Law will be required to be applied in accordance with the order of priority set out in the Post-Event of Default Priority of Payments.

The Trustee shall at all times be a credit institution or an affiliated company, within the meaning of article 32 of Greek law 4308/2014, of a credit institution that is entitled to provide services in the European Economic Area, in accordance with point 27 of article 5 of Greek Covered Bond Law (an “**EEA Credit Institution**”). If at any time the Trustee ceases to be an EEA Credit Institution, it will notify the Issuer immediately and take all steps necessary to find a replacement Trustee that is an EEA Credit Institution.

Release of Security

In accordance with the terms of the Deed of Charge all amounts which the Servicer (on behalf of the Issuer and the Trustee or its appointee) is permitted to withdraw from the Transaction Accounts pursuant to the terms of the Deed of Charge will be released from the Deed of Charge Security. In addition, upon the Issuer or the Servicer making a disposal of a Substitution Asset, Liquid Asset or Marketable Asset (to the extent governed by English law) charged under the Deed of Charge and provided that the proceeds of such disposal are paid into the Transaction Accounts in accordance with the terms of the Servicing and Cash Management Deed, that Substitution Asset, Liquid Asset or Marketable Asset (to the extent governed by English law) will be released from the Deed of Charge Security.

At such time that all of the obligations owing by the Issuer to the Secured Creditors have been discharged in full, the Trustee will, at the cost of the Issuer, take whatever action is necessary to release the Charged Property from the Deed of Charge Security to, or to the order of, the Issuer.

Enforcement

If a Notice of Default is served on the Issuer, the Trustee shall be entitled to appoint a Receiver, and/or enforce the Deed of Charge Security constituted by the Deed of Charge, and/or take such steps as it shall deem necessary, subject in each case to being indemnified and/or secured and/or pre-funded to its satisfaction. All proceeds received by the Trustee from the enforcement of the Deed of Charge Security will be applied in accordance with the Post-Event of Default Priority of Payments.

Law and Jurisdiction

The Deed of Charge is governed by English law.

Collection Accounts Pledge Agreement

In order to secure its obligations under the Covered Bonds and/or the Transaction Documents the Issuer created a financial collateral over the Collection Accounts. In particular pursuant to the terms of the Collection Accounts Pledge Agreement entered into on or about the date of this Base Prospectus by the Issuer, Eurobank in its capacity a Greek account bank and the Trustee. The Collection Accounts Pledge Agreement also provides for an undertaking of the parties to enter into an agreement on the same terms as the Collection Accounts Pledge Agreement, pursuant to which the Issuer will grant financial collateral over the Third Party Collection Accounts.

Enforcement

Following the delivery of a Notice of Default, the Trustee may enforce the security created under the Collection Accounts Pledge Agreement in accordance with the terms of Greek law 3301/2004. The proceeds of any such enforcement will be applied towards payment (including by way of set-off) of obligations secured under the agreement.

The Collection Accounts Pledge Agreement is governed by Greek law.

Interest Rate Swap Agreement

Some of the Loan Assets in the Cover Pool will pay from time to time a variable rate of interest for a period of time that may either be linked to the standard variable rate of the Issuer (the "**Issuer Standard Variable Rate**") or linked to an interest rate other than the Issuer Standard Variable Rate, such as EURIBOR or a rate that tracks the ECB base rate. Other Loan Assets will pay a fixed rate of interest for a period of time. However, the Euro payments to be made by the Issuer under the Covered Bonds or under each of the Covered Bond Swaps may vary. To provide a hedge against the possible variance between:

- (a) the rates of interest payable on the Loan Assets in the Cover Pool; and
- (b) payments by the Issuer under the Covered Bonds or the Covered Bond Swaps,

the Issuer, the provider of the Interest Rate Swaps (each such provider, an "**Interest Rate Swap Provider**") and the Trustee may enter into one or more interest rate swap transactions in respect of each Series of Covered Bonds under an "**Interest Rate Swap Agreement**" (each such transaction an "**Interest Rate Swap**").

Under the terms of each Interest Rate Swap, in the event that the relevant rating of the Interest Rate Swap Provider or any guarantor of the Interest Rate Swap Provider's obligations is downgraded by a

Rating Agency below the rating specified in the Interest Rate Swap Agreement, the Interest Rate Swap Provider may, in accordance with the Interest Rate Swap Agreement, be required to take certain remedial measures which may include providing collateral for its obligations under the Interest Rate Swaps, arranging for its obligations under the Interest Rate Swaps to be transferred to an entity with ratings sufficient to meet the then-current criteria of each of the Rating Agencies, procuring another entity with ratings sufficient to meet the then-current criteria of each of the Rating Agencies to become co-obligor or guarantor in respect of its obligations under the Interest Rate Swaps (such guarantee to be provided in accordance with the then-current guarantee criteria of each of the Rating Agencies), or taking such other action as it may agree with the relevant Rating Agency. A failure to take such steps within the periods set out in the Interest Rate Swap Agreement may, subject to certain conditions, allow the Issuer to terminate the Interest Rate Swap Agreement.

The Interest Rate Swap Agreement may also be terminated in certain other circumstances, together with any other events of default and termination events set out in the Interest Rate Swap Agreement (each referred to as an "**Interest Rate Swap Early Termination Event**"), which may include:

- at the option of any party to the Interest Rate Swap Agreement, if there is a failure by the other party to make timely payments of any amounts due under the Interest Rate Swap Agreement; and
- upon the occurrence of the insolvency of the Interest Rate Swap Provider or any guarantor of the Interest Rate Swap Provider's obligations, or the merger of the Interest Rate Swap Provider without an assumption of its obligations under the Interest Rate Swap Agreement.

Upon the termination of an Interest Rate Swap pursuant to an Interest Rate Swap Early Termination Event, the Issuer or the Interest Rate Swap Provider may be liable to make a termination payment to the other in accordance with the provisions of the Interest Rate Swap Agreement. The amount of this termination payment will be calculated and made in Euro. Any termination payment made by the Interest Rate Swap Provider to the Issuer in respect of an Interest Rate Swap will first be used (prior to the occurrence of an Issuer Event) to pay a replacement Interest Rate Swap Provider to enter into a replacement Interest Rate Swap with the Issuer, unless a replacement Interest Rate Swap has already been entered into on behalf of the Issuer. Any premium received by the Issuer from a replacement Interest Rate Swap Provider in respect of a replacement Interest Rate Swap will first be used to make any termination payment due and payable by the Issuer with respect to the previous Interest Rate Swap, unless such termination payment has already been made on behalf of the Issuer. Any tax credits received by the Issuer in respect of an Interest Rate Swap will first be used to reimburse the relevant Interest Rate Swap Provider for any gross-up in respect of any withholding or deduction for or on account of any present or future taxes, duties, assessments or governmental charges of whatever nature (and wherever imposed) made under the relevant Interest Rate Swap.

If a withholding or deduction for or on account of taxes is imposed on payments made by the Interest Rate Swap Provider to the Issuer under the Interest Rate Swaps, the Interest Rate Swap Provider shall

always be obliged to gross up those payments so that the amount received by the Issuer is equal to the amount which would have been received in the absence of such withholding or deduction. If a withholding or deduction for or on account of taxes is imposed on payments made by the Issuer to the Interest Rate Swap Provider under the Interest Rate Swaps, the Issuer shall not be obliged to gross up those payments.

Any tax credits or Swap Collateral Excluded Amounts will be paid to the Interest Rate Swap Provider directly and not via the Priorities of Payments.

The Interest Rate Swap Provider may transfer all its interest and obligations in and under the relevant Interest Rate Swap Agreement to a transferee with minimum ratings in line with the criteria of by the Rating Agencies, without any prior written consent of the Trustee, subject to certain conditions. If the Issuer is required to sell Selected Loans in the Cover Pool following the occurrence of an Issuer Event then, to the extent that such Selected Loans include Fixed Rate Loans, the Issuer may either:

- (a) require that the Interest Rate Swaps in connection with such Selected Loans partially terminate to the extent that such Selected Loans include Fixed Rate Loans and any breakage costs payable by or to the Issuer in connection with such termination will, following the occurrence of an Issuer Event, be taken into account in calculating the Cover Pool Payment Date for the sale of the Selected Loans; or
- (b) request that the Interest Rate Swaps in connection with such Selected Loans be partially novated to the purchaser of such Fixed Rate Loans to the extent that such Selected Loans

include Fixed Rate Loans, such that each purchaser of Selected Loans will thereby become party to a separate interest rate swap transaction with the Interest Rate Swap Provider.

Law and Jurisdiction

Each Interest Rate Swap Agreement (and each Interest Rate Swap thereunder) is governed by English law.

Covered Bond Swap Agreements

The Issuer may enter into one or more covered bond swap transactions with one or more Covered Bond Swap Providers and the Trustee in respect of each Series of Covered Bonds (each such transaction a "**Covered Bond Swap**"). Each Covered Bond Swap may be either a Forward Starting Covered Bond Swap or a Non-Forward Starting Covered Bond Swap and each will constitute the sole Transaction under a single "**Covered Bond Swap Agreement**" (such Covered Bond Swap Agreements, together, the "**Covered Bond Swap Agreements**").

Each Forward Starting Covered Bond Swap will provide a hedge (after the occurrence of an Issuer Event) against certain interest rate, currency and/or other risks in respect of amounts received by the

Issuer in respect of the Loans and any relevant Interest Rate Swaps and amounts payable by the Issuer in respect of the Covered Bonds ("**Forward Starting Covered Bond Swap**").

Each Non-Forward Starting Covered Bond Swap will provide a hedge against certain interest rate, currency and/or other risks in respect of amounts received by the Issuer in respect of the Loans and any relevant Interest Rate Swaps and amounts payable by the Issuer in respect of the Covered Bonds ("**Non-Forward Starting Covered Bond Swap**").

Where required to hedge such risks, there may be one (or more) Covered Bond Swap Agreement(s) and Covered Bond Swap(s) in relation to each Series or Tranche, as applicable, of Covered Bonds (such Covered Bond Swap Agreements, together, the "**Covered Bond Swap Agreements**").

Under the Forward Starting Covered Bond Swaps, the Covered Bond Swap Provider will pay to the Issuer on each Interest Payment Date, after the occurrence of an Issuer Event, an amount equal to the relevant portion of the amounts that are payable by the Issuer in respect of interest and principal payable in respect of the relevant Series or Tranche of Covered Bonds. In return, the Issuer (or the Servicer on its behalf) will periodically pay to the Covered Bond Swap Provider an amount in Euro calculated by reference to the relevant Euro rate plus a spread and, where relevant, the Euro Equivalent of the relevant portion of any principal due to be repaid in respect of the relevant Series or Tranche of Covered Bonds.

Under the Non-Forward Starting Covered Bond Swaps on the relevant Issue Date, the Issuer (or the Servicer on its behalf) will, if the Covered Bonds are denominated in a currency other than Euro, pay to the Covered Bond Swap Provider an amount equal to the relevant portion of the amount received by the Issuer in respect of the aggregate nominal amount of such Series or Tranche, as applicable, of Covered Bonds and in return the Covered Bond Swap Provider will pay to the Issuer the Euro Equivalent of the first-mentioned amount. Thereafter, and where the Covered Bonds are denominated in Euro, the Covered Bond Swap Provider will pay to the Issuer on each Interest Payment Date an amount equal to the relevant portion of the amounts that are payable by the Issuer in respect of interest and principal payable under the relevant Series or Tranche of Covered Bonds. In return, the Issuer (or the Servicer on its behalf) will periodically pay to the Covered Bond Swap Provider an amount in Euros calculated by reference to the relevant Interest Rate plus a spread and, where relevant, the Euro Equivalent of the relevant portion of any principal due to be repaid in respect of the relevant Series or Tranche of Covered Bonds.

Under the terms of each Forward Starting Covered Bond Swap and each Non-Forward Starting Covered Bond Swap, in the event that the relevant rating of the Covered Bond Swap Provider or any guarantor of the Covered Bond Swap Provider's obligations is downgraded by a Rating Agency below the rating specified in the relevant Covered Bond Swap Agreement (in accordance with the requirements of the Rating Agencies), the Covered Bond Swap Provider may, in accordance with the relevant Covered Bond Swap Agreement, be required to take certain remedial measures which may include providing collateral for its obligations under the Covered Bond Swap, arranging for its obligations under the Covered Bond Swap to be transferred to an entity with the ratings required by the relevant Rating Agency, procuring

another entity with the ratings required by the relevant Rating Agency to become co-obligor or guarantor in respect of its obligations under the Covered Bond Swap Agreement (such guarantee to be provided in accordance with the then-current guarantee criteria of each of the Rating Agencies), or taking such other action as it may agree with the relevant Rating Agency. In addition, if the net exposure of the Issuer against the Covered Bond Swap Provider under the relevant Covered Bond Swap exceeds the threshold specified in the relevant Covered Bond Swap Agreement, the Covered Bond Swap Provider may be required to provide collateral for its obligations. A failure to take such steps within the time periods set out in the Covered Bond Swap Agreement may, subject to certain conditions, allow the Issuer to terminate the Covered Bond Swap.

A Covered Bond Swap Agreement may also be terminated in certain other circumstances, together with any other events of default and termination events set out in the relevant Covered Bond Swap Agreement (each referred to as a "**Covered Bond Swap Early Termination Event**"), which may include:

- (a) at the option of any party to the Covered Bond Swap Agreement, if there is a failure by the other party to make timely payments of any amounts due under such Covered Bond Swap Agreement; and
- (b) upon the occurrence of an insolvency of the Covered Bond Swap Provider or any guarantor of the Covered Bond Swap Provider's obligations, or the merger of the Covered Bond Swap Provider without an assumption of its obligations under the relevant Covered Bond Swap Agreement.

Upon the termination of a Covered Bond Swap, the Issuer or the Covered Bond Swap Provider may be liable to make a termination payment to the other in accordance with the provisions of the relevant Covered Bond Swap Agreement. The amount of this termination payment will be calculated and made in Euro. Any termination payment made by the Covered Bond Swap Provider to the Issuer in respect of a Covered Bond Swap will first be used (prior to the occurrence of an Issuer Event) to pay a replacement Covered Bond Swap Provider to enter into a replacement Covered Bond Swap with the Issuer, unless a replacement Covered Bond Swap has already been entered into on behalf of the Issuer. Any premium received by the Issuer from a replacement Covered Bond Swap Provider in respect of a replacement Covered Bond Swap will first be used to make any termination payment due and payable by the Issuer with respect to the previous Covered Bond Swap, unless such termination payment has already been made on behalf of the Issuer. Any tax credits received by the Issuer in respect of a Covered Bond Swap will first be used to reimburse the relevant Covered Bond Swap Provider for any gross-up in respect of any withholding or deduction for or on account of any present or future taxes. Duties, assessments or governmental charges of whatever nature (and wherever imposed) made under the relevant Covered Bond Swap.

Any tax credits or Swap Collateral Excluded Amounts will be paid to the Covered Bond Swap Provider directly and not via the Priorities of Payments.

If withholding or deduction for or on account of taxes is imposed on payments made by the Covered Bond Swap Provider to the Issuer under a Covered Bond Swap, the Covered Bond Swap Provider shall always be obliged to gross up those payments so that the amount received by the Issuer is equal to the amount which would have been received in the absence of such withholding or deduction. If withholding or deduction for or on account of taxes is imposed on payments made by the Issuer to the Covered Bond Swap Provider under a Covered Bond Swap, the Issuer shall not be obliged to gross up those payments.

The Covered Bond Swap Provider may transfer all its interest and obligations in and under the relevant Covered Bond Swap Agreement to a transferee with minimum ratings in line with the criteria of each of the Rating Agencies, without any prior written consent of the Trustee, subject to certain conditions.

In the event that the Covered Bonds are redeemed and/or cancelled in accordance with the Terms and Conditions, the Covered Bond Swap(s) in connection with such Covered Bonds will terminate or partially terminate, as the case may be. Any breakage costs payable by or to the Issuer in connection with such termination may be taken into account in calculating:

- (a) the Adjusted Required Redemption Amount for the sale of Selected Loans; and
- (b) the purchase price to be paid for any Covered Bonds purchased by the Issuer in accordance with Condition 7.7 (*Purchases*).

Law and Jurisdiction

Each Covered Bond Swap Agreement (and each Covered Bond Swap thereunder) is governed by **English law**.

FX Swap Agreements

Some of the Loan Assets in the Cover Pool may be denominated in a currency other than euro and will either pay a variable rate of interest for a period of time that may either be linked to a specified interest rate, or a rate that tracks a specific base rate or will pay a fixed rate of interest for a period of time. As noted above, the Issuer will make payments to each Covered Bond Swap Provider in euro. To provide a hedge against the possible variance between:

- (a) the currency of the relevant Loan Assets and the rates of interest payable on such Loan Assets in the Cover Pool; and
- (b) the euro payments to be made by the Issuer under the Covered Bond Swaps,

the Issuer, the provider of the FX swap (each such provider, an "**FX Swap Provider**") and the Trustee may enter into one or more FX swap transactions in respect of the Loans in the Cover Pool which are denominated in a currency other than euro under one or more FX swap agreements (each, an "**FX Swap Agreement**" and each such transaction an "**FX Swap**").

Under the terms of each FX Swap, in the event that the relevant rating of the FX Swap Provider or any guarantor of the FX Swap Provider's obligations is downgraded by a Rating Agency below the rating specified in the FX Swap Agreement (in accordance with the requirements of the Rating Agency) for the FX Swap Provider or any guarantor of the FX Swap Provider's obligations, the FX Swap Provider may, in accordance with the FX Swap Agreement, be required to take certain remedial measures which may include providing collateral for its obligations in respect of the FX Swaps, arranging for its obligations under the FX Swaps to be transferred to an entity with ratings required by the relevant Rating Agency, procuring another entity with the ratings required by the relevant Rating Agency to become co-obligor or guarantor in respect of its obligations under the FX Swaps (such guarantee to be provided in accordance with then current guarantee criteria of the Rating Agency), or taking such other action as it may agree with the relevant Rating Agency. A failure to take such steps within the periods set out in the FX Swap Agreement may, subject to certain conditions, allow the Issuer to terminate the FX Swap Agreement.

The FX Swap Agreement may also be terminated in certain other circumstances, together with any other events of default and termination events set out in the FX Swap Agreement (each referred to as an "**FX Swap Early Termination Event**"), which may include:

- at the option of a party to the FX Swap Agreement, if there is a failure by the other party to make timely payments of any amounts due under the FX Swap Agreement; and
- at the option of the Issuer, upon the occurrence of the insolvency of the FX Swap Provider or any guarantor of the FX Swap Provider's obligations, or the merger of the FX Swap Provider without an assumption of its obligations under the FX Swap Agreement.

Upon the termination of a FX Swap pursuant to an FX Swap Early Termination Event, the Issuer or the FX Swap Provider may be liable to make a termination payment to the other in accordance with the provisions of the FX Swap Agreement. The amount of this termination payment will be calculated and made in euro. Any termination payment made by the FX Swap Provider to the Issuer in respect of an FX Swap will first be used (prior to the occurrence of an Issuer Event) to pay a replacement FX Swap Provider to enter into a replacement FX Swap with the Issuer, unless a replacement FX Swap has already been entered into on behalf of the Issuer. Any premium received by the Issuer from a replacement FX Swap Provider in respect of a replacement FX Swap will first be used to make any termination payment due and payable by the Issuer with respect to the previous FX Swap, unless such termination payment has already been made on behalf of the Issuer. Any tax credits received by the Issuer in respect of a FX Swap will first be used to reimburse the relevant FX Swap Provider for any gross-up in respect of any withholding or deduction for or on account of any present or future taxes, duties, assessments or governmental charges of whatever nature (and wherever imposed) made under the relevant FX Swap.

If a withholding or deduction for or on account of taxes is imposed on payments made by the FX Swap Provider to the Issuer under the FX Swaps, the FX Swap Provider shall always be obliged to gross-up

those payments so that the amount received by the Issuer is equal to the amount which would have been received in the absence of such withholding or deduction. If a withholding or deduction for or on account of taxes is imposed on payments made by the Issuer to the FX Swap Provider under the FX Swaps, the Issuer shall not be obliged to gross-up those payments.

The FX Swap Provider may transfer all its interest and obligations in and under the relevant FX Swap Agreement to a transferee with the minimum ratings in line with the criteria of the Rating Agency, without any prior written consent of the Trustee, subject to certain conditions.

Any tax credits or Swap Collateral Excluded Amounts will be paid to the FX Swap Provider directly and not via the Priorities of Payments.

The FX Swap Provider may transfer all its interest and obligations in and under the relevant FX Swap Agreement to a transferee with minimum ratings in line with the criteria of the Rating Agency, without any prior written consent of the Trustee, subject to certain conditions. The terms of an FX Swap Agreement may provide that if the Issuer is required to sell Selected Loans in the Cover Pool following the occurrence of an Issuer Event then, to the extent that such Selected Loans include Fixed Rate Loans, the Issuer may:

- (a) require that the FX Swaps in connection with such Selected Loans partially terminate to the extent that such Selected Loans include Fixed Rate Loans and any breakage costs payable by or to the Issuer in connection with such termination will, following the occurrence of an Issuer Event, be taken into account in calculating the Adjusted Required Redemption Amount for the sale of the Selected Loans; or
- (b) request that the FX Swaps in connection with such Selected Loans be partially novated to the purchaser of such Fixed Rate Loans to the extent that such Selected Loans include Fixed Rate Loans, such that each purchaser of Selected Loans will thereby become party to a separate FX Swap transaction with the FX Swap Provider.

Law and Jurisdiction

Each FX Swap Agreement (and each FX Swap thereunder) is governed by English law.

Bank Account Agreement

Pursuant to the terms of the Bank Account Agreement originally entered into on the Programme Closing Date between the Account Bank, the Issuer, the Servicer and the Trustee, the Servicer will maintain with the Account Bank the Bank Accounts, which will be operated in accordance with the Servicing and Cash Management Deed and the Deed of Charge.

If the long-term issuer default rating of the Account Bank falls below BBB- by S&P (or such other ratings that may be agreed between the parties to the Bank Account Agreement and the relevant Rating Agency

from time to time), then unless the Account Bank within 30 calendar days of such occurrence obtains an unconditional and unlimited guarantee of its obligations under the Bank Account Agreement from a financial institution having the long-term issuer default ratings at least equal to BBB- by S&P (and such Rating Agency has been notified), then:

- the Bank Account Agreement will be terminated in respect of the Account Bank provided that no such termination in accordance with the Bank Account Agreement shall occur later than 60 days or earlier than 45 days following the Account Bank ceasing to be an Eligible Institution; and
- the Bank Accounts will be closed and all amounts standing to the credit thereof shall be transferred to accounts held with a bank with a long-term issuer default rating of BBB- by S&P.

The Account Bank shall be responsible for its own costs (and, for the avoidance of doubt, shall not be responsible for the costs of any other party) arising from any remedial action taken by the Account Bank following the circumstances as set out in the Bank Account Agreement and the Servicing and Cash Management Deed.

The Bank Account Agreement is governed by English law.

Issuer-ICSDs Agreement

The Issuer will enter into an Issuer-ICSDs Agreement with Euroclear Bank S.A./N.V. and Clearstream Banking SA (the "**ICSDs**") in respect of any Covered Bonds issued in NGCB form. The Issuer-ICSDs Agreement provides that the ICSDs will, in respect of any such NGCBs, maintain their respective portion of the issue outstanding amount through their records.

The Issuer-ICSDs Agreement is governed by English law.

TAXATION

Greece

The following summary describes certain Greek taxation consequences of the purchase, ownership and disposal of Covered Bonds, is of a general nature and is based on the provisions of tax laws currently in force in Greece. The summary below does not constitute a complete analysis of all the possible tax considerations that may be relevant to your decision to purchase, own or dispose of the Covered Bonds and therefore, potential investors should consult their own tax advisers as to the tax consequences of such purchase, ownership and disposal. This summary is based on current Greek tax legislation and administrative practice of the Greek tax Authorities, without taking into account any developments or amendments thereof after the date hereof whether or not such developments or amendments have retroactive effect.

Income Tax

Pursuant to article 69 par. 9 Greek Law 3746/2009, as amended, in conjunction with article 33 of the Covered Bond Law, interest payments made as of January 1 2020 in respect of covered bonds issued under the Covered Bond Law, have the same tax treatment with interest in respect of bonds issued by the Hellenic Republic. Further to this, according to article 37 par. 2 of Greek Law 4172/2013 (the "Income Tax Code") in conjunction, where relevant, with article 47 par. 5 of the Income Tax Code as amended by article 52 par. 1 of Greek Law 5045/2023 interest from bond loans issued by the Hellenic Republic earned by individuals as well as, as of 29 July 2023, legal persons and legal entities is exempt from income tax. The provisions of article 52 par. 1 of Greek Law 5045/2023 are however stated as non-applicable to credit institutions as defined in EU Regulation 575/2013.

Based on the above, pursuant to the Income Tax Code, as in force, interest payments made to Covered Bondholders, provided that such Covered Bondholders are individuals will not be subject to Greek withholding income tax. Interest payments made to Covered Bondholders that are legal persons or legal entities who neither reside nor maintain a permanent establishment in Greece for Greek law tax purposes to which interest on the Covered Bonds would be attributable, will not be subject to withholding tax, except if such payments are made to credit institutions as defined in EU Regulation 575/2013 by a paying agent or other similar agent who either resides or maintains a permanent establishment in Greece for Greek tax law purposes in which case they should be subject to withholding tax at a flat rate of 15 per cent, subject to any more favourable provisions under any applicable tax treaty for the avoidance of double taxation entered into between Greece and the jurisdiction in which such a Covered Bondholder is a tax resident. Interest payments made to Covered Bondholders that are legal persons or legal entities who either reside or maintain a permanent establishment in Greece for Greek law tax purposes to which interest on the Covered Bonds would be attributable, except credit institutions as defined in EU Regulation 575/2013, should not be subject to income withholding tax. Interest payments made to Covered Bondholders that are credit institutions as defined in EU Regulation 575/2013 who either reside or maintain a permanent establishment in Greece for Greek law tax purposes to which

interest on the Covered Bonds would be attributable, when made by a paying agent or other similar agent who either resides or maintains a permanent establishment in Greece for Greek tax law purposes should be subject to withholding tax at a flat rate of 15 per cent. The overall income tax position of Covered Bondholders in respect of interest on the Covered Bonds would depend on their particular circumstances and should be reviewed on a case-by-case basis.

Capital gains realised from the transfer of Covered Bonds

Pursuant to the provisions of article 14 of Greek law 3156/2003 that are applicable to Covered Bonds by virtue of Article 3(2) of the Covered Bond Law, capital gains realised by Covered Bondholders from the transfer of Covered Bonds are not subject to taxation in Greece. This has been explicitly confirmed through Interpretative Circular No. 1032/2015 (item (iii) of paragraph 2). If the capital gains' beneficiaries are Greek legal persons or legal entities, or foreign legal persons or legal entities which have a permanent establishment in Greece to which the capital gains are attributable, no exemption is granted but the corporate taxation is under conditions deferred up to their distribution to the shareholders or capitalization. Upon capitalisation or distribution, they will be taxed at the corporate income tax rate applicable at the time of capitalisation or distribution (at the legal person/legal entity level).

Value Added Tax

No value added tax is payable upon disposal of the Covered Bonds (pursuant to Article 22(1)(ka) of Greek Law 2859/2000).

Death Duties and Taxation on Gifts

The Covered Bonds are subject to Greek inheritance tax if the deceased holder of Covered Bonds had been resident of Greece or a Greek national.

The rates of inheritance tax vary from 0 per cent. to 40 per cent., depending on the relationship between the heir and the deceased.

A gift of Covered Bonds is subject to Greek tax if the holder of the Covered Bonds (donor) is a Greek national or if the recipient thereof is a Greek national or resident.

The rates of gift tax vary from 0 per cent. to 40 per cent. depending on the relationship between the donor and the recipient.

Exemptions from Greek inheritance tax and Greek gift tax may apply in relation to Greek nationals residing outside Greece for a period of at least 20 or 10 consecutive years under certain conditions, as the case may be.

Stamp Duty

Pursuant to Article 14 of Greek Law 3156/2003 in conjunction with Article 3(2) of the Covered Bond Law, the issuance or transfer of Covered Bonds is exempt from Greek stamp duty.

Foreign Account Tax Compliance Act

Pursuant to certain provisions of the U.S. Internal Revenue Code of 1986, as amended, commonly known as **FATCA**, a **foreign financial institution** (as defined by FATCA) may be required to withhold on certain payments it makes ("**foreign passthru payments**") to persons that fail to meet certain certification, reporting, or related requirements. The Issuer is a foreign financial institution for these purposes. A number of jurisdictions (including Greece) have entered into, or have agreed in substance to, intergovernmental agreements with the United States to implement FATCA ("**IGAs**"), which modify the way in which FATCA applies in their jurisdictions. Under the provisions of IGAs as currently in effect, a foreign financial institution in an IGA jurisdiction would generally not be required to withhold under FATCA or an IGA from payments that it makes. Certain aspects of the application of FATCA provisions and IGAs to instruments such as Covered Bonds, including whether withholding would ever be required pursuant to FATCA or an IGA with respect to payments on instruments such as the Covered Bonds, are uncertain and may be subject to change. Even if withholding would be required pursuant to FATCA or an IGA with respect to payments on instruments such as Covered Bonds, such withholding would not apply to foreign passthru payments prior to 1 January 2019 and Covered Bonds characterised as debt (or which are not otherwise characterised as equity and have a fixed term) for U.S. federal income tax purposes that are issued on or prior to the date that is six months after the date on which final regulations defining foreign passthru payments are filed with the U.S. Federal Register generally would be grandfathered for purposes of FATCA withholding unless materially modified after such date (including by reason of a substitution of the Issuer). However, if additional Covered Bonds (as described under "*Terms and Conditions of the Covered Bonds – Further Issues*") that are not distinguishable from previously issued Covered Bonds are issued after the expiration of the grandfathering period and are subject to withholding under FATCA, then withholding agents may treat all Covered Bonds, including the Covered Bonds offered prior to the expiration of the grandfathering period, as subject to withholding under FATCA. Holders should consult their own tax advisers regarding how these rules may apply to their investment in the Covered Bonds. In the event any withholding would be required pursuant to FATCA or an IGA with respect to payments on the Covered Bonds, no person will be required to pay additional amounts as a result of withholding.

Luxembourg Taxation

The following information is of a general nature only and is included herein solely for information purposes. It is based on the laws presently in force in Luxembourg, though it is not intended to be, nor should it be construed to be, legal or tax advice. The information contained within this section is limited to Luxembourg withholding tax issues and prospective investors in the Covered Bonds should therefore

consult their own professional advisers as to the effects of state, local or foreign laws, including Luxembourg tax law, to which they may be subject.

Please be aware that the residence concept used under the respective headings below applies for Luxembourg income tax assessment purposes only. Any reference in the present section to a withholding tax or a tax of a similar, or to any other concepts, refers to Luxembourg tax law and/or concepts only.

Withholding Tax

(a) *Non-resident holders of Covered Bonds*

Under Luxembourg general tax laws currently in force, there is no withholding tax on payments of principal, premium or interest made to non-resident holders of Covered Bonds, nor on accrued but unpaid interest in respect of the Covered Bonds, nor is any Luxembourg withholding tax payable upon redemption or repurchase of the Covered Bonds held by non-resident holders of Covered Bonds.

(b) *Resident holders of Covered Bonds*

Under Luxembourg general tax laws currently in force and subject to the law of 23 December 2005 (as amended) (the "**Relibi Law**") mentioned below, there is no withholding tax on payments of principal, premium or interest made to Luxembourg resident holders of Covered Bonds, nor on accrued but unpaid interest in respect of Covered Bonds, nor is any Luxembourg withholding tax payable upon redemption or repurchase of Covered Bonds held by Luxembourg resident holders of Covered Bonds.

Under the Relibi Law payments of interest or similar income made or ascribed by a paying agent established in Luxembourg to an individual beneficial owner who is a resident of Luxembourg will be subject to a withholding tax of 20 per cent. Such withholding tax will be in full discharge of income tax if the beneficial owner is an individual acting in the course of the management of his/her private wealth. Responsibility for the withholding of the tax will be assumed by the paying agent. Accordingly, payments of interest under the Covered Bonds coming within the scope of the Relibi Law will be subject to a withholding tax at a rate of 20 per cent.

SUBSCRIPTION AND SALE

Covered Bonds may be issued from time to time by the Issuer to any of the Dealer(s). The arrangements under which Covered Bonds may from time to time be agreed to be issued by the Issuer to, and subscribed by, the Dealer(s) are set out in a Programme Agreement dated 15 October 2018 (such Programme Agreement as may be amended and/or supplemented and or restated from time to time, (the "**Programme Agreement**") and made between the Issuer and the Dealer(s). Any such agreement will, *inter alia*, make provision for the form and terms and conditions of the relevant Covered Bonds, the price at which such Covered Bonds will be subscribed by the Dealer(s) and the commissions or other agreed deductibles (if any) payable or allowable by the Issuer in respect of such subscription. The Programme Agreement makes provision for the resignation or termination of appointment of existing Dealers and for the appointment of additional or other Dealers either generally in respect of the Programme or in relation to a particular Tranche of Covered Bonds. The Programme Agreement will be supplemented on or around the date of each issuance by Subscription Agreement, which will set out, *inter alia*, the relevant underwriting commitments.

United States

The Covered Bonds have not been and will not be registered under the Securities Act and the Covered Bonds may not be offered or sold within the United States or to, or for the account or benefit of, U.S. persons except in certain transactions exempt from, or in transactions not subject to, the registration requirements of the Securities Act.

The Covered Bonds in bearer form are subject to U.S. tax law requirements and may not be offered, sold or delivered within the United States or its possessions or to U.S. persons, except in certain transactions permitted by U.S. Treasury regulations. Terms used in this paragraph have the meanings given to them by the United States Internal Revenue Code of 1986 and U.S. Treasury regulations promulgated thereunder. The applicable Final Terms will identify whether C Rules or D Rules apply or whether TEFRA is not applicable.

In connection with any Covered Bonds which are offered or sold outside the United States in reliance on Regulation S ("**Regulation S Covered Bonds**"), each Dealer has represented and agreed, and each further Dealer appointed under the Programme will be required to represent and agree that, it has not offered and sold, and will not offer, sell or deliver such Regulation S Covered Bonds (i) as part of its distribution at any time or (ii) otherwise until 40 days after the completion of the distribution of that Series of Covered Bonds of which such Covered Bonds or a part, as determined and certified by the relevant Dealer(s), in the case of a non-syndicated issue, as Lead Manager, in the case of a syndicated issue, and except in either case in accordance with Regulation S under the Securities Act. Each Dealer has further agreed and each further Dealer appointed under the Programme will be required to agree, that it will send to each dealer to which it sells Regulation S Covered Bond during the distribution compliance period a confirmation or other notice setting forth the restrictions on offers and sales of Regulation S

within the United States or to, or for the account or benefit of, U.S. persons. Terms used in this Paragraph have the meanings given to them by Regulation S under the Securities Act.

Until 40 days after the commencement of the offering of any Series of Covered Bonds, an offer or sale of such Covered Bonds within the United States by any dealer (whether or not participating in the offering) may violate the registration requirements of the Securities Act if such offer or sale is made otherwise than in accordance with an available exemption from registration under the Securities Act.

Prohibition of sales to European Economic Area Retail Investors

Unless the applicable Final Terms in respect of any Covered Bonds specifies "*Prohibition of Sales to EEA Retail Investors*" as "Not Applicable", each Dealer has represented and agreed, and each further Dealer appointed under the Programme will be required to represent and agree, that it has not offered, sold or otherwise made available and will not offer, sell or otherwise make available any Covered Bonds which are the subject of the offering contemplated by this Base Prospectus as completed by the Final Terms in relation thereto to any retail investor in the European Economic Area. For the purposes of this provision:

1. the expression "retail investor" means a person who is one (or more) of the following:
2. a retail client as defined in point (11) of Article 4(1) of MiFID II;
3. a customer within the meaning of Directive (EU) 2016/97, where that customer would not qualify as a professional client as defined in point (10) of Article 4(1) of MiFID II; or
4. not a qualified investor as defined in the Prospectus Regulation; and
5. the expression an "offer" includes the communication in any form and by any means of sufficient information on the terms of the offer and the Covered Bonds to be offered so as to enable an investor to decide to purchase or subscribe for the Covered Bonds.

If the applicable Final Terms in respect of any Covered Bonds specifies "*Prohibition of Sales to EEA Investors*") as "Not Applicable", in relation to each Member State of the EEA, each Dealer has represented and agreed, and each further Dealer appointed under the Programme will be required to represent and agree, that it has not made and will not make an offer of Covered Bonds which are the subject of the offering contemplated by this Base Prospectus as completed by the Final Terms in relation thereto to the public in that Member State except that it may make an offer of such Covered Bonds to the public in that Member State:

1. at any time to any legal entity which is a qualified investor as defined in the Prospectus Regulation;
2. at any time to fewer than 150 natural or legal persons (other than qualified investors as defined in the Prospectus Regulation) subject to obtaining the prior consent of the relevant

Dealer or Dealers nominated by the Issuer for any such offer; or

3. at any time in any other circumstances falling within Article 1(4) of the Prospectus Regulation, provided that no such offer of Covered Bonds referred to in (a) to (c) above shall require the Issuer or any Dealer to publish a prospectus pursuant to Article 3 of the Prospectus Regulation or supplement a prospectus pursuant to Article 23 of the Prospectus Regulation.

For the purposes of this provision, the expression an "offer of Covered Bonds to the public" in relation to any Covered Bonds in any Member State means the communication in any form and by any means of sufficient information on the terms of the offer and the Covered Bonds to be offered so as to enable an investor to decide to purchase or subscribe for the Covered Bonds.

United Kingdom

Prohibition of sales to UK retail investors

Unless the Final Terms in respect of any Covered Bonds specifies "*Prohibition of Sales to UK Retail Investors*" as "Not Applicable", each Dealer has represented and agreed, and each further Dealer appointed under the Programme will be required to represent and agree, that it has not offered, sold or otherwise made available and will not offer, sell or otherwise make available any Covered Bonds which are the subject of the offering contemplated by this Base Prospectus as completed by the Final Terms in relation thereto to any retail investor in the UK. For the purposes of this provision:

- (a) the expression "retail investor" means a person who is one (or more) of the following:
1. a retail client, as defined in point (8) of Article 2 of Regulation (EU) No 2017/565 as it forms part of UK domestic law by virtue of the European Union (Withdrawal) Act 2018 (EUWA); or
 2. customer within the meaning of the provisions of the FSMA and any rules or regulations made under the FSMA to implement Directive (EU) 2016/97, where that customer would not qualify as a professional client, as defined in point (8) of Article 2(1) of Regulation (EU) No 600/2014 as it forms part of UK domestic law by virtue of the EUWA; or
 3. not a qualified investor as defined in Article 2 of the UK Prospectus Regulation; and
 4. the expression an "offer" includes the communication in any form and by any means of sufficient information on the terms of the offer and the Covered Bonds to be offered so as to enable an investor to decide to purchase or subscribe for the Covered Bonds.

If the Final Terms in respect of any Covered Bonds specifies "*Prohibition of Sales to UK Retail Investors*" as "Not Applicable", each Dealer has represented and agreed, and each further Dealer appointed under the Programme will be required to represent and agree, that it has not made and will not make an offer

of Covered Bonds which are the subject of the offering contemplated by this Base Prospectus as completed by the Final Terms in relation thereto to the public in the UK except that it may make an offer of such Covered Bonds to the public in the UK:

- a) at any time to any legal entity which is a qualified investor as defined in Article 2 of the UK Prospectus Regulation;
- b) at any time to fewer than 150 natural or legal persons (other than qualified investors as defined in Article 2 of the UK Prospectus Regulation) in the UK subject to obtaining the prior consent of the relevant Dealer or Dealers nominated by the Issuer for any such offer; or
- c) at any time in any other circumstances falling within Section 86 of the FSMA,

provided that no such offer of Covered Bonds referred to in (a) to (c) above shall require the Issuer or any Dealer to publish a prospectus pursuant to Section 85 of the FSMA or supplement a prospectus pursuant to Article 23 of the UK Prospectus Regulation.

For the purposes of this provision, the expression "an offer of Covered Bonds to the public" in relation to any Covered Bonds means the communication in any form and by any means of sufficient information on the terms of the offer and the Covered Bonds to be offered so as to enable an investor to decide to purchase or subscribe for the Covered Bonds.

Other regulatory restrictions

Each Dealer has represented and agreed, and each further Dealer appointed under the Programme will be required to represent and agree, that:

- a) in relation to any Covered Bonds which have a maturity of less than one year, (i) it is a person whose ordinary activities involve it in acquiring, holding, managing or disposing of investments (as principal or agent) for the purposes of its business and (ii) it has not offered or sold and will not offer or sell any Covered Bonds other than to:
- b) persons whose ordinary activities involve them in acquiring, holding, managing or disposing of investments (as principal or as agent) for the purposes of their businesses; or
- c) who it is reasonable to expect will acquire, hold, manage or dispose of investments (as principal or agent) for the purposes of their businesses where the issue of the Covered Bonds would otherwise constitute a contravention of Section 19 of the FSMA by the Issuer;
- d) it has only communicated or caused to be communicated and will only communicate or cause to be communicated an invitation or inducement to engage in investment activity (within the meaning of Section 21 of the FSMA) received by it in connection with the issue or sale of any Covered Bonds in circumstances in which Section 21(1) of the FSMA does not apply to the Issuer; and

- e) it has complied and will comply with all applicable provisions of the FSMA with respect to anything done by it in relation to any Covered Bonds in, from or otherwise involving the United Kingdom.

Greece

Each Dealer has represented and agreed, and each further Dealer appointed under the Programme will be required to represent and agree, that it has complied and will comply with (i) the provisions described above in this section under "*Prohibition of sales to European Economic Area Retail Investors*"; (ii) all applicable provisions of Greek Law 4706/2020 that implemented in Greece certain provisions of the Prospectus Regulation; and (iii) all applicable provisions of Greek Law 4514/2018, which has transposed into Greek law MiFID II, with respect to anything done in relation to any offering of any Covered Bonds or advertisement, notice, statement or other action involving Covered Bonds in, from or otherwise involving the Hellenic Republic.

Japan

The Covered Bonds have not been and will not be registered under the Financial Instruments and Exchange Act of Japan (Law No.25 of 1948, as amended; the "**FIEA**") and each Dealer represented and agreed, and each further Dealer appointed under the Programme will be required to represent and agree, that it has not directly or indirectly, offered or sold and will not directly or indirectly, offer or sell any Covered Bonds, in Japan or to, or for the benefit of, a resident of Japan (as defined under Item 5, Paragraph 1, Article 6 of the Foreign Exchange and Foreign Trade Act (Law No. 228 of 1949, as amended)), or to others for re-offering or resale, directly or indirectly, in Japan or to, or for the benefit of, a resident of Japan, except pursuant to an exemption from the registration requirements of, and otherwise in compliance with, the FIEA and any other applicable laws, regulations and ministerial guidelines of Japan.

The Grand Duchy of Luxembourg

In addition to the cases described in the European Economic Area selling restrictions in which the Dealer(s) can make an offer of Covered Bonds to the public in an EEA Member State (including the Grand Duchy of Luxembourg), the Dealer(s) can also make an offer of Covered Bonds to the public in the Grand Duchy of Luxembourg:

- a) at any time, to national and regional governments, central banks, international and supranational institutions (such as the International Monetary Fund, the ECB, the European Investment Bank) and other similar international organisations;
- b) at any time, to legal entities which are authorised or regulated to operate in the financial markets (including, credit institutions, investment firms, other authorised or regulated financial institutions, undertakings for collective investment and their management companies, pension and investment funds and their management companies, insurance undertakings and

commodity dealers) as well as entities not so authorised or regulated whose corporate purpose is solely to invest in securities; and

- c) at any time, to certain natural persons or small and medium sized enterprises (as defined in the Luxembourg Act dated 16 July, 2019 on prospectuses for securities implementing Regulation (EU) 2017/1129, (the "**Prospectus Regulation**") into Luxembourg law) recorded in the register of natural persons or small and medium sized enterprises considered as qualified investors as held by the Commission de Surveillance du Secteur Financier as competent authority in Luxembourg in accordance with the Prospectus Regulation.

General

- a) Each Dealer has agreed and each further Dealer appointed under the Programme will be required to agree that it will comply with (in the best of its knowledge and belief) all applicable securities laws and regulations in force in any jurisdiction in which it purchases, offers, sells or delivers Covered Bonds or possesses or distributes this Base Prospectus and will obtain any consent, approval or permission required by it for the purchase, offer, sale or delivery by it of Covered Bonds under the laws and regulations or directives in force in any jurisdiction to which it is subject or in which it makes such purchases, offers, sales or deliveries and neither the Issuer, the Trustee nor any of the other Dealers shall have any responsibility therefor.
- b) None of the Issuer, the Trustee and the Dealers represents that Covered Bonds may at any time lawfully be sold in compliance with any applicable registration or other requirements in any jurisdiction, or pursuant to any exemption available thereunder, or assumes any responsibility for facilitating such sale.

GENERAL INFORMATION

Listing and admission to trading

Application has been made to the Luxembourg Stock Exchange to approve this document as a base prospectus. Application has also been made to the Luxembourg Stock Exchange for the Covered Bonds issued under the Programme to be admitted to trading on the Luxembourg Stock Exchange's Euro MTF market and to be listed on the official list of the Luxembourg Stock Exchange. The Luxembourg Stock Exchange's Euro MTF market is not a regulated market for the purposes of the MiFID II.

Covered Bonds may also be issued pursuant to the Programme which will not be listed on the Luxembourg Stock Exchange or any other stock exchange or which will be listed on such stock exchange or market as the Issuer and the relevant Dealer(s) may agree.

Authorisations

The establishment, implementation and operation of the Programme and the issue of Covered Bonds have been duly confirmed and authorised by a resolution of the Board of Directors of the former Eurobank Ergasias S.A., dated 29 August 2018. Following the latter's demerger, the Issuer, which assumed by operation of Greek law all the assets and liabilities of the core banking operations of the former Eurobank Ergasias S.A., authorised on 20 March 2020 the operation of the Programme, and further resolved and authorised, on 29 September 2023 the issuance of Covered Bonds (up to a maximum nominal amount from time to time outstanding of €5 billion) and the update and/or amendment of the Programme and the relevant Covered Bond Series.

Litigation

Save as disclosed in note 42 on page 129 of the Issuer's 2022 Consolidated Financial Statements, neither Issuer nor any other member of its Group is involved in any governmental, legal or arbitration proceedings (including any proceedings which are pending or threatened of which the Issuer is aware) which the Issuer believes may have or which have had a significant effect on the financial position or profitability of the Issuer in the 12 months preceding the date of this Base Prospectus.

No significant change or no material adverse change

Save for the risks and uncertainties as disclosed in note 2 "Basis of preparation and principal accounting policies – Going concern considerations" of the 1H2023 Financial Statements, there has been no material adverse change in the prospects of Eurobank Holdings or the Group since 31 December 2022. There has been no significant change in their financial position, except for the buyback of all Eurobank Holdings issued shares held by the HFSF, which was completed on 9 October 2023, or financial performance since 30 June 2023. In particular, in respect of the buyback of Eurobank Holdings issued shares held by the HFSF, on 9 October 2023 Eurobank Holdings announced the acquisition of all its issued shares held by the HFSF, namely 52,080,673 common registered shares, at a price of €1.80 per

share and a total consideration of €93.7 million. Following the full disposal of the shares HFSF holds in Eurobank Holdings, Eurobank Holdings and Eurobank will no longer be subject to Law 3864/2010 including the special rights of the HFSF set out in such law.

Save for the risks and uncertainties, as disclosed in note 2 “Basis of preparation and principal accounting policies – Going concern considerations” of the Issuer’s 2022 Consolidated Financial Statements, there has been no material adverse change in the prospects of the Issuer and its subsidiaries (the “**Eurobank SA Group**”) since 31 December 2022. There has been no significant change in the financial position or financial performance of the Eurobank SA Group since 30 June 2023.

- (e) a copy of this Base Prospectus;

- (g) any future prospectuses, Final Terms (save that a Final Terms relating to a Covered Bond which is neither admitted to trading on a regulated market in the European Economic Area nor offered in the European Economic Area in circumstances where a prospectus is required to be published under the Prospectus Regulation will only be available for inspection by a holder of such Covered Bond and such holder must produce evidence satisfactory to the Issuer and the Principal Paying

Agent as to its holding of Covered Bonds and identity), information memoranda and supplements to this Base Prospectus and any other documents incorporated herein or therein by reference.

In addition, copies of this Base Prospectus, any supplement to the Base Prospectus, any documents incorporated by reference and each Final Terms relating to Covered Bonds which are admitted to trading on the Luxembourg Stock Exchange's Euro MTF and admitted to trading on the official list of the Luxembourg Stock Exchange will also be available for inspection free of charge from the internet site of the Luxembourg Stock Exchange, at www.luxse.com

Clearing Systems

The Covered Bonds have been accepted for clearance and settlement through Euroclear and Clearstream, Luxembourg (which are the entities in charge of keeping the records). The appropriate Common Code and ISIN for each Series of Covered Bonds allocated by Euroclear and Clearstream, Luxembourg will be specified in the applicable Final Terms. If the Covered Bonds are to clear through an additional or alternative clearing system the appropriate information will be specified in the applicable Final Terms.

Conditions for determining price

The price and amount of Covered Bonds to be issued under the Programme will be determined by the Issuer and each relevant Dealer at the time of issue in accordance with prevailing market conditions.

In relation to any Tranche of Fixed Rate Covered Bonds, an indication of the yield in respect of such Covered Bonds will be specified in the applicable Final Terms. The yield is calculated at the Issue Date of the Covered Bonds on the basis of the relevant Issue Price. The yield indicated will be calculated as the yield to maturity as at the Issue Date of the Covered Bonds and will not be an indication of future yield.

Independent Auditors

The auditors of Eurobank Holdings are KPMG Certified Auditors S.A. whose address is Stratigou Tombra Street 3, Aghia Paraskevi GR-15342 ("**KPMG Athens**"), who have audited Eurobank Holdings's consolidated financial statements, without qualification, in accordance with IFRS, for each of the two financial years ended for the financial years ended 31 December 2022 and 31 December 2021. The auditors of the Issuer are KPMG Athens, who have audited the Issuer's individual and consolidated financial statements, without qualification, in accordance with IFRS, for each of the two financial years ended 31 December 2022 and 31 December 2021.

Third Parties

The Issuers confirm that third party information included in this Base Prospectus has been accurately reproduced and that, so far as it is aware and is able to ascertain from information published by each relevant source, no facts have been omitted which would render the reproduced information inaccurate or misleading.

Dealers

Certain of the Dealers and their affiliates have engaged, and may in the future engage, in investment banking and/or commercial banking transactions with, and may perform other financial advisory and other services for the Issuers and their respective affiliates in the ordinary course of business. Certain of the Dealers and their affiliates may have positions, deal or make markets in the Covered Bonds issued under the Programme, related derivatives and reference obligations, including (but not limited to) entering into hedging strategies on behalf of the Issuers and their respective affiliates, investor clients, or as principal in order to manage their exposure, their general market risk, or other trading activities. Certain of the Dealers may from time to time also enter into swap and other derivative transactions with the Issuers and their respective affiliates. In addition, in the ordinary course of their business activities, the Dealers and their affiliates may make or hold a broad array of investments and actively trade debt and equity securities (or related derivative securities) and financial instruments (including bank loans) for their own account and for the accounts of their customers. Such investments and securities activities may involve securities and/or instruments of the Issuers and their respective affiliates. Certain of the Dealers or their affiliates that have a lending relationship with the Issuers routinely hedge their credit exposure to the Issuers consistent with their customary risk management policies. Typically, such Dealers and their affiliates would hedge such exposure by entering into transactions which consist of either the purchase of credit default swaps or the creation of short positions in securities, including potentially the Covered Bonds issued under the Programme. Any such positions could adversely affect future trading prices of Covered Bonds issued under the Programme. The Dealers and their affiliates may also make investment recommendations and/or publish or express independent research views in respect of such securities or financial instruments and may hold, or recommend to clients that they acquire, long and/or short positions in such securities and instruments.
