You are about to purchase a product that is not simple and may be difficult to understand

#### What is this product?

Type: Structured Note.

**Term:** The product has a fixed term and will be due on 20 October 2026.

Objectives:

The product is designed to provide (1) a return in the form of variable interest payments calculated by reference to the SOFR and (2) repayment of the product notional amount on the Maturity Date. The product has a fixed term and will terminate on the Maturity Date.

On a quarterly basis, you will receive an interest payment calculated by observing the SOFR compounded over the last 3 months in each interest calculation period (using 5 days lag). The interest rate applicable to each interest period will be:

- If SOFR compounded over 3 month is higher than 5%, the investor receives a quarterly interest equals to 7% p.a.
- If SOFR compounded over 3 month is higher than 2.5% and lower or equal to 5%, the investor receives a quarterly interest equals to the SOFR compounded over 3 month plus 0.50% p.a.
- If SOFR compounded over 3 month is lower or equal to 2.5%, the investor receives a quarterly interest equals to 1.25% p.a.

SOFR: The Secured Overnight Financing Rate (SOFR) is a broad measure of the cost of borrowing cash overnight collateralized by Treasury securities. The SOFR includes all trades in the Broad General Collateral Rate plus bilateral Treasury repurchase agreement (repo) transactions cleared through the Delivery-versus-Payment (DVP) service offered by the Fixed Income Clearing Corporation (FICC), which is filtered to remove a portion of transactions considered "specials".

The SOFR is calculated as a volume-weighted median of transaction-level tri-party repo data, GCF Repo transaction data and data on bilateral Treasury repo transactions. Under the product terms, certain dates specified above will be adjusted if the respective date is either not a business day or not a trading day (as applicable). The product terms also provide that if certain exceptional events occur (1) adjustments may be made to the product and/or (2) the product issuer may terminate the product early. These events are specified in the product terms and principally relate to the SOFR, the product and the product issuer. The return (if any) you receive on such early termination is likely to be different from the scenarios described above and may be less than the amount you invested.

The product does not offer any protection from the effect of inflation rate on Notional Amount at Maturity Date. The return adjusted for inflation rate might be lower or even negative.

The product is intended to be offered to retail investors who fulfil all of the criteria below:

# What are the risks and what could I get in return?



The risk indicator assumes you keep the product until the Maturity Date. The actual risk can vary significantly if you cash in at an early stage and you may get back less. You may not be able to end your product early. You may have to pay significant extra costs to end your product early.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you. We have classified this product as 5 out of 7, which is a medium-high risk class. You are entitled to receive back at least 103.75% of your capital. Any amount over this, and any additional return, depends on future market performance and is uncertain. However, this protection against future market performance will not apply if you cash-in before the Maturity Date. If we are not able to pay you what is owed, you could lose your entire investment. However, you may benefit from a consumer protection scheme (see section "What happens if the Bank is unable to pay out?"). The indicator shown above does not consider this protection. #### What happens if the Bank is unable to pay out?

# How long should I hold it and can I take my money out early?

# **Recommended Holding Period: 3 years**

The product aims to provide you with the return described under "1. What is this product?" above. However, this only applies if the product is held to maturity. It is therefore recommended that the product is held until maturity.
