What is this product?

Type:	Structured Note (Senior Preferred Funding Instrument)
Term:	The product has a fixed term and will be due on 15 June 2029
Objectives:	<p>The product is designed to provide (1) a return in the form of variable interest payments calculated by reference to the EURIBOR 3 months and (2) repayment of the product notional amount on the Maturity Date. The product has a fixed term and will terminate on the Maturity Date.</p> <p>On a quarterly basis, you will receive an interest payment calculated by observing the EURIBOR 3 months. The interest rate applicable to each interest period will be:</p> <ul style="list-style-type: none"> If EURIBOR 3 months is higher than 2.75%, the investor does not receive interest. If EURIBOR 3 months is higher than or equal to 1.70% and lower than or equal to 2.75%, the investor receives a quarterly interest of 4.00%. What are the risks and what could I get in return?



The risk indicator assumes you keep the product until the Maturity Date. The actual risk can vary significantly if you cash in at an early stage and you may get back less. You may not be able to end your product early. You may have to pay significant extra costs to end your product early.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you. We have classified this product as 5 out of 7, which is a medium-high risk class. You are entitled to receive back at least 100% of your capital. Any amount over this, and any additional return, depends on future market performance and is uncertain. However, this protection against future market performance will not apply if you cash-in before the Maturity date. If we are not able to pay you what is owed, you could lose your entire investment. However, you may benefit from a consumer protection scheme (see section "What happens if the Bank is unable to pay out?"). The indicator shown above does not consider this protection. Performance Scenarios

What you will get from this product depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted. The scenarios shown are illustrations based on results from the past and on certain assumptions. Markets could develop very differently in the future.

The favourable, moderate and unfavourable scenarios represent possible outcomes that have been calculated based on simulations using the reference asset's performance over up to 5 past years. The stress scenario shows what you might get back in extreme market circumstances. This product cannot be easily cashed in. If you exit the investment earlier than the recommended holding period you do not have a guarantee and you may have to pay extra costs.

What happens if the Bank is unable to pay out?

You are exposed to the risk that the Bank, as issuer, might be unable to meet its obligations in connection with the product, for instance in the event of bankruptcy or an official directive for resolution action. What are the costs?

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. How long should I hold it and can I take my money out early?

Recommended Holding Period: 4 years

The product aims to provide you with the return described under “1. What is this product?” above. However, this only applies if the product is held to maturity. It is therefore recommended that the product is held until maturity.
