You are about to purchase a product that is not simple and may be difficult to understand

What is this product?

Type: This product is a structured note.

Objectives: This product is designed to provide (1) a return in the form of semiannual variable interest amounts paid on Interest Payment Dates and calculated by reference to the relative level of 6 month Euribor (Underlying) on Interest Determination Dates, and (2) a cash payment of the Product Notional amount on the maturity date. The product has a fixed term and will terminate on the maturity date.

Interest amounts: on each Interest Payment Date you will receive an interest payment of EUR: Product Notional amount * Interest Rate.

Interest Rate: A per annum rate equal to 6 month Euribor plus 2.90%, subject to a floor of 1.50% and a cap of 6.30%

Termination on the maturity date: On termination of the product on the maturity date, you will receive the Product Notional amount.

<u>Underlying</u>: 6 month Euribor: Euro Interbank Offered Rate (the benchmark rate of Euro money markets) with designated maturity 6 months. Bloomberg screen page: EUR006M<Index>

The 6-month Euribor rate is published by the official website of the <u>European Money Markets Institute (EMMI)</u>. Eurobank, in case of a significant change or interruption of the provision of the Reference Index, will take the actions described in the <u>Action Plan</u> document (https://www.eurobank.gr/-media/eurobank/footer/pdf/plan-alternative-benchmarks-eurobank-global-markets-en.pdf) prepared in compliance with Article 28 (2) of Regulation (EU) 2016/1011 of the European Parliament and of the Council of 8th June 2016 on indices used as benchmarks in financial instruments and financial contracts or to measure the performance of investment funds.

Interest Determination Dates: Two TARGET Settlement Days preceding the first day of each calculation period.

Under the product terms, certain dates specified above will be adjusted if the respective date is either not a business day or not a trading day (as applicable). The product terms also provide that if certain exceptional events occur (1) adjustments may be made to the product and/or (2) the product issuer may terminate the product early. These events are specified in the product terms and principally relate to the underlying index, the product and the product issuer. The return (if any) you receive on such early termination is likely to be different from the scenarios described above and may be less than the amount you invested.

Intended investor: The product is intended to be offered to retail investors who fulfil all of the criteria below:

- 1. they have the ability to make an informed investment decision through sufficient knowledge and understanding of the product and its specific risks and rewards, with experience of investing in and/or holding a number of similar products providing a similar market exposure, either independently or through professional advice;
- 2. they seek income and/or full principal protection, subject to the issuer's ability to pay, expect the movement in the underlying to perform in a way that generates a favourable return and have an investment horizon of the recommended holding period specified below;
- 3. they accept the risk that the issuer could fail to pay or perform its obligations under the product but otherwise they are not able to bear any loss of their investment; and
- 4. they are willing to accept a level of risk to achieve potential returns that is consistent with the summary risk indicator shown below.



What are the risks and what could I get in return? The risk indicator assumes you keep the product until the agreed settlement date. You may not be able to end your product early. You may have to pay significant extra costs to end your product early.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 5 out of 7, which is a medium-high risk class. Be aware of currency risk. In case that the currency of the country that you purchased the note is different than the currency of the note, you may receive payments in a different currency, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above. You are entitled to receive back at least 100.00 % of your capital. Any amount over this, and any additional return, depends on future market performance and is uncertain. However, this protection against future market performance will not apply if you cash-in before the Maturity date. If we are not able to pay you what is owed, you could lose your entire investment. However, you may benefit from a consumer protection scheme (see section "What happens if the Bank is unable to pay out?"). The indicator shown above does not consider this protection. This table shows the money you could get back until the Maturity date, under different scenarios, assuming that you invest EUR 10,000.00. The scenarios shown illustrate how your investment could perform. You can compare them with the scenarios of other products. What happens if the Bank is unable to pay out?

What are the costs?

The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account one-off, ongoing and incidental costs.

The amounts shown here are the cumulative costs of the product itself, for the Recommended Holding Period. They include potential early exit penalties. The figures assume you invest EUR 10,000.00. The figures are estimates and may change in the future.

How long should I hold it and can I take my money out early?

Recommended Holding Period: 3 years
