You are about to purchase a product that is not simple and may be difficult to understand

What is this product?

Type:	Structured Note
Term:	The product has a fixed term and will be due on 20 October 2028 (Maturity Date).
Objectives:	This product is designed to provide the investor with (1) a return in the form of a fixed interest amount paid on the first Interest Payment Date (2) a return in the form of annually variable interest amounts paid on Interest Payment Dates starting from the second year until the Maturity Date and calculated by reference to the relative daily level of SOFR, and (3) a cash payment of the Product Notional amount on the Maturity Date. The product has a fixed term and will terminate on the Maturity Date.

Interest amounts: on each Interest Payment Date, starting from the second year, you will receive an interest payment of USD: Product Notional amount * Interest Rate per annum.

Interest Rate: the Interest Rate in respect of each Product Notional Amount and an Interest Period is the percentage determined by the formula: $6.00\% \times \text{Range Accrual}$

Range Accrual: a fraction calculated by Eurobank S.A., by reference to the formula: $(\text{Days Accrued}) / (\text{Actual Days})$.

Actual Days: the actual number of calendar days in such Interest Period.

Days Accrued: the number of calendar days in such Interest Period for which the Underlying is greater or equal to 2.50% and less than or equal to 4.50%.

Rate Determination Date: in respect of any calendar day in an Interest Period, (i) where such calendar day falls in the period from and including the fifth Business Day prior to the Interest Payment Date on which such Interest Period ends, the fifth Business Day prior to the Interest Payment Date on which such Interest Period Ends, or (ii) on any other calendar day, such calendar day, PROVIDED THAT IN EACH CASE, if any such day is not a Business Day or if the Relevant Screen Page is not available and/or the Relevant Rate does not appear on the Relevant Screen Page, in each case, on such day, (each such day, a Non-Determinable Day), the relevant Rate Determination Date will instead be the immediately preceding Business Day for which the Relevant Screen Page was available and such Relevant Rate appeared on the Relevant Screen Page.

Interest Payment Dates: 20th of October of each year, from and including 20th of October 2025 to and including the Maturity Date.

Underlying: "SOFR": Secured Overnight Financing Rate administered by the Federal Reserve bank of New York.

Relevant Screen page: Bloomberg page "SOFRRATE INDEX".

"SOFR" in respect of any U.S. Government Securities Business Day ("USBDx"), is a reference rate equal to the daily secured overnight financing rate as provided by the Federal Reserve Bank of New York, as the administrator of such rate (or any successor administrator of such rate) on the New York Fed's Website, in each case at or around 3.00 p.m. (New York City time) on the U.S. Government Securities Business Day immediately following such USBDx;

Under the product terms, certain dates specified above will be adjusted if the respective date is either not a business day or not a trading day (as applicable). The product terms also provide that if certain exceptional events occur (1) adjustments may be made to the product and/or (2) the product issuer may terminate the product early. These events are specified in the product terms and principally relate to the underlying index, the product and the product issuer. The return (if any) you receive on such early termination is likely to be different from the scenarios described above and may be less than the amount you invested.

The product does not offer any protection from the effect of inflation rate on Notional Amount at Maturity Date. The return adjusted for inflation rate might be lower or even negative.

Intended retail investor:

The product is intended to be offered to retail investors who fulfil all of the criteria below:

1. they have the ability to make an informed investment decision through sufficient knowledge and understanding of the product and its specific risks and rewards, with experience of investing in and/or holding a number of similar products providing a similar market exposure, either independently or through professional advice;
2. they seek for income and/or full principal protection, subject to the issuer's ability to pay;
3. they accept the risk that the issuer could fail to pay or perform its obligations under the product but otherwise they are not able to bear any loss of their investment provided the investor will hold the product till the Maturity Date and
4. they are willing to accept a medium-high risk level to achieve potential returns as specified in the summary risk indicator shown below.

What are the risks and what could I get in return?



The risk indicator assumes you keep the product until the Maturity Date. The actual risk can vary significantly if you cash in at an early stage and you may get back less. You may not be able to end your product early. You may have to pay significant extra costs to end your product early.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you. We have classified this product as 5 out of 7, which is a medium-high risk class. You are entitled to receive back at least 100.00% of your capital. Any amount over this, and any additional return, depends on future market performance and is uncertain. However, this protection against future market performance will not apply if you cash-in before the Maturity date. If we are not able to pay you what is owed, you could lose your entire investment. However, you may benefit from a consumer protection scheme (see section "What happens if the Bank is unable to pay out?"). The indicator shown above does not consider this protection. Performance Scenarios

What you will get from this product depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted. The scenarios shown are illustrations based on results from the past and on certain assumptions. Markets could develop very differently in the future.

The favourable, moderate and unfavourable scenarios represent possible outcomes that have been calculated based on simulations using the reference asset's performance over up to 5 past years. The stress scenario shows what you might get back in extreme market circumstances. This product cannot be easily cashed in. If you exit the investment earlier than the recommended holding period you do not have a guarantee and you may have to pay extra costs.

What happens if the Bank is unable to pay out?

What are the costs?

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

How long should I hold it and can I take my money out early?

Recommended Holding Period: 4 years

The product aims to provide you with the return described under "1. What is this product?" above. However, this only applies if the product is held to maturity. It is therefore recommended that the product is held until maturity.

The product does not guarantee the possibility to disinvest other than by selling the product, either (1) through the exchange (if the product is exchange traded) or (2) off-exchange, where an offer for such product exists. By selling the product before its maturity, you may receive back less than you would have received if you had kept the product until maturity.
