

ANNOUNCEMENT**PURCHASE OF OWN SHARES**

Eurobank S.A. (hereinafter “Eurobank” or the “Bank”), following its announcement of 10.06.2026 with respect to the commencement of the Share Buyback Programme (“Programme”), which was approved pursuant to the resolution of the Annual General Meeting of the Bank’s Shareholders held on 28.04.2026, in accordance with Article 49 of Law 4548/2018 (the “Programme”), and following the resolution of the Bank’s Board of Directors dated 29.04.2026, hereby informs the public that during the period 10.08.2026 – 14.08.2026, it repurchased, within the framework of the Programme, a total of 1,245,703 shares issued by the Bank (“Own Shares”) and traded on the Euronext Athens, with an average purchase price of €4.4941 per share and a total cost of €5,598,354.27.
